

**ORDINANCE NO. 4  
Series 2010**

January 5, 2010: Introduced as Council Bill 20, Series 2009 by Councilor Mark Griffin, seconded by Councilor Harriet Crittenden LaMair, and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

January 19, 2010: Considered in full text on second reading. Passed by a vote of 4 yes and 0 no.

**A BILL FOR AN ORDINANCE  
OF THE CITY OF CHERRY HILLS VILLAGE,  
AUTHORIZING A SUPPLEMENTAL APPROPRIATION FOR PAYMENT TO ERIC ENSEY  
WITH RESPECT TO THE SETTLEMENT AGREEMENT AND RELEASE IN FISCAL YEAR  
2010**

**WHEREAS**, the City of Cherry Hills Village and Eric J. Ensey (“Ensey”) entered into a Settlement Agreement and Release (“Agreement”) dated December 18, 2009, and which was approved by the Cherry Hills Village City Council on January 5, 2010; and

**WHEREAS**, the Agreement requires Cherry Hills Village to pay to Ensey the gross amount of fifty-eight thousand, eight hundred eighty-eight dollars and sixty-eight cents (\$58,888.68) on January 15, 2010; and

**WHEREAS**, the payments were not budgeted for in the 2010 budget; and

**WHEREAS**, the January 5, 2010 City Council meeting is the first opportunity the Council has had after Ensey’s employment has ended to approve a supplemental appropriation. Recognizing that this ordinance approving the supplemental appropriation will not technically become effective until after passage of second reading at the Council’s second meeting in January, City Council directs staff to make payments to Ensey by January 15, 2010 as required in the Agreement.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:**

Section 1. That the 2010 Budget and Appropriations be hereby supplemented by increasing the following funds and accounts, to-wit:


