RESOLUTION
OF THE CITY COUNCIL
OF THE CITY OF CHERRY HILLS VILLAGE
APPROVING THE ARAPAHOE COUNTY CONSOLIDATED LAW ENFORCEMENT CAD
INTERGOVERNMENTAL AGREEMENT

WHEREAS, in accordance with Section 13.6 of the City of Cherry Hills Village Home Rule Charter, the City Council may, by resolution, enter into intergovernmental agreements with other governmental agencies for the use of buildings, equipment or facilities, and for furnishing or receiving commodities or services; and

WHEREAS, Arapahoe County, and the cities of Englewood, Glendale, Littleton, and Greenwood Village, each operate a Public Safety Answering Point (PSAP), which provides e-911 and law enforcement dispatch services; and

WHEREAS, the Arapahoe County PSAP provides E-911 and law enforcement dispatch services to the City of Cherry Hills Village and the City of Sheridan; and

WHEREAS, in order to save costs and increase interoperability among the above-named parties' law enforcement agencies, the parties, along with the Arapahoe County E-911 Communications Service Authority, which provides financial assistance to the PSAPs, desire to select, design, purchase and use a single consolidated computer aided dispatch (CAD) to be hosted and operated by Arapahoe County pursuant to the terms of an intergovernmental agreement; and

WHEREAS, the City Council desires to continue receiving cost-effective dispatch services from the Arapahoe County PSAP and to participate in the CAD system through execution of an intergovernmental agreement in substantially the same form as attached to this Resolution as Exhibit A.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Cherry Hills Village, Colorado that:

Section 1. The City Council of the City of Cherry Hills Village approves the Arapahoe County Consolidated Law Enforcement (CAD) Intergovernmental Agreement between and among the Cities of Englewood, Glendale, Littleton, Sheridan, Greenwood Village, Cherry Hills Village, and Arapahoe County and the Arapahoe County E-911 Communication Service Authority, in substantially the same form as attached hereto and made a part of the Resolution and the Mayor is authorized to sign the Intergovernmental Agreement on behalf of the City.

Section 2. This Resolution shall be effective immediately.
