March 7, 2017: Introduced as Council Bill 2, Series 2017 by Councilor Katy Brown, seconded by Councilor Dan Sheldon and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

March 21, 2017: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

**A BILL FOR AN ORDINANCE  
 OF THE CITY OF CHERRY HILLS VILLAGE,  
 AUTHORIZING A SUPPLEMENTAL APPROPRIATION FOR FISCAL YEAR 2017  
 RELATED TO PUBLIC WORKS VEHICLES**

**WHEREAS**, in accordance with Article IX of the Home Rule Charter, the City Council of the City of Cherry Hills Village budgeted and appropriated funds in 2016 for the replacement and installation of a new bed and paint on a City owned dump truck; and

**WHEREAS**, the work related to such appropriation was not completed in 2016; however, the 2017 budget does not authorize such expenditure; and

**WHEREAS**, the City Council desires to pay the contractor for these materials and services in 2017; and

**WHEREAS**, in accordance with Section 9.10 of the Home Rule Charter, the City Council desires to make an additional appropriation in the 2017 budget for the necessary expenditure related to public works vehicles as set forth herein; and

**WHEREAS**, the additional appropriation contemplated by this Ordinance does not exceed amount by which actual and anticipated revenues of the year are exceeding the revenues as estimated in the 2017 budget

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS  
 VILLAGE, COLORADO, ORDAINS:**

**Section 1.** That the 2017 Budget and Appropriations is hereby supplemented by increasing the following fund and account, to-wit:

Vehicles Public Works 02-441-3104

**Section 2.** The City Council hereby ratifies all expenditures heretofore and hereafter made pursuant to this supplemental appropriation ordinance.

**Section 3.** This Ordinance shall become effective ten (10) days after publication on second reading in accordance with Section 4.5 of the Charter for the City of Cherry Hills Village.
