

**A RESOLUTION  
OF THE CITY COUNCIL  
OF THE CITY OF CHERRY HILLS VILLAGE  
APPOINTING NEW MEMBERS TO THE PARKS, TRAILS AND RECREATION COMMISSION**

**WHEREAS**, Section 3.1 of the City of Cherry Hills Village City Charter authorizes the City Council to “delegate to board and commissions...such functions, powers and authority of the City as it deems proper and advisable”; and

**WHEREAS**, Ordinance 02-06 established the Parks, Trails and Recreation Commission (the “Commission”); and

**WHEREAS**, Sections 2-8-20 and 2-8-30 of the City Municipal Code require that the Parks, Trails and Recreation Commission shall consist of seven (7) members: one (1) from each Council district; and one member appointed by the City Council on an at-large basis; provided, however that if the Council is not reasonably able to appoint one member from each Council district the Council may appoint one or more members of the commission on an at-large basis. On the date of appointment, each district member shall be a registered elector of the City for at least three (3) years immediately preceding the date of appointment. Each district member shall be a resident of the district on the date of appointment and throughout his or her term of office; and

**WHEREAS**, Commissioner Robert Eber was elected to the City Council in November 2022 and assumed duties on January 17, 2023, prior to the end of his term on the Commission; and

**WHEREAS**, Commissioners Fred Wolf and Kate Murphy have chosen not to seek reappointment at the end of their current terms which end in May 2023; and

**WHEREAS**, applications were solicited in the Village Crier and through the City website, and past applicants from the last two years were contacted; and

**WHEREAS**, Councilors Al Blum and Robert Eber reviewed applications and conducted interviews; and

**WHEREAS**, Councilors Blum and Eber recommend appointment of Mary Prescan to fill the current vacancy; and

**WHEREAS**, Councilors Blum and Eber recommend appointment of Howard Sherr and Laurel O’Brien to the Commission beginning in May 2023; and

**WHEREAS**, the City Council determines that Ms. Prescan, Mr. Sherr, and Ms. O’Brien are qualified and desires to appoint Ms. Prescan, Mr. Sherr, and Ms. O’Brien to the Commission.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO THAT:**

The City Council hereby makes the following appointments to the City of Cherry Hills Village Parks, Trails and Recreation Commission:
