November 7, 2023: Introduced as Council Bill 9, Series 2023 by Councilor Earl Hoellen, seconded by Mayor Pro Tem Randy Weil, and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

December 6, 2023: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

A BILL FOR AN ORDINANCE OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO AUTHORIZING APPROPRIATIONS FOR FISCAL YEAR 2024

WHEREAS, the City of Cherry Hills Village has prepared and approved a Budget for fiscal year 2024 and the City is authorized and required to make appropriations by ordinance for each fiscal year pursuant to Article IX of the Charter of Cherry Hills Village.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

Section 1. From the monies obtained from taxation and from all other sources of revenue of the City of Cherry Hills Village, Colorado, during the year beginning January 1, 2024, and ending December 31, 2024, there is hereby appropriated the following sums for the following funds, to-wit:


General Fund	\$ 8,561,550
Capital Fund	3,340,760
Parks and Recreation Fund	4,407,933
Conservation Trust Fund	64,500
Arapahoe County Open Space Fund	110,000
Water & Sewer Enterprise Fund	300,610
Catherine Anderson Land Donation Fund	213,120
American Rescue Plan Act Fund	1,305,490
COP Fund (Capital Projects)	<u>333,900</u>
TOTAL	\$ 18,637,863

Section 2. The City Council, pursuant to Article XX of the Colorado Constitution, deems that this ordinance supersedes the provisions of C.R.S. § 29-1-301, and that said statute is inapplicable to the matters addressed by this ordinance.



Should any section, clause, sentence or part of this Ordinance be adjudged by any court to be unconstitutional or invalid, the same shall not affect, impair or invalidate the ordinance as a whole or any part thereof other than the part so declared to be invalid, except to the extent that such invalidation defeats the purpose and intent of the City Council in adopting this ordinance.


