

**A RESOLUTION
OF THE CITY COUNCIL
OF THE CITY OF CHERRY HILLS VILLAGE
APPOINTING NEW MEMBERS TO THE PARKS, TRAILS AND RECREATION COMMISSION**

WHEREAS, Section 3.1 of the City of Cherry Hills Village City Charter authorizes the City Council to "delegate to board and commissions...such functions, powers and authority of the City as it deems proper and advisable"; and

WHEREAS, Ordinance 02-06 established the Parks, Trails and Recreation Commission (the "Commission"); and

WHEREAS, Sections 2-8-20 and 2-8-30 of the City Municipal Code require that the Parks, Trails and Recreation Commission shall consist of seven (7) members: one (1) from each Council district; and one member appointed by the City Council on an at-large basis; provided, however that if the Council is not reasonably able to appoint one member from each Council district the Council may appoint one or more members of the commission on an at-large basis. On the date of appointment, each district member shall be a registered elector of the City for at least three (3) years immediately preceding the date of appointment. Each district member shall be a resident of the district on the date of appointment and throughout his or her term of office; and

WHEREAS, Commissioners Stephanie Dahl and Chelsea Scott have chosen not to seek reappointment at the end of their current terms which end in May 2024; and

WHEREAS, applications were solicited through the Village Crier, the City website, and City social media accounts; there were no past applicants from the last two years; and

WHEREAS, no applications were received by the deadline from residents in District 3 or District 4; and

WHEREAS, Mayor Pro Tem Randy Weil and Councilor Robert Eber reviewed applications and conducted interviews; and

WHEREAS, Mayor Pro Tem Weil and Councilor Eber recommend appointment of Martin Greer and Kevin Kanouff to serve on the Commission; and

WHEREAS, the City Council determines that Mr. Greer and Mr. Kanouff are qualified and desires to appoint Mr. Greer and Mr. Kanouff to the Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO THAT:

The City Council hereby makes the following appointments to the City of Cherry Hills Village Parks, Trails and Recreation Commission:

Kevin Kanouff	1 (or at-large)	3 rd Tuesday in May 2024	3 rd Tuesday in May 2027


This Resolution shall be effective immediately upon adoption.

Introduced, passed and adopted at the regular meeting of City Council this 21st day of May, 2024, by a vote of 5 yes and 0 no.


