

A RESOLUTION
OF THE CITY COUNCIL
OF THE CITY OF CHERRY HILLS VILLAGE
REAPPOINTING A MEMBER AND APPOINTING NEW MEMBERS
TO THE CHERRY HILLS VILLAGE ART COMMISSION

WHEREAS, Section 3.1 of the City of Cherry Hills Village City Charter authorizes the City Council to "delegate to board and commissions...such functions, powers and authority of the City as it deems proper and advisable"; and

WHEREAS, the Cherry Hills Village Art Commission (the "Commission") was established by Resolution 6, Series 2011 and expanded by Resolution 10, Series 2017; and

WHEREAS, Commissioner Della Patteson is ending her first term on May 21, 2024 and desires to be reappointed to a second three-year term; and

WHEREAS, Commissioner Kristen Moore has chosen not to seek reappointment at the end of her current term which ends May 21, 2024; and

WHEREAS, Commissioner Pamela Hall resigned from the Commission prior to the end of her term; and

WHEREAS, applications were solicited through the Village Crier, the City website, and City social media accounts; there were no past applicants from the last two years; and

WHEREAS, Mayor Pro Tem Randy Weil and Councilor Robert Eber reviewed applications and conducted interviews; and

WHEREAS, Mayor Pro Tem Weil and Councilor Eber recommend appointment of Julie Mirr and Scottie Iverson to serve on the Commission; and

WHEREAS, the City Council determines that Ms. Patteson, Ms. Mirr and Ms. Iverson are qualified and desires to reappoint Ms. Patteson and appoint Ms. Mirr and Ms. Iverson to the Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE THAT:



The City Council hereby makes the following appointment to the City of Cherry Hills Village Art Commission:

Scottie Iverson	3 rd Tuesday in May 2024	3 rd Tuesday in May 2027


This Resolution shall be effective immediately.

Introduced, passed and adopted at the regular meeting of City Council this 21st day of May, 2024, by a vote of 5 yes and 0 no.


