## **RESIDENTS ELIGIBLE FOR RECREATION REFUNDS**

With the exclusion from South Suburban finalized (pending an appeal of the amount to be paid to South Suburban), effective January 1, 2005, residents will no longer be eligible for in-district rates at South Suburban facilities. The City will begin a reimbursement program for residents.

### **RECREATION REIMBURSEMENT**

The City has implemented a Recreation Reimbursement Program beginning January 1, 2005. Residents of Cherry Hills Village who participate in any recreation program, activity, class or event *offered by a municipal or special district recreation department* in the seven county Denver metropolitan area (Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, Jefferson), will be eligible for a partial reimbursement of certain costs from the City of Cherry Hills Village.

### **REIMBURSEMENT PROVISIONS**

The amount of reimbursement shall be 50 percent of the cost incurred by the resident; however, costs shall not exceed a maximum of \$50.00 per single activity, per resident to include memberships and passes. The purchase of a membership or multiple use pass is considered a single activity. There is a total annual maximum reimbursement for all recreation activities of \$500.00 per household.

*All requests for reimbursement must be submitted to the City no later than January 31 for the previous year. Submittals for reimbursement may occur throughout the calendar year and reimbursement will be made*

# MAYORAL MUSINGS

*"The taxpayer — that's someone who works for the government but doesn't have to take the civil service examination."* - Ronald Reagan

With, arguably, two of the largest milestones in the City's history – the exclusion from South Suburban and the building of a new Village Center - taking place simultaneously, I've gotten more than a few questions of late. And though a fair share of those are related to the health of my brain, the prevailing one is, "Where is the money coming from?"

It is important to remember: neither of these events increases our current mill levy. In other words, **"no new taxes"** - George H.W. Bush.

In 1999, we, the voters approved a measure by which the City can retain revenues over the Tabor limit. These revenues are kept in the fund appropriate to their revenue source (for example, excess revenue in the Conservation Trust Fund is retained in that fund). Most of the excess revenues are held in the General Fund for the City. This fund has increased since 1999 with the intent that the funds will be used for capital expenditures instead of operations or maintenance. This is where we are getting the money to build your new Village Center.

For the first time in the history of the Village, the City will collect taxes for park, trail and recreation purposes. Two, ten, even forty years ago taxes paid for the purposes of parks, recreation and open space were being paid to the South Suburban Park and Recreation District. The funds the City has collected have been from taxes generated for general governmental purposes, including the operation of City functions such as police, public works and administration. The use of these funds were never intended for park and recreation purposes as residents were separately taxed for those purposes by South Suburban.

Until the exclusion election in 2002, the City did not have a revenue source for parks and recreation purposes other than the Conservation Trust Fund. This fund is derived from Lottery funds and is approximately \$28,000 per year. The City has used these funds for joint projects with South Suburban or for other authorized park and trail purposes.

The election in 2002 authorizes the City to collect property taxes for park, trail and recreation purposes upon the exclusion of the City from the South Suburban Park and Recreation District. That has now happened. Also, any payment for the assets in the Village to South Suburban reduces the net amount of tax revenues the City will receive until the full amount is paid. The big difference is we will have local control over those funds. Again, there is **no new tax**.

Cherry Hills is fortunate in not having felt the impact of the State's budget crisis as much as other communities who depend upon retail taxes and state funded programs. Of course the obvious counter-point to that is we depend upon property taxes more so than most cities...which is to say, your money, my money and every member of the City Council's money is what runs the city. We "feel your pain" - William J. Clinton.

For the next year, we, as Council, will be dealing with making the best of these two very important issues in addition to other concerns such as berms, house to lot size ratios, traffic calming and the Blue Ribbon Panel recommendations. As we move forward in time, the voters of Cherry Hills will elect new Councils. A central theme for many of those campaigns will likely be how our tax dollars are spent because now "the buck stops here" - Harry Truman

### IDENTITY THEFT

Identity theft has been around as long as people have made monetary and credit transactions without having to be present or show photo I.D. However, it has become more prevalent through the use of the Internet. 1 out of 5 people will be a victim of identity theft or know someone who is.

#### **Shred any of the following that you are discarding.**

- Charge receipts
- Copies of credit applications
- Insurance forms
- Physician statements
- Bank checks and statements
- Expired charge cards
- Credit offers you get in the mail

#### **Minimize Your Risk**

- Adopt a “need to know” approach about giving out your personal information to others.
- Never give out credit card numbers or personal information.
- Pay attention to billing cycles.
- Only carry ID and credit cards or bank cards that you will be using.
- Keep items with personal information in a safe place.
- Know who has access to your personal information at work.

#### **Passwords**

##### **Never Use:**

- Your mother’s maiden name.
- Your middle name, your children’s names, or a nickname.
- Your birthdate, your children’s birthdates, or an anniversary.
- The last four digits of your SSN or phone or house number.
- A series of consecutive numbers.
- Your pet’s name.

## 2005 DOG LICENCES/ALARM PERMITS

Residents are reminded that CHV dogs must be licensed every year by March 1st. The fee for licensing is \$10 per dog. To license your dog, bring or mail in proof of the current rabies vaccination and (at least) one emergency number to the Village Center, Monday - Friday, from 7:30am to 4pm.

Villagers with security alarm systems are reminded that they must register their systems with the Cherry Hills Police. Security Alarm Permits are \$25 and must be renewed annually. # CHERRY HILLS VILLAGE'S BLUE RIBBON PANEL

## History

In April of 2004 the City Council of Cherry Hills Village enacted a citizen panel (The Blue Ribbon Panel) to make recommendations on the Parks, Trails and Open Space within Cherry Hills Village in anticipation of Exclusion from the South Suburban Park and Recreation District. Citizens supported the exclusion from SSPRD because of their desire to secure more open space, parks, and trails within the City, to obtain more recreational opportunities and to achieve a better quality of trail and park maintenance.

## Task

The Blue Ribbon Panel has been working on the many issues that are facing Cherry Hills Village as it prepares to take control of the parks, trails and open spaces within the City. Cherry Hills Village has made a substantial investment in the trails system, but has relied heavily on private lands for many of the open vistas which its citizens have perceived to be perpetual. While Cherry Hills Village is lucky to have had these private resources in the past they may not be here for long. The City now has an opportunity to provide a more thorough, well-rounded and protected system of parks, trails and open space.

## Purpose

The purpose of the Blue Ribbon Panel's recommendations is to set and establish vision, goals and objectives needed to prioritize and ensure the success of the parks, trails and open space programs within the Village. The recommendations will support a system that connects the entire community to parks, trails, open space areas, schools and the High Line Canal, for the benefit of all of the residents. The recommendations may include an analysis of the various methods of acquiring trail segments, parks and open space areas including cost estimates, implementation strategies and maintenance standards. In order to accomplish this, the Blue Ribbon Panel has been studying what is currently available to the citizens and what is necessary to create a cohesive park and trail system that is an amenity to the whole Village and surrounding communities.

## Trail Connection Needs

There are many important trail connections that need to be completed within the system. The Panel has been exploring opportunities to expand the trail system along important natural features serving as both neighborhood and community trails. The Blue Ribbon Panel has involved the Cherry Hills Village Parks and Trails Committee and tapped into their experience to help identify some of the deficiencies in the City's current parks, open spaces and key trail links.

## Open Space

Many of the key views and open spaces that are so valued by citizens and wildlife are based on private ownership and could face development in the future. Should the ownership change on any of these key pieces, the resources could be compromised and the character of the community could be altered dramatically. The Blue Ribbon Panel is looking into ways to promote opportunities for citizens to protect key natural and scenic properties within Cherry Hills Village with methods such as donations of conservation easements, trail easements, deed restrictions, grants, and cash purchases.

## Possible Recommendations

The Blue Ribbon Panel will also be making recommendations that may include changing or adding ordinances that will provide for permanent protection and enhancement of the resources that are within Cherry Hills Village's parks, trails and open spaces. The Panel's vision is to build on the Village's historical strength of a unique semi-rural character, and to preserve and acquire open space, parks and trails and to preserve remaining vistas for greater public access and enjoyment. Maintaining this semi-rural character that has drawn many of Cherry Hills Village's residents to live here is one of the Panel's main focuses.

The Blue Ribbon Panel will be making recommendations to City Council in March or April of 2005. The Panel is currently soliciting input from the general public to help them formulate their recommendations for Council. # SURVEY SUPPORTS PRESERVATION/ ACQUISITION OF PARKS & OPEN SPACE

The Cherry Hills Village Blue Ribbon Panel recently surveyed Villagers to learn more about community priorities. The Panel was appointed by City Council to make recommendations to the Council regarding the protection and enhancement of open space, trails, historic preservation and parks and recreation opportunities in the Village. The Panel is preparing to report to Council, and asked Villagers to participate in the planning process by way of the survey.

129 surveys were returned; Villagers who responded overwhelmingly supported the preservation and acquisition of open space, parks and trails to preserve and protect the Village's semi-rural atmosphere. Villagers reported a wide variety of individual uses of Cherry Hills Village's open space, trails and parks and also described favorite places in the Village. Issues raised also included suggestions for enforcement of existing rules, and changes to ordinances to better protect and enhance a Villager's experiences in open space, parks and trails. The survey results will provide direction and guidance to the Panel.

The Panel will continue to meet and to prepare its report for Council. Visit the web site for more information, member names and email addresses, and to communicate your thoughts. The Panel thanks all Villagers who responded to the survey request.

### ABOUT THE CRIER

The Crier is published 6 times annually - every other month - starting with the January/February issue. Other issues are: March/April, May/June, July/August, Sept/Oct, and November/December. The deadline for each issue is *approximately* the middle of March, May, July, September and November.

In 2004, Crier revenues were *approximateley* **\$13,700.00**. Costs were *approximately*: **\$13,600.00**. Surplus revenue is held over to the following year.

## ON THE TRAIL SUDERMAN TRAIL AND THE TRAILS NEAR ST. MARY'S ACADEMY

**\*STARTING POINT:** South High Street Cul-de-sac south of Quincy Avenue. There is plenty of on-road parking at the end of High Street.

**ROUTE:** Follow the “new” Trail #4420—THE SUDERMAN TRAIL—east to Trail # 2043 proceeding north to the Quincy Avenue east-west elevated trail on the south side of Quincy. This trail is #4320 and is delineated by a brick wall and a split-rail fence with very nice views of the Cherry Hills golf course on the north. However, as you approach Cherrymoor, this part of trail is NOT yet delineated. Continue walking easterly almost to University to Trail # 2445. Head south on Trail # 2445 which parallels University and curves west into Trail # 4522. This is a beautiful tree-lined section of trail, fragrant with big evergreens. Turn south on Trail # 2245 which runs along the west side of St. Mary's campus. This area is very open and has good views along the trail. As you walk south Trail #2245 becomes Trail # 2247. Head west on Trail # 4720 to South Vine Way—an on-road trail. You will connect with Trail # 4520, which goes west to Trail # 2043, walk north back to Trail #4420—our starting point on South High Street.

**DISTANCE:** Approximately 1 1/2 miles

**WALKING TIME:** 50 minutes (total loop)

**NOTES OF INTEREST:** This section of the Village has a great network of trails which connect in many different directions. Most of these trails are delineated with split rail fencing and clearly marked with Trail Marker Bollards. As you walk along the west side of St. Mary's you will notice a Fantasia-like Butterfly Bridge on their school grounds. At the south end of St. Mary's campus, there is an east-west trail (#4722 & #4720) that will take you either east to University Blvd. (where a future Trail Underpass could connect the east and west sides of the Village), or west and south to Woodie Hollow Park. Further north at Trail # 4618 is Little Dry Creek and all the wildlife the creek supports. We are so very fortunate to have trail supporters like Mr. Suderman, who so generously has given a trail easement along his property allowing Village residents a wonderful new access to the trail system. Hats off to Mr. Suderman! We are grateful for this important section of trail and his vision for the future.

**P.S.** As you enjoy walking our neighborhood trails, you can PITCH IN to keep our trails clean and beautiful by picking up trash along the trails. “EVERY LITTER BIT HELPS.”





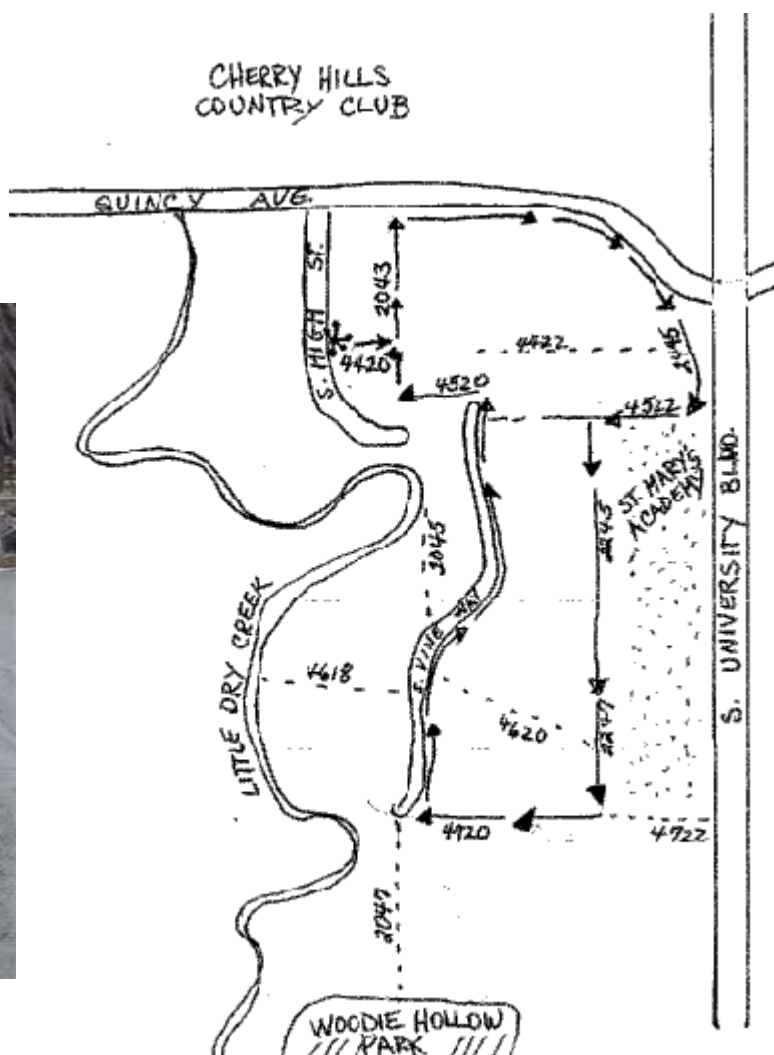

## FREQUENTLY ASKED QUESTIONS ABOUT RECREATION REIMBURSEMENT

**Can my membership to the YMCA be submitted for reimbursement?**

*No, the YMCA is not a municipal or special district recreation department.*

**Can my membership to the Greenwood Athletic Club be submitted for reimbursement?**

*No, the Greenwood Athletic Club is not a municipal or special district recreation department.*

**Can I submit my childcare costs for reimbursement?**

*No, childcare is not considered a recreation program, activity, class or event.*

**Can I submit for reimbursement a receipt for a \$100 ice skating class that my daughter is taking through South Suburban Recreation District?**

*Yes, the amount of the reimbursement will be \$50 (50 percent of the cost incurred not to exceed a maximum of \$50.00 per single activity) as long as you have not exceeded the maximum reimbursement for all recreation activities of \$500.00 per household.*

**Can I submit my receipts for classes from 2004?**

*No, our recreation reimbursement program begins for the calendar year 2005.*

**Can I submit a photocopy of my receipt?**

*No, original receipt is required.*

**Where can I get a recreation reimbursement form and instructions?**
