

VILLAGERS CREATE LAND PRESERVE ORGANIZATION

**THE CHERRY HILLS LAND PRESERVE IS A NON PROFIT
ORGANIZATION DEDICATED TO PRESERVATION**

In May, 2004, the Cherry Hills Land Preserve received its tax-exempt status and formally came into existence. The Cherry Hills Land Preserve is Cherry Hills Village's own community-based non-profit organization. It is dedicated to preserving the rural character of CHV by working to preserve open lands and natural areas of significant scenic, environmental, historic, and recreational value. The group has spent the last several months putting its Board of Directors and its organizational structure into place. Board members say they are now ready to go public.

"There are so many of my friends and neighbors - so many Villagers - who were lamenting the loss of what we value most about our community not to step forward and do something about it," says Board member **Harriet LaMair**. "We looked carefully at the models at what other communities who have been successful at preservation have done, and those models have always included a community non-profit organization, primarily because of the impact this kind of organization can have and what it is capable of doing.

VILLAGE CENTER UPDATE

Through a Supplemental Appropriation for Fiscal Year 2005, the City Council has purchased the parcel of land located at 125 Meade Lane for the purpose of shifting the Village Center and Fire Station out of the flood plain and using the additional land to enhance John Meade Park. The property was purchased for \$1,319,500; the funds came from the surplus fund balance. The preliminary plat for reconfiguration of the property boundaries was heard by the Planning Commission at the March 22nd meeting and at the April 5th Council meeting.

LPGA JUNE EVENT SUBJECT OF HEARING

At the City Council meeting on March 15, Council held a public hearing on the U.S. Women's Open Golf Championship to be held at Cherry Hills Country Club from **June 19 - 26**.

One issue of concern for Villagers is the daily transportation of approximately 20,000 - 25,000 spectators and participants to and from the event. CHCC does not have the space to accommodate the numbers of people needing to park, so spectators will be bussed from the Mt. View Golf Course at I-25 and Bellevue to St. Mary's Academy; the proposal is that spectators will then walk from St. Mary's to the Country Club along the bridle path in Cherrymoor. Volunteers at the event will park at Kent school and walk or be shuttled from there to CHCC.

CRIME PREVENTION TIPS

The police are seeing a sharp rise in property crimes within the Village. Crimes range from mail thefts, burglaries, and car thefts to thefts from cars. The thieves do not appear to be professionals but rather opportunists who are looking for "easy pickings."

It is startling how many crimes we have investigated which involve entry through open garage doors, unlocked side/rear doors, keys left in cars, cars left running but unoccupied, and valuables left in plain view inside cars. Theft of mail is also noticeably on the rise.

Here are some **tips to prevent identity theft** we hope you will find useful:

- Use checks as little as possible. With an account and routing number on the paper, checks provide a direct link to your checking account.
- Pay bills on-line. It is a misconception that identity theft occurs online. In fact, 80% of identity theft happens offline.
- If you must mail a check, take it to the post office directly. **Never put outgoing mail in your home mailbox.**
- Keep track of your credit cards while in restaurants. Make sure your card is given back to you and not someone else's card.
- Never leave a receipt on a table unattended in a restaurant. Merchant copies of credit card and debit cards sometimes list full card numbers and expiration dates.
- Cross out credit card numbers on merchant copies of receipts. It is legal to cross out numbers so others cannot copy down the number.
- Keep Social Security and driver's license numbers private.
- Shred all documents containing any personal information before throwing them away.
- Get low limit credit cards.

DOOR-TO-DOOR SOLICITATION

Commercial Door-to-Door Solicitation is unlawful in Cherry Hills Village at all times.

• Commercial Door-to-Door Solicitation means the act of going in or upon private properties or private residences, without the consent of the owners or occupants for the purpose of advertising, offering, promoting, selling, explaining, or soliciting the sale, rental, lease or other form of conveyance or transfer of any product, goods, wares, merchandise or services.

Door-to-Door Solicitation is permitted in Cherry Hills Village with the following restrictions:

- It is unlawful for any person to solicit after the earlier of sunset or 8:00 pm and before 9am
- It is unlawful for any person to solicit at a private residence where it is displayed at the primary entrance of the residence a sign reading "No solicitation" in legible print not smaller than one and one-half (1.5) inches in height.
- Door-to-Door Solicitation includes (1) the solicitation or acceptance of donations incidental to and associated with the discussion, advocacy, explanation, or promotion of ideas or beliefs or a non-commercial nature, and (2) the distribution of printed materials at the primary entrance of a residence without attempting to personally contact the owner or occupant.

Persons conducting Door-to-Door Solicitation in Cherry Hills Village do not need to register with the Police Department, but must adhere to the aforementioned rules. If you witness a violation to the Door-to-door Solicitation Law, please immediately contact the Police Department non-emergency number at **303-795-4711** and request that an Officer be dispatched.

FROM ANIMAL CONTROL:

SPRING COYOTE ACTIVITY ON RISE

With the arrival of spring, the coyote mating season is in full swing; consequently, there will be more coyote activity during the daylight hours. During this time, the coyotes are also very territorial, and this means pet owners need to keep an especially close eye on their dogs, including large dogs. A coyote may see a large dog as a threat to its territory. Small dogs (under 30 lbs) should never be left outside unattended. Owners who do leave small dogs outside during the day should consider a *fully* enclosed dog run. Coyotes have been known to jump six-foot fences.

Coyotes have their young between April and May, and the pups will stay in the den until they are approximately eight weeks old when they begin to hunt with their parents. Coyotes are opportunists, and they will hunt small animals including dogs, cats, and other small domestic pets.

If you encounter a coyote, make a lot of noise and throw things at the coyote. Coyotes in the area have become habituated, and are not very concerned with the presence of humans. Our job is to coexist with the wildlife that lives here, but we also need to let the coyotes know that we do not want them to become comfortable living in our back yards.

DOG TAG REMINDER: All dogs that live in the City limits must be licensed annually. Licenses expire March 1st of each year. To get a license, bring or mail proof of a current rabies/vaccination(s) along with ten dollars (make out checks to "Cherry Hills Village") for each dog needing a license to the Police Department at the Village Center. Should your dog escape and be found roaming, a happy reunion is much easier and quicker when your dog has its tags and your information (including emergency numbers) is on file.

With 2004 property taxes due during the months of February, April and May (depending on the schedule you have chosen to pay them), residents may find it interesting to see how their property taxes are apportioned to the various government entities.

Total Assessed Valuation is determined by taking your actual valuation and multiplying by the residential assessment rate of 7.96% for 2005. This value is then multiplied by the tax levy to determine the amount of tax you will pay to each taxing entity.

Each individual taxing authority sets the mill levy for the services that they provide to you.

Your residence could be subject to additional taxing entities.



We took the time to form the kind of organization that could benefit the Village and its citizens."

As Board member **Klasina VanderWerf** points out, Cherry Hills Village is fortunate in that we currently have a group of elected officials on our City Council who are very sympathetic to preservation: "They know how important it is to preserve the Village's character - this is one of the main reasons people are attracted here in the first place. In fact," VanderWerf adds, "most, if not all, of our Council members ran on or had as a part of their election platform the importance of preserving open space and Village character."

Some of what a community non-profit can do, **Jane Soderberg**, also a Board member notes, will complement what the City does. "But we also have access to resources a governmental organization does not. Further, we can serve as a united voice for preservation in the Village. We can be extremely effective in this way as well."

CHLP has established key relationships with representatives from GOCO, Colorado Historical Society, Trust for Public Land, Colorado Conservation Trust, and the Land Trust Alliance. These groups are actively supporting this new community non-profit by lending their technical expertise and years of experience to ensure that the Cherry Hills Land Preserve achieves its goals.

One of CHLP's initial projects is the writing of the history of Cherry Hills Village. Board member **Suzie Halle'** describes this project. "The history of this City is rich and wonderful. It is a story about character - and characters. It will make us all realize that our links to our past are well worth preserving." The group is drawing on archival information as well as the memories of people who have lived in the Village long enough to remember the City's early years.

VanderWerf indicates that, in its final form, the history will be an artful and engaging book that everyone who lives here now, or, who has lived here in the past, will want to own. She notes that resident **Francis "Hecky" Heckendorf**, a local resident who does portrait photography as a hobby and who is especially noted for his work in black and white portraiture, has been generous enough to volunteer his time and expertise to this project. Well known Colorado photographer, **John Fielder**, has also made an initial commitment to provide a landscape photo of CHV specifically for this project. This history is projected to be printed and available in late spring, 2006.

The CHLP's other immediate project is to raise funds from private sources to cover the up front ad other costs incurred by property owners who choose to place a conservation easement on their land. For a property that qualifies, a conservation easement can be a wonderful means to preserve the land you've cherished - in the way you've cherished it - in perpetuity and receive tax benefits at the same time."
