APPELLATE COURT SENDS SSPRD CASE BACK TO TRIAL COURT JUDGE

On March 22nd, 2007, the Colorado Court of Appeals sent the litigation between the Village and South Suburban Park and Recreation District back to the trial judge for further proceedings. This litigation involves the Village decision to withdraw from South Suburban following the 2003 Village election authorizing exclusion. There was a trial, and in August 2004, the trial judge approved the exclusion, but ordered the Village to pay South Suburban \$9,660,838.00, the fair market value of certain parks and facilities located in the Village.

Both parties appealed the trial judge's order. Under the Court of Appeals decision, the exclusion stands, but the Court held that Colorado law does not require payment of fair market value as a condition for exclusion under these circumstances. The trial judge must reconsider the evidence and make new findings to support any judgment awarding compensation to South Suburban. The trial judge may not hear additional evidence, but may allow the parties involved to file additional briefs. At the time of publication of this Crier issue, there is no indication from the trial judge of the timing of the next steps.

MASTER PLAN CONSULTANTS HIRED

In an extensive process, the qualifications of six firms interested in managing the City's Master Plan Project were reviewed by the Master Plan Interview Committee (Councilmembers Bonnie Blum, Harriet La Mair, and Klasina VanderWerf; Planning & Zoning Commissioners Kevin Iverson & Kristy Schloss; residents David Cooper, Jeff Welborn, and Debbie Welles).

The Committee interviewed three of the firms and recommended that Council hire the Gould Evans firm. The estimated cost of the project is \$99,990, and the City budgeted \$100,000 in the 2007 budget. For more details about the Project, see the *Mayoral Musings* on page two of this issue.

IN A "Q & A" FORMAT,
MAYOR WOZNIAK EXPLAINS THE
MASTER PLAN PROJECT

What is a master plan?

The purpose of a master plan is to memorialize our vision for the future of our community. It is the embodiment of values and a plan of action for achieving the goals we share as a community. The plan considers the balance between the physical environment and the social well-being of the community's residents, businesses, institutions and districts. It will focus on many aspects of life within the Village, including but not limited to, such issues as the community's vision and goals, land use, traffic and transportation, parks, recreation and open space, utility infrastructure as well as community facilities and services. Master plan documents are generally broad in scope, and do not generally address every issue in great detail or each parcel individually. However, the document is designed to apply generally to all Village issues and properties and to act as a guide to boards, commissions, City staff and the City Council in making day-to-day decisions.

Why does the City of Cherry Hills Village need a master plan?

Under Colorado Statutes, municipalities having a certain population and/or growth rate are required to prepare and adopt a master plan. By virtue of this statute, the City of Cherry Hills Village is one of the communities required to adopt a master plan. The City currently has a master plan document, which in reality is more of a brochure or an executive summary, that was adopted by the City Council in 1993 and has not been revised since.

Why does the master plan need to be updated?

The master plan has not been updated since it was adopted in 1993. Over the past 14 years, there have been significant changes in the community and in the south Denver metropolitan region. As a general practice, master plan documents should be routinely reviewed to assure that they are consistent with the community's evolving vision and goals for the future. In addition, the current Cherry Hills Village master plan document is not in full compliance with the requirements for master plan documents outlined in the Colorado Statutes.

Who has the City hired as a consultant for the master plan project?

The City Council has entered into a contract for services with Gould Evans Associates to assist the City with the master plan process. Gould Evans is a

nationally recognized leader in urban planning and design. With more than 100 associates on staff, the firm offers a full complement of services in the fields of urban planning and design, landscape architecture, architecture, graphic design and interior design. The firm's 12-member Urban Planning | Landscape Architecture Studio includes nationally certified planners, urban designers, licensed landscape architects, licensed architects and an attorney specializing in land use regulations.

These associates work together with communities of all sizes to develop innovative solutions to challenging community development and revitalization issues. Gould Evans has seven offices around the country including Kansas City, MO; Phoenix, AZ; Salt Lake City, UT; San Francisco, CA; Tampa, FL and Boston, MA. The firm's Kansas City office will work hands-on with the City of Cherry Hills Village for this important project.

Gould Evans is teamed with four national experts to round out the skills necessary to achieve the goals of the Cherry Hills Village community. Three of these firms are based in / near the Denver area.

Community Futures (Brighton, CO) provides expert economic and demographic analysis based on expertise in both the public and private sector. The Greenway Team (Littleton, CO) is a recognized national leader in open space and greenway / trails development as an integral part of the community. LSA Associates (Fort Collins, CO) is known for its holistic view of multi-modal transportation systems including pedestrian and bicycle components. Finally, Economics Research Associates (Olathe, Kansas) presents an extensive history of working with cities in community surveying and analysis.

What is the process of citizen involvement in the master plan?

As the master plan is designed to be a reflection of the vision of a community, the development of the plan will be a community-wide effort. The City Council is in the process of appointing a Citizen's Advisory Committee to work with the Planning Commission to commence work on the Plan. The City Council has had two retreats to brainstorm possible issues and solutions. The desired outcome is that the citizen participation effort will lead to an interactive process in which citizens have the opportunity to provide significant input into the development of the master plan document. Methods of participation anticipated throughout the process include participation in a community survey, an interactive website, personal interviews, focus group meetings, community meetings and multiple public hearings.

When will the master plan be finished?

The master plan project will be completed in March 2008 with the formal adoption by the City Council. We are all very excited to embark on this ambitious and worth-while process. We welcome all of your help and support as we undertake to develop our master plan.

NOISE ORDINANCE AMENDED

On February 20, 2007, the City Council approved Ordinance 4, Series 2007 amending the City's noise ordinance. The proposed ordinance clarifies the legal methods for the regulation of noise nuisances through measuring decibel levels. The maximum decibel level for residential properties is 55 decibels between 7:00 a.m. and 7:00 p.m. and 50 decibels between 7:00 p.m. and 7:00 a.m. In addition, specific changes were made to the noise nuisance provisions related to construction projects in the community including limiting the maximum decibel level from construction sites to 90 decibels and prohibiting amplified sounds, including music, on construction sites.

HOW MUCH SALES AND USE TAX SHOULD YOU BE PAYING?

The local sales tax in the City of Cherry Hills Village is 3.5%. However, unlike most municipalities in Colorado, your City ordinance states that *only* those businesses actually located within the Village are to collect the local sales tax. Moreover, the zoning in Cherry Hills Village is almost entirely residential. Occasionally certain venues, i.e., churches or schools, may conduct a special event for which sales taxes are to be collected and paid to the City.

Therefore, the state's sales and use tax rates are the only taxes to be levied on any deliveries of tangible personal property made to your home from outside City limits. Presently, the total state sales/use tax rate applicable within Cherry Hills Village is 4.35% (comprised of the state's sales/use tax rate of 2.9%, RTD's sales/use tax of 1.0%, the Scientific and Cultural Facilities District's 0.1% sales/use tax, the Football Stadium District's sales/use tax of 0.1% and Arapahoe County Open Space Sales Tax of 0.25%).

Please be aware that the City does impose a use tax of 3.0% on the sale/purchase or lease of licensed vehicles. A use tax is different than a sales tax in that the application of a use tax is dependent upon where the purchaser resides as opposed to in what jurisdiction the transaction takes place.

REVALUATION COMING UP

Each property is revalued by the County every other year. This year, 2007, is a year for revaluation. This usually occurs in June. Values are most often determined by comparing your property with the properties similar in location, design, size, age and amenities.

Total assessed valuation is determined by taking your actual valuation and multiplying by the residential assessment rate of 7.96% for 2006. This value is then multiplied by the tax levy to determine the amount of tax you will pay to each taxing entity.

Each individual taxing authority sets the mill levy for the services that they provide to you. Your residence could be subject to additional taxing entities.

CITY MAY INSTALL VIDEO CAMERA AT BUSY INTERSECTION

At the April 4th City Council meeting, Mayor Wozniak said that he had met with Chief Patterson and Sergeant Jody Sansing to discuss what other municipalities are doing for safety at stop lights. Greenwood Village has installed video cameras to record drivers running red lights.

There is a company that installs the video at no cost to the City and the system pays for itself from the corresponding traffic ticket fees that are paid. Chief Patterson said that the Colorado Department of Transportation used to oppose the system, but has started to approve it and has been pleased with the success of the system.

The Council and Mayor voiced their support for installing one of these video cameras at University and Belleview where red light running is a serious safety problem.

FROM PUBLIC WORKS

CHERRY HILLS VILLAGE CLEAN-UP PROGRAMS

The CHV Public Works Department will again be providing a dumpster for residents to use for spring clean up. The trash dumpster will be located east of the maintenance shop at the Village Center. Residents are encouraged to take advantage of this opportunity to dispose of rubbish not included with normal curbside service. The dumpster will be at the Village Center Friday, June 8 to Monday, June 18. Please note: the City will be **UNABLE** to accept the following items for disposal: tires, appliances, oil, antifreeze, fuels, any hazardous materials, paints and thinners.

NEW THIS YEAR!!! - RECYCLE OLD COMPUTERS/ PARTS, ARRANGE TO HAVE HAZARDOUS WASTES REMOVED SAFELY

This Year the City will be accepting **e-waste** for recycling. Bring in your old computer and electronic equipment, but don't throw it in the dumpster. There will be pallets next to the dumpster for all electronics and computer equipment. *The City is unable to accept appliances and television sets over 19", so please do not bring these items in.*

In addition, **a hazardous waste collection program will be initiated for all residents.** The City has contracted with Curbside Recycling Inc. to do a door-to-door recycling program for hazardous waste. Residents will be required to pay a \$20.00 co-pay and may use the service only one-time per year. Funds are limited and the program will be suspended once all the funds have been used, so please use the service wisely. We encourage you to work with your neighbors and pool hazardous waste to maximize the available funds. GIFT FUND

The City Council is bringing back the Gift Fund in a new and more efficient format. Instead of a printed brochure (the form of the previous Fund), residents and other interested individuals can access the Fund via the Village internet home page.

An additional change includes the ability for the donor to have more flexibility with their gift by working with Division staff to find the most appropriate donation possible (the previous Fund required the donor to choose a specific item they wished to donate to.) Finally, residents will have the ability to start a land donation process via the gift fund if they are interested in preserving their lands in perpetuity.



TREE INVENTORY

City Council has approved the expenditure of funds for the Village Parks Division to conduct a city wide tree inventory. This information gathering process will include an inventory of trees planted on all Village public lands. The process will record tree location, health, species, and condition and make care need recommendations. Staff has also asked the arborist to make tree planting recommendations and to record any special tree information such as special and interesting species.

The primary goal of the inventory is to gather information to assist staff in producing a healthy, sustainable urban forest. An eventual secondary goal is to make all inventory information readily available to the community so individuals or arborists can access information regarding trees in the community. In this way if a resident is interested in what a specific mature species looks like, staff can direct them to where in the Village they can go and see it.

EFFORTS UNDERWAY TO PRESERVE OPEN SPACE AND RECREATIONAL OPPORTUNITIES ALONG THE SOUTH PLATTE

In 2004, residents of Arapahoe County voted in favor of the County's first sales tax to be used to acquire and enhance parks and to protect open space, wildlife habitat, and scenic viewsheds. As part of its effort to fulfill this voter directive, last fall Arapahoe County convened representatives from the municipalities in western Arapahoe County and other interested groups and asked them to work together to develop a strategy that would successfully protect critical areas along the South Platte for open space, wildlife habitat, and recreational uses and which would provide for improved east/west access to the South Platte corridor. Arapahoe County committed \$3 million dollars to this project at that time.

As a result, the South Platte Working Group (SPWG) was formed. SPWG is a coalition which represents the patchwork of jurisdictions in western Arapahoe County, including the municipalities of Cherry Hills Village, Greenwood Village, Littleton, Englewood, Sheridan and Bowmar. This coalition has worked over the last several months to identify and qualify ten acquisition projects and seven recreational projects which meet criteria for area preservation and enhancement.

Preservation efforts come at a time when development in Arapahoe County along the South Platte has burgeoned; this corridor is the last remaining segment along the river within the metro Denver area in need of conservation. In Adams County, efforts have already been made to preserve over 900 acres along the South Platte, and with its development of Commons Park and restoration of other important parcels, the City and County of Denver has led efforts to integrate the river corridor as it flows through Denver.

This spring, the SPWG will submit a concept paper describing the project to Great Outdoors Colorado (GOCO) in preparation for submitting a Legacy Grant requesting \$8 million dollars which would help acquire land, enhance recreational opportunities, and enhance and develop key east/west trail connections including the High Line Canal Trail, Bear Creek Trail, Little Dry Creek Trail, and Big Dry Creek Trail.

Total cost of this visionary project is estimated to be \$20 million dollars. The monies from Arapahoe County and a GOCO grant could help leverage additional government, corporate, and other foundation dollars. More to come.
