## South Suburban Update

I want to update everyone on the May 2008 Arapahoe County District Court decision in the South Suburban case. The Council has decided to seek further clarification from the Court of Appeals.

In 2004 Cherry Hills Village residents voted to withdraw from South Suburban Recreational District. The Village filed a Plan with the Arapahoe County District Court, as required by Colorado statute, with proposed terms for the exclusion. The Plan proposed that the Village pay its proportionate share of the District's outstanding indebtedness — more than \$6.6 million — existing *before* November 2004, the effective date of the exclusion, as required by the statute. The Plan also proposed to take over the maintenance obligation of the Village parks in perpetuity, while continuing to allow park access to Village and District residents, alike.

The District objected to the Village's ability to withdraw from the District, as well as the Village Plan for payment. Following a trial in 2005, the District Court ordered that withdrawal was permitted, and that the Village must pay, in addition to \$6.6 million preexisting indebtedness required by statute, \$9.6 million for the *fair market value of the parks*. The ruling was an error, because, among other things, (1) the Village could not sell the parks, (2) District residents enjoy the same access to the parks before and after November 2004, (3) transferring control of the Parks to the Village did not create any burden for the District (indeed the District was relieved of all maintenance obligations in perpetuity), and (4) the District paid only a small amount of money to acquire the Parks, at a time when the Village was contributing substantially to the District's revenues. The Village took an appeal to the Colorado Court of Appeals which agreed with the Village, and remanded the matter with an order that "the trial court shall delete its finding that the fair and equitable criterion alone requires Cherry Hills to reimburse the District for the fair market value of the facilities."

On May 15, 2008, the trial court, despite the Court of Appeals' directions, held that "in order for the exclusion to be fair and equitable, the City should pay the District the fair market value of the facilities" (\$9.6 million). The trial court added, as new support for this ruling, that "a reasonable estimate of the financial impact of the exclusion is over one million dollars per year, or 10.4 million dollars through the years 2014." Why the trial court ended the Village's obligation in 2014 is unclear.

The effect of the trial court's ruling is that Village residents must continue to pay taxes to the District *after* 2004. That obligation was imposed by the trial court even though the Village and its residents are no longer part of the District. The order, that Village residents must effectively pay taxes to a district to which they do not belong, is unprecedented. Indeed, the opinion of the Village attorneys is that the statute *expressly prohibits* the District from taxing Village property after November 2004.

The Council's considered view is that an appeal of the trial court's May 2008 ruling is essential to safeguard the public funds. The amount in dispute, much more than \$10 million with interest, is more than the Village's annual budget, and requires that the Village seek an opinion, again, from the Colorado appellate courts.

I want to thank Council Member **Russell Stewart** for his exemplary effort in dedicating so much of his time on behalf of all of us to insure that a correct decision is secured.

## FROM DENVER WATER

Residents in Cherry Hills Village receive their water from a number of water districts, all of which adhere to Denver Water's summer watering program. Denver Water's summer watering program began May 1<sup>st</sup>. Although this year's rules are not as strict as the drought restrictions of 2002 and 2004, they are mandatory and failure to comply can result in fines. The following is a list of the rules being enforced by Denver Water this summer:

- No lawn watering between 10 a.m. and 6 p.m.
- Do not waste water by allowing it to pool in gutters, streets and alleys.
- Do not waste water by letting it spray on concrete and asphalt.
- Repair leaking sprinkler systems within 10 days.
- Do not use spray irrigation while it is raining or during high winds.
- There are no assigned watering days at this time, but watering more than three days per week is prohibited. To report water waste, please call Denver Water at 303-893-2444.

## FROM NEW FIRE AUTHORITY BOARD



### ELECTION RESULTS FOR MAY 12

It was a record-setting turnout for South Metro Fire Rescue's Board of Directors election. 7167 ballots were returned - more than twice the number of any other election.

"This is by far the best turnout we have ever had - polling place or mail ballot" according to Susan Schledorn, the fire district's election official. Three candidates were elected from a field of seven, which is the largest number of candidates in at least a decade.

The new board members, David Jackson, Laura Simon and Hank Eng, were sworn in at a meeting May 8th.

The Board is responsible for setting the tax rate and overseeing the department's finances. Three of the five members on the board will serve on the new Parker-South Metro Fire Rescue Authority Board. The first meeting date of the new Authority Board will not be set until after the Parker Fire District Board chooses its representatives to it on May 20th. *South Metro Fire Rescue and the Parker Fire District began operating as a joint agency on May 1st.*

The men and women of the Parker-South Metro Fire Rescue Authority provide emergency medical, fire suppression, and fire prevention services to the people living and working in Arapahoe and Douglas counties. The Authority covers 176 square miles and includes; the cities of Parker, Greenwood Village, Cherry Hills Village, Centennial, Lone Tree; Castle Pines North, and Foxfield as well as much of the Denver Tech Center, Meridian, Inverness; Park Meadows; Centennial Airport; and the communities of Castle Pines Village and Louviers. ### BOARD SEEKS FINAL MEMBER

After a meeting of the Parker Fire Protection District Board May 20th, six of the seven members of the new Parker-South Metro Fire Rescue Authority Board were chosen. Nominations are now being accepted for the seventh position. Interested persons only need to be a registered elector of either the Parker Fire or South Metro fire districts. A qualified elector is someone who is registered to vote and either lives in or owns taxable property in one of the two fire districts. The person selected will be asked to fill a two-year term of office.

The new fire authority was established at the beginning of this month and it may lead to a full merger of the two fire districts. The Authority Board will be responsible for overseeing the finances and setting policy for the new agency. At its meeting last night the Parker board elected Linda Ganz, Ken Molcsan and Gary Culig to be its representatives to the Authority Board. On May Eighth, the South Metro board chose Pete Webb, Hank Eng and Laura Simon as its representatives. These six will choose the seventh member.

These must be received no later than June 5<sup>th</sup>. The Authority Board's initial meeting is scheduled for June 10<sup>th</sup>.

# ELECTION TIME IS HERE AGAIN

## FROM NANCY A. DOTY, ARAPAHOE COUNTY CLERK & RECORDER

With the Primary and General Elections just around the corner, the Arapahoe County Clerk and Recorder's Office is gearing up for the predicted highest turnout election ever. All voters should be aware of how they can help to make their voting experience an easy exercise of the democratic process.

**Are you ready?** You can now check your voter registration online at [www.arapahoevotes.com](http://www.arapahoevotes.com) to make sure the information is current. If you have moved since the last election, you will need to contact the clerk's office to update your address. If you want to change your party affiliation, that can also be done by downloading the form and sending it to the clerk's office or by calling 303-795-4511 to request a form be sent to you.

Nancy Doty, Arapahoe County Clerk and Recorder, is urging voters to sign up for permanent mail-in ballots. "Voters can now apply to have their ballot automatically mailed to them for each election the county coordinates. There are 13 convenient locations to drop off ballots, or, a ballot can be returned by mail." A voter can get this information on the website or by calling the above number. In Arapahoe County in 2006 over 51% of the voters voted by mail, and that number will increase with each election cycle.

**Be Involved – Be an Election Judge.** Arapahoe County needs 1,600 precinct poll workers for the Primary and General Elections. It is a great way to be involved in the democratic process, and you can earn \$200 for the day. Just call the clerk's office at **303-795-4511** for more information.
