## **RESIDENTIAL DEVELOPMENT STANDARDS COMMITTEE TO HOLD PUBLIC INPUT MEETING**

The Residential Development Standards Committee (RDSC) will be holding a public input meeting on Monday, May 4, 2009 at the Village Center. The meeting will start at 6:00 p.m. Refreshments will be served.

This five-member citizen advisory committee, appointed by the City Council in September of 2008, was established in response to the numerous concerns expressed by the residents of the Village to study the impact of development on the character of the community.

The RDSC has been asked to provide a comprehensive evaluation of Village residential zoning and building standards and to provide recommendations to the City Council on possible actions that the Village could take to address concerns. After several months of research, evaluation of the Village Master Plan, meeting with focus groups and discussion, the RDSC has created a list of priority issues to evaluate. These issues include: home size, building height, building setbacks, grading, open space, and landscape preservation.

The public input meeting will include an update by the Committee on their research to date, and include public comment and discussion on possible solutions to the issues being addressed by the Committee.

If residents are unable to attend the meeting, but would like to participate in the Committee's work, they may attend any of their regular meetings or provide the

Committee with written comments. The Committee typically meets every other Monday at 4:00 p.m. at the Village Center. ## **MAYORAL MUSINGS**

As summer approaches, I recommend our City website and the City information on Channel 22, both of which should be up and running during April this year. You'll find significant information about City programs, services and related issues.

### Establishment of Open Space Program

Council is establishing the "Catherine H. Anderson Land Donation Fund" to honor Cat Anderson's generous gift of the conservation easement on the Anderson property to Colorado Open Lands bordering the High Line Canal. We have authorized the transfer of significant reserves to the Fund and are considering annual transfers of funds from other sources. Stay tuned for the details of this program, and keep it in mind if you are in a position to consider donations towards open space preservation. The Fund is a way for the Council to renew its commitment to our 2006 Resolutions supporting open space and the recommendations of the Blue Ribbon Panel.

### RFP for Village Center Area

Council has issued an RFP for re-design and re-development of the Village Center Area. No decisions to proceed have been made, but the Council has determined that it is prudent to re-evaluate the work previously done, incorporate the recommendations of the City Center Citizen's Committee, and review the options that the existing City facilities and campus area offer. Please stay tuned.

### Land Dedication

Based upon recommendation of the Parks, Trails and Recreation Committee, Council has been studying and evaluating the land dedication requirements imposed on prospective subdivisions. There has been significant public input, and Council continues to evaluate the issue. The difficult challenge is to balance the community's desire for open areas, parks and trails memorialized in the Master Plan with private property rights.

### Budget

Our property tax collections are now estimated to be \$100,000 lower than originally expected, but we continue to feel that we will remain on budget for fiscal year 2009. Audited financial statements will be presented at the next City Council meeting on April 7, 2009.

### Legislative Issues

I participate in the Metro Mayors Caucus, and Council Member LaMair participates in DRCOG. Through those organizations, we are periodically asked to support our regional local governments in various legislative endeavors. Recently, we have been asked to support the "FASTER" bill which was signed by Governor Ritter in March. This bill was expected to generate approximately \$250,000,000 for transportation projects including improvements to more than 100 structurally deficient and obsolete bridges.

Another recent challenging issue for regional mayors is FasTracks. To build the FasTrack/light rail system completely by 2017 would entail supporting a 0.4% (4¢ per \$10.00) sales tax increase to take effect no sooner than 2011. This is necessitated because the current projection for sales tax revenue is down 31% from the 2004 Plan projection.

We have done our best to continue to support our regional neighbors in the Metro area and to work well with all of our adjacent cities.

### South Suburban Appeal

Oral argument has been set by the Colorado Court of Appeals in the South Suburban litigation for April 21, 2009. We are hopeful that the Court of Appeals will render a favorable decision in early summer of 2009.

### Coyote Hotline

Animal Control Officer, Michelle Edwardson, is doing an excellent job. Michelle has established a coyote hotline (**303-783-2708**), and we are working with Greenwood Village and other adjacent communities in implementing our coyote plan. We are beginning to see some progress and have not authorized the use of firearms to kill coyotes in the Village.

I remain excited that we continue to maintain a lean City government and avoid any tax or fee increases while still maintaining the level of services you deserve and expect. These goals have been accomplished by the dedicated voluntary service of our City Council Members, Planning and Zoning Commission, Board of Adjustment and Appeals and Parks, Trails and Recreation Commission, as well as the staff of the Village Crier. I want to personally thank the City staff and Police Department for their continued efforts to exceed our expectations. We are truly blessed to continue to live in the City of Cherry Hills Village, and I want to warmly thank all of our City volunteers and staff members. Have a great beginning of summer.

## COUNCIL AUTHORIZES FUNDS FOR COUNTY DISPATCH SERVICES

The Arapahoe County Sheriff's Office provides Emergency 911 and Communications Center services to the Village and has done so for the past 30 years. Up until last year, the Village had not been billed for these services by the County; however, the recent downturn in the economy has forced Sheriff Robinson to begin charging municipalities for use of the County's Communications Center.

The annual service fee for these services is based upon its operating costs divided by the number of calls of service for each participating agency.

The 2009 Communications Center contract is \$82,700 which is a 3% increase over the 2008 billing (but was originally budgeted for \$90,000). Council voted to approve this agreement at its March 3rd meeting.

## POLICE DEPARTMENT RECEIVES FEDERAL GRANT

The Police Department has received a Federal Grant for \$18,000 for the purchase and installation of a bi-directional antenna which improves radio reception and transmission capabilities.

# FROM ANIMAL CONTROL

**PET LICENSING – DON'T FORGET!** All pets residing in Cherry Hills Village must be licensed each year and the licenses expire on March 1<sup>st</sup>. There is some confusion regarding the difference between a rabies tag and a CHV dog license. They are not the same thing. In order to license your dog you need to come in to the Cherry Hills Police Department and bring your dog's current rabies information, along with \$10.00 fee per dog. Once you have licensed your dog, you will receive a reminder card the following year. Pet licenses are so important in getting loose dogs returned to their owners as quickly as possible and helps to insure that dogs are current on their rabies vaccinations.

**KENT DENVER IS NO LONGER ALLOWING DOGS TO BE OFF LEASH ON THEIR PROPERTY.** After a lot of discussion, Kent has decided it is time to have the City's leash-law enforced on their property. A thirty-day warning period and new signage have given everyone a chance to get used to the changes. Now dog owners that let their dogs off leash, or violate any other CHV animal ordinance may get issued a summons.

**A COYOTE HOTLINE HAS BEEN ESTABLISHED.** This hotline is to give our residents information on coyote activity, how to keep your pets and family safe, or just to report a sighting of coyote. We use this information for tracking coyote activity within the City. If you would like information sent to you regarding coyotes and local and state laws, please leave your information on the hotline and I will send it to you. The number for the hotline is **303-783-2708**. The City has also purchased whistles for the hazing of coyotes or just to keep with you while out walking. If you would like to have one of these whistles, you can stop by the Village Center during business hours or I have them in my truck at all times.

## PROPERTY TAX VALUATION AND ASSESSMENT

Property tax valuation and assessment are determined every two years by the Arapahoe County Office of the Assessor. Property values (actual values) are most often determined by comparing your property with properties that are similar in general location, design, size, age, and amenities. The value placed on your property by the County in 2009 is based on sales between January 1, 2007 and June 30, 2008, which is known as the "Sales Comparison Approach". A copy of this method for your property is available from Arapahoe County and was also included with the Notice of Value sent to you from the County.

Your property taxes are calculated by taking the actual value multiplied by the assessment rate multiplied by the mill levy. The residential assessment rate is 7.96% for 2007 and 7.96% for 2008. The assessment rate for all other property, including vacant land is 29%. Below is an example based on a property that has a \$1,000,000 actual value (please note this is only an example and your property value and total mill levy may be different).

Each individual taxing authority such as school, county, city, fire district, water and sanitation district, and recreation district sets its mill levy. These authorities provide services to you and are listed on your last tax notice.
