The RDSC is a five-member citizens advisory committee created by the City Council in September of 2008. The Committee has been asked to evaluate the City's zoning and building standards and make recommendations to the City Council on possible actions that will address concerns related to the impact of large scale residential development on the character of the community.

### Residential Development Building Standards Committee

The Residential Development Building Standards Committee held an open house on May 4th to solicit input on myriad options they are considering for recommendation to Council. They have developed a survey, available on the CHV website, which concerns a number of issues including the size and scale of new homes, building facades, bulk/mass issues, re-grading for new construction, sustainable residential development, impacts of development on the surrounding neighborhood and landscape and habitation issues. If you wish to provide input, please obtain a copy of the survey or contact one of the members of the Committee for further information.

### South Suburban

In light of the recent affirmation of the Court of Appeals of the South Suburban decision, Council is undertaking a review of its options including possibly proceeding with the litigation to the Colorado Supreme Court. We will advise you of our decision as soon as possible.

### Trail Issues

Council continues to work with Greenwood Village to study the Bellevue Avenue underpass at Little Dry Creek and possible improvements that can be made with respect to that underpass. Similarly, with the help of the Parks, Trails and Recreation Commission, we are working on the Mansfield Avenue Trail issues and plan to better delineate the trail on the south side of the street this summer.

### Ordinances

Council has passed an ordinance helping residents engage in stream bank stabilization within the confines of their property without having to go through a cumbersome hearing process. Hopefully, this will help enable minor stabilization projects proceed expeditiously. Further, Council has recently passed a bill allowing wireless communication facilities to be located on existing telephone poles through a new technology that creates a sheath around the pole instead of extending the pole height as required under existing technologies. This should enable carriers to reach areas of the Village that have been without cellular service.

### Mansfield Heights Chip Seal Project

As most of you know, our Public Works Department has a long range plan with respect to street, curb and gutter maintenance improvements. Neighborhoods and streets are addressed not only on an as-needed basis but also on a rotational basis. Early this year, Council approved our annual street maintenance program which includes a chip seal project in the Mansfield Heights Area. As this project commenced, we received a number of comments about how this project might adversely affect the usability of neighborhood streets. Letters were sent prior to the commencement of the project to all affected homeowners, and I might encourage any of you with concerns to visit areas in old Cherry Hills which have had similar street treatments in the past to witness first hand their viability. We hire excellent public works consultants who are well trained in street maintenance, and we rely upon their recommendations as to the nature of the treatment and the viability of preserving, maintaining and extending the life of all of our public streets. I commend Jay Goldie, our Director of Public Works, for his stellar efforts in maintaining the utility of our public streets.

### Sanitary Sewer Replacements

We have had many construction activities this year upgrading and maintaining many of our Village sanitary sewer lines. We have worked cooperatively with Cherry Hills Country Club to coordinate the efforts during their recent construction.

### New Hybrid Vehicle

The City recently purchased a new Ford Escape Hybrid to be used by the Code Enforcement Officers. While the vehicle is a little more expensive in the short run, due to its quiet operation and increased fuel economy, it should be a positive long range purchase for the Village.

### Coyote Management Plan



Council has established the Catherine H. Anderson Open Space Program in honor of Cat Anderson's wonderful gift of land along the Highline Canal. As part of the resolution, each year the City Council will consider various funding mechanisms for other open space maintenance and acquisition programs. The resolution contains a number of options that Council may consider each year during its budgeting process as funding sources for open space, recognizing that our fiscal situation changes from year to year. We are excited to implement the outline of this plan to preserve the unique, special place in which we live.

## FROM THE CHERRY HILLS POLICE



### CHERRY HILLS VILLAGE POLICE DEPLOY A HYBRID VEHICLE

The Cherry Hills Village Police Department has added a 2009 Ford Escape "Hybrid" to its fleet. This is the first hybrid-technology vehicle placed into service by Cherry Hills Village. The Escape Hybrid will be a "Community Services" vehicle and will be driven by code enforcement officers.

The Ford Escape uses hybrid technology that combines gasoline power with a battery/electric system. The batteries allow the vehicle to alternate between gasoline power and electric power as driving conditions dictate, requiring no outside plug-in or charging. The vehicle recharges the batteries during braking while driving.

The Escape gets an average of 34 city / 31 highway miles per gallon. This represents a mileage increase of about 80% over the standard gasoline powered-Escape and an increase in mileage of approximately 120% over the 2000 Ford Explorer it replaced. This vehicle will be used primarily for city driving, which means a significant cost savings over the projected life of the vehicle.

Keep an eye out for the new Escape Hybrid. Our Code Enforcement Officers began driving it in May!



## THE VILLAGE ACQUIRES A SPEED MONITORING AWARENESS RADAR TRAILER

The Village has a new SMART Trailer, which was acquired through a \$7500 federal grant. The new trailer replaces one which had been in use since 1998.

The SMART system is a portable, light weight, self-contained speed display unit. The speeds of passing vehicles are measured by a radar unit while simultaneously being displayed on a large LED display board to remind drivers of their speeds. If a vehicle is travelling faster than the posted speed limit, the LED display flashes the speed to warn the driver. The new SMART trailer has an on board computer which allows it to monitor and record vehicle speeds over an extended period of time. This feature will allow us to contact speed surveys along streets within the Village.

The SMART trailer will be used on a weekly basis throughout the Village. The Police Department will consider several factors when selecting the locations where the SMART trailer is placed. These factors include requests from neighborhood groups/HOAs, requests from specific residents and awareness by the police department of problem areas.

## COUNCIL ESTABLISHES CATHERINE H. ANDERSON OPEN SPACE PROGRAM & FUND

In 2007, Catherine Anderson conveyed her 17.5 acre parcel of land (located on both sides of the High Line Canal south of E. Quincy Avenue) to the City of Cherry Hills Village. Her conveyance was subject to a conservation easement held by Colorado Open Lands and a reserved life estate.

At its May 5th meeting, Council adopted two resolutions to honor Mrs. Anderson.

One resolution establishes the Catherine H. Anderson Open Space Program that will build upon this private donation and further the goal of the City Master Plan to protect and increase Village open areas and the trail system. This new Program is intended to support the development of funds to foster and encourage open space and the preservation of natural areas.

The second resolution renames the existing Land Donation Fund which is to be used for the primary purpose of acquisition of open space, parks, and trails. This fund is now called the *Catherine H. Anderson Land Donation Fund* (Fund 8). It will continue to receive cash-in-lieu dedications associated with subdivision applications; however, Fund 8 will now also receive any other private monetary donations received by the City, including donations made through the City's various recreational events. During the annual budget process, the Council will consider other possible sources of monies for Fund 8 including annual appropriations from the General Fund or from Fund 30 (Parks and Recreation Fund).



## BOARD OF ADJUSTMENT AND APPEALS

The Board of Adjustment and Appeals hears requests for variances from the zoning standards and requirements of the building and zoning codes. The Board meets on the first Thursday of each month. ## CODE ENFORCEMENT REMINDERS

### WEEDS AND DEAD TREES

With the coming of (a particularly wet) spring we face the issues of weeds and dead trees in the Village. Code Enforcement Officers will be contacting residents, in person or via mail, to address these nuisances when discovered or reported, and to suggest property owners take remedial action.

Cherry Hills Village City code section 7 (articles 3 and 4 respectively) serves as a useful guide when determining what property owner responsibilities are. ### NOISE

The warm weather invites us all to enjoy outside activities and in doing so all are reminded to be "noise conscious". Code Enforcement Officers can measure noise levels upon request using specialized equipment, and they have done so at various locations including construction sites, private residences and businesses within the Village.

Cherry Hills Village City code sections 7 and 10 address nuisance noises ranging in source from animals to man-made. They are enforced by Police and Code Enforcement Officers. ## BUILDING PERMIT NOTIFICATION PROGRAM TO START IN JUNE

The Village Community Development Department will be initiating a program starting in June to notify home owners associations and architectural review boards of building permit applications submitted to the Village for review. The notification program is intended to assist home owners' associations and architectural review boards in monitoring development in their neighborhoods and ensuring that private covenants and restrictions are being followed.

Any interested homeowners' association or architectural review board in the Village may register for the program and receive weekly email updates of building permit activity in the Village. The weekly emails will include a list of all building permits under review and permits issued that week.

## COUNCIL APPROVES NEW PROCEDURE FOR STABILIZATION OF DRAINAGEWAYS IN FLOODPLAIN

At their June 2<sup>nd</sup> meeting, the City Council approved an amendment to the Floodplain Management Regulations creating an expedited review procedure for the stabilization of drainageways located in FEMA regulated floodplains. Among the issues created by an unstable channel are increased sedimentation, impaired water quality, and dangerous conditions around steeply cut channel banks.

Prior to the creation of the new review procedure, a property owner proposing to stabilize a drainageway would be subject to a lengthy public hearing process that could take months to complete. The new procedure allows for an expedited administrative review without a public hearing requirement. The applicant will still be required to provide a study by a professional engineer showing that the proposed stabilization will not alter the floodplain boundary or elevation.

## CHERRY HILLS VILLAGE SANITARY SEWER PROJECT

In the Village we have 13 separate sanitary sewer districts. In the past there were upwards of 30 separate districts providing sanitary sewer services. The City acquired a number of these districts a number of years ago in an effort to consolidate these services. As a result, the City now maintains a sanitary sewer system that provides service to 151 homes within the Village, and it owns and operates transmission lines that service other residents and sewer districts.

These sewer lines are maintained through a users fee. Last year the City began the process of rehabilitating the system to ensure uninterrupted service to the residents that rely on these facilities. This project focused on the lines that run through the Cherry Hills Country Club property and was completed in conjunction with the total revamp of the Country Club's golf course. This partnership saved both time and money for all involved parties. The project will take approximately three years to complete.

In 2009 the project will focus on the Cherryridge neighborhood and parts of old Cherry Hills Village to the west of University. The City has completed an evaluation of the entire system and will only rehabilitate the lines and manholes that no longer meet operational standards. Citizens may see minor delays and inconveniences on their streets and will be without sanitary services for short periods of time while their lines are being upgraded. The City will notify individual homeowners prior to a loss of any such services. The schedule for this project will be available once all the bids are received and City Council gives final approval to move forward with this phase of the project. # FROM CHERRY HILLS ANIMAL CONTROL

## PROTECT DOGS FROM HEAT EXHAUSTION

As the summer heats up, so do our concerns for animals. While on patrol, I notice more and more people jogging with their dogs. This can be a great way to spend some time together and get that needed workout. However, I sometimes worry about the dogs and that is why I wanted to bring up some important points to consider when deciding to take your dog on a run:

- Start gradually and work your way up. The pads on a dog's feet can be soft if they spend most of their time indoors. They will toughen up slowly, but don't overdue it early in your/their workout program. Their pads can burn and blister which is very painful. Imagine running with sore feet! Dogs will generally continue to run, whether or not they're in pain, as they want to please you, their master.
- Keep in mind the time of day and the weather conditions when planning a run. Dogs are affected by the weather more than we are, especially when it is hot. We need to remember they are wearing coats and can only cool themselves by panting and sweating through their pads. Jogging in the early morning, before it gets warm, is best. Remember to always carry water with you *for your dog*.
- If your dog is a puppy or a large breed, don't jog for long periods of time; it's too hard on their joints.
- Dogs with short noses, such as Bulldogs, Boxers, and Pekinese sometimes have difficulty breathing, and they may do better on frequent but short walks.
- Asphalt and concrete can be too hot for furry feet, and rocks and gravel may cause cuts. Monitor your dog's pads for cracking and wear.

Also, please, **NEVER** leave a dog in a car even on a mild day. Temperatures inside a car (even with the windows cracked) can raise 20-30 degrees in just 10-15 minutes. On a 75 degree day, the temperature inside your car could easily get to over 100 degrees. If you think you need to run errands, consider not bringing your dog with you.

If your dog is left outside during the day, please make sure that it always has access to shade, shelter and water. And take extra precautions to keep your dog safe from wildlife as well.

Overheating in dogs is very serious and can result in death. A dog's internal body temperature is between 100 and 102 degrees Fahrenheit. If your dog's temperature is over 103.5, take the dog to the vet immediately. Signs of overheating are excessive panting, increased salivation, red gums, increased heart rate, vomiting and diarrhea. If you notice any of these signs, get your dog some water and wet your dog down with tepid, not cold water.

## A FEW OTHER THINGS TO REMEMBER:

- ✓ All areas of Cherry Hills Village require dogs to be on a leash once they leave their own property. This now *includes* the Kent Denver School property. *There are no off-leash parks inside the City.*
- ✓ Do not feed wildlife. If you should have any questions regarding wildlife we have information on the City website as well as a **COYOTE HOTLINE (303-783-2708)**.
- ✓ All dogs that reside in Cherry Hills Village must be licensed. Please bring proof of a current rabies vaccination to the Police station. Licenses cost \$10 per dog and must be renewed every year.

The Police Department has set up a **Coyote Hotline** telephone number for residents with questions about coyotes and coyote activity to call. Residents may report coyote sightings, request additional information from Animal Control, and find out whom to contact in case of an actual attack.
