## APRIL ELECTION CANCELLED

The City Council approved a resolution at its regular meeting on Monday, March 15<sup>th</sup>, 2010 cancelling the Cherry Hills Village Municipal Election scheduled for Tuesday, April 6, 2010. The City of Cherry Hills Village would normally hold an election this April to elect the Mayor and City Council members for Districts 2, 4, and 6.

Colorado Statutes and the City's Municipal Code allow for elections to be cancelled if there is only one candidate for each of the open positions on City Council and for Mayor, including candidates filing affidavits of intent to be a write-in candidate. In the upcoming Municipal Election, the City received petitions from only one person for each of the City Council positions up for election (Districts 2, 4, and 6) as well as for the position of Mayor.

In addition to cancelling the April 6, 2010 Municipal Election, the resolution passed by the City Council declared the following candidates elected to the following positions:

**Mike Wozniak**, the current **Mayor**, will serve as mayor for a third and final two year term.

**Russell Stewart**, the current councilmember for District 2, will represent **District 2** for a second and final four year term.

**Scott Roswell**, the current councilmember for District 4, will represent **District 4** for a second and final four year term.

**Harriet Crittenden LaMair**, the current councilmember for District 6, will represent **District 6** for a second and final four year term.

The next regular election for the City of Cherry Hills Village will be April of 2012. The positions of Mayor and City Councilmember seats for Districts 1, 3, and 5 will be on the ballot for the April 2012 election.

## CITY ISSUES FIRST LIQUOR LICENSE TO A FOR PROFIT BUSINESS

At the January 5th Council meeting, the City Council approved an application for a new Hotel & Restaurant liquor license for JTM investments doing business as Pulcinella Pizzeria at the shopping center at 1400 E. Hampden Ave. The only other two liquor licenses in the City are for Cherry Hills Country Club and Glenmoor Country Club.

## MAYORAL MUSINGS

As we move into spring, Council has been busy attempting to continue to provide services while maintaining a tight fiscal budget for the City.

We have recently approved three separate contracts for street maintenance throughout the City. The first deals with our concrete replacement program, the second with our chip seal upgrades, and finally we have approved a separate contract with respect to the asphalt milling and overlay program. Our Public Works Director, **Jay Goldie**, oversees all three of these contracts which will cost less than the amount provided for in our annual budget. Should you need information as to the various locations within the City that are subject to the concrete, chip seal or asphalt programs for 2010, please contact the Public Works Department or check out the maps that have been placed in the City website.

Council received a report from the Technical Advisory Committee of the Denver Water Distributors. Since 2003, we have been a member of this Technical Advisory Committee which is a watchdog organization that insures Denver Water complies with contractual quality and cost-of-service rate provisions. Our consultant has prepared a report of the Committee's effort to insure that the suburban users of Denver Water have input into our water service, water quality and water cost. Prior to the formation of this group, the City was on its own in negotiating and monitoring our Denver Water Board service. I am very pleased that this watchdog group has been able to maintain our levels of service and cost of service.

Council has recently established an Arts Committee to work in conjunction with the Parks, Trails and Recreation Commission. **Ann Columbus**, a former City Council Member, proposed this idea and has volunteered to spearhead this group which will be responsible for public art within the City. I want to personally thank Ann for her significant contributions to the City and her willingness to take on this ambitious project.

The final report issued by the Residential Standards Committee was presented to Council on October 20, 2009, followed by study sessions held in November and December to discuss the recommendations of the Committee in more detail. Basically, as we have highlighted in previous Village Crier articles, the Committee made several interconnected recommendations with respect to the following: floor area ratio standards; daylight plane standards; building height allowance; limitation on grade changes; preservation of natural surroundings; sustainability/green building standards; and a contextual design review requirement.

Upon reflecting on these very significant and well thought out recommendations, Council expressed concern that the proposed daylight plane standards could create issues with respect to homes located in our higher density zone districts and neighborhoods. We have therefore applied to the Denver Regional Council of Governments for a small community technical assistance program grant to conduct a detailed daylight plane study to review the recommendations insofar as they apply in different zone districts and neighborhoods and to propose more specific daylight plane standards for consideration. DRCOG has recently informed us that they have awarded us \$5,000.00 for partial contribution to the three study areas: the daylight plane study, undeveloped land mapping project and a GIS data conversion and inventory program. In order to supplement the remaining portions of the daylight plane study, we have begun a competitive RFB process to attempt to begin work on this study.

Council is also evaluating which portions of the Residential Development Standards Committee recommendations can be implemented in isolation and we are looking forward to implementing many of those recommendations. A public hearing will be required on every ordinance change, and we welcome your input.

I am most pleased that **Lieutenant Jody Sansing** has been promoted to Deputy Police Chief. During my many years of work with Lieutenant Sansing, I couldn't be more pleased with his professionalism, dedication to the community, and leadership within the Department. We are truly blessed not only to have Chief Patterson but also Deputy Chief Sansing in charge of our safety and security.

In the event that you are considering landscaping near the City's rights-of-way, please be aware that an ordinance has been enacted which limits citizens' ability to plant any large trees or bushes within the City's rights-of-way. More modest plantings within the rights-of-way are permitted; however, a permit is now required. Please contact the City should you wish to commence any landscaping activities within the City's rights-of-way.

We have also been impressed by citizen involvement and participation in recent public meetings respecting Oxford speed bump proposals, Dahlia Hollow Park suggestions, and input regarding in-home sprinkler issues on major remodels.

I hope you partake in the community spring clean-up and recycling efforts to be held from May 29 - June 6; also, please see the flier in the center of this Crier announcing a summer riding event on June 12th, and stay tuned for other outdoor summer activities planned in the City. For updates on Village events, refer to the signage on Quincy on the north side of the Village Center (across from the elementary school), or visit the City's updated website.

As always, your elected officials welcome your input and hope to hear from you soon.

On December 18<sup>th</sup>, Eric Ensey resigned his position as City Manager. Following a conversation with Mayor Mike Wozniak and Councilor Scott Roswell, I agreed to accept the challenge and assumed the duties of Interim City Manager while continuing as the Police Chief for the Village. I currently spend about 70% of my time dealing with issues at the City Manager level.

I am transitioning into my new duties by meeting with Council members, citizens and other City Managers to get an understanding of their expectations of City government and of me. Many technical facets of the City Manager's job are new to me, and I appreciate your patience as I grow into the position.

Deputy Chief Jody Sansing will be responsible for the day to day operations within the police department.

## HOUSEWATCH PROGRAM

The Police Department's housewatch program is a community program that allows citizens to request additional police patrol of their unoccupied residential property due to vacation, relocation or other absence of the resident. To request a period of additional patrol of your unoccupied residence, please contact the Police Department with the following information:

- Name, address and telephone number
- Dates of departure and return
- Name and telephone number of an emergency contact
- Specific information regarding your residence, such as persons who have permission to go inside your residence, whether an alarm system will be activated, if lights will be on timers, and if there will be any pets left at the residence.

## HOME BUSINESSES IN CHERRY HILLS VILLAGE

The City has received many questions over the years from residents regarding the operation of a business from their home. Chapter 16 of the Cherry Hills Village Municipal Code defines "home occupation" as "a use which is clearly incidental and secondary to the use for dwelling purposes and does not change the character or exterior appearance of the dwelling." Section 16-5-10(8) provides that any home occupation operated in a single-unit dwelling may be operated **only** if it complies with **all** of the following conditions:

- The home occupation is operated in its entirety within the single-unit dwelling and only by the persons maintaining a dwelling therein.
- The home occupation does not have an exclusive entrance from outside the dwelling unit.
- The home occupation does not display or create outside the building any external evidence of the operation of the home occupation except that one (1) sign, not exceeding one (1) square foot in area, non-illuminated, and mounted on the wall of the principal structure, is permitted.
- The home occupation does not have any employees or regular assistants not residing in the single-unit dwelling.
- The home occupation is not conducted in an accessory structure.
- No article may be sold or offered for sale from the premises. This restriction does not apply to occasional garage sales, the sale of a single used car, the sale of a litter of animals and other similarly non-continuous and non-repeated transactions.

If you are having a garage sale or similar occasional event at your home, you will have to remit sales tax to the City for any articles sold. The City sales tax is 3.5% and should be remitted with the Sales Tax Return Form that can be found on the City's website at [www.cherryhillsvillage.com](http://www.cherryhillsvillage.com).

## SPRING CLEANUP MAY 29 - JUNE 6

The City will again be offering a Spring Cleanup for residents this year. Dumpsters will be provided for citizens to dispose of their unwanted trash and rubbish. The City will continue to accept electronics; however, paint will no longer be accepted.

There will also be a community shred day on **Saturday, June 5, 2010 from 9:00 a.m. to 12:00 p.m.** The City will bring in a large mobile shredding operation and citizens will be able to destroy any personal documents. ### ELECTRONIC RECYCLING

The dumpster and electronics recycling will be available from **May 29 - June 6, 2010**. The City is unable to accept large appliances and television sets over 19", so please do not bring these items to the site. **Also, please do not bring any hazardous chemicals or waste.** You may be asked to provide proof of residency as you drop off items, so please be prepared to show a drivers license with a Cherry Hills Village address on it.

The trash dumpster will be located east of the maintenance shop at the Village Center. Electronics may be dropped off on the appropriate pallets next to the dumpster. Residents are encouraged to take advantage of this opportunity to dispose of rubbish not included with normal curbside service. **Please note: the City will be UNABLE to accept the following items for disposal: paint, tires, appliances, oil, antifreeze, fuels and any hazardous materials.**

### OTHER HAZARDOUS HOUSEHOLD CHEMICALS

The City has contracted with Curbside Recycling Inc. to do a door-to-door recycling program for hazardous waste again this year. Residents will be required to pay a \$20 co-pay and may use the service only one time per year. Funds are limited, and the program will be suspended once all the funds have been used, so please use the service wisely. Residents are encouraged to work with their neighbors and pool hazardous waste to maximize the available funds. 
# RESIDENTIAL DEVELOPMENT STANDARDS COMMITTEE

## RECOMMENDS “DAYLIGHT PLANE” STUDY

Following a recommendation of the Residential Development Standards Committee (RDSC) Report, the City is seeking the services of an architectural or planning firm to conduct a follow-up study on the RDSC’s recommendation to create a “daylight plane” standard for new residential development. A “daylight plane,” often referred to as a “bulk plane,” is an angled building envelope designed to ensure that larger homes do not “loom” over adjoining properties or block daylight. The “daylight plane” concept is currently implemented in other municipalities.

The purpose of the study is to make zone district and neighborhood specific recommendations on how to implement the “daylight plane” concept. The study will be partially funded by a grant through the Denver Regional Council of Governments.

The “daylight plane” standard is one of several recommended changes to the City’s building and zoning codes by the RDSC.



The City Council directed City staff to move forward with the “daylight plane” study at their March 1<sup>st</sup> meeting. The Council also directed City staff to begin looking into two of the other recommendations made by the RDSC. The first is to explore the possibility of adopting a “green building” code similar to the United States Green Building Council’s LEED rating system ([www.usgbc.org](http://www.usgbc.org)). The second is to explore a landscape preservation ordinance, whereby mature landscaping outside of the building envelope would either need to be preserved or replaced as part of a new home development.

The RDSC is a five-member citizens’ advisory committee that was appointed by the City Council in September of 2008 to study the impact of large scale residential development on the character of the community. We have a unique opportunity to work with land owners to develop partnerships and resources needed to protect treasured lands from future development.

**Reasons for seeking office/What do you hope to contribute as a CHV elected official**

I hope to continue to provide leadership from District 6 to the Village in the areas of environmental stewardship, proactive land protections, trail enhancements and Village safety and quality of life issues. It is my goal to serve my neighbors in a responsive and collaborative manner. Our Village government can improve citizens quality of life through excellent public works, police protections, community development and building oversight, expanded trail systems and enhanced communications. In addition, I am committed to working toward protecting the semi-rural heritage of this community through attention to environmental threats, wetlands protections, and open lands conservation. I hope to work with other residents to place Cherry Hills Village in the forefront on recycling, composting, green building and public works practices.

# FROM PUBLIC WORKS

## COUNCIL MAKES RIGHT-OF-WAY CHANGES

In February of 2010, City Council made a number of amendments to Chapter 11 (Streets, Sidewalks and Public Property) of the Cherry Hills Village Municipal Code.

**The first change concerns mowing rights-of-way that abuts each property in the Village.** For decades, City crews have been mowing certain portions of rights-of-way throughout the City while not mowing other portions. This pattern evolved over time with no consistency or logic as to how this mowing was being done and it needed to be corrected to make a consistent policy that will treat all residents equally. The residents most affected are those who live in the areas of the Village where there are no curbs and gutters, only open ditches.

*Staff will continue to mow the rights-of-way, as they have historically done, through the end of 2010.* After 2010, City crews will only mow the City's "main" streets, which include; Quincy Avenue, Clarkson Street, Colorado Boulevard, Holly Street, Happy Canyon Road, and all of the state rights-of-way. The City will send notices throughout 2010 to remind the affected residents that in 2011 they will need to make arrangements to have the area in front of their homes mowed to the edge of the street. City Code Officers will assist the Public Works staff in communicating with residents to make sure they understand their responsibilities under this new code amendment.

**The second change concerns landscaping within the right-of-way.** Residents often plant trees and other vegetation next to City streets, and it becomes increasingly difficult to maintain the streets as this vegetation matures. This amendment requires that *residents must now apply for a permit prior to planting most vegetation within the City's rights-of-way.* Residents need to realize that the right-of-way in most cases is 5 to 20 feet wider than the actual road surface itself. This space outside the driven road surface is needed so the City can perform the necessary maintenance and snow removal operations without encroaching on private property. The right-of-way is to be maintained by each private property owner in a manner that does not interfere with the City's ability to properly maintain the street.

This amendment has been added to avoid future issues as trees and other vegetation grow and mature. The amendment states that, "No private improvements are allowed within the City's right-of-way without the approval of the City with the exception of placing and maintaining limited landscaping, such as sod or grasses,

flowers, and no more than four (4) bushes or small trees of a caliber not to exceed two (2) inches, and will not interfere with the public's use of the right-of-way." At no time will trees or bushes be placed in drainage ditches/areas. All newly planted trees must be at least 10 feet from the actual road surface.

Be sure to contact the City before improving any landscaping next to the street to avoid future issues.

**The third change to Chapter 11 of the Code strengthens the City's ability to ticket and fine individuals and companies that cause damage to the City's street surface.** As contractors load and unload equipment on City streets there is often damage that compromises the integrity of the street and shortens the useful life causing accelerated deterioration and increased maintenance costs. *This amendment allows these costs to be passed on to the person or persons who caused the actual damage* and in the long run saves taxpayer dollars.

## PUBLIC WORKS DIRECTOR GOLDIE APPOINTED TO LAKWOOD PLANNING COMMISSION

The Cherry Hills Village Public Works Director, **Jay Goldie**, a resident of Lakewood, was appointed to the City of Lakewood's Planning Commission on February 9, 2010. The terms are four years in length and the Commissioners may serve two terms. The Commission has two meetings and two study sessions per month.

# FROM ANIMAL CONTROL

I get really excited about this time of year!! Spring Fever has set in for sure. I'm not the only one that is feeling it.... So are our pets and the local wildlife. Spring is the time of year when everything seems to "come to life". A few things you will see in the next few months are all the "new additions" to the wildlife families. They may be cute and you may have an urge to get close and take pictures, but please observe our wild neighbors from a distance. Wild animals are extremely territorial when it comes to protecting their young. NEVER, ever feed wild animals!! Feeding wildlife is against the law, but there is a very good reason for that...it makes them want to be around humans, because they will then associate us with food. This can cause some very serious problems, not only for us but for the four-legged members of our families. If you have questions on how to haze coyotes or how to try and keep coyotes off your property, please give me a call and I will send you a very useful packet of information. I emphasize coyotes because I get the most questions about them, but we need to be aware and cautious of **all** wildlife. Something as simple as a bird feeder can attract all sorts of wild animals to your property.

## DOG LICENSING AND RABIES INFORMATION

I am reminding you of the Dog Licensing program in Cherry Hills Village. All dogs residing in the City limits need to be licensed here. Bring in your dog's rabies certificate, along with \$10.00, to the Village Center. It is extremely important to vaccinate your dogs for rabies. Over the past several years, the country has gotten a little complacent with rabies vaccinations and now we are starting to see more animals that have been confirmed positive for rabies. Recently Elbert County had a rabid skunk in the City of Elizabeth. To prevent exposure to you or your pets:

- Do not feed wild animals. Do not leave pet food outside.
- Do not leave livestock feed containers open in sheds or barns. Remove junk piles from around your home that may be attractive nesting areas for wild animals.
- Teach your children to stay away from all wild animals or stray domestic animals, or any dead animals they may find.
- Do not let your pets roam freely, as this increases the chance they are exposed without your knowledge.
- If your pet is bitten, scratched or sprayed by a wild animal, please contact your veterinarian as soon as possible.

- Report any dog or cat bites to your doctor and Animal Control immediately.

Typically, raccoons and skunks are rarely seen in the daylight hours. If you see any wild animals exhibiting odd or aggressive behavior, please contact Tri County Health Department immediately at **303-220-9200** and contact Animal Control.

Spring is here and that means the equestrians in our community are going to be out and about again on the highline & bridle trails, and on-street trails. Please observe the following when passing equestrians in your car, bike or while jogging or walking your dog.

If in a vehicle, SLOW TO 20 MILES PER HOUR 6 car lengths BEFORE and AFTER the rider. PLEASE YIELD to horses crossing the streets. If you are riding a bike or jogging, please be aware that horses can startle easily...when approaching from behind, slow down and make sure the rider is aware of your presence; if you are with a dog, please be aware that even leashed dogs can become nervous around bigger animals and may re-act out of fear...keep your dogs leashed tightly next to you as you walk by a horse.
