## **NEW ART COMMISSION FORMED**

City Council has formed a new Art Commission within Cherry Hills Village. This commission will be made up of 3-5 residents and will include a representative from City Council. Klasina VanderWerf, Councilmember from District 5, was appointed by Council at their June 7th meeting. The mission of the Art Council is as follows:

***"The Cherry Hills Village Public Art Commission is devoted to developing a Public Art collection by selecting, locating, placing and maintaining art in public places, exposing the community to the arts, [and] fostering education programs."***

If you are interested in applying for appointment to this commission, applications are now being accepted. The application is online at the City's website: [www.cherryhillsvillage.com](http://www.cherryhillsvillage.com). The Art in Public Places Master Plan is also on the website. This Master Plan outlines how the commission will be organized. The Commission will be looking to place art throughout the community (in public places, parks and public buildings). Below is a short excerpt from the Art Master Plan:

***The purpose of the Art in Public Places Master Plan is to further the City of Cherry Hills Village's goals with respect to art in public places, by creating a Public Art Commission (PAC), and providing a guide to the City Council, the PAC and the citizens of Cherry Hills Village in locating,***

*selecting and maintaining public art within the City of Cherry Hills Village. This master plan is intended to provide objective direction to develop art for public places. The placement of art in public places enriches, stimulates, and enhances the aesthetic experience. Public art illuminates the diversity and history of a community and points to its aspirations for the future. A wealth of art and culture in the public realm will foster educational opportunities and economic development for Cherry Hills Village.*

# MAYORAL MUSINGS

I hope everyone is having a good start to the summer.

I thought it might be important to advise everyone about some of the quasi-law enforcement work that is undertaken on a daily basis by our Code Enforcement Division. We have two full time code officers and one full time animal control officer. Chuck Friend and John Bayman are Code Enforcement officers and are responsible for ensuring that all properties are in compliance with our City of Cherry Hills Village Municipal Code and for conducting inspections of construction sites. The type of activities that are reviewed include: checking to ensure that construction hours and days of activities are complied with, viewing whether materials and equipment are stored in the streets or City rights-of-way, checking for removal of dumpsters, inspecting street tracking and permit compliance, verifying that parking is properly undertaken in compliance with permitted staging areas, inspecting excavations, checking for storm water compliance and similar types of code compliance.

So far, through April of this year, our two code enforcement officers have discovered 11 fence violations, 17 permit violations, 66 sign violations, 16 right-of-way violations, and 330 construction site violations. They have received requests for service 215 times and have issued 362 warnings and personal contacts, followed-up with a 147 posted notices and letters and issued 7 notices of violation, 3 summonses and 8 stop work orders - all in the first 4 months of this year. Through the strong efforts of our Code Enforcement Officers, we can ensure that our construction codes and municipal and zoning ordinances are properly enforced.

On the animal control side, through the first 4 months of 2011, Michelle Edwardson has addressed 26 aggressive or excessive barking dog issues, 101 educational contacts, 59 wildlife complaints and has issued 8 warnings and 11 summonses. Coyote complaints usually decrease in the summer.

Finally, it continues to be a source of pride for me to review the stellar work of our police department under Deputy Chief Sansing's day-to-day leadership and Chief Patterson's guidance as they continue to implement community policing. When we compare 2011 to last year, our traffic accidents are down 10%, our traffic warnings are down 23%, our number of alarms is down 3%, our number of arrests is down 11%, our citizen assists are up 57% and our DUI arrests are up 5%. Overall, all of our citations are up 21%. It is most amazing that our crime reports are down over 50% which is a testament to the hard work of our officers. Burglaries have been reduced every year since 2007. I can assure you from personal experience that many of our neighboring cities would love to have this track record. While these are all positive signs, I know that our police department is not resting on its laurels and is continuing to strive to improve performance. Our assistance to other neighboring police departments is up 14%, our crime prevention notices are up 8% and our field interviews with our citizens and residents are up 32%.

If you get a chance to discuss safety issues with any of our police officers, please be sure to express thanks for their hard work and dedication.

The Police Department's housewatch program is a community program that allows citizens to request additional police patrol of their unoccupied residential property due to vacation, relocation or other absence of the resident. To request a period of additional patrol of your unoccupied residence, please contact the Police Department with the following information:

- Name, address and telephone number
- Dates of departure and return
- Name and telephone number of an emergency contact
- Specific information regarding your residence, such as persons who have permission to go inside your residence, whether an alarm system will be activated, if lights will be on timers and if there will be any pets left at the residence.

Traditionally lieutenants supervise shifts and small units within police departments. With the advent of community policing, the role of lieutenants has changed and expanded to include more responsibilities such as community outreach, problem solving initiatives, budget responsibilities and wider supervisory responsibilities. Commander Weathers has been a Cherry Hills Village Police Officer for 30 years.

City Manager Chief John Patterson says of Goldie, "He has raised the performance bar for contractors; I have come to rely on Jay's expertise and respect his abilities a great deal. In my absence, he has assumed the duties of the City Manager." Goldie has obtained his Masters degree and is currently enrolled in the University of Colorado at Denver's Certified Public Managers Program.

## SPRING CLEAN UP BIG SUCCESS

Once again the Spring Clean Up was a big success. Hundreds of residents participated and cleaned out their homes and yards of unwanted rubbish. More than 8000 pounds of landscape debris and trash were removed from the City. Additionally, approximately 100 people participated in the annual shred day event that was held at the same time as the spring clean up. Look for these events again next year in April.

### PT & R

The City of Cherry Hills Village would like to thank **Ann Gallagher** for the dedication and service she provided as a volunteer on the Parks, Trails and Recreation Commission as Vice-Chair. She will be missed and the City wishes her success in all future endeavors.

Council has appointed **Bill Lucas** to fill the PT & R vacancy. Other members of the Commission who were re-appointed are **Jeff Ferrell**, **Karen Barsch**, and **Jim Fairbairn**. The PTR Commission consists of 7 members - one from each Council District - but a member at large may be appointed by the Council if needed.

## BOARD OF ADJUSTMENT AND APPEALS

**Kerry Sullivan** was appointed to serve a three year term on the Board of Adjustment and Appeals at the June 7th Council meeting. Mr. Sullivan has been a City resident for 13 years. He previously served on the City's Planning and Zoning Commission for six years and was a Parks and Trails Liaison for one year.

## JOINT PUBLIC SAFETY FACILITY COMMUNITY MEETING

The first of two community input meetings pertaining to the new Joint Public Safety Facility was held at the Village Center on Wednesday, May 18, 2011. The Joint Public Safety Facility is the structure that will be built to house both the Cherry Hills Police Department and the South Metro Fire Department. Several Village residents were in attendance for a short presentation by Roth Sheppard Architects regarding preliminary conceptual planning. While an actual building design has not yet been established, the meeting concentrated on the initial site plan and potential building orientation.

Discussion focused on integrating the new building into the current Village Center Master Plan and maintaining the integrity of the rural aspect of the site. Roth Sheppard is committed to designing a building that will complement the character of the community while creating a cornerstone for the Village Center complex. The final community meeting will be held later this summer and will include a more finalized rendering of the new facility and site plan.

The City of Cherry Hills Village and the South Metro Fire Rescue Authority are currently constructing a new website specifically dedicated to the new building project. The website will include up to date information on the progress of the building, images of conceptual designs and a current project schedule. Links to the website will be included on the City of Cherry Hills Village and the South Metro Fire Rescue Authority websites and should be accessible in June.

# KUDOS TO RETIRING LONGTIME CHVE STAFFERS



On May 26, 2011, Cherry Hills Village Elementary School held a bench dedication ceremony to honor three significant people who have greatly impacted the school community for many years. **Principal Pam Livingston**, second grade teacher **Randy Nelson**, and librarian **Sandy Collier** will retire at the end of the current school year.

To commemorate their longtime service and contributions to the CHVE community, the names of Mrs. Livingston, Mr. Nelson and Mrs. Collier were inscribed on a bench near the main entrance of CHVE. Their names, together with the names of past retirees, are inscribed under the heading "Dedicated Excellence."

**Pam Livingston** has served in different positions in education for 31 years, and has worked in the Cherry Creek School District for a total of 28 years. For the past four years she has served as the Principal of CHVE and comments, "CHVE feels like my home." She has a total of 13 years as a Principal in the CCSD, two years as Assistant Principal, and four years in Staff Development. Mrs. Livingston also spent nine years in the classroom as a kindergarten, first grade and second grade teacher. Teachers and parents commended Mrs. Livingston's sense of humor, and her willingness to take the time to get to know the students and teachers personally.

**Molly Drvenkar** will succeed Mrs. Livingston as Principal of CHVE. Mrs. Drvenkar has spent the majority of her professional career with the CCSD. She has held the positions of classroom teacher, writing specialist, assistant principal and, most recently, principal of Bellevue Elementary School.

**Randall Nelson** has been a teacher for 30 years. He started his teaching career in Iowa before moving to Colorado, and has been with the Cherry Creek School District for the past 27 years. He taught at Sunrise Elementary School for nine years, and has taught for 18 years at Cherry Hills Village Elementary. Mr. Nelson currently is a second grade teacher at the school, but also has taught third, fourth, fifth and

seventh grades. At the bench dedication ceremony, Mr. Nelson said that he would never forget the support and friendship he received from the parent community and staff at CHVE where he was fortunate to call his fellow teachers his friends. He added, "Thank you to all the kids for letting me be part of your lives, and for sharing your lives with me."

**Sandy Collier** has been with CHVE for 18 years. Mrs. Collier currently is the librarian at the school, but also has been a reading specialist, technology specialist, and Spanish instructor. Mrs. Collier described her time at CHVE as a "wonderful journey," and added that it was a "tremendous honor and challenge to have worn so many hats and taught so many kids."

About the staff she has worked with, Principal Livingston added, "Cherry Hills Village Elementary is an outstanding elementary school due to the dedication of our teachers and classified staff; they come to work every day determined to make a difference in the lives of the students. We could not do our job without our supportive parent community who are here for us every day, asking what they can do to help. And then, of course, our children come to school to learn and to do their best. The three of us feel blessed to have had the opportunity to end our careers at CHVE!"

# FROM ANIMAL CONTROL

Summer is finally here!! The spring rain was wonderful, but the sunshine has brought everyone outdoors. During this time of year, please be thinking about the safety of your pets. Dogs that are left outside need to have shelter and water available at all times and also protection from wildlife.

## CAR SAFETY FOR ANIMALS

Please remember that to leave a dog inside a car (even on a 70 degree day with the windows cracked) can be a death sentence. The temperature on the inside of a vehicle can rise to over 100 degrees within a matter of only a few minutes. Dogs cannot sweat when they get hot, so they pant which causes more humidity inside the car which then causes it to be even hotter inside the car. If you have to run errands during the day, it is always best to leave your dog at home. If you are ever concerned about a dog left inside of a vehicle, please call the local police department or animal control.

## BARKING DOGS

Another thing that happens during this time of year is that some people like to leave their windows open at night. Please be considerate when letting your dog outside day or night. Dogs may bark for many reasons. If left outside too long, this can be a nuisance and a violation of our barking dog ordinance.

## DOG LICENSES

Dog licenses are now available on our City website. All dogs residing inside the City that are at least four months old, are required to have a Cherry Hills Village license. This is different from a rabies tag. Please have your dog's current rabies information available when you register.

## COYOTES & CHV's COYOTE MANAGEMENT PLAN

The coyotes have had their pups and will be visible while out and about. If you see pups, please do not attempt to pick them up or take pictures of them. Mothers are very protective of their young. Also, please continue to haze the coyotes every time you see them on your property. Adult coyotes need to teach their young that humans are something to be afraid of. For different hazing techniques, please give me a call and I can send you the information.

The City has a Coyote Management Plan that you can find on the City website; it explains how to handle different coyote situations, the laws pertaining to coyotes, and definitions of coyote activity. All metro area cities are trying to have the same or similar definitions of problems with coyotes, so we are all reporting the same type of activity to the State. If you have questions regarding whether to call and report coyote activity, the following definitions may help you:

## DEFINITIONS OF COYOTE INTERACTIONS

**Observation:** The act of noticing or taking note of tracks, scat or vocalizations.

**Sighting:** A visual observation of one or more coyotes.

**Encounter:** An unexpected direct meeting between a human and one or more coyotes with no physical contact and no aggressive behavior from the coyote.

**Incident:** A conflict between a human and a coyote where a coyote exhibits behavior creating an unsafe situation, but the human was uninjured. This includes the following type of behavior: growling, baring teeth, lunging toward a human.

**Attack:** An aggressive action by a coyote where a human is injured or killed.

Reporting the above defined behaviors by using the given verbiage helps animal control keep track of coyote activity in the City, and, hopefully, the above definitions of each type of coyote situation will help residents report them more accurately.

When situations occur, the City also wants to know if any pets were involved. Reports of attacks on pets are kept track of too, but ultimately it is every pet owner's responsibility for keeping his/her pets safe. Please note: all "encounters," "incidents" and "attacks" are investigated thoroughly by police personnel as well as by officers with the Department of Wildlife. **DO NOT make false reports regarding coyote behaviors.** If we discover a report was fabricated to get a police response, the person making the report could be charged with a crime. We take every report very seriously and want to help, but it doesn't help us, your neighbors, or the coyotes when we spend a lot of time on a case to find out the story was made up.

## MEADE PARK ROUNDUP CANCELLED

For the second year in a row, the Meade Park horse roundup event was cancelled. Last year the event was cancelled due to rain. This year it was cancelled because of the Equine herpes virus - or EHV-1. EHV-1 is a very serious and highly contagious neurological disease that affects horses. As of June 3rd, Colorado State Veterinarian Dr. Keith Roehr states on the [www.colorado.gov/ag](http://www.colorado.gov/ag) website "The encouraging news for us is that we have not seen any new confirmed cases in Colorado since May 20, 2011 and we hope that the trend continues, but we still cannot let down our guard as we work to mitigate and control EHV-1."

To date there are nine confirmed cases of horses with EHV-1. Two horses that tested positive for EHV-1 were euthanized after showing severe neurological signs associated with the disease; there have been 22 suspect cases. (NOTE: "suspect cases" are those horses that are believed to have been exposed to EHV-1). Twelve quarantine and hold orders have been issued in 8 counties (Bent, Boulder, Garfield, Gunnison, Larimer, Mesa, Morgan and Weld).

### How is the virus spread?

The most common way for EHV-1 to be spread is by direct horse-to-horse contact. EHV-1 can also be spread directly through contact with physical objects contaminated with infectious virus. Examples of such objects include: tack, wipe rags or other grooming equipment, feed and water buckets, and people's hands or clothing.
