Police Department Announces Changes To SECURITY ALARM PERMITS

As the new year unfolds, residents of our city will notice a significant change in the way the Police Department manages security alarm permits. Traditionally, January marks the time when the Police Department dispatches its annual security alarm permit invoices to residents. However, in a progressive move, the City has decided to eliminate the requirement to pay for and obtain a security alarm permit. Instead, the Police Department is introducing a more streamlined process, urging residents and business owners to voluntarily register their security alarm systems through the newly designed department website.

This shift in policy aims to enhance community safety while simplifying the process for residents. With the elimination of alarm permit fees, the Police Department is encouraging everyone to take advantage of the opportunity to register their security

alarms online. By doing so, residents contribute to a safer community and help deter criminal activity.

One of the key advantages of this new approach is the elimination of fines associated with false alarms. With the repeal of the permit requirement, homeowners no longer need to worry about fines incurred due to false alarms. The focus is now on ensuring that security alarms are actively used, providing an additional layer of protection for homes and businesses.

The Police Department emphasizes the importance of remaining vigilant and setting security alarms. Experience has shown that the activation of audible security alarm systems serves as a powerful deterrent to criminals. The Department believes that responding to a false alarm is a small price to pay for maintaining a secure environment.

To facilitate a more efficient response to alarm calls, the Police Department strongly encourages residents and business owners to voluntarily register their alarm systems on the Department's website. This registration process is not only free but also ensures that officers have access to the



most accurate and up-to-date information during emergency situations. Details on the "Alarm Registry" can be found on the Department's website, CHVPD.com, under the "Forms" tab.

The Department is committed to fostering a sense of security within the community and believes that this new initiative will strengthen the partnership between law enforcement and residents. Vacation HOME CHECK

If you're going on vacation, let Cherry Hills Village Police Department know! We offer the service of checking on your home or property while you are away. In order to request this service, complete the form online at www.chvpd.com at least two days prior to your departure.



What is a House Check?



Your house will be checked by an Officer every other day. This, of course, depends on the manpower and availability of Officers.



What does the Officer do when checking my house?



The Officer will walk around the residence to ensure the house is secured and there are no signs of forced entry. They will also be looking for any signs that unwanted persons, or vehicles have been there. They will watch for things that may seem out of the ordinary. The Officer will log the times of the check in their activity log.



What happens if something is wrong?



The person(s) you list as an emergency contact will be notified; most likely you will also be notified immediately afterwards. Don't forget to give us your cell phone number in case of an emergency.

comfort in the knowledge that our police will do everything in their power to help. I will be more than a statistic. The City is committed to the safety of our community and the support of our Police Department.

■ Quincy Farm – Located where the High Line Canal crosses Quincy, Quincy Farm is a beautiful reminder of our community's origins as farm country. The Hopkins House, on the National Register of Historic Places, is a well-maintained example of an early Colorado farm house. I love that we have one of the few remaining examples of Colorado's rural heritage right here in our community. The City is committed to the conservation of the property and making it accessible to the public.

■ Our neighborhoods – I discovered Cherry Hills Village years ago while driving down Colorado Boulevard. As soon as I crossed over Hampden I was struck by the beautiful houses with large yards, pastures and sometimes horses or other animals. Our neighborhoods stand in stark contrast to the flat grid of streets in Denver with homes practically on top of each other. I love that it just feels different here. As I hope you are aware, there are efforts in the legislature again this year to preempt local control of zoning and development. The City is absolutely committed to the protection of our community and its unique neighborhoods and residential experience.

■ Our roads – Have you noticed, on a snowy day, that you can always tell when you have crossed into Cherry Hills Village? As soon as I cross Hampden I can feel the blood returning to my white knuckles and feel my shoulders relax because I know that here, the roads will be plowed and pothole-free. Our public works department does an amazing job maintaining our roads throughout the year. I love knowing that I won't be trapped in my home! In addition to plowing and repairs, the City supports an annual road maintenance program that resurfaces all roads in the city on a 8-year rotation.

■ Our art – Beauty is in the eye of the beholder, so I know some of you might not agree, but I love the pieces in our public art collection. Whether or not you like Charlo - the Butterfield horse in front of

Ahh, February... the season of love. In honor of Valentine's Day, I wanted to share some of the things I love about Cherry Hills Village.

■ Open spaces and trails – Cherry Hills Village has more than 50 acres of public open space and 25 miles of trails in our small community of 6 square miles. When combined with private open spaces created by low-density development and recreation areas, our community boasts more open space per acre than any other community in the metro area. I love that I have a stunning view of the mountains as I drive down Quincy thanks to these open spaces. They are valuable not only because they create a beautiful, bucolic community and viewsheds, but also because they contribute to ecological conservation and wildlife protection. The City is totally committed to the preservation of open space in Cherry Hills Village.

■ Our Police Department – According to FBI crime statistics, crime rates in Colorado are significantly higher than the national average. But here in Cherry Hills Village, thanks to our tremendous police department, our per capita crime rates are about 1/3 of the Colorado median and far less than that compared to the Denver metro area. Even though the crime rate is very low here, it is not zero. When these events occur, they are very traumatic to both the victims and the community. I love knowing that our police department is looking out for me. And if something were to happen, I take

the Joint Public Safety Facility, the Robert Mangold sculpture at Quincy Farm, or any of the other pieces in our collection, I hope you love that there is a place for art in our community. The City has recently added three new sculptures by artist Joe Norman to our collection. The pieces appear to be local wildlife (a monarch butterfly, a broad-tailed hummingbird, and a great horned owl) when viewed from one direction and playing children when viewed from a different angle. You can see this "Resilience" series in John Meade Park.

■ Our community events – Each year the city organizes several events to bring the community together. This year's events include our annual outdoor movie night, winter celebration, and a new spring trail event. You should also be sure to check out the annual Exotic Car Show which was started by the City years ago but is now a benefit for the CHV Police Foundation. I love meeting new people at these fun family events. Thanks to all the staff and volunteers who make those events happen every year.

■ Our residents – The thing I love most about Cherry Hills Village are you, my fellow residents and neighbors. Do you know what makes a house a home? The people inside. It's the same thing that makes a city a community. I love how invested and committed all of you are to this special place we share. I assure you that the city staff and council are completely committed to this community as well.

It is my honor to serve as Mayor of this remarkable community, a place I love deeply. Cherry Hills Village, you're my Valentine!

SNOW REMOVAL

Every municipality in the northern portion of the nation hears the same complaints after every major snowstorm: City plow trucks push big piles of snow right back in front of my driveway just after the driveway is cleared. Public Works staff would like to address this issue and provide some insight into how plowing operations take place.

The primary goal of plowing is to remove snow from streets so that the road is open and safe for vehicular traffic. Plowing pushes snow to the side from the middle of the street naturally, and, unfortunately, this results in snow piling up in front of driveways. Snowplow operators do not place snow in driveways on purpose. There is no practical way for the snowplow operator to cut off the windrow of snow that slides off the plow when crossing each driveway. This problem is especially acute in cul-de-sacs because of the space limitations. The driver cannot stop or raise the plow at each driveway as this would leave a pile of snow in the roadway.

If possible, plow drivers will try to prevent excessive blockages at driveways but at times this is not possible. Please remember that the clearing of driveway and mailbox areas is the responsibility of each resident. This issue is only magnified if you live on a cul-de-sac. With the absence of sidewalks in the Village the problem is even more exaggerated and frustrating. Plow drivers make every attempt to keep this issue to a minimum, and we ask citizens to be patient and recognize that during the winter months there will be some inconveniences.

If the plow comes through and you must clear snow again from your driveway or mailboxes, please do not shovel snow into the road. For safety and travelability this snow will be plowed back to the side of the road to remove the hazard from the street. Residents are advised to wait until the plow has been through their road prior to cleaning their driveway and mailbox area. If drifting or more snow occurs, the plows may have to make multiple passes on a road at a later time to keep the road clear.

City snowplow drivers will continue to do everything they can to avoid this problem. If you believe there

is an “excessive” amount of snow in your driveway, call or email the Public Works Department and a work order will be generated. After the snowstorm is over and after all City streets have been cleared of snow, staff will investigate all snow-related work orders. If the amount of snow in the driveway or in front of the mailboxes is determined to be excessive, meaning significantly more than all the other driveways/mailboxes in the City for a particular storm, staff will remove the excess as best they can. Residents may still need to shovel and clean up the remaining snow. If the amount of snow is not excessive as determined by staff, the snow will not be removed. The City does not have the resources to clean out private driveways and mailboxes that have an ordinary amount of snow deposited in front of them. Homeowners are responsible for access to their driveways and mailboxes.

REVITALIZING THE HIGH LINE CANAL ECOSYSTEM and Ensuring Public Safety through Comprehensive Tree Care

A dedicated effort amongst Canal partners is set to prioritize the health of the High Line Canal's ecosystem and improve public safety through comprehensive tree care along the 71-mile Canal. Commencing in early 2024, dedicated forestry crews will be along the Canal, supporting these revitalization and sustainability efforts.

This tree care work includes critical measures to fortify the Canal's ecological integrity and ensure the safety of its users. Trail users can expect to see:

- Removal and pruning of hazardous trees
- Mitigation efforts to combat the spread of the Emerald Ash Borer pest through tree inoculation of healthy ash trees and removal of unhealthy ash trees
- Removal of invasive Russian olive
- Clearing of woody material and other debris from the Canal channel

While the project unfolds, we anticipate occasional disruptions to trail access which will be kept up to date on highlinecanal.org/trail-notices. Signage along the Canal will indicate work areas, ensuring safety and awareness for trail users.

This essential tree care work is a step toward a healthier and more vibrant ecosystem. In tandem with these efforts, the Conservancy and its partners are actively engaged in revegetating the corridor with new trees and native plants. New plantings can already be found across many miles of the trail, enhancing the Canal's beauty and biodiversity.

GOOD BONES: THE RESTORATION OF QUINCY FARM'S HISTORIC 'BIG BARN'



Built in the 1930's, this historic barn serves as the iconic centerpiece for educational programs and community events at Quincy Farm. Beginning in spring 2024, a thoughtful rehabilitation project will commence to address the Big Barn's significant structural issues. Additionally, a larger interior gathering space will be created, while preserving the Barn's historic character and original horse stalls.

The partnership between the City of Cherry Hills Village and Cherry Hills Land Preserve has forged the way, led by a dedicated team comprised of both entities. The vision of the Big Barn project has been years in the making, and the City Council-approved annual plan/budget for Quincy Farm was the final step to making the dream a reality.
