2024 Spring Clean-up

May 18, 2024 | 9 a.m. to 2 p.m.

The 2024 Spring Cleanup will be held **ONE DAY ONLY** on Saturday May 18, 2024 from 9:00 am to 2:00 pm at the Public Works Facility (2101 W Quincy Avenue, Sheridan, CO 80110). Residents can bring the materials listed below for recycling or disposal. This program is for residents only so please be prepared to show your driver's license with a Cherry Hills Village address.



Acceptable Items for drop-off:

- **Paper Shredding**
- **Tree branches and yard debris** (no more than two pickup/trailer loads per household)
- **Car batteries** (provided they are not leaking)
- **Consumer electronics** (laptops, desktops, monitors, microwaves, cell phones, printers, gaming systems, CD/DVD players, fax machines and scanners)
- **Flat screen televisions up to 48"**
- **Paint products** (oil based paint, latex paint)
- **Batteries** (AA, AAA, C, D and rechargeable)
- **Fluorescent light bulbs** (compact fluorescent lamps, CFL) and straight fluorescent tubes) **and lamp fixtures**
- **Trash, including bulky items, and furniture**

Items that will NOT be accepted

- **Large appliances** (refrigerators, washers, dryers, vacuums, etc.)
- **Hazardous materials/chemicals** (i.e. liquid mercury, leaking or empty containers, unknown or unlabeled materials and radioactive items)
- **CRT (tube or projection) televisions**
- **Biological waste**
- **Commercial or business supplies**
- **Incandescent light bulbs**
- **Asbestos**

Quincy Farm Update



Last September, I wrote an article for the Village Crier about Quincy Farm, the City's 17 ½ acre parcel of open space on the south side of Quincy at the High Line Canal crossing. As we move into the warmer months of 2024, I wanted to provide an update to that article.

WEST SIDE NATURE TRAIL

Since that last article, and as previously announced, work has begun to improve the nature trail on the west side of the property. The existing trail, installed several years ago, was a mowed path through the pasture, along with another loop through the wooded area on the northwest corner of the property. The current improvements include making the trail a uniform width and laying down a crusher fine surface to create a low-impact walking trail. These trail improvements were developed in direct consultation with the same environmental expert who performed the 2007 environmental baseline report for Cat Anderson (who graciously donated Quincy Farm to the City) underlying the conservation easement she placed on the property, as well as with Colorado State Extension.

When finished, the ¼ mile walking trail will allow community members to enjoy the natural landscape as well as the beautiful vistas uniquely located on the west side of Quincy Farm. The defined trail will also serve as an additional limitation to public access on the west side, in accordance with the conservation easement, as visitors will be required to always remain on the trail while visiting the pastures and wooded areas. This will help to ensure protection of the wildlife and natural habitat, again in concert with the conservation easement. The use of crusher fines will also limit the spread of weeds and

minimize impact on the pastures from regular City tree and pasture maintenance.

The main part of the trail is expected to be completed by this spring, weather permitting, at which time the City will open the west side to the community from dawn to dusk, similar to the east side of Quincy Farm. The north-west loop through the wooded area will not be constructed and opened until the summer to avoid disturbing the great-horned owls that are known to nest in that area. Going forward, access to that part of the trail will always be closed during the nesting season for the same reason.

POND

In addition to the work on the nature trail, the City plans to dredge the pond on the southern end of the property. The pond was originally an irrigation pond fed from the High Line Canal, but with Denver Water no longer supplying the Canal with water the ability of the pond to sustain a healthy eco system has diminished substantially. Dredging the pond to make it a bit smaller and a little deeper will improve the pond's water quality and create an improved habitat for wildlife. The City is currently working with engineering and environmental consultants on the design and specifications for this environmental improvement which should be completed this summer, with dredging operations to begin this fall when the water level is lowest.

EAST SIDE/BIG BARN

As hopefully most readers know by now, the east side of the property was opened to the community last year. During 2023, the Cherry Hills Land Preserve (CHLP), the City's partner on Quincy Farm, put on over 15 different nature classes and programs, ranging from bee keeping to vegetable gardening, from learning about raptors to learning about the stars, and many more. For 2024, CHLP plans to offer similar classes and programs to allow our community to learn more about the local flora and fauna and help to instill an appreciation for nature and promote conservation and sustainability. In addition to the various programs that CHLP will conduct on the east side, the Big

Barn will be renovated this year to stabilize the structure and its historic elements and to create a gathering place for future programs. The City and CHLP intend for the Big Barn to become the educational hub for high-quality nature experiences and small community events. Engineering and construction drawings for this project are nearing completion, which should allow construction to begin later this summer. This approximately \$760,000 investment in Quincy Farm is being funded in part by CHLP and their donors as well as by the City.

While we are excited about our continuing efforts to preserve this amazing and historic property and make it available to the community, there continues to be a lot of misinformation about the City's intentions in this regard. From the start, the City has been dedicated to being good stewards of this extraordinary gift to the people of Cherry Hills Village and to adhering to the conservation easement on the property. Cat Anderson donated this property to the people of Cherry Hills Village under that conservation easement such that the land, wildlife, and environment could be protected, preserved, enhanced, and managed for the use, benefit, and enjoyment of our community. As with any municipal project, there will always be differences in opinion as to how something should be done, and Quincy Farm is no exception. However, I believe the City's work on Quincy Farm in conjunction with CHLP has not only been consistent with the conservation values enumerated in the conservation easement but has, in fact, enhanced those values.

If you haven't had a chance to visit Quincy Farm, the crown jewel of the City's public lands, I urge you to do so, or sign up to attend one of CHLP's upcoming programs. The east side barnyard is currently open to visitors daily, dawn to dusk, and as noted above, the west side will be open later this spring.

Favorite Pollinator Plants

The Lima Plaza Pollinator Garden just outside the Arapahoe County master gardener office features native and low-water plants that support pollinators. 50 species of plants were installed in this garden. All are important, but I have a few favorites. The perennials featured below are easy to tuck into a garden as you transition to a more native or native-adapted landscape. Plant them in groups of three or more for visual impact and to allow pollinators to work the area more efficiently.

Purple Prairie Clover (*Dalea purpurea*) makes a wonderful addition to any sunny garden. This native summer blooming perennial is not particular about soil, it grows in average to dry conditions and is a survivor because it is tap-rooted. Best of all, it blooms in the most unusual way – bottom to top. It is a delight to watch pollinators as they move around and around circling the attractive flowers to gather pollen.

Purple Prairie Clover is in the legume family, so it takes nitrogen from the air within the soil and stores it in the plant. It is often used in seed mixes for prairie restoration because of its nitrogen fixation properties. It is a favorite of over 50 species of bees including bumble bees, honey bees and “specialist bees” in the genus *Colletes*. Specialist bees require pollen from specific plants to



raise their young. This is a great example of the intrinsic connection between insect and plant where one relies on the other for survival.

Try Purple Prairie Clover in your garden. You won't be disappointed. Oh, and did I mention it is deer and rabbit resistant?

Firecracker Penstemon (*Penstemon eatonii*) is one of the early spring blooming perennials that supports migrating

hummingbirds when food is scarce. It is easy to grow, drought tolerant, can go in full sun or part shade and is native to the western US.

Overwatering can shorten its lifespan. The sturdy foliage is nice too. Many xeric plants have fine foliage; Firecracker Penstemon has



bigger leaves that provide a nice contrast in texture. Although relatively short-lived, this penstemon is worth planting. You will be rewarded with brilliant red flowers that provide abundant nectar for visiting hummingbirds. What's not to like?

Desert 4-O'Clock (*Mirabilis multiflora*) is a stunning native plant.

The sheer size is quite astonishing; it can spread up to four to six feet. This is handy when you want to fill a space. The color is equally astonishing—

vibrant magenta-

pink—and looks rather tropical.

Desert 4-O'Clock is a long-lived and undemanding perennial that needs full sun to part shade, dry conditions and can go in any type of soil.

The flowers open in late afternoon so be sure to watch for the many pollinators it will attract including the Sphinx moth, hummingbirds, butterflies and bees. Save some space in the garden for this beauty.

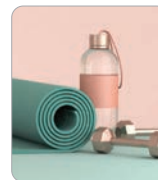
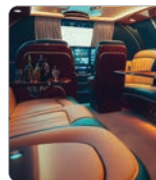
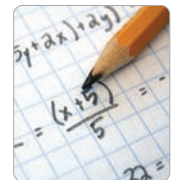

Swarm Hotline

Bees swarm in the spring. In Colorado, bees swarm from approximately April 1st until the end of the summer with May and June being the busiest months. A swarm occurs when a hive, wild or managed, becomes overcrowded and the old queen and approximately half of the original hive leaves to find a new home. Swarms are generally quite docile but they can be disconcerting due to the sheer numbers of bees within the swarm. It is still a good idea to keep your distance so as to not make the bees feel threatened.

Swarms will eventually leave on their own, once the scout bees have returned to inform the group that they have found a suitable new home. Where it may have taken an hour or more for the swarm to collect, they can be gone in less than a minute once they get word it is time to go. However, beekeepers prefer to catch the bees as a swarm in case their new home—is yours!

If you are lucky enough to witness one of nature's most fascinating migrations, a swarm,

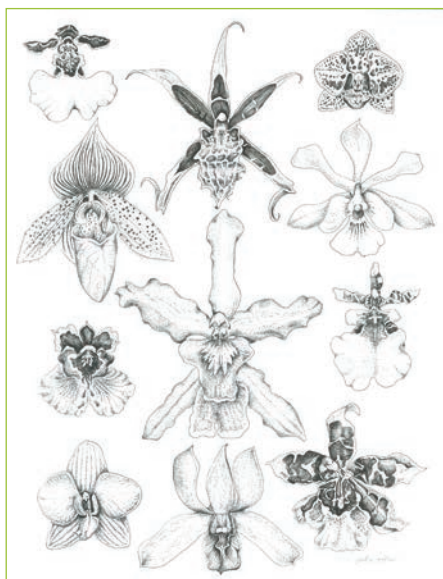
