JOHN REYNOLDS 30 YEARS OF SERVICE

Our department proudly celebrated a remarkable milestone in our law enforcement community: the 30-year anniversary of John Reynolds, our esteemed Support Services Supervisor. With unwavering commitment and tireless dedication, John has become an invaluable asset to our department and a trusted leader among colleagues.

After starting with Cherry Hills Village Police as a reserve officer in 1992, John's father (who was a career long Denver police officer) told him to find a place that shared his values, that would allow for him to grow in his chosen career and that would afford him a life of greater balance and so, two years later, when the opportunity of full-time employment came up, he seized the chance and never looked back.

Over the last 30 years, John has had many amazing accomplishments. Just to name a few as a police officer, John took



on additional responsibilities such as an Arrest Control instructor, Firearms instructor for many years and was also a canine handler, with K9 Magnum. John also had a passion for DUI enforcement and in 2005, he received an award from Mothers Against Drunk Driving (MADD) for those efforts.

He was named "Officer of the Year" for heroic actions in a rescue attempt after 3 employees working on a water main break in front of Cherry Hills Country Club, fell into the hole. During another shift, he was on patrol and spotted a smoldering fire directly under a family's natural gas box. He was able to evacuate the family and notified the Fire Department. He received a Police Commendation Award for that action.

I have been asked to write a column about my eight years on Council.

It has been an absolute privilege to serve our wonderful citizens of Cherry Hills Village. Having served on the Planning and Zoning Commission for three years I had a general understanding as to how our government works. Upon being elected by a small majority (Landslide A1), I relied on certain mentors to educate myself on the duties and responsibilities of a councilmember. I relied on my spouse who served eight years on Council and Alex Brown who succeeded her and preceded myself, and Laura Christman who was Mayor and previously headed Planning and Zoning. The City provided orientation and education about the do's and don'ts.

I feel that the most important thing to understand is that Council is nonpartisan. Thus, it allows for the free flow of ideas without the interference of political biases. I have worked with all members of Council, who come from all political persuasions, to resolve any and all issues that come before us to the benefit of our residents. I want to thank each of the members I have served with for putting the interests

of the citizens first, without any political bias.

I am proud of what Council accomplished during my terms. We undertook, along with Greenwood Village, the installation of a stop-light on Bellevue Avenue at Glenmoor Country Club. It was warranted due to a fatal accident many years ago, but CDOT was a road-block, and it took some eighteen years to get it done. We renamed the Swastika Acres subdivision, located in the southwest quadrant of our Village. It had been named that many years before the Nazis used that symbol, but it carried a stigma. I, along with other members of Council, stood fast to retain Quincy Farm's ownership by the City, despite other efforts to give up title.

Councilor Earl Hoellen and I have worked on multiple proclamations and resolutions together, including one to honor Senator John McCain upon his death as well as one in support of Israel in its defense against the war launched by Hamas and other terrorist organizations.

As to other responsibilities of the job, I spent four years as the

liaison to the Public Works Department, two years as the liaison to the Finance Department and two years as liaison to the Police Department, thus observing and participating in many aspects of Cherry Hills Village operations.

I want to welcome the new members of Council. I also want to thank each of the Council members and Mayors I have worked with over the past eight years, the entire staff of the Village including City Managers, and especially City Clerk Laura Gillespie without whom the City could not function.

It has been an honor to work with Council, especially Randy Weil and Dan Sheldon who have served all eight years with me. We always did what was best for the City. As Mark Twain once said, “Always do right. It will gratify some people and astonish the rest.”

Public Works

The mission of the Cherry Hills Village Public Works Department is to provide high quality streets, infrastructure, parks, and open space for all residents. The Department strives to be stewards of the environment and be fiscally responsible in all aspects of its operations. The Cherry Hills Village Department of Public Works is comprised of 2 main divisions (Parks and Streets) with 18 full-time employees who possess special skills and knowledge acquired through education, training, and experience to meet the public's needs. The Department also employs 6 seasonal employees in the summer. Some of the many responsibilities of the Department include:

- Maintain 50 miles of streets (100 lane miles)
- Maintain 26 miles of bridle trails, 55 acres of open space and park land
- Stormwater management
- Operate 6.8 miles of sanitary sewer lines
- Oversee all City facility maintenance and repairs
- Plan and manage recreation special events
- Administer the Recreation Reimbursement Program
- Manage the household hazardous waste program and Spring Clean-Up
- Right-of-way construction permitting
- Capital construction management
- Snow removal

Know Before You ROW



Whether by bike, by car, or on foot, one of the reasons that the City's rights-of-way (ROW) exists is to safely move people in and around the Village. Since all ROW are owned by the City, there are regulations within the Municipal Code regarding private improvements within the ROW. Depending on location, landscaping such as boulders, trees and bushes may not be allowed in the ROW. Due to the pastoral character of

Cherry Hills Village, it is often difficult to know where the ROW ends, and private property begins. It can be further complicated because the boundaries of the ROW do not always coincide with physical improvements (e.g. pavement or a formalized dirt road). Often, the City's ROW extends beyond what is paved or formalized. Before installing any of these improvements next to a street or road, property owners should contact the City. For more information on improvements adjacent to, or within City ROW,



CHERRY HILLS VILLAGE RECREATION REIMBURSEMENT RULES

Residents of Cherry Hills Village (primary residence only) who participate in a recreation program, activity, class or event offered by a municipal or special district recreation department, a non-profit youth sports organization or any municipal golf course located within the seven-county Denver metropolitan area (Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, Jefferson) may be eligible for a partial reimbursement of certain costs from the City of Cherry Hills Village. For purposes of this program, "youth sports organization" shall mean a sports organization whose primary purpose is to provide recreational activities for primary or secondary school students.

REIMBURSEMENT PROVISIONS

Each primary household in Cherry Hills Village is eligible for a maximum \$500.00 annual reimbursement when participating in an activity that qualifies for reimbursement. The amount of reimbursement shall be 50 percent of the cost incurred by the resident; however, reimbursement costs shall not exceed a maximum of \$50.00 per single activity, per resident, to include memberships and passes. The amount of reimbursement for an annual membership or pass shall be 50 percent of the cost incurred by the resident; however, reimbursement costs shall not exceed a maximum of \$500.00 annually per household. An annual membership is intended to designate a year-long membership and includes such facilities as Greenwood Athletic and Tennis Club and municipal recreation centers such as South Suburban. Seasonal sporting activities such as soccer, baseball, lacrosse, swimming, hockey, gymnastics, etc., are considered single activities.

REIMBURSEMENT PROCEDURE

1. Obtain an itemized receipt that includes the participant's name, address, name of agency, name of activity, activity fee(s) and activity date(s). Receipts must be submitted in the year the fee was paid, not the year the activity takes place.
Note: The following will not be accepted as receipts: bank statements, cancelled checks, non-itemized credit card receipts, handwritten receipts and registration forms. Initiation fees, rentals, tax charged, national dues, merchandise, childcare, travel, uniforms and golf carts do not qualify for reimbursement.
2. Complete the Recreation Reimbursement Form, attach all itemized receipts and email, mail or deliver this information to the Village Center by **4:30pm on the second Friday in January** for the previous year's reimbursements. **NO EXCEPTIONS.**
3. To conserve City staff time and resources, and to help us easily track each household's reimbursement we are asking our residents to submit all their receipts for the program year on no more than 2 reimbursement submittals in a program year.

It is the resident's responsibility to ensure that their recreation reimbursement application is complete and has been received by the City by 4:30 PM on the second Friday in January.

All the information above will be required, and residency will be verified. It is the obligation of the City staff to ensure against abuse of this program and final authority will rest with the City Manager to suspend or eliminate reimbursement requests determined to be in violation of the terms of this program.
