2012 REGULAR MUNICIPAL ELECTION

The City of Cherry Hills Village will be holding its regular municipal election as a mail ballot election on **Tuesday April 3, 2012**. There are four Cherry Hills Village City Council seats up for election: Mayor (currently held by Mike Wozniak), District 1 Councilmember (currently held by Mark Griffin), District 3 Councilmember (currently held by Alex Brown), and District 5 Councilmember (currently held by Klasina VanderWerf).

IMPORTANT ELECTION DATES

January 23, 2012 – Candidate Packets available at the Village Center

February 6, 2012 – First day candidate nomination petitions may be circulated

February 24, 2012 – Candidate nomination petitions are due

March 2, 2012 – Last day that nomination petitions may be amended; last day for a candidate to withdraw; last day an Affidavit of Intent for Write-In Candidate may be filed with the City Clerk

March 5, 2012 – Last day to register to vote; election may be cancelled if the only issues on the ballot are Mayor and Council members and there is not more than one candidate for each position

March 12 to March 16, 2012 – Ballots will be mailed to each active registered voter

March 19, 2012 – Counting of ballots may begin and continue until counting is done. Last day to apply for an absentee ballot

April 3, 2012 – **ELECTION DAY** - ballots must be received by mail or dropped off at the Village Center, 2450 E. Quincy, by 7pm

April 9, 2012 – Swearing in for elected officials

April 10, 2012 – Last day for canvas board to certify results

CITY RECEIVES EXEMPTION FOR EXCEPTIONAL SAFETY AND TRAINING RECORD

The City's Worker's Compensation and Property Casualty insurance is provided by Colorado Governmental Risk Sharing Agency (CIRSA). Each year, the City is audited by CIRSA to determine if there are safety or training concerns that need to be addressed. The CIRSA Board of Directors recently approved a procedure that now provides members the opportunity to earn an exemption from the annual loss control standards audit. In order to receive this exemption, a member must achieve an audit score of 100 or higher and have a loss ratio of 50% or lower for two years consecutive years.

The City of Cherry Hills Village achieved audit scores of 104 in 2010 and 100 in 2011, in addition to obtaining a loss control ratio well under 50%. Therefore, we are pleased to report that the City met the above criteria and has received an exemption for the loss control standards audit for 2012. The City will strive to continue its exceptional safety record and continuous training of its employees.

PARKS, TRAILS & RECREATION COMMISSION UPDATE

In January of 2012, PTRC Commissioner **Bill Callison** resigned from his position leaving one seat vacant. The Village wishes to thank Bill for his service to the community while on PTRC.

At the February 7th Council meeting, City Council appointed **Jeff Welborn** to the Parks, Trails and Recreation Commission. Welborn, who lives in District 5, will be a member-at-large on the PTRC and will enter the appointment vacated by Callison which expires in May 2013.

DOG LICENSE RENEWAL

2012 dog licenses are now available. All dogs residing within the City of Cherry Hills Village must be licensed with the City no later than March 1st on a yearly basis. **The fee for licensing is \$10.00 per dog.** The dog licenses are available at the Village Center Monday – Friday from 8:00 am- 4:30 pm. INTRODUCING CHERRY HILLS VILLAGE TREE PLANTING PROGRAM

The City of Cherry Hills Village Parks Department would like to introduce the first Tree Planting Program for Cherry Hills Village residents. This newly incorporated program is intended to encourage new tree plantings throughout the City and also encourage a diversity of trees which will aid in water conservation. All funds received through this program will be placed in the City's Open Space Fund. This program is open to all property owners in the City.

The City will offer trees at a reduced cost with 7 varieties to choose from. The trees will cost \$40.00 each for Bare Root, and \$50.00 each for Ball and Burlap; the trees will be approximately 5 to 6 feet tall. The following trees have been ordered for the 2012 program and will be available in April:

- (5) BR Skyline Honey Locust
- (5) BR Spring Snow Crabapple
- (5) London Plantree Bloodgood
- (2) BB Bur Oaks
- (2) BB English Oaks
- (5) Red Buds
- (1) BB Horsechesnut

A total of 25 trees will be available to residents in 2012. Trees will be limited to 2 per household and will be reserved on a first come, first serve basis. The Parks Department is hoping to continue with this program every spring and order additional trees depending on the interest of homeowners.

CANDIDATE INFORMATION

Candidate information packets are available at the Village Center and can be picked up between 8:00 am and 4:30 pm Monday through Friday. Information for candidates can also be found on the City's webpage at www.cherryhillsvillage.com. When picking up a candidate packet, residents will be asked to provide their name, address, and the office which they are interested in. This information is necessary for the City to update election information during the campaign.


To be nominated for the election ballot, candidates must obtain signatures of registered electors through a petition process. The petition form, which is included in the candidate packet, can be circulated beginning **Monday, February 6, 2012** and must be turned in to the City Clerk's office no later than **4:30 pm on February 24, 2012**. Candidates for Mayor will need to obtain **25 signatures** of registered electors; which can be obtained citywide. Candidates for Councilmember will need to obtain **10 signatures** of registered electors from their respective districts.

Also, The Village Crier is requesting that all **candidates fill out a brief candidate profile and submit a digital picture to be included in the March/April Crier. The form is included in the candidate information packet and is due by **February 29, 2012**.**

VOTER INFORMATION

Applications for absentee ballots, for registered electors of the City of Cherry Hills Village who are unable to receive their ballot at their resident address for the Municipal Election, April 3, 2012, may be made to the City Clerk, 2450 E. Quincy Ave., Cherry Hills Village, CO 80113 during regular business hours (Monday – Friday 8:00 am – 4:30 pm) on or before Friday, March 23, 2012.

You **MUST** be a registered voter in order to vote in this election! To check your registration status, visit the Arapahoe County Voter and Election Information website at www.arapahoevotes.com. To register to vote pick up a registration form at the Village Center or download the form at www.arapahoevotes.com. All registration information must be submitted to the Arapahoe County Clerk's office no later than **Monday, March 5, 2012** in order to vote in the April 3, 2012 Municipal Election.



POSSIBLE CITY CHARTER AMENDMENTS FOR THE APRIL 3, 2012 REGULAR MUNICIPAL ELECTION

The City Council is currently considering three possible Charter amendments which, if approved by City Council, will appear on the ballot for the April 3, 2012 municipal election. Changes to the City Charter can be made only by a majority vote of Village residents.

The first possible Charter amendment would add language to the Charter to protect City parks by placing them into a public trust. The effect of the change would be to preclude the sale or transfer of parks in the Village without a majority vote of our residents.

The second possible Charter amendment would amend the City's emergency ordinance procedure to allow City Council to enact emergency ordinances more efficiently in those rare circumstances when the City needs to act quickly to protect the health, safety and welfare of Village residents.

The third possible Charter amendment would move the date of the City's regular municipal elections from April to November, allowing elections to be coordinated with Arapahoe County. The potential benefits of this change include higher voter participation and lower cost to the City. The negative effects could include that the City's ballot issues would be combined with County and State issues. If the election date is changed, newly elected Council members would be seated in January to allow the City's budget to be considered and passed by the previous Council.

COUNTY VOTER INFORMATION

Recently, Arapahoe County registered voters received voter information cards advising them of changes to their congressional, legislative and commissioner districts and precincts.

Nancy Doty, Arapahoe County Clerk and Recorder, says voters do not need to take action to return the card or contact her office **unless** they need to update their voting preferences, party affiliation, or contact information.

Voter information cards are provided for the voter's knowledge and do not need to be brought to the polls on election day. Voters may return the card to make a new request for a mail-in ballot for every election, but citizens who have already done so do not need to take action and will remain on the mailing list.

Doty points out that the majority of Arapahoe County registered voters will see a change to one or more of their districts or their election precinct. These changes are a result of the reapportionment of Colorado's senatorial and representative districts required by law every 10 years following the U.S. Census. County election precincts and commissioner districts were also redrawn as a result of these changes.

The primary election scheduled for June 26 is anticipated to be conducted by mail-in ballot only. All active voters will automatically receive the ballots through the mail. The general election in November will offer three options for voting: mail-in ballots, early voting or voting on Election day as usual.

SNOW REMOVAL IN CHERRY HILLS VILLAGE

By the time you read this publication, we will be well into the snowiest months of the year. Each year when the City performs snow removal operations we receive a number of inquiries as to the process and the reasons we do certain things.

Cherry Hills Village is one of the few municipalities in the metro area that plows residential streets on a consistent basis. In fact, any time there is more than 3 inches of snow on the roads, it is City policy to plow all streets. The benefits of this policy far outweigh the few inconveniences that this may sometimes cause. Plowing the streets shortens the duration of ice and snow packed roads, making driving much safer. By removing snow and ice, the useful life of the streets is extended due to the reduction of the effects caused by the freeze thaw cycles. This is not eliminated by any means, but it is reduced drastically.

The City rotates the order in which it plows the streets with each snowstorm. This ensures that no one area of the City is always the last to have their streets plowed. The drawback to this is that you may need to shovel the end of your driveway and mailbox multiple times. This is unavoidable; we are not able to clear the streets properly and avoid depositing snow in each cleared drive. It is the responsibility of each resident to clear their driveways and mailboxes. The City is unable to respond to requests to clear drives and mailboxes due to the man hours that would be required to complete this task.

Another concern that comes up is the accidental damage to landscaping during the snow removal process. Our drivers make every effort to avoid this situation, but it still occurs on occasion. It is very difficult at times to determine exactly where the edge of the road is when everything is snow covered, or it is dark. We apologize if this has happened to you in the past. The City's right-of-way extends well beyond the actual paved or driven surface for a number of reasons, including; drainage, utility and maintenance work and snow storage. Residents are responsible for any private improvements that are installed within the right-of-way. Damage to private improvements in public rights-of-way during snow removal operations is the responsibility of the homeowner to repair or replace. The Public Works Department will do all it can to conduct operations in a manner not to disturb such improvements.

There are several ways that residents can help with the snow removal effort. First, be aware of the snowplows working in your area and where you are driving. Be careful not to follow too closely or to block their path. If possible, let the snowplow pass before you reach the intersection. Second, as you shovel your walks and driveways do not place any of the snow in the street. This can cause problems with snow removal operations and can be a hazard for other drivers. Third, when it is snowing or a snowstorm has been forecast,

please remove your vehicles from the street. If vehicles are left in the street, the plows must plow around them. This slows the snow removal operation, increases the chance of accidents, and ultimately increases the amount of snow that residents need to shovel in order to move their vehicles.

Additionally, you may not have private contractors remove snow from public streets or deposit snow from private property onto public streets. This is the cause of a majority of the damage to private structures and landscaping in the public right-of-way. Please help us keep our streets safe and remind your contractors of these rules.

CODE ENFORCEMENT REMINDER

EXTERIOR LIGHTING

Many of you may not be aware that our code on outdoor lighting changed less than two years ago. On 5-4-10, City Council adopted this new ordinance. The following is a brief synopsis of the ordinance:

The purpose and intent of the new ordinances on lighting was to address the needs of residents to preserve the semi-rural character of the city. Council also wanted to promote safety, reduce the amount of light pollution, reduce glare and light onto adjacent properties, conserve energy, and promote the appropriate design of outdoor lighting.

THE NEW ORDINANCES READ AS FOLLOWS:

1. All exterior lights shall include fixtures that fully shield the light source so that light is not emitted above the horizontal plane of the fixture. (Certain exceptions as to lights on flags, signs etc. are also addressed in the code).

2. Each light fixture shall not exceed a maximum output of one thousand eight hundred, (1800) lumen. This is the approximate equivalent of a one hundred-watt light bulb.

3. All exterior lights shall be designed and oriented in a way to minimize glare and light spillage onto adjacent lots, streets and rights-of-way. Additionally lights are not allowed to shine directly onto neighboring lots, or create a hazard to pedestrian or vehicular traffic.

4. Landscape and architectural accent lights shall be turned off from 11:00pm to sunrise the following day. This lighting can include up lighting as long as such lighting is shielded and the bulb is not visible by a direct line of sight.

5. Recreational lighting. Lights associated with an accessory or recreational use structure exceeding 12 feet in height, shall be turned off between 11:00pm and sunrise the next day. These lights can exceed the 1800 lumens requirement but can not be directly visible from the adjoining lots or street.

6. Motion detected security lighting. Unshielded spotlights activated by a motion sensor shall be allowed with a maximum output to two thousand eight hundred lumens, (approximate equivalent to a 150 watt bulb). These lights can only be activated by movement on the property and must go off with in 5 minutes after detection motion ceases.

EXCEPTIONS:

1. Seasonal and holiday lighting displays which are only permitted for 45 days per calendar year.

2. Lighting on homes prior to this effective day are grandfathered into ordinances and must meet separate performance standards.

3. Homes that expand by 50% after the new ordinance date are also required to bring the new site into compliance. The entire ordinance can be read under the zoning section of our code 16-16-50, at www.colocode.com/cherry.html

THERE'S A COYOTE, WHAT DO I DO?

A coyote **sighting** or **visual observation** of a coyote is a common occurrence throughout the metro area. There are times when there is an unexpected direct meeting with a coyote or an **encounter**, but these end with a coyote running or strolling away. Unfortunately there are also **pet attacks** and even **pet losses** because of coyotes. To date, there have been **NO incidents or attacks** on a person by a coyote in Cherry Hills Village.

Why are the above words in **bold**? These are the key words that Colorado Parks and Wildlife, formerly Colorado Division of Wildlife, use when taking coyote reports. Cherry Hills Village Animal Control is currently taking coyote reports for Colorado Parks and Wildlife. Colorado Parks and Wildlife is responsible for managing, conserving, and protecting wildlife. 2012 SPRNG CLEANUP SCHEDULE

SPRING CLEANUP MAY 12- MAY 20, 2012

The City will again host a Spring Cleanup for Cherry Hills Village residents this year. Dumpsters will be provided for citizens to dispose of their unwanted trash and rubbish. **Electronics and paint recycling will be available only one day this year (SATURDAY MAY 19th). Please do not bring these items except during the designated drop off time.** All other hazardous materials will need to be disposed of through the door to door program (see "Other Hazardous Household Chemicals" below).

Dumpsters for household rubbish and trash will be available from **May 12 – May 20, 2012**. The City is unable to accept large appliances, so please do not bring these items to the site. You may be asked to provide proof of residency as you drop off items, so please be prepared to show a drivers license with a Cherry Hills Village address on it if asked.

The trash dumpsters will be located east of the maintenance shop just past the main entrance to the Village Center. Residents are encouraged to take advantage of this opportunity to dispose of rubbish not included with normal curbside service. Please note: the City will be **UNABLE** to accept the following items for disposal in the dumpsters: paint, electronics, tires, appliances, oil, antifreeze, fuels and any hazardous materials. Depositing these items in the dumpsters may jeopardize the future of this program.

COMMUNITY SHRED DAY – MAY 19th

Identity theft is a problem, so have your sensitive documents shredded. This is your opportunity to empty all those old personal files in your house. The free community shred day will be from **9 a.m. to 2 p.m. on Saturday, May 19th** at the Cherry Hills Village City Center, 2450 E Quincy Avenue. Residents can protect themselves against identity theft by shredding any personal documents confidentially and securely, at no charge.

ELECTRONICS AND PAINT RECYCLING – MAY 19th

The City will once again accept electronics and paint for recycling, but on a limited basis due to escalating regulations and cost. These items will be accepted between the hours of **9:00 am and 2:00 pm on Saturday, May 19th only!** Staff will be on hand to help unload your acceptable items. Only paint, small appliances, and electronics including TV's 19 inches and smaller will be accepted. The cost is too substantial for the City to accept larger items and all hazardous chemicals and products. Please note restrictions.

OTHER HAZARDOUS HOUSEHOLD CHEMICALS

The City has contracted with Waste Management/ Curbside Recycling, Inc. to do a door-to-door recycling program for hazardous waste again this year. Residents will be required to pay a \$20.00 co-pay and may use the service only once per year. Funds are limited and the program will be suspended once all the funds have been used, so please use the service wisely. We encourage you to work with your neighbors and pool hazardous waste to maximize the available funds. NEW REGULATIONS FOR INDIVIDUAL SEWAGE DISPOSAL SYSTEMS

Effective July 1, 2011, Tri-County Health Department(TCHD) Regulation Number I-11, Individual Sewage Disposal Systems (ISDS) will require that all sellers of properties with existing buildings served by ISDS in Douglas, Arapahoe, and Adams Counties and the municipalities therein, obtain a Use Permit prior to selling their property. There are several benefits of the program:

- Assures you and your buyer that the ISDS is functioning adequately
- Allows for identification and repair of small less costly problems before they become big and expensive problems
- Assures that the inspector of your ISDS is trained and certified
- Assures a complete and thorough evaluation of your ISDS is performed
- Educates your buyer about how to properly maintain and care for their new ISDS
- Gives approval by TCHD for ISDS that were not originally permitted
- Assures that your ISDS is protective of the public health and environment

In order to obtain the Use Permit, the owner or seller will need to have their ISDS inspected by an independent and certified third-party inspector. TCHD will include a list of approved inspectors on their website at www.tchd.org. The inspector will be required to complete a TCHD inspection form. If problems are identified by the inspector during the inspection, those problems will need to be repaired and certification of the repairs provided, before TCHD will issue the Use Permit.

In the case of larger problems found during the inspection that require a repair permit from TCHD, such as replacing a septic tank or absorption area (leachfield), TCHD will allow a sale to proceed, provided there is adequate assurance that the ISDS will be repaired within a reasonable time after the sale and both buyer and seller are in agreement about the schedule for repair. The seller will need to submit a use permit application, a completed inspection form, and verification of repairs (if applicable) and fee (proposed to be \$90.00) in order to obtain a use permit. Upon receipt of those documents, TCHD anticipates that it will take no more than three working days to issue a Use Permit. TCHD recommends that listing agents inform their clients about the requirement for a Use Permit as soon as possible during the process.

CAMPAIGN SIGNS-CODE REMINDER

With the upcoming April election just around the corner, campaign signs may begin appearing around the City. Criteria for posting campaign signs are provided in the City's Municipal Code. The following are some of the criteria to be aware of if you are posting signs on your property:

- Campaign signs must be placed on private property with the consent of the property owner or occupant and may not be placed in the public right-of-way.
- Campaign signs may not be placed in a manner that obstructs visibility at an intersection.
- An individual sign face may not exceed six (6) square feet in area and the total area of all signs on a single property is limited to twelve (12) square feet.
- Campaign signs may not be illuminated.
- Campaign signs may be posted for up to 90 days, at which time the sign must be removed or replaced with a new sign.
- Campaign signs may not advertise or promote a commercial enterprise not located on the same lot.


