## CHV MUNICIPAL ELECTION RESULTS

On April 3rd 2012, there were 1,173 ballots cast for a voter participation rate of only 29.47%. The race for Mayor was won by **Doug Tisdale** with 540 votes, or 47.45%. Candidate **Russell O. Stewart** received 437 votes, or 38.40% and candidate **Joseph R. Poché** received 161 votes or 14.15%. **Mark L. Griffin** was re-elected for Council District 1 with 758 votes. **Alex Brown** was re-elected for Council District 3 with 772 votes. **Klasina VanderWerf** was re-elected Council District 5 with 761 votes. Issue #1, the Parks Charter Amendment, passed with 1,020 votes or 93.66% of voters who voted on the issue. Issue #2, the Emergency Ordinance Charter Amendment, passed with 653 votes or 63.34% of voters who voted on the issue. Issue #3, the Election Charter Amendment, passed with 983 votes, or 92.56% of voters who voted on the question.

Passage of **Ballot Issue #3** means that the City's regular municipal elections will be held in November instead of in April. Elections will still be held in even-numbered years. This will allow the City to coordinate its elections with Arapahoe County. In coordinated elections, Arapahoe County will prepare and mail the ballots, and City issues will be included along with County, State, and Federal issues. **The next regular municipal election will be November of 2014**, when the offices of Mayor, Council District 2, Council District 4, and Council District 6 will be on the ballot.

## UPDATE ON JOINT FACILITY

In March, ground was broken for the new \$6.6 million Public Safety Facility at the southeast corner of Quincy and Meade Lane. The joint facility has come about through an IGA (Intergovernmental Agreement) between South Metro Fire Rescue and Cherry Hills Village. The facility will house both the Cherry Hills Village Police Department and South Metro Fire Rescue. Both departments have outgrown their current facilities and have been existing in extremely crowded quarters. The original Police Department was built for 20 employees; now there are about 47 employees. The original fire station was built in 1980 and housed two firefighters; now there are four full time firefighters plus updated equipment and storage needs. The two departments will be able to share spaces like the work out area.

Money for the project comes from City cash reserves and South Metro capital reserves. The project is scheduled to be finished by late 2012 or early 2013. When the project is finished, the current fire station will officially be transferred to the City and will be used by Public Works. For more information about the joint facility, please visit:

## COUNCIL CONSIDERING NEIGHBORHOOD MEETING REQUIREMENTS BEFORE NEW HOMES AND MAJOR ADDITIONS ARE BUILT

At the May 15<sup>th</sup> City Council meeting, the Council approved, on first reading, a proposed ordinance that requires neighborhood meetings before building permit applications for new homes and major additions to homes can be submitted. The ordinance is intended to foster dialogue between neighboring property owners before building permits are submitted and give neighbors the opportunity to review general site plans and building height diagrams for the proposed development. The design elements and architectural style of the building would not be part of the review. Neighbors would also be able to review a construction schedule and all staging plans. Any comments made at the meeting by neighbors would be *for advisory purposes only*. The ordinance is scheduled for second reading by City Council during one of their June meetings. ## CODE ENFORCEMENT

### WEEDS, RIGHTS-OF-WAY

The Code Enforcement Department sends out notices for weeds that are over ten inches in height. If the problem is not corrected, property owners can be cited and required to appear in Municipal Court.

Other common complaints for Code Enforcement are: uncovered trash, piles of branches, left over construction materials, broken fences, trees and bushes growing in the right-of-way and/or obstructing traffic views at intersections, and dead or diseased trees.

Residents are reminded that the City does not allow dumping or storage of any landscaping materials (i.e. mulch, dirt, rocks, etc) on City streets or in rights-of-way. Residents should also make sure that roll-off-dumpsters or porta-lets are not placed on any City streets or in the rights-of-way.

### CONSTRUCTION HOURS

Cherry Hills Village construction hours are: Monday - Friday 7am - 6pm and Saturday 8am-4pm. Interior construction is allowed on Sunday within an entirely enclosed structure from 8am - 4pm.

## ARAPAHOE COUNTY VOTERS TO RECEIVE BALLOTS BY MAIL FOR JUNE 26 PRIMARY ELECTION

The Arapahoe County Clerk and Recorder's Office will conduct the June 26 Primary Election by mail. Ballots will begin arriving in mailboxes on June 5 to all active registered voters in Arapahoe County who are affiliated with either the Democratic, Republican or American Constitution Party.

"Colorado's primary elections have historically taken place in August; however, the State Legislature approved moving these elections to the month of June," said Clerk and Recorder Nancy A. Doty. "By conducting the June 2012 Primary Election by mail ballot, Arapahoe County can help to ensure that eligible voters are made aware of the earlier date, and also conserve approximately \$100,000 in taxpayer dollars compared to the costs of a polling place election."

Voters will have until 7 pm on Primary Election Day, June 26, to return their ballot by mail or deliver it to any of the County's 16 drop-off locations. No polling places will be available; however, voting machines for voters with disabil-

## HOUSEWATCH PROGRAM

The Police Department's housewatch program is a community program that allows residents to request additional police patrol of their unoccupied residential property due to vacation, relocation or other absence of the resident. To request a period of additional patrol of your unoccupied residence, please contact the Police Department with the following information:

- Name, address and telephone number
- Dates of departure and return
- Name and telephone number of an emergency contact
- Specific information regarding your residence, such as persons who have permission to go inside your residence, whether an alarm system will be activated, if lights will be on timers and if there will be any pets left at the residence.

ties will be available at the Clerk and Recorder's Motor Vehicle branch offices in Aurora, Byers, Centennial and Littleton.

The Clerk and Recorder's proposal to conduct the 2012 Primary Election by mail was approved by the Board of County Commissioners and was favored by a majority of citizens who responded during a public comment period in January. Also, 73 % of active voters in Arapahoe County have requested to be permanent mail ballot voters in every election.

Citizens may visit [www.arapahoevotes.com](http://www.arapahoevotes.com) to register to vote, choose a political affiliation, find locations and hours for ballot drop-off boxes, and track their mail ballot. The final date to register to vote for the 2012 Primary Election is May 29. Voters who are already registered and affiliated with a major political party have until May 25 to change or withdraw from their affiliation. Voters who are registered but not previously affiliated have until 7 pm, June 26 to affiliate. Ballots will not be mailed after June 22. Voters must go in-person to a Clerk and Recorder's Branch Office to request a ballot after this date.

Arapahoe County's General Election in November 2012 will give voters the option to cast a mail ballot, vote at one of eight Early Vote sites, or vote at any one of 32 Vote Centers on Election Day, Nov. 6.

# CHERRY HILLS VILLAGE ART COMMISSION TO CONSIDER ADDITIONAL WORKS

# SUMMER OZONE SEASON BEGINS JUNE 1

## RESIDENTS ASKED TO PLEDGE OZONE-REDUCING BEHAVIORS

May 31, 2012 - June 1 marks the official start of ozone season in the Denver Metro/Northern Front Range area. The season will last through the summer months until Aug. 31.

The Regional Air Quality Council (RAQC) is kicking off the eighth year of its Ozone Aware campaign by asking residents to join its Clean Air Community and pledge certain ozone-reducing behaviors throughout the summer. The RAQC asks citizens to help reduce ozone by taking actions such as driving less, taking transit, and mowing their lawns after 5 p.m. on hot summer days.

Ground level ozone pollution forms when emissions from gas-powered vehicles and lawn equipment, industrial and chemical processes, and even household activities react with heat and sunlight. The highest ozone levels usually occur in summer months when temperatures approach the high 80s and 90s and when the wind is stagnant or light. During the 2011 ozone season, the RAQC issued high ozone alerts for 36 out of 92 days.

Ozone can trigger attacks and symptoms in people with pre-existing health conditions such as asthma or other respiratory diseases. High levels of ozone pollution may also affect healthy people who work or exercise outdoors, and it can cause breathing difficulties, eye irritation and reduced resistance to lung infections and colds with exposure for prolonged periods.

The Denver Metro/North Front Range region fell out of compliance with the federal standard for ozone pollution in 2007 and 2008, and the Environmental Protection Agency (EPA) has recently given the Denver Metro Area/North Front Range region until 2015 to meet the 2008 federal standard. Local residents, businesses and industry can help by making voluntary changes in their behavior to reduce ozone and bring the area back into compliance.

Residents can sign up to receive action alerts and pledge to the Clean Air Community at [www.ozoneaware.org](http://www.ozoneaware.org). Those who pledge to take certain voluntary actions to reduce ozone will be entered to win prizes such as bicycles, electric lawn mowers and Rockies tickets throughout the summer months.

### SOME OF THE ACTIONS DENVER METRO RESIDENTS CAN TAKE TO REDUCE GROUND-LEVEL OZONE ARE:

- Drive less - walk or ride your bike when you can, group errands, take public transit and carpool
- Mow in the evening after 5 p.m.
- Refuel in the evening after 5 p.m.
- “Stop at the click” - do not overfill gas tanks when refueling.
- Keep vehicles regularly maintained.
- Tighten gas caps after refueling.
- Use new, earth-friendly lawn equipment.
- Avoid solvent-based products; use water-based paint, stain and sealants.
- Make a smart vehicle choice - choose hybrid, electric or more fuel-efficient vehicles when purchasing or renting a car.
- Avoid idling and drive-thru lines - turn off your engine and go inside.
- Sign up for Ozone Action Alerts.
- Take the Clean Air Community Pledge.

Welcome to our first gardening column specifically designed for Villagers by Colorado Master Gardener Volunteers who live here. This first article will vary from the norm and will give readers an overview of who we are and what services we offer. Happy Gardening!

## THE COLORADO MASTER GARDENER PROGRAM<sup>SM</sup>

Sponsored by CSU Extension, Colorado Master Gardener (CMG) Volunteers are committed to providing scientific, research-based information and education in all gardening and insect topics. We are volunteers who undergo extensive training and annual recertification. We provide thousands of hours of services such as:

- Guidance on caring for trees, plants & turf
- Identification and management of plants, weeds, insects & disease
- Help picking the right plant for the right place
- Information on planting, pruning, fertilizing, watering/irrigation & applying chemicals
- Ideas for container gardens
- Guidance with soil amendments & testing

And so much more! Working out of the CSU Extension Office in Littleton, a CMG is available March through September (see hours below) for walk-ins, calls, or sample drop offs. In the off-season, the office remains open with a CMG regularly checking voicemail. Samples can still be submitted. The majority of our services are free and only a call, click or short car ride away.

- **Watering in a Drought (June)**

On April 25<sup>th</sup>, Denver Water (DW) issued Stage 1 drought restrictions calling for voluntarily reduction of outside water use to 2 days/week, with no lawn watering between 10 AM – 6 PM. Villagers, who lived here in the 2002 drought, experienced mandatory restrictions limiting our watering times.

Even after reducing water budgets, some large properties could not fit all their irrigation zones into the allotted DW watering times. If a home-owner had a well-founded case for needing extra watering time, DW considered individual homeowner applications for variances. This year, think conservatively by scaling back or postponing water intensive projects such as installing sod or tree planting. Instead, add mulch or transform a water-loving garden into xeriscape.

- **Pruning Lilac & Forsythia (June only)**

Shortly after blooming is the time to deadhead, prune, thin or shape these bushes. Waiting until later in the season will impact next year's blooms. See: [www.colostate.edu/ptlk/1713.html](http://www.colostate.edu/ptlk/1713.html)

- **Fertilizing your Lawn (June)**

Lawns should be fertilized by early-to-mid June. Unless you have a rare grass, fertilizer is not required again until mid-August. Drought conditions may impact fall fertilization, so stay tuned for more information in the next Crier edition. - **Deadheading (Tulips, Daffodils, etc.)**

For spring bulbs, clip off spent flowers leaving the leaves until they are wilted yellow. For annuals and perennials, pinch off or prune spent blooms to encourage new blooming. See: [www.ext.colostate.edu/ptlk/1072.html](http://www.ext.colostate.edu/ptlk/1072.html)

- **Getting Rid of Pesky Weeds**

To eliminate weeds, positive identification of the weed(s) must be the first step in the process. If you need help, bring a weed sample to the CMG office calling first for sample guidelines.
