## **COUNCILMEMBER RESIGNS**



At the September 4<sup>th</sup> Council meeting, Cherry Hills Village Councilmember from District 6, **Harriet LaMair**, announced that she would be resigning effective in November when a new Council person could be appointed. She explained that her decision was for personal and professional reasons and that she was not able to dedicate the proper energy to a number of issues

that she was responsible for indicated that as she stepped down from this position she would not step away from what has inspired her to get involved in the first place: preserving and celebrating the very special place that is Cherry Hills Village.

LaMair noted that she will continue to be active through her roles with the Cherry Hills Land Preserve, the High Line Canal Working Group and the Cat Anderson property. LaMair also pointed out that through the Master Plan and the Residential Standards Development Committee, the Village has laid a foundation for continued sensitivity to the balance between the rights of homeowners to build and the rights of their neighbors to the enjoyment of their property.

Mayor Tisdale indicated that the City would regretfully accept Councilor LaMair's resignation and that Council would find an appropriate time in the future to express its appreciation for the incredible gift that she has been to the city as a gracious, sensitive, civil, intelligent and articulate spokesperson for the people of her district, the Village, Arapahoe County and of Colorado.

The City Council will be accepting applications to fill the vacancy, but those applying will need to be from District 6. Councilmember LaMair has been on the Council for six years; there are 2 more years left in her four year term which runs until January 2015.

### High Line Canal Trail to be Celebrated in Student Videos.

I am extremely pleased to share with all Villagers my recent announcement of a Mayor's Competition for the creation of student-produced videos celebrating the beauty, history, legacy and value of the High Line Canal Trail that traverses Cherry Hills. The High Line Canal, designated as a National Landmark Trail, was completed in 1883 to deliver irrigation water throughout the region. In 1970 the Trail was opened up by Denver Water for recreational use. Its total course is 66 miles, with almost four of its most scenic miles meandering through the heart of Cherry Hills Village. Over 93% of our residents live within one mile of the High Line Canal. No other city along the Canal enjoys that kind of access!

The competition is open to students enrolled at Cherry Hills Village Elementary School, Kent Denver School and St. Mary's Academy (all of which are located within Cherry Hills Village), as well as West Middle School (which sits on the border of Cherry Hills). Students are challenged to create an eight minute video presentation addressing a theme selected by the students. Entries will be due by January 7, 2013.

The winning videos will be broadcast on the Village's about-to-be-launched Channel 8, KCHV (which will replace our current Comcast Cable Channel 22) and will also be played continuously at the Village Center on the "Big Screen" in the Council chambers, as well as being submitted by the Village in a national competition for locally-produced videos.

There are three divisions for the competition: Elementary School students, Middle School students, and High School students. In addition to one winner from each division, there will be a **Leone d'Oro** awarded as the grand prize for the best video submitted. Prizes will be awarded at a regularly scheduled meeting of the Cherry Hills Village City Council.

An independent panel of media experts and personalities will review the videos and select the winners based upon five criteria: Artistry / Creativity / Imagination; Storytelling; Visual Appeal; Effective Use of Music and Focus on Theme Selected.

Possible themes for students to focus on include the following: the intrinsic value of the Trail as an earth sculpture; the character of the Trail; experiencing the Trail; the Trail as wildlife habitat; "Coyotes and Rabbits and Crows! Oh my!"; the vegetation along the Trail; the historic Canopy of Cottonwoods; the epiphanies enjoyed while using the Trail; the evolution of a working canal into a recreational trail; "When Perfect Geometry meets Wild Nature;" early users of the Trail; modern recreational use of the Trail; the romance of the Trail; romance on the Trail; the building of the Trail; what has the Trail meant to residents of the Village; what is the future of the Trail; "Four Miles with No Restrooms?!?," "Why do we love the Trail?" or any other stated theme.

Students may consult with a faculty moderator or teacher-advisor to come up with a theme suitable to their age group and abilities. Students are encouraged to use their imaginations. They are also encouraged to form teams and to work collaboratively with each other to create their videos. Individual submissions by "auteurs" will be accepted, but film is inherently a collaborative medium and these productions will serve as an effective team-building exercise.

Students must work under the supervision and guidance of a faculty moderator or teacher-advisor. In addition, students are encouraged to consult with any other teachers and faculty, but the final product must be certified in writing by the students and a designated faculty moderator or teacher-advisor as a "completely student-run" project.

The panel of judges is being assembled now and will include officials of Cherry Hills Village, along with media experts and personalities who have some connection with Cherry Hills Village. The judging will be "blind" as to school, meaning that the judges will not know which school presented which video. The only identification of the students that will be given to the judges will be as to which division the students are from: elementary, middle or high.

Although both virtue and fame are their own reward, I am soliciting prizes to be awarded for the competition, details of which will be announced when available.

When needing police aid, please use the most suitable telephone number from the following list:

**911 - Emergency Dispatch:** Use this number to report crimes in progress as well as fire and medical emergencies.

**303-795-4711 Non-Emergency Dispatch:** Use this number to notify the Police Department of a crime or incident of a non-emergency nature to which a Police, Code Enforcement or Animal Control Officer response is requested. This is the direct number to the Arapahoe County Sheriff's Office Communications Center. The Arapahoe County Sheriff's office provides dispatching services for our Police Department and the residents of Cherry Hills Village.

**303-761-8711 Police Department business office:** Use this number to reach the business office and administration personnel for the Cherry Hills Village Police Department. This number is also used to request house watches and obtain general information from the Police Department. **The business office is open from 8:00 am to 4:30 pm Monday through Friday.**

Residents may receive Arapahoe County emergency alerts and other important news by signing up at <http://www.arapahoe911.com/>.

This emergency notification system enables the County's Public Safety agencies to provide residents with critical information quickly in a variety of situations such as crime situations, missing persons, and evacuations of buildings and neighborhoods.

## COUNCIL DISTRICT 6 VACANCY INFORMATION

Due to the resignation of City Councilor Harriet Crittenden LaMair from the Cherry Hills Village City Council for personal reasons, the City Council will now appoint a resident of District 6 to complete the unfinished term of Councilor LaMair. The newly appointed member will serve until January 2015. The regularly scheduled election for the seat will be conducted in November 2014.

"This is an exceptional opportunity for residents of Cherry Hills to become engaged in their own governance," said Mayor Doug Tisdale. "All politics are local, and you can't get any more local than serving on your city council. It is a wonderful contribution that residents can make to their community, their region and their state. I am encouraging residents to submit their names as soon as possible and fill out the form found on our website," Mayor Tisdale added.

The Mayor will appoint a selection committee that will review applications in September and October, with the goal of an appointment being made in November. "This is not a 'lame-duck' appointment. This is an opening for a working, active council person who will have at least until January 2015 to serve the community," Mayor Tisdale said. "It is an opportunity to serve without necessity of a campaign and an election," the Mayor concluded.

City Council meets on the first and third Tuesday of each month at 6:30 pm at the Village Center.

## **NEW CITY COUNCIL BOUNDARIES SET BASED ON 2010 US CENSUS DATA**

After reviewing several different options to adjust City Council District Boundaries based on population data for the 2010 US Census, the City Council adopted new Council District Boundaries at the September 24<sup>th</sup> meeting. The Village Charter requires the City Council to re-evaluate Council District Boundaries after each federal decennial census to ensure that the Districts have approximately the same number of voters. The difference between District populations may not exceed ten percent, and the old district boundaries exceeded this maximum threshold. Although all City Council members are elected at large, it is helpful for each Village resident to know who their main representative is on the Council. # 2012 GENERAL ELECTION INFORMATION

**Are you registered?** In order to vote in the November 6, 2012 election you must have been registered to vote by **Tuesday, October 9, 2012**. Check your registration status at [www.arapahoevotes.com](http://www.arapahoevotes.com) or by calling Arapahoe County at 303-795-4200. Registration forms are available at the Village Center or at Arapahoe County offices at 5334 S Prince Street, Littleton CO 80120.

Cherry Hills Village does not have any issues on the November ballot.

The 2012 General Election will be run by Arapahoe County as a Vote Center election. Vote Centers are similar to polling places except that any voter in Arapahoe County can vote at any Vote Center regardless of where the voter lives in the County. Vote Centers use multiple electronic voting stations and a real time electronic poll book.

Please be advised that identification must be presented at all election sites in order to vote.

Early voting will be conducted from Monday, October 22, 2012 through Friday, November 2, 2012. Early voting locations will be open on Saturday, October 27, 2012. A full list of early voting locations can be found at [www.arapahoevotes.com](http://www.arapahoevotes.com).

Election Day Vote Centers will be open from 7:00 a.m. to 7:00 p.m. **Cherry Hills Village Elementary School will serve as a Vote Center on Election Day.** A full list of Vote Centers can be found at [www.arapahoevotes.com](http://www.arapahoevotes.com).

Registered electors who have requested a mail ballot for this election will receive their ballot by mail. Mail ballots will be mailed beginning Monday, October 15, 2012. Ballots must be received at a drop-off location by 7:00 p.m. on Election Day. **The Cherry Hills Village Center will serve as a mail ballot drop-off location.** A full list of drop-off locations can be found at [www.arapahoevotes.com](http://www.arapahoevotes.com).

# MUNICIPAL COURT FINES INCREASE

Mayor Tisdale appointed a Municipal Court fine task force in June to review the fine schedule. The task force recommended increasing fines for violations for no proof of insurance and for violations involving an accident.

The minimum fine amount for no proof of insurance violations has been raised to \$400.00. The Municipal Judge is authorized to suspend half of this amount if valid insurance is obtained within a reasonable amount of time and presented to the Court at the of arraignment. The fine for a violation involving a non-injury accident was increased to \$250.00 and the fine for an injury accident has been increased to \$500.00.

These fines were increased to help cover costs incurred by the Cherry Hills Village Police Department for responding to and investigating accidents. City Council approved the new fine schedule at their meeting on September 18<sup>th</sup>.

## THE 2013 PROPOSED BUDGET

The City Manager submitted the proposed 2013 budget to City Council on September 18, 2012. A study session was held to review the proposed 2013 budget on October 3, 2012. A public hearing will take place concerning the proposed 2013 budget and first readings of the Appropriations Ordinance and Mill Levy Ordinance at the City Council meeting on November 20, 2012. Finally, the Appropriations Ordinance and Mill Levy Ordinance will be adopted on second reading before the certification of tax levies deadline on December 15, 2012 as required by Arapahoe County Assessor's Office.

# POLITICAL SIGNS - CODE REMINDER

With the upcoming November elections just around the corner, campaign and political signs have been seen across the Village. Criteria for posting campaign and political signs are provided in the City's Municipal Code. The following are some of the criteria to be aware of if you are posting signs on your property:

- Campaign and political signs **must be placed on private property** with the consent of the property owner or occupant and **may not be placed in the public right-of-way**.
- Campaign and political signs may not be placed in a manner that obstructs visibility at an intersection.
- An individual sign face may not exceed six (6) square feet in area and the total area of all signs on a single property is **limited to twelve (12) square feet**.
- Campaign and political signs may not be illuminated.
- Campaign and political signs may be posted for up to 90 days, at which time the sign must be removed or replaced with a new sign.
- Campaign and political signs may not advertise or promote a commercial enterprise not located on the same lot.

Parks, Trails & Recreation Commission has been, and is busy on a number of different fronts.

Many of our parks and open space areas are connected by trails and paths. The Parks, Trails and Recreation Commission has developed a park inventory identifying current and future uses and needs for each City-owned park and open space areas. CHV citizens are encouraged to share their thoughts and ideas for preserving and enhancing our parks and open areas.

Denver Water owns the High Line Canal; however, the City, working with Denver Water, maintains the 3.7 mile stretch of the Highline Canal that meanders through CHV. Over the years, the High Line Canal has transformed from an irrigation canal and service road to a spectacular recreational amenity. 93% of Cherry Hills residents live within one mile of the High Line Canal. The CHV Parks, Trails & Recreation Commission is intimately involved in the stewardship and future of the High Line Canal. Two years ago, 11 neighboring municipalities collaborated on The High Line Canal Preservation Study which looked at the history, current use and future needs related to numerous criteria (safety, preservation, recreation, wildlife, vegetation, signage and use). 

## FROM PUBLIC WORKS

### DENVER WATER INSTALLING WATER MAINS IN AREA

Denver Water will be improving water service by installing water mains and service lines on South Dahlia Street from East Quincy Avenue to East Oxford Avenue from September 10, 2012 through November 15, 2012. Crews will do their best to complete the project as quickly as possible.

Unfortunately, this work will cause some inconveniences during the construction, including water service interruptions, on-site storage of heavy equipment and materials, and limited access to streets and driveways. Steel plates will be used to cover access holes, and pipe will be temporarily placed in the roadway. Denver Water will notify residents in advance of any interruption in water service. Denver Water needs the cooperation of residents to help provide safe access in and out of driveways and streets. Parking restrictions will be in effect from 7:00 am to 3:30 pm, Monday through Friday, unless otherwise noted.

Water service emergencies in other parts of Denver Water's system will take precedence over this project. Those affected should be aware that workers may leave at a moment's notice to work on those emergencies and may not return the following day.

# SNOW REMOVAL IN CHERRY HILLS VILLAGE

WITH COLDER WEATHER COMES THE SNOW!

Cherry Hills Village is one of the few municipalities in the metro area that plows residential streets on a consistent basis. **In fact, any time there are more than 3 inches of snow on the roads, it is City policy to plow all streets.** The benefits of this policy far outweigh the few inconveniences that this may sometimes cause. Plowing the streets shortens the duration of ice and snow packed roads, making driving much safer. By removing snow and ice, the useful life of the streets is extended due to the reduction of the effects caused by the freeze thaw cycles.

**The City rotates the order in which it plows the streets with each snowstorm.** This ensures that no one area of the City is always the last to have their streets plowed. The drawback to this is that you may need to shovel the end of your driveway and mailbox multiple times. This is unavoidable, we are not able to clear the streets properly and avoid depositing snow in each cleared drive. It is the responsibility of each resident to clear their driveways and mailboxes. The City is unable to respond to requests to clear drives and mailboxes due to the man hours that would be required to complete this task.

Another concern that comes up is the accidental damage to landscaping during the snow removal process. Our drivers make every effort to avoid this situation, but it still occurs on occasion. It is very difficult at times to determine exactly where the edge of the road is when everything is snow covered, or it is dark. We apologize if this has happened to you in the past. The City's right-of-way extends well beyond the actual paved or driven surface for a number of reasons, including, drainage, utility and maintenance work and snow storage. Residents are responsible for any private improvements that are installed within the right-of-way. **Damage to private improvements in public rights-of-way during snow removal operations is the responsibility of the homeowner to repair or replace.** The Public Works Department will do all it can to conduct operations in a manner not to disturb such improvements.

**There are several ways that residents can help with the snow removal effort.** **FIRST**, be aware of the snowplows working in your area and where you are driving. Be careful not to follow too closely or to block their path. If possible, let the snowplow pass before you reach the intersection. **SECOND**, as you shovel your walks and driveways, do not place any of the snow in the street. This can cause problems with snow removal operations and can be a hazard for other drivers. **THIRD**, when it is snowing or a snowstorm has been forecast, please remove your vehicles from the street. If vehicles are left in the street the plows must plow around them. This slows the snow removal operation, increases the chance of accidents and will increase the amount of snow that you need to shovel in order to move your vehicle.

**Also, private contractors may not remove snow from public streets or deposit snow from private property onto public streets;** this is the major cause of damage to private structures and landscaping in the public right-of-way. Please help us keep our streets safe and remind your contractors of these rules.

# WINTER DRIVING TIPS

For many drivers, navigating on snow and ice is cause for alarm. Few are educated and practiced in how to drive in heavy rain, snow or on slippery surfaces. When bad weather approaches, remember these driving tips to steer clear of trouble:

## **ADJUST YOUR SPEED TO CURRENT CONDITIONS:**

Slow down when driving in challenging conditions. Decreasing your speed will allow more time to respond when a difficult situation arises. Factors such as the type of vehicle you are driving, the quality of snow tires your car is equipped with and your abilities as a driver should all be considered in the speed adjustment.

## **ANTICIPATE DIFFICULT SITUATIONS:**

Studies have shown that 80% of all accidents could be prevented with only one more second to react. In many situations, this second can be gained by looking far enough down the road to identify problems before you become a part of them.

If you find yourself in a slippery situation and your car starts to skid, follow these tips from AAA Colorado:

## **IF YOU ARE IN A REAR-WHEEL SKID:**

Look and steer in the direction you want the front of the vehicle to go. Take your foot off the brake and ease off the gas pedal. Continue steering to avoid a rear-wheel skid in the opposite direction. As the vehicle straightens, shift to the gear appropriate to your driving speed and accelerate gently.

## **IF YOU ARE IN A FRONT-WHEEL SKID:**

Look in the direction you want to go. Take your foot off the brake and ease off the gas pedal. If the front wheels turned before the loss of traction, don't move the steering wheel. When traction returns, you'll be able to steer the vehicle again. Steer gently in the direction you want to travel and gently accelerate to a safe speed.



# THE VILLAGE GARDENER

## THE PESTICIDE DILEMMA

To use pesticides or not? To use manufactured, organic or biologics or not? Over the next year, insect populations are likely to rise attacking stressed plants from the drought. Whichever pesticide you may or may not choose a few considerations are worth taking into account.

**Consideration #1: Plants are tougher than they often look.** Many outdoor plants can withstand a considerable amount of defoliation before they become stressed or unable to produce. For example, a green bean plant can withstand 50% defoliation from pests before it stops production and is overly stressed; a raspberry plant can handle 30% defoliation. The message is do not panic when you first observe insect damage.

**Consideration #2: Your best defense may be a garden hose.** Imagine being the size of a pinhead or pencil eraser being sprayed by a strong jet of water. The result, at the very least, will be displacement to the ground if not death. Garden hoses are the most effective, inexpensive, least invasive pesticide available at our fingertips. This method requires some persistence as new insects may return after being washed off. Spray all parts of the plant daily for several days to get ahead of the curve. If this yields success, a maintenance level spray of 1 or 2 times per week may prove useful.

**Consideration #3: Choose your pesticide carefully.** Pesticides mostly fall into 3 categories: contact sprays, systemic products, and biologics predators. Each insect is susceptible to certain pesticides: there is no one size fits all. Your first step should be to identify the insect, which can be done at the CMG office. Contact sprays, which kill only what they touch, may require multiple applications. Systemics, absorbed into the plant, kill good (e.g., bees) and bad insects as the insect eats the plant or nectar. Biologic predators, such as aphid eating ladybugs, are best used in a greenhouse-like structure, where they cannot fly to tastier pastures. Picking the right tool for your infestation is key.

**Consideration #4: Be mindful of when/how pesticides are applied to avoid harm.** Most pesticide directions indicate that application should occur in the early morning hours in non-breezy conditions. Pesticides easily float in air currents and can contaminate other sensitive plants, ground water, aquatic creatures and your neighbors' yards. Read the directions before application to avoid harm.

### ACTIONS YOU CAN TAKE TO HELP YOUR GARDENS IN THE DROUGHT

Drought conditions have caused havoc in our yards this year. Aspens, cottonwoods and maples are dropping leaves early (<http://www.ext.colostate.edu/pubs/garden/02911.html>) because the trees do not have sufficient uptake water. Some tree leaves are turning yellow, while the leaf veins remain green from an iron deficiency which is treatable. This yellowing condition is not from the normal fall changing of color. For treatment, add chelated iron (<http://www.ext.colostate.edu/pubs/garden/02911.html>). Help with other drought conditions can be found at <http://www.ext.colostate.edu/drought/>.

#### FALL Action Items:

**Fertilize turf by applying approximately 1 lb. of nitrogen for every 1,000 square feet of lawn.**

**When planting spring bulbs, try layering the bulbs with the deepest bulbs first working your way to the shallowest, skewing them slightly to provide a more varied, longer show of spring flowers.**

**Last, remove fallen leaves from turf and gardens using them for compost or as winter coverage for vegetable gardens.**
