## THE 2014 BUDGET

On September 3, 2013, Staff presented the City Council with a proposed budget for 2014. A study session to discuss the budget was held on September 17<sup>th</sup>. The budget public hearing and first reading of budget ordinances was held on November 19<sup>th</sup>. Finally, reading of the proposed budget occurred on December 10, 2013.

The 2014 budget takes into consideration the following priorities presented to staff by City Manager John Patterson:

- Continue to pro-actively address safety, health and welfare issues within the Village.
- Improve service delivery & responsiveness.
- Master Plan implementation.
- Remain fiscally responsible and conservative in how we handle public monies.
- Completion of the Public Works Study.
- Successfully work with the Cherry Hills Country Club and the Western Golf Association managing the 2014 BMW Golf Tournament.
- Successfully manage the 2014 Municipal Election Process.
- Improve public outreach efforts.
- Professional development (accreditation, GFOA, intergovernmental cooperation, conferences).
- Evaluate staffing levels & job functions.
- Maintain and evaluate IT systems.
- Employee training and development.
- Annual Employee Compensation Study.
- Monitor and evaluate the Coyote Management Program.

## PUBLIC ART

His commitment to the Village is exemplified by his volunteer service on our City Council and by the fact that he has donated proceeds from the sale to Cherry Hills Village. Tremendous thanks to our Public Art Commission, and especially Commissioner **Teresa Harbaugh**, for mounting this exhibition! Your Public Art Commission, under the leadership of **Chair Ann Columbus**, has done an exceptional job of implementing the Mayor's directive that public art does not only mean outdoor art. It means art in public places, and that includes inside public buildings. Our goal is to have public art displayed in every appropriate venue available throughout the Village, to celebrate and to enoble the human spirit through artistic expression. The purpose of art is to amuse, to arouse, to assuage, to engage. If it incites energized dialogue, it has served its purpose. And we invite all artists in the Village to contact our Public Art Commission in order to explore opportunities to share your art with your fellow Villagers.

## PUBLIC WORKS

As we have mentioned here before, The Village is in the process of exploring the improvement of Public Works operations in the Village. The Public Works Facility is over 40 years old. (Of interest, it is actually more than ten years newer than the Village Center—our Administration Building.) We have engaged in an extensive process with all residents and other stakeholders to examine what the right solution would be. This has included numerous public meetings, surveys, interviews and more. Recently the staff and the design consultant reported that there was some sentiment to keep Public Works located essentially where it is now. Your Mayor and your Councilors weighed in on the issue and have carefully examined all sides of it. As a result, the team has been instructed to explore other available opportunities, with a directive that an alternate site must be proposed—one that will be adequate to our needs, effective to our mission and efficient to our task. This process will be cautious and considered as we examine workable solutions outside of the Village Center Complex. Your patience in this important process is greatly appreciated!

## PUBLIC SPACES

Related to the topic of Public Works is the question of public spaces in the Village. Most notably, public open space. The exceptional gift of The Alan Hutto Memorial Commons to the Village, when coupled with the eventual relocation of the Public Works Facility, affords us the chance to create a masterpiece of open space in the very heart of our Village, to be accompanied at some time in the future by an appropriately-sized, tasteful new Administration Building that will complement the architecture around it. The Village Center Complex is not the end of our discussion, however. Your Mayor and your Council continue to investigate other options for the creation and enhancement of public open space in the Village. We look forward to many exciting new developments in that regard in 2014. Stay tuned!

## PUBLIC SERVICE

Speaking of your public servants, have I mentioned lately that we love you? We must, for all of us – your Mayor, your Councilors, your Commissioners – serve as volunteers. Some of us spend literally 40 hours a week in our public service to the Village. By way of example, in the past month your Mayor was part of the Denver Region team at the global Aerotropolis Americas Conference in Dallas, where representatives of most of the major airports in the world gathered to discuss the impact of air travel on the economy of regions with large international airports,. That was followed by a week in Seattle at the National League of Cities annual Congress of Cities, where your Mayor mixed and mingled with thousands of other mayors and councilors from all across the United States and learned first-hand about best practices that may be employed in our Village and throughout our region. # HOLIDAY HOME & SHOPPING SAFETY TIPS FROM THE CHV POLICE DEPT

**Be aware!** Crime can happen at any time, day or night. It is important for homeowners to take steps to deter crime. It is also important for neighbors to watch out for each other. Vigilance is imperative. Below are tips each household can easily implement.

## HOLIDAY CRIME PREVENTION TIPS:

- **ALWAYS** set the burglar alarm – even when leaving home for only a short period of time. An alarm may chase off a burglar before he gets inside your home.
- Lock all doors and windows. Burglars like to work quickly. Use locks on all doors and windows.
- Be aware! Report all suspicious vehicles and persons immediately.
- Holiday mail: empty your mailbox every day to prevent mail theft. Take outgoing mail to the post office for maximum safety.
- Do not display your Christmas gifts where they may be seen through your living room windows.

## HOLIDAY SHOPPING SAFETY:

- Park and lock your car under a light. Use well traveled and well populated areas. Park near the store entrance, if possible.
- If you observe people loitering around your car, return to the store and request help from the store staff.
- Lock your car as soon as you are inside.
- Keep your packages out of sight – place them in the trunk.
- Carry only the credit cards and cash needed for your planned purchases.
- Walk with confidence and stay aware of your surroundings.
- Keep your purse close to your body to deter theft.
- Keep your children close and teach them to go to store employees for help if you become separated.

## GOING ON A HOLIDAY TRIP?

- Have your mail held by the post office while you are away.
- Stop newspaper delivery while you are gone.
- Leave lights on automatic timers.
- Contact the police department and request a “House Watch” while you are away.
- Ask a neighbor or friend to stop by your house periodically; have them open and close blinds, turn on different lights.
- Let your neighbors know when you are leaving and when you plan to return home and if you are expecting anybody at your house while you are away.
- Burglars desire easy access to your home. Eliminate hiding places by ensuring all trees and shrubs are trimmed around doors and windows.
- Exterior lights with motion sensors help protect your property.
- Don’t place the fact you are gone on your voice mail.
- Don’t hide your keys on your property.
- Store jewelry and other valuables in a safe hiding place, such as a safety deposit box.

## PROTECT YOURSELF FROM FLOODING

Since standard homeowners insurance doesn't cover flooding, it's important to have protection from the floods resulting from heavy rains that can occur around the Denver-Metro area. In 1968, Congress created the National Flood Insurance Program (NFIP) to help provide a means for property owners to financially protect themselves. The NFIP offers flood insurance to homeowners, renters, and business owners within participating communities. Cherry Hills Village has participated in the NFIP since 1978 and also qualifies under the NFIP Community Rating System for discounted flood insurance premiums. - Determine Community Strategies for:
  - Open Space Acquisitions.
  - High Line Canal.
  - Undergrounding Utilities.
- Maintain close Staff liaison with the various Village Boards and Commissions.
- Closely coordinate/monitor activities of those outside entities that have a direct impact on Village operations and quality of life issues within the City, i.e., CDOT, Denver Water, Xcel Energy, Century Link, etc.

The City's budget contains **The General Fund** and six small funds. The General Fund is broken out into **Revenues, Administration, Judicial, Data Processing, Community Development, Public Safety, the Village Crier, Public Works and Capital**.

Approximately 34% of the General Fund Revenues come from Property Taxes, approximately 31% come from use tax/sales tax, approximately 9% come from building permits and the remainder of revenue is from municipal court fines and other taxes received from the State and County. The proposed 2014 budget has an increase in revenues of \$398,490 from 2013. The increase is mainly due to a slight increase in building permits and use tax.

**The Administration Division** is comprised of the City Manager, Director of Finance and Administration, HR Analyst and City Clerk. Some expenses of this division include: salaries, election costs, personnel management, City insurance programs, records management and utilities. The total 2014 budgeted administrative expenditures are \$1.8 million.

**The Judicial Division** is comprised of the Court Clerk, Bailiff and Municipal Judge. The expenses of this department are all for the purpose of running the Municipal court. The total 2014 budgeted judicial expenditures are \$89,063.

**The Data Processing Division** accounts for all computer related expenses of the City. The total expenses budgeted for 2014 are \$134,060. This cost includes the replacement of five computers that have become outdated.

**The Community Development Division** is comprised of a Community Development Director and a Building Clerk. This department provides day-to-day administration and coordination of all building activities along with consultants and civil engineers. The total 2014 budgeted expenditures for Community Development are \$442,527.

**The Public Safety Division** delivers a full range of professional law enforcement services. The Police department staff includes the Police Chief, Police Commander, four Sergeants, sixteen Police Officers, one Animal Control Officer, one Code Enforcement Officer, one Police Technician and one Police Clerk. The total expenditures for 2014 are \$2.8 million and are expenses to run the Police department such as salaries, uniforms, crime prevention, animal control, vehicle and equipment maintenance, training and investigations.

**The Village Crier Division** is used to track expenses for the publication of The Village Crier. The expenses of

this department are funded by contributions from residents and advertisements.

**The Public Works Division** is responsible for the maintenance of City buildings, grounds and streets. The department staffs six and a half full time employees and two seasonal workers. The budget expenditures for 2014 total \$994,808.

**The Capital Fund** is used to track equipment or vehicles that cost in excess of \$5,000 and have a useful life greater than one year. Total expenditures budgeted for 2014 are \$980,900 and include a couple of new police vehicles and equipment; in addition to some new public works equipment and yearly street improvements.

The six small funds are the **Conservation Trust Fund, The Catherine H. Anderson Land Donation Fund, The Arapahoe County Open Space Fund, The Special Improvement District #7 Fund, The Water and Sewer Fund and the Parks and Recreation Fund**.

The Colorado State Legislature requires the establishment of **The Conservation Trust Fund** if a local government desires to receive state allocations for the acquisition, development and maintenance of parks and open space properties. The Colorado Lottery is the primary source of this fund. The balance in reserves is approximately \$634,000.

**The Catherine H. Anderson Land Donation Fund** was established by the subdivision regulations of the City and derives its revenues from subdividers within the City, in addition to recreation reimbursement donations or charitable contributions. These revenues are earmarked for parks, open space, trails or other public improvements. The balance in reserves is approximately \$398,000.

**The Arapahoe County Open Space Fund** was created to account for sales tax revenues generated from the Arapahoe County Open Space ballot measure. The City receives a shareback of the tax revenues collected. These funds may be used to acquire real estate, easements, water rights and to improve, restore and protect open space. The balance in reserves is approximately \$471,000.

**The SID #7 Bond Fund** was established for collecting assessments and paying debt services on the bonds that finance the construction of the new water improvement system for the Cherry Hills Village residents of the subdivisions Charlou Park and Charlou Park second addition. The first year of collections was in 2001 and the final payments are to be made in 2020.

**The Water and Sewer Fund** was created to account for all the revenues and expenses associated with the consolidation and operation of water and sewer utilities coming under the auspices of the City of Cherry Hills Village. The balance in reserves is approximately \$493,000.

**The Parks and Recreation Fund** was established in 2004 for the purpose of accounting for costs related to the exclusion of the City from the South Suburban Park and Recreation District and to establish park and recreation functions within the City of Cherry Hills Village. The Parks Fund currently has a fund balance of approximately \$1 million.

# CHERRY HILLS VILLAGE JOINT PUBLIC SAFETY FACILITY WINS ARCHITECTURAL AWARD

The new Joint Public Safety Facility located in Cherry Hills Village, housing Station No. 38 of the South Metro Fire and Rescue Authority and the Cherry Hills Police Department, was given the prestigious Honor Award for Built Architecture at the AIA Colorado 2013 Design and Honor Awards. The award acknowledges the design by Roth Sheppard Architects of Denver. The awards were announced by the American Institute of Architecture Colorado chapter in Keystone, Colorado, in October.

One of only three projects to receive the Honor Award, the Public Safety Facility, was recognized for how it met the described challenge, how well it functions, and how well it respects the local context. Additional points were scored based upon the relative use of materials, sustainability parameters and overall clarity of design. A Seattle-based jury, headed by Jury Chair Ruth Baleiko, AIA, selected the Facility for the Honor Award, the highest honor given by the AIA. More than 130 projects were entered in the competition.

"We hope that Cherry Hills and South Metro enjoy the facility as much as the architectural community," said Jeff Sheppard, AIA, the lead partner at Roth Sheppard Architects. "Indeed we do," responded Cherry Hills Mayor Doug Tisdale. "This project, long in the planning but quick in the building, deserves this high accolade and we congratulate Roth Sheppard Architects and the City Council and former Mayor Mike Wozniak for bringing it about," Tisdale concluded.



## CITY CLERK LAURA SMITH RECEIVES MUNICIPAL CLERK CERTIFICATION

Congratulations to The City of Cherry Hills Village City Clerk, **Laura Smith**, who recently received her Municipal Clerk Certification. This certification requires a lot of work and takes several years to achieve. The City is very proud of Ms. Smith.

The Certified Municipal Clerk program is administered by the International Institute of Municipal Clerks and is "designed to enhance the job performance of clerks in small and large municipalities". To earn the CMC designation, a Municipal Clerk must attend extensive education programs, as well as gather pertinent experience in a municipality. The Colorado Municipal Clerks Association organizes an annual Clerks Institute in partnership with the University of Colorado at Boulder. At this Institute, clerks from all over the state gather for an intensive week of classes that cover topics such as elections, records, liquor licenses, communication and leadership. Attendance of three years of the Institute fulfills the education requirements of the CMC. In addition to education, experience points are required to obtain the CMC designation. Experience points are gained from years working as a Municipal Clerk, attendance at state, national and international conferences, and workshops as well as participation in the Colorado Municipal Clerks Association as a member of a committee or the board.

## COLD WEATHER DOG CARE

Colorado can experience extreme temperature changes that may present challenges for dog owners. Being familiar with cold weather health hazards can keep your pet safe. Puppies, senior dogs, and dogs with certain health problems are more susceptible to cold temperatures.

If a dog is left outside, it must have food, water, and shelter. During cold temperatures, outdoor dogs will burn up to 30% more calories. Change water daily or use a heated water bowl to prevent freezing. An appropriate shelter, with clean and dry bedding is essential to keep a dog warm when weather conditions become extreme. When temperatures get too cold, please consider bringing your pets indoors if you don't already.

# 2013 PARKS TRAILS AND RECREATION COMMISSION OVERVIEW

The Cherry Hills Village (“CHV”) Parks Trails & Recreation Commission (“PTRC”) welcomed two new commissioners: **Josh DeCarlo** and **Mike Gallagher**. Josh hails from District 3 and is a relatively new resident of the Village. Mike is a life long resident of CHV who is following in his wife, Anne’s, footsteps by serving on the commission.

We also say goodbye to Jeff Welborn. A few years ago, without hesitation, Jeff filled a PTRC vacancy when called upon. Sadly, he was not reappointed to the commission; a loss for the PTRC, but moreover, a loss for the city of CHV. Jeff brought a wide breath of experience and talent to the PTRC. As PTRC wraps up 2013, we are pleased to report the following:

**Special Events** – With tremendous enthusiasm, Colleen Dougherty chaired our special events committee. Highlights included Movie Night this summer which is always a family favorite. The 10 days of torrential downpour rain did not dampen the spirits for the Car Show in September which was well received even under gray (and wet) skies. Finally, next week, Friday the 13<sup>th</sup>, is the annual Tree Lighting.

The City acquired 2.5 acres at 115 Meade Lane, adjacent to John Meade Park from the Hutto family. In appreciation to the Hutto family generosity the property will be incorporated into the John Meade Park and will feature the Alan Hutto Memorial Commons which include the creation of a natural open-air sloped grassy area suitable for seating. ## **CHERRY HILLS VILLAGE RECREATION REIMBURSEMENT RULES**

Residents of Cherry Hills Village (primary residence only) who participate in a recreation program, activity, class or event offered by a municipal or special district recreation department, a non-profit, 501(c)(3) youth sports organization or any municipal golf course located within the seven-county Denver metropolitan area (Adams, Arapahoe, Boulder, Broomfield, Denver, Douglas, Jefferson) may be eligible for a partial reimbursement of certain costs from the City of Cherry Hills Village. For purposes of this program, "youth sports organization" shall mean a sports organization whose primary purpose is to provide recreational activities for primary or secondary school students.

### **REIMBURSEMENT PROVISIONS**

Each primary household in Cherry Hills Village is eligible for a maximum \$500.00 annual reimbursement when participating in an activity that qualifies for reimbursement. The amount of reimbursement shall be 50 percent of the cost incurred by the resident; however, reimbursement costs shall not exceed a maximum of \$50.00 per single activity, per resident to include memberships and passes. The purchase of a monthly membership, or multiple use pass is considered a single activity. The amount of reimbursement for an annual membership or pass shall be 50 percent of the cost incurred by the resident; however, reimbursement costs shall not exceed a maximum of \$500.00 annually per household. An annual membership is intended to designate a year-long membership and includes such facilities as Greenwood Athletic and Tennis Club and municipal recreation centers such as South Suburban. Seasonal sporting activities such as soccer, baseball, lacrosse, swimming, hockey, gymnastics, etc., are considered single activities.

### **REIMBURSEMENT PROCEDURE**

1. Obtain an itemized receipt that includes the participant's name, address, name of agency, name of activity, activity fee(s) and activity date(s). Receipts must be for the year in which they are paid, not the year in which the activity takes place.  
**Note:** The following **will not be accepted** as receipts: bank statements, cancelled checks, non-itemized credit card receipts, handwritten receipts and registration forms. Initiation fees, rentals, tax charged, national dues, merchandise, child care, travel, uniforms and golf carts do not qualify for reimbursement.
2. Complete the Recreation Reimbursement Form, attach all itemized receipts and mail or deliver this information to the Village Center by January 15 for the previous year's reimbursements. **NO EXCEPTIONS.**  
**Note:** It is the resident's responsibility to ensure that all recreation reimbursement applications have been received by the City prior to January 15<sup>th</sup>.

All of the information above will be required and residency will be verified. It is the obligation of the City staff to ensure against abuse of this program and final authority will rest with the City Manager to suspend or eliminate reimbursement requests determined to be in violation of the terms of this program.

## CHERRY HILLS VILLAGE BABYSITTERS

### COYOTE BEHAVIOR IN WINTER

The City of Cherry Hills Village wants to remind residents that coyote activity can increase in winter, as coyotes pair up to breed. Coyotes may be more territorial than usual and defend their space as they look for a den site to start their families, so citizens need to be aware of their presence, as well as the potential for conflict. Although naturally curious, coyotes are usually timid animals and normally run away if confronted. Coyote attacks on humans are rare, and can usually be traced to people feeding them, a nearby den site being perceived as threatened, or the presence of another dog with a person in their territory.

In January and February, coyotes are focused on pairing up and finding a good location to give birth to and raise their offspring. As a result, they may become less tolerant of people and pets in open space and parks. Unfortunately, coyotes can see our smaller pets as a food or prey source and may view larger dogs as a threat or as competition for mates, so pet owners need to be extra diligent about protecting their animals.

Timely and accurate reporting of coyote sightings allows the City to determine how many coyotes are out there, where they are, and if they are a danger. As Mayor Tisdale says, "If you see something, say something." **Please continue to report coyote activity to the Coyote Hotline at 303-783-2708.**
