RESOLUTION  
OF THE CITY COUNCIL  
OF THE CITY OF CHERRY HILLS VILLAGE  
ACCEPTING A DONATION FROM THE CHERRY HILLS LAND PRESERVE FOR THE  
RENOVATION OF THE BIG BARN AT QUINCY FARM

**WHEREAS**, pursuant to Section 13.7 of the City of Cherry Hills Village Home Rule Charter, the City Council, on behalf of the City of Cherry Hills Village ("City"), is authorized to receive bequests, gifts, and donations of all kinds of property for public, charitable, or other purposes, and do all things and acts necessary to carry out the purposes of such bequests, gifts, and donations; and

**WHEREAS**, the City owns a 17.5-acre property known as "Quincy Farm" that is subject to a Deed of Conservation Easement recorded in the Arapahoe County real property records on December 18, 2007 at Reception Number B7157828 ("Conservation Easement"); and

**WHEREAS**, the City Council desires to express gratitude to individuals and organizations for monetary donations to the City for the purposes of building, installing, and renovating structures, facilities, and other structural or ecological improvements at Quincy Farm; and

**WHEREAS**, Resolution 10, Series 2024 approved and adopted a Donor Recognition Policy for Donations to Quincy Farm to establish standards and procedures for recognizing such donations ("Donation Policy"); and

**WHEREAS**, Resolution 23, Series 2024 approved a Quincy Farm Donor Recognition Application and accepted a \$125,000.00 donation from the Cherry Hills Land Preserve for the renovation of the Big Barn at Quincy Farm; and

**WHEREAS**, the Cherry Hills Land Preserve desires to donate an additional \$25,000.00 to the City for the renovation of the Big Barn at Quincy Farm, for a total donation of \$150,000.00 towards this project; and

**WHEREAS**, the Cherry Hills Land Preserve has completed and submitted a Quincy Farm Donor Recognition Application ("Application"), attached to this Resolution and incorporated herein as **Attachment A**, in accordance with the Donation Policy; and

**WHEREAS**, City staff has reviewed the Application to ensure its conformance with the standards set forth in the Donation Policy; and

**WHEREAS**, City Council desires to approve the Application and further desires to accept the \$25,000.00 donation from the Cherry Hills Land Preserve for the renovation of the Big Barn at Quincy Farm.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Cherry Hills Village, Colorado that:

**Section 1.** The City Council hereby: (1) approves the Application attached to this Resolution as **Attachment A**; and (2) gratefully accepts a cash donation in the amount of twenty-five thousand dollars and no cents (\$25,000.00) from the Cherry Hills Land Preserve for the renovation of the Big Barn at Quincy Farm, to be paid to the City in installments as indicated in the Application.

**Section 2.** The City Council hereby directs City staff, including the Parks Project and Operations Manager and Finance Director, to take all steps necessary in conformance with the Donation Policy to effectuate the donation and to carry out the purpose of such donation, including but not limited to, preparing a plaque identifying the names indicated in the Application ("Donor Plaque").

**Section 3.** This Resolution shall be effective immediately upon adoption.
