## 2014 REGULAR MUNICIPAL ELECTION – NOVEMBER 4, 2014

Cherry Hills Village will be holding its regular municipal election as a coordinated election with Arapahoe County on **Tuesday November 4, 2014**. Every registered voter will receive a **mail ballot** for this election from the County. You can mail in your ballot to Arapahoe County or drop it off at any of the designated ballot drop-off sites, **including the Village Center**. Every voter also has the option of surrendering their mail ballot and vote in person at any one of the several Vote Centers in Arapahoe County. Arapahoe County will have a final list of Vote Centers and ballot drop-off sites as the election date gets closer. Visit [www.arapahoevotes.com](http://www.arapahoevotes.com) for more information. ### IMPORTANT ELECTION DATES

**August 5, 2014** – First day candidate nomination petitions may be circulated

**August 25, 2014** – Candidate nomination petitions are due to the City Clerk by 4:30 p.m.

**August 29, 2014** – Last day nomination petitions may be amended; last day for a candidate to withdraw; last day an Affidavit of Intent for Write-In Candidate may be filed with the City Clerk

**October 14, 2014** – Ballots will be mailed to registered voters

**October 27, 2014** –Deadline to register to vote by mail or on-line

**November 4, 2014** – **ELECTION DAY**

**January 6, 2014** –Newly elected officials are sworn in and take office

## NOVEMBER 4, 2014 REGULAR MUNICIPAL ELECTION BALLOT MEASURES

At the August 19, 2014 Council meeting city staff will present two ballot measures for the November 4, 2014 election for City Council's consideration.

**The first ballot measure** would propose several amendments to the City Charter in order to **clarify that newly elected officials will not begin their duties of office until the first meeting in January**. Historically, city elections have been held in April and elected officials assumed the duties of office on the following Monday. At the April 2012 election, residents approved a ballot measure that changed city elections from April to November and changed newly elected officials from assuming their duties directly after the election to the first (Please see page 4 for the remainder of this story)

## MESSAGE FROM YOUR MAYOR

### “LOCATION, LOCATION, LOCATION!”

According to The New York Times (“The Gray Lady”), the real estate broker’s mantra of “location, location, location” is at least 90 years old. Real estate is the only truly unique commodity available in large supply. As Will Rogers (the first Mayor of our informal “sister city” of Beverly Hills, CA) once famously quipped, “They ain’t making any more of it!” The Realtor’s™ mantra about location refers to the fact that real estate is first—and best—judged by its proximity to other desirable things around it. The Golden Gate Bridge is a beautiful architectural masterpiece, but it would scarcely rate a second glance if it spanned a lonely stretch of the South Platte River somewhere near Ogallala, Nebraska.

Cherry Hills Village is blessed by the beneficence of location, situated as we are in the very heart of one of the most dynamic metropolitan areas in the United States of America. We enjoy spacious lots with scenic views of the Front Range of the Rocky Mountains, while being mere minutes away from all of the cultural, commercial and recreational opportunities offered in the Denver Region.

As the region has grown, our location has become even more singularly attractive. Many of the corporate headquarters in the Denver Region (whose C-Suite residents occupy our homes) have chosen the South Denver area as their location, preferring campus-type settings and TODs (transit-oriented developments) to the congestion of other areas. George M. Wallace’s dream development, the Denver Tech Center, was begun in the late 1950’s. (My late Father bought three acres near there in 1958, being seduced by the device of buying two acres at full price and getting the third acre for one cent.) Wallace’s vision was a draw for many such non-manufacturing operations and it has come to full and productive life a half century later, benefiting Cherry Hills Village by virtue of our proximate locations.

The north part of the Denver Region, soon to enjoy the building of the North Line of FasTracks, has grown and matured very nicely, enjoying its own prosperity. That said, there is little question that the South Metro Denver Region has enjoyed a more robust prosperity. And there is no question that we will continue to enjoy increased economic growth as the communities around us bring in new corporate headquarters, drawn by our location and the many diverse amenities it affords.

Witness the fact that Regis University (which pioneered the concept of satellite campuses), the University of Colorado and Colorado State University have established campuses in the South Denver Metro area. (The University of Denver had located from downtown Denver to the south side of town some 125 years ago.) These institutions of higher education are a key factor in economic development in the region. Employers and corporate headquarters are looking for—and locating near—universities, drawing on the talent pool of faculty and students they provide and affording continuing education opportunities for their employees.

It is important to remember that economic development of the South Denver Region and the continuing vitality of Cherry Hills Village are not Republican issues. They are not Democratic issues. They are not Independent issues. They are universal issues. Your Mayor and your Councilors are **NON-PARTISAN**. In our elected duties and functions we act for you, *regardless of party*. We are **BIPARTISAN** in our outreach and collaboration across the state. We celebrate the successes of our neighboring communities on every level and “across the aisle.”

Cherry Hills Village does not house any of those corporate headquarters spoken of here. Cherry Hills Village will never house any of these corporate headquarters. Cherry Hills Village does not want to house any of these corporate headquarters.

But we do house—and want to continue to house—the owners, executives and managers of these corporate headquarters. We want to be, we are, and we always will be, the “Destination of Choice” for all of these people...while they are working, and while they enjoy their respites from that work, either through re-engineering themselves or retirement. They will continue to enjoy the benefits of living in ... {“Wait for it!”} ... The #1 Best Suburb of America to Live In! And they will continue to enjoy the benefits of “location, location, location.”

**A Final Reminder.** Always remember that our Village is an island of splendor in the heart of one of the most dynamic, vibrant metropolitan regions in the United States, populated by philanthropically minded citizens. We are secluded but not isolated, exclusive but not exclusory, insulated but not insular. We may be viewed as out of reach, but we certainly are not out of touch. We’re engaged!

## NIGHTTIME-FOCUSED SEAT BELT ENFORCEMENT BEGINS STATEWIDE JULY 21

### *Seat belts save more than lives, they save money too*

Seat belt use is consistently lower at night than during the day, resulting in more unbuckled fatalities.

“A lot of dangerous behavior seems to occur after the sun goes down,” said Col. Scott Hernandez, Chief of the Colorado State Patrol. “We consistently see an increase in DUIs and decrease in seat belt use at night, and the two are sometimes related – many impaired drivers don’t wear their seat belts.”

Not only does wearing a seat belt save lives, but it also has a positive economic impact. According to a National Highway Traffic Safety Administration (NHTSA) report titled, “The Economic and Societal Impact of Motor Vehicle Crashes,” seat belt use has saved approximately \$1.6 trillion in economic costs (2010 dollars) since 1975. The deaths and injuries that occur from nonuse continue to cost an estimated \$14 billion each year in medical care, lost productivity and other injury related costs.

“Crashes have a cost for everyone involved,” said Darrell Lingk, Director of the Office of Transportation Safety at the Colorado Department of Transportation. “If you don’t wear your seat belt you will receive at least a \$65 ticket. If you don’t wear your seat belt and are in a crash, the costs – both personal and financial – are much higher. And remember: seat belts are your best defense against an impaired driver.”

### COLORADO’S SEAT BELT LAWS

**ADULTS** – Colorado has a secondary enforcement law for adult drivers and front-seat passengers. Drivers can be ticketed for violating the seat belt law if they are stopped for another traffic violation. *Click It or Ticket* enforcement focuses on speeding and aggressive drivers. Drivers who are stopped for a traffic violation and are not using a seat belt will be ticketed. The minimum fine is \$65.

**TEENS** – Colorado’s Graduated Drivers Licensing (GDL) law requires all drivers under 18 and their passengers, no matter what their age, to wear seat belts. This is a primary enforcement, meaning teens can be pulled over simply for not wearing a seat belt or having passengers without seat belts. **CHILDREN** – Colorado’s child passenger safety law is primary enforcement, meaning the driver can be stopped and ticketed if an officer sees an unrestrained or improperly restrained child under age 16 in the vehicle.

In 2012, seat belts saved an estimated 12,174 lives nationwide. An additional 3,031 lives could have been saved if all unrestrained passenger vehicle occupants five and older involved in fatal crashes had been properly restrained. ## THE 2015 BUDGET CALENDAR

The City Charter requires the Council to adopt a budget calendar by resolution each year. The following calendar was adopted as the budget calendar for the preparation of the 2015 annual budget by the City Council at the July 15th, 2014 meeting:

1. The City Manager submits the Proposed 2015 Budget on or before September 16, 2014.
2. The City Council holds a study session to review the Proposed 2015 Budget on or before October 7, 2014.
3. A Public Hearing will be held on or before November 18, 2014 to consider the Proposed 2015 Budget on first readings of the Appropriations Ordinance and Mill Levy Ordinance.
4. The Appropriations Ordinance and Mill Levy Ordinance be adopted on second reading before the certification of tax levies deadline of December 15, 2014 required by Arapahoe County Assessor’s Office.

## OPEN SPACE GRANTS AWARDED TO THE CITY

Cherry Hills Village received two Open Space grants from Arapahoe County at their annual Share Back Ceremony on Friday, June 27th.

The ceremony was a breakfast event hosted by the County Commissioners and was held at the 17 Mile House Park in unincorporated Arapahoe County.

Cherry Hills Village received two grants:

- A \$50,000 grant for consultant fees to develop a **Master Plan for John Meade Park**.
- A \$130,000 grant for **Bank Stabilization work along Little Dry Creek**. Urban Drainage has committed an additional \$150,000 for this project.

Over the course of the past 10 years, Arapahoe County Open Space grants to Cherry Hills Village have totaled \$1,874,196.

With the summer in full swing, the Public Art Commission is busy reviewing the recent CAFÉ (Call For Entry) applications from regional sculptors. meeting in January. Since then, staff has found several sections of the City Charter that reference when elected officials assume their duties after an election, and these are now inconsistent with the section that was amended in the April 2012 election. Staff will ask Council to consider placing a measure on the ballot that amends these sections and creates consistency throughout the Charter.

**The second ballot measure** would authorize the City to make reasonable use of any future fiber optic infrastructure that the City might install. In 2005 the State Legislature enacted Senate Bill 05-152 (codified at Title 29, Article 27, C.R.S.) to revoke and deny all Colorado municipalities the right of using municipal facilities, improvements, and fiber optic infrastructure to provide high-speed Internet, advanced telecommunications, and cable television services to residents and businesses, but authorized every local government to submit a ballot question to the local voters to reauthorize and reclaim the local right to use the municipal fiber optic infrastructure. While the City does not currently own or operate any fiber optic infrastructure, Council has discussed the desire the reinstate the City's right to use future fiber optic infrastructure by submitting a ballot question to the voters.

## MUNICIPAL COURT WELCOMES NEW CLERK

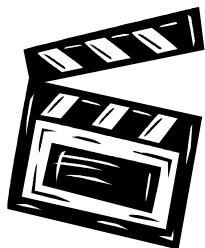

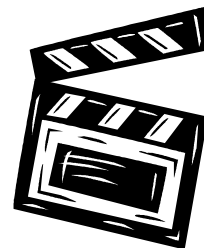

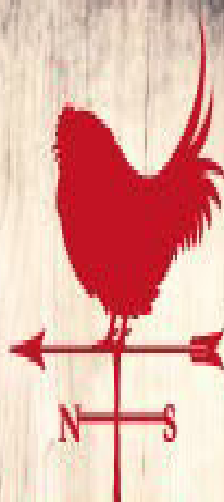

## REPORTING A LOST PET

Reporting a lost pet to your local police department can be the fastest and most effective way to locate the animal - **day or night and on weekends, too**. The City of Cherry Hills Village has a "microchip scanner" that may be utilized when a pet is found. It is important to register the microchip with the company and provide them with up to date contact information. If your pet is missing, the following may be helpful in recovering your animal:

## ANIMAL MISTREATMENT/NEGLECT

### WHAT IS NEGLECT/MISTREATMENT IN RESPECT TO ANIMALS?

Colorado State Statute defines the following:

- "Mistreatment" means every act or omission that causes or unreasonably permits the continuation of unnecessary or unjustifiable pain or suffering.
- "Neglect" means failure to provide food, water, protection from the elements, or other care generally considered to be normal, usual and accepted for an animal's health and well-being consistent with the species, breed and type of animal.

The City of Cherry Hills Village Municipal Code Sec. 7-5-110 - Improper Treatment of Animals - includes the following:

- Cruelty
- Neglect
- Unsafe Tethering
- Unsafe Transporting
- Poisoning domestic animals
