May 9-17th Trash and Rubbish

The City will host a Spring Cleanup for Cherry Hills Village residents again this year. Dumpsters will be provided for residents to dispose of their unwanted trash and rubbish. **Electronics and paint recycling will be available only one day this year (SATURDAY, MAY 9th).** Please do not bring these items except during the designated drop off time. All other hazardous materials will need to be disposed of through the door-to-door program (see Other Hazardous Household Chemicals).

Dumpsters for household rubbish and trash will be available from **May 9 – May 17, 2015**. The City is unable to accept large appliances, so please do not bring these items to the site. You may be asked to provide proof of residency as you drop off items, so please be prepared to show a driver's license with a Cherry Hills Village address on it if asked.

The trash dumpsters will be located east of the maintenance shop just past the main entrance to the Village Center. Residents are encouraged to take advantage of this opportunity to dispose of rubbish not included with normal curbside service. Please note: the City will be **UNABLE** to accept the following items for disposal in the dumpsters: paint, electronics, tires, appliances, oil, antifreeze, fuels and any hazardous materials. Depositing these items in the

dumpsters may jeopardize the future of this program.

There will be a designated area near the dumpsters for all tree branches and shrubbery. Please do not put these items in the dumpsters. City Staff will be chipping and recycling these materials. There will also be a designated area for recyclable metal items. Many thanks to the Public Works staff for their assistance in coordinating this event every year!



Other Hazardous Household Chemicals

The City has contracted with Waste Management/Curbside Recycling, Inc. to do a door-to-door recycling program for hazardous waste again this year. Residents will be required to pay a \$20.00 co-pay and may use the service only once per year. Funds are limited and the program will be suspended once all the funds have been used, so please use the service wisely. We encourage you to work with your neighbors and pool hazardous waste to maximize the available funds. MESSAGE FROM YOUR MAYOR



Every March the Sturm School of Law at the University of Denver, together with the Rocky Mountain Urban Land Institute, put together a series of forums and seminars outlining changes and issues in land use planning regionally, nationally and globally. This year their keynote speaker from the University of Virginia discussed the “new” and increasingly important concept of the Biophilic City; a concept being adopted by many cities both nationally and internationally.

I concluded from this presentation that our Village is ahead of the curve, a leader in the Biophilic movement, we just did not know it. Below is a quote from the homepage of www.biophiliccities.org:

“Biophilic Cities are cities that contain abundant nature; they are cities that care about, seek to protect, restore and grow this nature, and that strive to foster deep connections and daily contact with the natural world. Nature is not something optional, but absolutely essential to living a happy, healthy and meaningful life.”

Since the founding of Cherry Hills Village, emphasis has been placed upon the importance of nature in planning and development, and although we may have lost the way occasionally, we have always returned to the importance of maintaining a semi rural atmosphere in our Village. Our most recent Master Plan developed hand-in-hand with the citizens of the Village is clear evidence of that desire. This Fall as I walked around the Village campaigning and talking to residents, it was clear to me that we have a Village focused on preserving trees, wild life, trails and natural spaces. There may have been different visions of how to accomplish this (with or without coyotes, for example), but disagreement and discussion is healthy.

I am proud to be a part of a community that, long before it was the fashionable thing to do, put a priority on nature. We do not join London, Singapore and New York as Biophilic Cities, they join us. Perhaps I should write a letter congratulating them on reordering their priorities, or perhaps not.

ROADWORK EMINENT IN CHV

It happens every summer. The weather turns warm, and City contracted crews begin chip sealing roadways all around the City. Some residents may start

grumbling because of the mess it makes and the chance of chips hitting their cars. Some may even ask why the City insists on using this process. Despite the drawbacks, chip sealing roads remains the most cost-effective method of road maintenance. Cherry Hills Village has chosen this method for the last decade despite other agencies going away from it.

The purpose of chip sealing is to extend the life of an asphalt road. After the streets crew seals up the cracks in the road the contractor will come in and start the chipseal process. First they cover the road with hot tar, spray a tar substance on the road, followed quickly by a machine that spreads a certain size of gravel along the road. A roller then follows, pressing the chips tightly into the tar. After a while, cars are allowed to drive on the road, further pushing the gravel into the road. This is an older but a proven technology, there are other kinds of newer technology, but a chip seal is a very proven and worthy technology to use.

With that being said Cherry Hills Village is now one of the leaders in the Metro area when it comes to preventative maintenance on its roads. Even with all of the new technology and processes a lot of agencies are coming back to this old technology for a number of reasons. The biggest benefit of using chip seal is how inexpensive the process is compared to other roadway maintenance. Chip seals will cost the City around \$3.00 a square yard in 2015. The City is able to perform maintenance on all of its streets in a cycle of approximately 7 years. Repaving the streets is much more expensive and in many cases is replaced long after it fails due to the cost of the product. The installation process is much quicker and requires a shorter period of closed roadways and reduced inconvenience.

Chip seal is the best maintenance process that you can do to extend the life of the road for the least amount of money. The City's roads are one of the most expensive and cost intensive parts of its municipal operations. We have worked hard developing the most cost effective and efficient process to keep all of the paved streets at an acceptable level. If you look at the system as a whole it is in much better shape than most other municipalities around the country. We try and stretch the dollar as far as we can the best we can and using chip seal gives the best benefit for the least amount of money.

The City has been using ¼ inch chip (the smallest) on all residential streets for many years as a way to make the roads almost as smooth as newly paved streets.

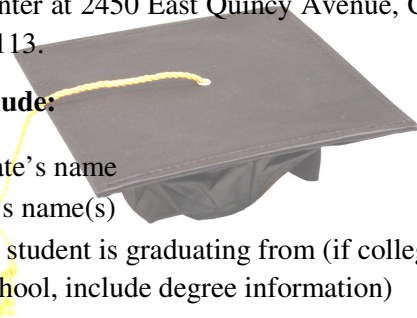

PTRC PURSUING BUSY 2015

The Parks, Trails and Recreation Commission (PTRC) is off to a fast start in 2015! PTRC starts by thanking the Village staff for all its hard work. The parks and trails look great as we welcome spring and get heavy use of our beautiful assets.

PTRC's major focus has been to generate the John Meade Park Master Plan. This work encompasses both John Meade Park and the Alan Hutto Memorial Commons immediately adjacent to John Meade Park. As a result of a generous donation, Cherry Hills Village acquired ownership of a parcel just east of the current Village Center, across Meade Lane. Terms of the acquisition require certain improvements to the Alan Hutto Memorial Commons, specifically to include a landscaped portion that includes a natural, open-air sloped grassy area suitable for seating, and construction of a hard-surface pad approximately thirty two feet by sixteen feet at the lower end of the sloped area. The gift allows relocation of the improvements to any area within the study area, so PTRC has expanded the entire John Meade master planning to include the Alan Hutto Memorial Commons requirements. With the assistance of consultant THK Associates, Inc., PTRC has developed a number of potential options, and will refine the planning process through the spring. Meetings occur twice a month until the plan is completed, and PTRC encourages your participation and input as we hope to implement the plan starting later in 2015. The PTRC held a Public Input Meeting on April 9th at 5:30 p.m. to gather input from the Community, but there are still plenty of opportunities for you to get involved and to help plan the Village's "Central Park!" The PTRC will meet on **April 27th at 8:00 a.m.** at the Village Center, **May 14th at 5:30 p.m.** at the Village Center, **May 18th at 8:00 a.m.** at the Village Center, **June 11th at 5:30 p.m.** at the Village Center and **June 22nd at 8:00 a.m.** at the Village Center.

PTRC's agenda includes a review of the open space sections of the Village Master Plan and consideration of any necessary revisions will be made later this summer and fall of 2015. Planning and Zoning is doing the same, and there will be a joint PTRC/P&Z

session to address overlapping concerns. As always, we welcome community involvement. While we do not envision changes altering the Village's mandate to retain its semi-rural character, the PTRC will study whether other changes are merited and refine how to implement the mandate moving forward. Also, the Parks, Trails and Recreation Commission continues to monitor City Council's ongoing efforts for Quincy Farms and stands ready to move the process forward. PTRC's continuing evaluation of the Village's trails and parks has stimulated multiparty relationships concerning Highline Canal transition, vegetation, recreation and safety needs. A recent instance of vandalism in the trail underpass at Bellevue at the Highline Canal has prompted PTRC's decision to install security measures to monitor that area. As with all areas of our open spaces, the public is asked to report any suspicious activities so our police department can respond quickly. Finally, the Parks, Trails and Recreation Commission recently reviewed a subdivision application and approved acceptance of funds in lieu of property dedication, contingent upon City Council's acceptance of the subdivision application and PTRC's acceptance of an appraisal for the parcels, and also favorable resolution of title issues establishing the applicant's ownership of the land at issue.

Mark your calendars for upcoming community events. The ever popular **Movie Night** will be **August 22nd**, in John Meade Park. This year's car show should be bigger and better than ever, and it will take place in September or early October, so watch the Village's website and the *Village Crier* for the date announcement. Get your cars ready and enjoy a wonderful gathering with your neighbors. The **Holiday Tree Lighting and Celebration** will be **December 11th** at the Village Center.

CODE VIOLATION NUISANCE

There are all types of nuisances that can be found in Cherry Hills Village. From a habitually barking dog, to bright lights, construction noise, water and air pollution. Even the smell from an unclean horse stable or stall can be considered a nuisance. The Cherry Hills Village City Code pertaining to the care of horse stables is as follows:

"Any stable, stall, shed, yard or appurtenance thereto in which refuse shall collect and accumulate to an extent offensive or unhealthy to others, or which shall not be kept protected from flies and other insects and rodents in clean or wholesome conditions, is declared a nuisance."

Barking dogs can create a problem in all neighborhoods. If a dog barks for 30 minutes or longer, no matter what time of day or night, it might constitute as a nuisance violation.

The most common nuisance complaints from construction sites are: amplified music, tracking mud from the site onto the roadway and working outside of the approved construction times.

Enforcement of Code violations can be in the form of a verbal warning, formal notice of violation (written warning) or a municipal summons. BEWARE OF FRAUDULENT CALLS

There has been an increase in Cherry Hills Village residents receiving two types of fraudulent calls. The first type of calls are from individuals fraudulently posing as Internal Revenue Service (IRS) agents. In these phone calls, the individuals threaten residents with arrest, deportation and driver's license revocation if they do not immediately pay their taxes.

The callers posing as IRS agents demand immediate payment by wire transfer or with a prepaid money card. The Cherry Hills Village Police Department advises residents that these types of telephone calls are fraudulent. Initial contact by the IRS will customarily be through the U.S. Mail service and **NOT** by telephone. The following signs will help residents spot an IRS debt collection scam:

- **Threats of arrest or prosecution**
- **Demand of immediate payment or police will respond to your home**
- **Requirement of specific payment method (i.e. wire transfer or prepaid money card)**
- **Request for card or debit card numbers**
- **Request for personal or financial information**

Residents are encouraged to follow these tips to stay safe:

- **Do NOT give out personal information by phone**
- **Do NOT give out financial information by phone**
- **Try to write down the basic details of the call, such as the caller's name and telephone number**
- **If you are unsure of the call's legitimacy, contact the IRS directly at (800) 829-1040**

The second type of fraudulent telephone calls that Cherry Hills Village residents have been receiving are individuals posing as **Microsoft** employees with the intent to gain access to personal computers. The callers identify themselves as technicians from Microsoft and they explain they received a report from another company (usually an internet service provider) that there is a virus on your computer. **Microsoft Corporation does NOT make unsolicited phone calls to help fix your computer or offer virus protection.**

If these callers are given access to your computer, they will install malicious software to steal personal information or to take control of the computer for fraudulent purposes. The caller might make the following claims to appear legitimate:

- **Your computer is infected with a virus and it was reported to a technical support company**
- **Your computer is infected with a virus and it is sending out spam emails**

FRAUDULENT CALLS CONTINUED

- **Your Windows Operating System is corrupted and might fail**

Residents are encouraged to follow these tips to protect themselves from scammers attempting to access your personal computer:

- **Never grant remote access to your computer to unknown individuals**
- **Install a firewall and anti-virus program to protect your computer and personal information**
- **Protect your passwords and keep them in a safe place**
- **Never give out personal or financial information to unknown callers**
- **Contact your internet service provider directly if you are concerned your computer might be exposed to viruses or other security threats**
- **Do not open or respond to emails or click links from unknown senders**
- **If you do encounter a problem, be sure to find a reputable computer repair company**

UTILITY LINE UNDERGROUNDING STUDY COMMITTEE UPDATE

As mentioned in the last issue of *The Village Crier*, the City has received several responses to the Request for Information for Improved Broadband Communications (RFI) that was issued in January. The services offered by the companies responding to the RFI include design, construction, management and leasing activities for a fiber optic infrastructure. The City issued the RFI in order to determine how improved broadband communications can be brought into the City at the same time as the undergrounding of overhead utility lines. The Utility Line Undergrounding Study Committee will follow-up with individual companies to discuss the needs of the City and potential public-private partnerships.

Xcel Energy has completed the engineering design for a section of E. Quincy Avenue between S. Holly Street and Happy Canyon Road. The design was requested by the City in an effort to provide a more accurate cost estimate for the overall project. The Committee is currently analyzing the results of the design and will update the estimated project cost based on the new infor-

mation. While the design helps to provide a more approximate total for design, construction and ancillary expenses, it should be noted that the cost to bury utility lines in the City will vary according to location and the existing equipment installed at each site.

All residents should have received notice of a survey asking for input as to whether they would or would not support a tax increase for undergrounding and improved broadband communications. Survey results are currently being compiled and will be provided to City Council as part of the Committee's final report in June. The survey results will also be available at a community open house scheduled for **Wednesday, May 6th at 6:00 p.m.** The open house will include an overview of the proposed scope of work, an updated cost estimate and an opportunity for residents to provide feedback. The meeting will be held in the Joint Public Safety Facility at 2460 E. Quincy Avenue. For more information, please contact Emily Kropf, Special Projects Coordinator, at (303) 783-2742.

2014 ANNUAL REPORT

2015 BUDGET DOCUMENT

The Cherry Hills Village Finance Department has submitted the 2015 Budget to the Government Finance Officers Association (GFOA) for consideration for their Distinguished Budget Presentation Award Program. This is the first year the Finance Department has applied for this award. The program encourages state and local governments to prepare documents of the highest quality that reflects guidelines established by the National Advisory Council on State and Local Budgeting and the GFOAs best practices on budgeting. ROADWORK CONTINUED

This process has proven to work well and is now being used around the country with endorsements from many user groups because it makes the streets usable for everybody including bike riders, long-boarders, roller-skiers, kids in strollers, etc., but more importantly the product seals the streets and extends the life of the roadway for less tax dollars. This is a point that Cherry Hills Village has been making about chip seal while others were being resistant to the process. With funds dwindling, other agencies are now looking to Cherry Hills Village to draw on the success of its chip seal program.

Within the chip seal program, the City has been evaluating the effectiveness of a number of different processes to improve certain areas that are not performing as desired; including performing a process called double chip in cul-de-sacs to help keep the aggregate in place. This year a section of the bike path will be covered with the ¼ inch chip and will be evaluated for future consideration on the entire paved system. Other sections of the bike path will receive a slurry seal, which is similar to a chip seal, but with a higher price and a longer installation time needed before letting traffic back on for normal use. The City has used this process before in the past on its streets, but the cost and substandard performance keep Cherry Hills Village vested in the chip seal process.

In the near future, the City will post a list of all of the 2015 capital improvements programs and all of the affected streets and paths on the City's website at www.cherryhillsvillage.com. The affected residents will also receive notification by mail before any street improvement begins.

COLORADO MEDICATION TAKE-BACK PROGRAM

When over-the-counter or prescription medications are no longer needed, they should be removed from the home or they can fall into the hands of small children and cause accidental poisoning. The Colorado Medication Take-Back Program is a network of secure boxes for collecting unused and unwanted household medications.

Medication disposal should be done in a way that minimizes the chance of misuse and protects the environment. Flushing them down the toilet or throwing them in the trash can pollute lakes, streams and water supplies. The medications collected by this program are sent to a specialized industrial landfill, offering a high degree of environmental protection.

Partial list of medications allowed in this program include:

- Prescription medications (except for narcotics or controlled substances)
- Over-the-counter medications
- Medication samples
- Liquid medications in glass or leak-proof containers
- Medicated ointments or lotions
- Inhalers

Partial list of medications that are **NOT** allowed in this program include:

- Narcotics and other controlled substances
- Personal care products
- Hydrogen peroxide
- Aerosol cans
- Thermometers
- IV bags
- Needles and other sharp objects
