## **NATIONALLY RENOWNED SCULPTOR VISITS CHERRY HILLS VILLAGE**

Village residents, Ken and Trish Green hosted a lively reception for the acclaimed American sculptor, **Deborah Butterfield**. Marie and Buck Fredrickson, Sara and Larry Grace and Anne and Nick Hackstock were among those excited to hear that the Cherry Hills Village Art Commission is fund-raising to acquire a Butterfield bronze horse to be placed on the Joint Public Safety Facility property. The Green's beautiful horse property on Village Road was the perfect venue for such an event. Sally and Ray Duncan graciously contributed the wine for the evening. Others being greeted by the Greens were gallery owners from around the country

who are representing Butterfield: Greg Kucera, Seattle; William Lieberman, Chicago; Ed Gilbert, San Francisco; and Carol Corey, New York.

The Art Commissioners have often discussed the possibility of choosing a signature piece of art, the horse, which would capture the essence and culture of the Village. Deborah Butterfield is renowned for her life-size horses made from "found" objects in nature and bronzed to last forever.

## ST. MARY'S CELEBRATES 150 YEARS

The spirit of pride and gratitude was almost palpable when the St. Mary's Academy community celebrated 150 years of educating the children of Colorado on Sunday, April 19th. The day capped off a year of festivities. As Academy President Deirdre V. Cryor said in her welcome, "This year has not let us down. It has been a year filled with history lessons, reunions, remembering and parties".

Nearly 400 students, parents, graduates and friends filled the Bishop Evans Sports Center for a joyous Mass honoring the school's legacy of academic achievement, resilience, service and Loretto values. Also in attendance were many members of the Loretto Community, whose Sisters founded the school in 1864. A pioneering institution of the state, St. Mary's Academy has the distinction of awarding the first diploma in the Colorado territory.

Following the Mass, a high-spirited reception was the inaugural event hosted in the new Community Center located on the southwest side of the campus. A multi-use building, it was designed by The Roybal Corporation Architects and built by Haselden Construction. From there attendees enjoyed views of the new Pam Bent Turf Field, the first Nike Grind field in Colorado, made of ground up soles of Nike shoes rather than the traditional rubber tires usually used on fields.

St. Mary's Academy's home on South University Boulevard may be best known for the iconic Georgian Revival home that is the centerpiece of the campus. It is the oldest building on campus and was the residence of Alan and Lorena Hickerson until it was purchased in 1951. St. Mary's Academy is proud of its 150 years of educating boys and girls, first downtown and for the past 64 years in Cherry Hills Village.

## DEBORAH BUTTERFIELD VISIT continued from cover page

Her work is represented in more than 30 museum collections including the Denver Art Museum, the Metropolitan Museum of Art, the Smithsonian American Art Museum, Museum of Contemporary Art in Chicago and Los Angeles, the Dallas Art Museum and more.

Butterfield's work is a combination of abstraction and reality. Using found objects from her ranch as well as wood collected from her worldwide travels, she creates strong, lovable, calm horses. She has said the sculptures are self-portraits

and most are individually named. Horses are a major part of her life and art. She practices the art of dressage as well as running a riding program for the handicapped at her stables. Butterfield, born in San Diego, California, studied art at the University of California Davis where she met and married fellow art student, John Buck. They have homes and studios in Montana and Hawaii.

Denver Botanic Gardens, recognized as one of the premiere botanic gardens in the world, is hosting the first major outdoor exhibition of her work, *Deborah Butterfield: The Nature of Horses*, from May 23<sup>rd</sup> through October 18<sup>th</sup> where 15 of her life-size bronze horses are placed throughout the York Street location. The sculptures are originally created in wood. Molds are made of each branch, the wood is burnt out and the cavity is filled with molten bronze. The elegant and organic forms provide a lovely compliment to the Gardens' natural setting and colorful summer flowers. This is an extraordinary opportunity to see sculptures created by this gifted American artist. We encourage you to see this exhibit.



## MAIL & PACKAGE SECURITY TIPS

Residents should be aware that there has been an increase of mail and package thefts throughout the Metro area including the City of Cherry Hills Village. Cherry Hills Village Police Department recommends the following safety tips for securing mail and packages:

- Retrieve mail from your mailbox as soon as possible and never leave items in your mailbox overnight or for extended periods of time. If you are going on vacation, either put a stop mail order in with your local postal service or have someone you trust pick up your mail daily.
- Install a locking mailbox that is approved by the United States Postal Service.
- Have packages delivered to your work place or

sent to a relative or neighbor who is usually at home during the day. You may also consider having the package held at the delivery service that you use, such as Federal Express or UPS.

If you see anyone suspicious looking into or opening mailboxes or casing front porches, please report this activity immediately to the Cherry Hills Village Police Department at 303-761-8711; normal business hours are Monday-Friday from 8:00-4:30 p.m. If it is after normal business hours, you can reach Arapahoe County Dispatch 24 hours a day at 303-795-4711.

The Cherry Hills Village Police Department would also like to remind residents that have their homes listed for sale, to ensure that all doors and windows are locked when the home is vacant or being shown to prospective buyers. Denver County has experienced a rash of burglaries with people going into the home as a prospective buyer and unlocking windows and doors for a later entry. If your house is on the market, you can contact the Cherry Hills Village Police Department to arrange for a housewatch. The housewatch program is a community program that allows residents to request additional police patrol of their unoccupied residential property due to vacation, relocation or other absence. To request a period of additional patrol of your residence, please contact the Cherry Hills Village Police Department at 303-761-8711 during normal business hours with the following information:

- Name, address and telephone number
- Dates of departure or return/potential listing dates or purchase dates
- Name and telephone number of an emergency contact
- Specific information regarding your residence; such as persons who have permission to go inside your residence, if an alarm system will be activated, if lights will be on timers or if pets will be left at the residence.



## POSSIBLE CHANGE IN CHERRY HILLS VILLAGE ZIP CODES


Cherry Hills Village residents continue to have difficulties with many retailers around Denver who continue to charge sales tax on delivered goods into Cherry Hills Village. Most retailers base their sales tax computations upon the zip code of the buyer which means the tax is charged and paid to Englewood, in most cases, and occasionally to Littleton and Greenwood Village.

The zip code not only determines sales taxes, but it is also used for gathering data. For example, residents with an 80113 zip code may be included within insurance rate data gathering for Englewood. Multiple zip codes (Cherry Hills Village has 3 that fall within the city limits) causes confusion and divides the community into unrelated jurisdictions for the benefit of the postal service delivery process.

The solution suggested by several residents is for Cherry Hills Village to have its own zip code. In that event, if a retailer refused to exempt a resident from sales tax on a delivered item, at least the sales tax would go to Cherry Hills Village rather than as a gift to another jurisdiction. The process of changing zip codes is not easy, but is certainly worth the effort. One application may be made per annum. After the application is made in accordance with the procedures created by the United States Postal Service, the city requesting the change is required to produce a survey showing that a majority of its residents would approve a change to a new zip code. Everyone's zip code would change to the new number if the application is approved.

Below is a map showing the zip codes that apply to Cherry Hills Village. As mentioned, the Village is divided into three zip codes: 80113, 80121 and 80111. Before City Council approves an application to the United States Postal Service to consolidate the entire Village into one zip code, it is important for Council to get feedback as to whether it is probable that the survey requirements would be met. As we move forward, Council will be exploring the best method to achieve preliminary feedback.

In the interim, Mayor Laura Christman will be contacting the Cherry Hills Village Congressional representatives to assure that the Village will have their support if the residents elect to move forward.



June is only a few days away and you know what that means for Denver Water....it's time to talk about watering. Between the sunny days and recent rain showers across the metro area, the grass is green and flowers are in bloom, signaling many to turn on their sprinklers. Because about half of single-family residential use goes to outdoor watering, it's the perfect time to establish more water-wise practices.



Denver Water's team of Water Savers provides customers with tips and tools for efficient watering during the summer. Denver Water's summer watering rules are in effect beginning May 1st through October 1st. The Water Savers remind you that the watering rules are:

- Water during cooler times of the day to avoid evaporation (typically between 10 a.m. and 6 p.m.).
- There is no need to water more than three days per week.
- Turn off your sprinklers when it's windy because the water isn't reaching its desired destination.

- Monitor your sprinkler system throughout the summer and immediately repair leaks. If your system runs at night (an ideal watering time) check your system after mowing to make sure everything is functioning properly.
- Use a nozzle with a shut-off valve on your hose when washing your car and gardening.
- Adjust sprinkler heads to avoid watering concrete or asphalt.
- Landscapes do not need the same amount of water in May as they do in July so adjust your watering schedules based on the season.

Water Savers will be in every Denver Water community to address misperceptions about watering. A few of the misperceptions are listed below.

**Fact 1:** Denver's water supply is in good shape heading into the summer.

**Misperception:** This means we don't need to worry about water conservation and supply.

**Reality:** The Colorado River - the source of half Denver's water supply - has been gripped with a decade-long drought, which has impacted our water supply as recently as 2012. This embodies why we've created a culture of conservation, not just during dry times, but also in years like this when we can maintain our supply and prepare for the next dry period. Every drop saved now is a drop available when the next dry spell returns.

**Fact 2:** Denver Water has a team of Water Savers out in the community each summer.

**Misperception:** This is a team of "water cops" out to issue and collect fines.

**Reality:** Denver Water takes pride in being a part of our community and what better way to do this than face-to-face interaction? Our Water Savers met with more than 3,400 customers last year and never needed to issue a single fine.

## SUMMER CODE ENFORCEMENT REMINDERS

With all the rain Colorado has received lately, we face the issue of weeds in the Village. Code Enforcement Officers will be contacting residents to address these nuisances when discovered or reported. Cherry Hills Village City Code Section 7 (articles 3 and 4) serve as a useful guide when determining what property owner responsibilities are. These codes are available on the City's website at [www.cherryhillsvillage.com](http://www.cherryhillsvillage.com). If the problem is not corrected, the owner can be given a citation for their appearance in Municipal Court.

Other common complaints for Code Enforcement are uncovered trash, piles of branches, left over construction material, broken fences, trees and bushes growing in the right-of-way and/or obstructing traffic views at intersections and dead/diseased trees. Residents are responsible for maintaining the rights-of-way that surround their properties. Also, residents that have landscaping companies working at their proper-

ties must let them know that the City does not allow dumping or storage of any landscaping materials (i.e., dirt, rocks, mulch, etc.) on City streets or in City rights-of-way.

In the City of Cherry Hills Village, construction hours are Monday-Friday from 7:00 a.m. to 6:00 p.m. and Saturday from 8:00 a.m. to 4:00 p.m. Interior construction **only** is allowed on Sunday within an entirely enclosed structure from 8:00 a.m. to 4:00 p.m.

For questions or complaints, you can call the Code Enforcement Hotline at 303-783-2752. This hotline is voicemail only and callers can remain anonymous if they choose.

## ARAPAHOE COUNTY FUNDS

Arapahoe County Open Space recently awarded the City \$125,000 for the 2015 spring grant cycle. The first award for \$50,000 is to conduct a survey of all trails and associated infrastructure and prepare a master plan to establish long-term strategies for pedestrian and bicycle facilities. The City will issue a Request for Proposals this summer to begin the process of mapping trails and easements and completing legal research. The second award for \$50,000 is to apply a surface maintenance treatment to all asphalt trails in the Village to enhance the lifespan of the existing trail system and improve the overall quality of the City's infrastructure. A crack seal treatment must be completed on all existing trails before the surface maintenance treatment can be applied in the fall. The third award of \$25,000 is to construct an irrigation system and plant a number of new trees to maintain the existing canopy in Three Pond Park. Installation of the irrigation system will take place this summer. Arapahoe County Open

Space works to preserve natural areas, enhance regional parks and build and maintain trails.



## CUSTOMER SERVICE STANDARDS FOR CABLE OPERATORS

At the April 21st City Council meeting, City Council adopted Resolution 16, Series 2015 which specifically addresses customer service standards when dealing with cable operators. These standards were created by the Colorado Communication and Utilities Alliance (CCUA) in order to outline specific expectations that residents should expect when dealing with ANY cable operator. A few of the standards are listed below:

**Courtesy** - Cable operator employees, contractors and subcontractors shall be courteous, knowledgeable and helpful and shall provide effective and satisfactory service in all contacts with customers.

**Accessible** - A cable operator shall provide customer service centers/business offices ("Service Centers") which are conveniently located and which are open during normal business hours. Service Centers shall be fully staffed with Customer Service Representatives offering the following services to customers who come to the Service Center: bill payment, equipment exchange, processing of change of service requests and responses to customer inquiries and requests. The cable operator shall maintain local telephone access lines that shall be available twenty-four hours a day, seven days a week for service/repair requests and billing/service inquiries. A cable operator shall have dispatchers and technicians on call twenty-four hours a day, seven days a week, including holidays.

**Responsive** - A cable operator shall complete all standard residential installations or modifications to service requested by customers with seven business days after the order is placed, unless a later day for installation is requested. If the customer requests a nonstandard residential installation or the cable operator determines that a nonstandard residential installation is required, the cable operator shall provide the customer in advance with a total installation cost esti-

mate and an estimated date of completion. The "appointment window" alternatives for specific installations, service calls, and/or other installation activities will be either a specific time, or at a maximum, a four hour time block between the hours of 8:00 a.m. and 6:00 p.m. six days per week. In the event of system outages resulting from cable operator equipment failure, the cable operator shall correct such failure within two hours after the third call is received. All other service interruptions resulting from cable operator equipment failure shall be corrected by the end of the next calendar day.

**Complaints** - A cable operator shall establish written procedures for receiving, acting upon and resolving customer complaints and crediting customer accounts. At the conclusion of the cable operator's investigation of a customer complaint, but in no more than ten calendar days after receiving the complaint, the cable operator shall notify the customer of the results of its investigation and its proposed action or credit. The cable operator's customer service representatives shall have the authority to provide credit for interrupted service, to waive fees, to schedule service appointments and to change billing cycles (where appropriate). Any difficulties that cannot be resolved by the customer service representative shall be referred to the appropriate supervisor who shall contact the customer with four hours and resolve the problem with forty eight hours or within such other time frame as is acceptable to the customer and the cable operator. The cable operator shall issue a credit or refund to a customer within thirty days after determining the customer's entitlement to a credit or refund.

## SAFE SUN IN COLORADO

As the sun's rays get stronger heading into summer, now is the time to focus on sun protection in order to prevent skin cancer and other sun damage; such as signs of premature aging. Living in Colorado, residents enjoy over 300 days of sunshine a year at an elevation a mile closer to the sun than in other parts of the country. "Unfortunately, this increases the incidence of skin cancer and melanoma; which is even

higher in our mountain communities," states Castle Rock Dermatologist, Mohs Surgeon and Cherry Hills Village Resident, Dr. Richard Asarch. Dr. Asarch received the Melanoma Research Foundation's 2015 Humanitarian Award and has performed over 35,000 Mohs Micrographic procedures in the treatment of skin cancer. It is the most common cancer among 25-29 year olds and the second most common in 17-25 year olds. In America, one in five will develop some form of skin cancer and one in fifty will develop melanoma. Fortunately skin cancer is the most preventable cancer, particularly with early detection and by following the steps below:

- Seek shade. The sun's rays are strongest between 10 a.m. and 3 p.m., so limit your sun exposure during those hours.
- Wear protective clothing. Opt for fabric made with chemical UV absorbers for the best protection.
- Apply a broad-spectrum sunscreen to provide protection from both UVA and UVB rays. Use a sunscreen with at least a 30 SPF and re-apply every two hours and even more if you are sweating or swimming.
- Watch out for water, snow or sand. These reflective surfaces intensify the damaging rays of the sun and increase risk of sunburn and long-term damage.
- Schedule an annual skin check with your dermatologist and do frequent self-examinations of your skin, since finding melanomas early is the most effective treatment of all.
