## John Meade Park & Alan Hutto Memorial Commons DESIGN/PLANNING UPDATE

The City of Cherry Hills Village is in the final stages of planning and designing John Meade Park, and Alan Hutto Memorial Commons. To the right is a schematic of the preferred design for the site, subject to final City Council approval. In January, City Council approved the issuance of Certificates of Participate (COPs); \$2.6 million of that will be used to fund improvements in the Park to include floodplain development, wetlands regrading, and habitat restoration. The COPs will also help fund park improvements such as soft surface trails, vegetation, and play equipment. The City will also apply for grant opportunities to further reduce City costs.

# LAND-SCAPING IN THE *Right-of-Way*

**W**ith all the warm weather we have experienced early this year, more and more residents will start thinking about making improvements to their landscaping. Residents should be aware that these landscaping improvements may fall within the City's right-of-way. In most cases the City owns property past the actual road surface that runs in front of the property; however in some cases, the City may have over ten feet of additional property. Residents are responsible for maintaining the area in front of their residence and are welcome to landscape it, if it does not interfere with street maintenance, snow removal or stormwater drainage. If the improvements impede the ability of the City

to properly maintain the street, remove snow or drain water, residents will be required to remove the landscaping from the City right-of-way at their own expense.

The City Municipal Code provides for landscaping improvements in the following section:

## **SECTION 11-2-40 PERMIT REQUIRED (e)**

No private improvements are allowed within the City's right-of-way without the approval of the City, with the exception of placing and maintaining landscaping that will not interfere with the public's use of the right-of-way. Allowing the placement and maintenance of landscaping in the right-of-way shall not be construed to abridge, limit or restrict the City in exercising its right to make full use of the City right-of-way encroached upon as public thoroughfares or public places, nor shall it operate to restrict utility companies or any other licensees in exercising their rights to construct, remove, operate and maintain their installations within the City's right-of-way, having first obtained the proper permits required.

# *ROW PERMIT REQUIRED*

**C**herry Hills Village has made a significant investment in its streets and roads and the Public Works Department works hard to stretch the limited funds it receives for capital improvements and maintenance to make each project count. Once a street is improved and resurfaced, the work to maintain it in this condition requires vigilance and perseverance. Utility repairs and construction equipment in the streets must be regulated to keep the streets from failing prematurely.

To help keep the roads in an acceptable condition, new construction and excavation standards were adopted to ensure that when individuals or utility companies perform work on the roads or within the right-of-way; they restore them back to the original state.

## **Some of these standards include:**

- No loading and unloading of materials from the street with skid steers or other construction equipment.
- No storage of materials of any kind on the street.
- Temporary construction access must meet all stormwater regulations and be approved by the City.
- Right-of-way permits may be denied if the City determines the work can be reasonably performed from private property.

The City requires utility companies and contractors to provide performance bonds when they pull a right-of-way permit. This performance bond alleviates any need for the City to spend taxpayer money repairing damage caused by these types of jobs. Streets are intended for vehicle and pedestrian use. They are not designed to be used as construction staging areas as these types of activities significantly reduce the life of the pavement. The Public Works Department requests that residents remind their contractors to check with the City prior to working in the street or performing any other type of construction, to make sure their contractors are in full compliance with all permitting requirements.

*Jack Hyatt, a life well lived.*

Normally I would not write a eulogy of a resident, especially a resident for whom several wonderful eulogies have previously been printed, but I wanted to write about the Jack Hyatt that I knew and loved from my personal perspective. All of the wonderful things said about Jack in the numerous eulogies are true.



Jack, a Cherry Hills Village resident and one of the founders of a well-known law firm in Denver, was brilliant, caring, philanthropic, and a great family man.

Those are wonderful attributes that can be said of many past and current members of our community. When I think of Jack, I smile, because for me, he was one of the funniest and most wonderful and eccentric people I have had the privilege to know. Jack had an unerring sense of fairness, compassion for those less fortunate, a playful and joyous love of all families, and he absolutely did not care about what others thought of him, as long as he believed that he had kept to his core values. Those core values were excellence in endeavor and honesty toward others, while spending the least amount of money to achieve the foregoing.

When my children were very young and visited me at the firm, the first place they would run was to Jack Hyatt's office. I knew they had arrived when I heard peals of laughter from down the hall as Jack entertained the children with games, magic tricks and stories. My son Aaron was so impressed by Jack that when Aaron was four, he told me that the reason the world was safe from dinosaurs was because Jack Hyatt had killed them all. I did not argue, as it seemed totally plausible to me.

Jack taught me to not take life too seriously, to look at the humor in situations and to smile with him at the sometimes ridiculous situations that presented themselves. I say smile, not laugh, because Jack rarely laughed out loud. He would start with a completely straight face, daring you to contradict him, and then you would see the smile in his eyes before his face would light up with the classic somewhat crooked Jack Hyatt smile. Jack wore a cap every day at work along with an amazing tie, of which he seemed to have a never ending supply. On Father's day the firm initiated an ugly tie contest, which Jack inevitably won, simply by wearing whatever tie he had chosen for that day.

With Jack gone, I have lost a mentor and a friend. The community has lost a wonderful citizen, and lest it be forgotten, but for Jack we would have velociraptors running through our backyards.

# Drug Take Back

**O**n April 29, 2017 from 10 a.m. to 2 p.m. the Cherry Hills Police Department and the Drug Enforcement Administration (DEA) will provide the public another opportunity to dispose of potentially dangerous expired, unused, and unwanted prescription drugs. Bring your medications for disposal to the Cherry Hills Police Department at 2460 E. Quincy Ave. The service is free and anonymous, no questions asked.

Last year, Cherry Hills Village residents turned in 215 pounds of prescription drugs during the Prescription Drug Take Back days facilitated by the Cherry Hills Village Police Department. It is important to remember that the following items are not accepted during these take back events.

## THE ITEMS ARE AS FOLLOWS:

- Needles & Sharps
- Mercury (thermometers)
- Oxygen Containers
- Chemotherapy/Radioactive Substances
- Pressurized Canisters
- Illicit Drugs

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines—flushing them down the toilet or throwing them in the trash—both pose potential safety and health hazards.

## Are you planning A SPECIAL EVENT?

**T**he Cherry Hills Village Police Department would like to encourage residents that are planning a special event like a graduation, party or any other large gathering to contact them at least a week before the event to advise the best course of action for parking and noise issues. The non-emergency Police Department phone number is (303) 761-8711 Monday-Friday from 8:00 a.m. to 4:30 p.m.

If you are planning to hold a larger event such as a block party, festival or other planned group activity that could require a **SPECIAL EVENT PERMIT**, you will need to contact the Police Department at least two months in advance of the event. Events or organized activities that involve street closures, held in a City owned park or trail or include event components requiring the coordination of a number of city departments are reviewed through the citywide special event permit process.
