## DOG LICENSE RENEWAL REGISTER AND PAY ONLINE....IT'S QUICK AND EASY

**T**he Cherry Hills Village Municipal Code requires every resident that owns a dog six months of age or older to obtain a City dog license (City Code section 7-5-310). Licenses are valid for the calendar year and must be renewed annually. Dogs are required to wear the license any time they are off of their own property and a rabies vaccination is required to obtain the license. These licenses help reunite lost dogs with their owners, allow Animal Control officers to regulate dangerous dogs and encourage dog owners to vaccinate their dogs against rabies. Residents can obtain a dog license online at [www.cherryhillsvillage.com](http://www.cherryhillsvillage.com); the cost is \$10.00 for every dog over six months of age, per year. Click the button on the right that says “Pay and Register Online” and select the Dog License link to complete the dog license application. Once the dogs have been registered and the payment has been processed, the Cherry Hills Village Police Department will mail the tag to the address that was provided. Dog licenses are also available in person at the

## JANUARY 2018 MAYOR MUSINGS

I recently discovered that our Village has an emergency call system through Arapahoe County; this system is referred to as **ARAPALERT**. In this issue of the Crier are instructions for signing up and there is no cost to you.



It may appear to you that this is a waste of time. What could possibly happen that would necessitate the Village contacting you? For starters, an emergency situation in which the Police Department needs to contact residents. Hopefully, our community will never face this type of emergency, but the Police Department may want to contact those nearby to have folks stay in their homes and lock the doors or evacuate; depending on the situation. As curious humans, especially children, we are inclined to go to where the “action is” to see what is happening, rather than take precautions. An emergency call from the Village could save lives by keeping all of your family safe.

Another emergency may be severe weather situations. A tornado has not touched down in Cherry Hills Village during recent memory, but we have had several close calls over the years. Freak weather events are becoming the norm, not the exception. Fire station sirens cannot be heard in all parts of the Village and may not be heard in the middle of the night if people are asleep.

Lastly, along these same lines, it is important that you get to know your neighbors. If there is an emergency, an elderly couple or children staying at home one afternoon may not react appropriately when faced with an emergency. A quick call by you after receiving a call from the Village, to assure that our vulnerable citizens are aware of the emergency and are okay, will be welcomed by all.

We are a small and quiet community. We should not let the stresses of our everyday lives overcome what is most important.... each other. Oh, and Happy New Year!

# SIGN-UP FOR **ARAPALERT** ON THE CITY'S WEBSITE

Residents can now sign up for ARAPALERT (Arapahoe County's Emergency Notification System) by going to [www.cherryhillsvillage.com](http://www.cherryhillsvillage.com) and clicking the link under Village News Highlights. When Arapahoe County issues a notification about a potential safety hazard, residents that signed up to receive notifications, will receive a message on the voice or text communication methods that were registered. This service allows residents to opt-in to receive notifications via phone calls, text messaging, e-mail and more based on specific locations such as home, workplace, school, etc (home land lines have already been included into this program). The system will be used to send out notifications regarding imminent threats to health and safety, as well as informational notifications that impact locations or work environments. Administrators will also send notifications regarding severe weather, flooding, gas leaks, police activity, unexpected road closures, missing persons and more.




## FINAL RECREATION REIMBURSEMENT REMINDER

There will be no exceptions to the January 16th deadline so residents are strongly encouraged to submit all receipts early.

# HAZARDOUS WASTE COLLECTION PROGRAM

**D**id you know the City has a Hazardous Waste Collection Program through Waste Management? This program assists residents with the disposal of household hazardous chemicals even if Waste Management is not your trash service provider. Their hours are Monday-Friday 5 a.m. to 5 p.m. PST.

WM At Your Door will explain to you a number of hazardous waste pick-up options for you to consider and will help you decide which is the most economical for you. The total cost for these services range from \$88.00 to \$109.00. Residents are required to pay a co-payment in the amount of \$20.00 upon pick-up and the City will cover up to a maximum of \$89.00 per household, per year. If you have more hazardous material than can be picked up through this option, the City will not be responsible for the larger cost of such services. You can have WM At Your Door pick up any additional hazardous waste you may have, but please keep in mind that these services must be paid for in advance by you.

The program's budget is limited and this year's program will continue only while funds are available so please be conservative. The City encourages residents to work together to combine pick-ups in an effort to maximize the program's funds as you may only use the service once per year.

# NEW DENVER WATER RATES WILL BECOME EFFECTIVE IN MARCH 2018

**I**n November, the Denver Board of Water Commissioners adopted a rate change that will help fund projects such as the new, state of the art water treatment plant, the installation of a new 8.5 mile water pipeline that will replace two pipelines that were built in the 1930s and 1950s and expanding the Gross Reservoir to provide a more reliable future water supply.

The Denver Water 5-year plan

outlined 143 projects for a total cost of \$1.25 billion.

The City of Cherry Hills Village has a total service agreement with Denver Water. According to Denver Water's website, in 2018 a typical customer who uses 84,000 gallons of water (under the total service agreement rate structure) will pay about \$547 more than in 2017. All individual water bills will depend on how much water each household uses.

The map to the right depicts the different rate structures and each tier within those rate structures.

Annual fixed charges:  \$42.36

Beginning March 1, 2018, fixed monthly charges rise from \$11.86 to \$15.39 per month, for both Denver and suburban residents who have a  $\frac{3}{4}$ -inch meter. That's about 95 percent of all residential customers.

# ANNUAL & FALSE ALARM PERMITS

The 2018 alarm permit invoices will be mailed towards the end of January. All alarm permits can be paid on the City's website at [www.cherryhillsvillage.com](http://www.cherryhillsvillage.com) using a checking account or any type of credit card. Click on the "Pay & Register Online" button to the right and select the Sewer or Security Alarm Invoice link. Instructions for paying the permit will also be printed on the invoice. If you have set-up your Xpress Bill Pay account as an "auto pay account," you will receive a notification that an invoice is ready, but it will automatically debit the payment type that was originally attached the account. Security alarm systems can help prevent burglaries; however, false alarms divert police resources from other important duties. Most false alarms can be prevented through both the proper maintenance and careful operation of the alarm system. In order to promote the responsible usage of alarm systems, the City of Cherry Hills Village Municipal Code (Chapter 6, Article IV) regulates the operation of security alarm systems. The key provisions of the Code are as follows:

- An annual security alarm permit is required to use a security alarm system. The fee for this permit is \$25.00.
- The City Code establishes the following false alarm response service charges:

## RESPONSE CHARGES ARE PER CALENDAR YEAR

**First Response** – No Charge

**Second Response** – No Charge

**Third Response** - \$100.00

**Fourth and Subsequent Responses** - \$200.00 each response

- It is unlawful for an alarm to be in use without a valid permit. Violation of the City Code could result in the user being cited into Cherry Hills Village Municipal Court.
