## PLANS FOR JOHN MEADE PARK

**W**ith construction of the new Public Works Facility completed and new City Hall underway, we're gearing up for our third major project: John Meade Park. City Council reviewed the 95% construction documents for the park at the May 15th meeting. The design is based on feedback from residents, gathered through three years of community meetings and surveys. Staff and the Parks, Trails, and Recreation Commission worked intensively with the consultant, Mundus Bishop, to ensure the new park is one that residents will enjoy.

The center of the park features a picnic shelter with seating and restrooms. This structure includes water fountains and a wash station to rinse off muddy hands, feet, or paws. Solar paneling on the roof will help offset energy costs. The adjacent playground contains natural play

features like logs and boulders, as well as large hammocks for kids and families to enjoy. A “shaky-bridge” leads from the playground to an observation tower overlooking the wetlands.

The lawn area gently slopes down to the wetlands, which will be graded and replanted with a diverse group of plants. This creates an even healthier habitat for animals and improves water quality. A boardwalk will bring park users out into the wetlands; a net across one corner will allow kids to climb out and look down into the water. An area of seeded concrete at the edge of the wetlands will give park users access to a few inches of water for splashing. Fishing piers at each pond will give better access to anglers of all ages – we already see them every day during nice weather and hope the piers bring even more families out!

Across Meade Lane, Alan Hutto Memorial Commons will still feature a lasso-shaped path, with a small amphitheater created by a gently terraced grass area. It will be surrounded by trees and taller grasses to enclose visitors into the space. The only lighting in the park will be safety lighting on the shelter – staff will have the ability to add temporary pathway lighting for special events.

Construction is planned to begin on the park in May 2019. The park shelter will be located where the temporary City Hall stands right now, so staff must move to the new building before that construction can take place. Staff and the Parks, Trails, and Recreation Commission are excited about the new plans, and we hope residents are too. **September 4, 2018** Draw lots for candidate order on ballot; Last regular Council meeting to add ballot issues or measures; Last regular Council meeting to cancel the election

**October 15, 2018** Ballots mailed to all registered voters; Ballot drop-off locations and Voter Service Centers open

### January 1, 2019 Organizational Meeting


– Newly elected officials are sworn in and take office – Meeting will need to be rescheduled due to the holiday

- *At least 21 years old*

- *Resident of the district the candidate wants to represent.*

Any person elected as a City Council member must continue to live within the district for which he or she was elected throughout the term of office. The Mayor need only continue to live within the City.



**“SEMIRURAL”**  
which is the  
Cherry Hills  
Village mantra,  
is a simple concept  
and we are all in  
agreement as to what it  
means, or are we?

**A**s we approach the time to update our Master Plan, it would be great if folks thought about what semirural means to them. To assist in this exercise, let's look at a bit of our history.

When the Village was first incorporated, there were large swaths of undeveloped agricultural land both in the Village and along our southern border. The Collins dictionary definition of “partly rural: between rural and urban; somewhat but not wholly characteristic of rural areas” was an apt description of our community. That is no longer the case. With the passage of time our borders have seen both increased suburban and urban development, with more to come. Additionally within the Village, there have been a variety of developments, some more urban in nature than others.

These changing times require different definitions. Two definitions that may apply are “somewhat rural” or “a location that is sort-of-country.” Many articles use semirural and semi-urban interchangeably.

I do not expect our community to come to complete agreement as to what constitutes somewhat rural or sort-of-country, but it would be helpful if we could start the discussion. As you walk or ride around the Village, think about what you value and where it is located. Would you describe your neighborhood as semirural? If so,



what makes it semirural? If your neighborhood is more suburban, are there elements that you would change? Do you prefer a semirural feel for our parks and trails, but not neighborhoods? Is preservation of wildlife and wildlife habitats important to you?

For example, I think the neighborhood in which I reside is semirural. There are dirt roads, horses and large lots, with natural grasses. Coyotes, foxes, raccoons, Canadian geese, great horned owls and hawks frequent our yards. As with most things, there is a downside. Cars are always dusty. Mice and rabbits, necessary for feeding predators, munch their way through gardens. The Canadian geese hiss at intruders and never clean up after themselves, regardless of how politely they are asked.

I have heard from residents over the years that semirural is a fiction in Cherry Hills Village and it should be set aside. I believe that is a minority viewpoint, but it is important that Villagers take a serious look at what elements of semirural they value so that our Master Plan and ordinances can be designed to preserve those characteristics in a rapidly changing local and global environment.

On another subject, several residents have noticed increased low flying private jets over the Village. I spoke with Centennial Airport and in order for Centennial Airport to respond, I need residents to keep a diary of the date and time of these flights. If you will forward this information to me, along with your name and address, I will consolidate it and submit it to the appropriate powers that be at Centennial Airport. # CITY COMMISSION & COMMITTEE VACANCIES

The City is currently accepting applications for the Planning and Zoning Commission (P&Z) and the Quincy Farm Committee (QFC).

The P&Z reviews all subdivision applications, rezoning requests, floodplain modifications and other development applications submitted to the City, and provide a recommendation to the City Council on those applications. The P&Z is also responsible for the preparation of the City's Master Plan and makes recommendations to the City Council on updates to the Master Plan. Currently, the Planning & Zoning Commission meet on the second Tuesday of every month at 6:30pm in the Community Room of the Joint Public Safety Facility (located at 2460 East Quincy Avenue).

Quincy Farm is the 17.5-acre property that was donated to the City by Catherine Anderson for preservation and education about nature and history. Committee members provide recommendations about the future of the property and are currently developing a long-term Master Plan for Quincy Farm. The QFC meets on the third Tuesday of every month from 8:15am-10am at the Farm. A background or interest in historic preservation/planning, agriculture, nature or art education would be especially valuable.

# MANAGING JAPANESE BEETLE

**J**apanese beetles appeared in the U.S. in the early 1900's, mostly staying east of the Mississippi. Approximately 10 years ago, the first confirmed sighting of the beetle occurred in Colorado. Japanese beetles can cause substantial plant damage when they fly in June and July frustrating homeowners.

Adult beetles (see photo) feed on leaves and flowers. They are particularly fond of roses, grapes, lindens, beans, crabapple, raspberry and Virginia creeper to name a few. After eating a leaf, a skeletal-like appearance remains. The larval form of the beetle is a white grub. The grub lives in the soil and feeds on turf roots.

## THREE METHODS ARE AVAILABLE FOR HELPING TO MANAGE BEETLES: traps, natural controls and pesticides.

None of these methods are foolproof, and each has its pros and cons. In locations where beetles are well established, scientists believe that the beetle cannot be eradicated.

### 1 JAPANESE BEETLE TRAPS

Japanese beetle traps capture copious quantities of insects, but they make an insignificant dent in the overall population. Consequently, traps do not reduce the damage caused by beetles. Because traps work by luring beetles to a specific area, the beetle population increases in that area and can result in increased damage.

### 2 NATURAL & BIOLOGIC CONTROLS

Natural controls include depriving beetle eggs and young larvae of water, handpicking beetles, parasitic insects and a bacterium which causes a beetle disease.

Newly hatched beetle eggs and young larvae are susceptible to reductions in turf moisture. By depriving the top few inches of soil water during the early larval period (July – early August), death to beetle eggs and larvae will result. This approach requires preplanning in the spring by modifying your irrigation practices. A second natural option for management is handpicking the beetles off plants where there are small, contained infestations. The beetles move slowly and can be nudged into a tub of water, bag or similar receptacle. Dispose of them after collection.

Introducing insect parasitic nematodes into the soil can help control beetle larva thereby reducing the number of adult beetles. Insect parasitic nematodes are insects which feed on other insects. Applications are made by drenching the soil when the larva are young. Nematodes in the genus *Heterorhabditis* are used.

**Dr. Whitney Cranshaw** from CSU is working to establish a comprehensive biological control program for Japanese beetles in Colorado. Biological control programs use natural enemies of pests, like predators, pathogens, and parasites, to control populations. One of the sites where this work is taking place is Quincy Farm. Dr. Cranshaw is introducing a pathogen (*Ovavesicula popilliae*) and a tachinid fly (*Istocheta aldrichi*) that are each capable of killing beetles. He will monitor the numbers of Japanese beetles across different sites to determine the effectiveness of these biological controls.

### 3 INSECTICIDES

A variety of insecticides can be used for control of adult beetles once they are flying (mid-June – July). The decision to use any insecticidal product should be weighed carefully because insecticides may harm other beneficial insects and pollinators such as native bees and honeybees. A couple of insecticides do not have restrictions for use on plants in bloom because they have very little, if any, toxicity to bees. These include *Bacillus thuringiensis* var. *galleriae* (beetleJUS, beetleGONE!) and *chlorantraniliprole* (Acelepryn).
