

SCULPTURE LOAN BY ARTIST JAMES SURLS

Since its inception in 2011, the Art Commission (CHVAC) has solicited loans of sculpture from artists for display in the City. "The Cherry Hills Village Art Commission would like to provide more access to great art in our community," states Ann Columbus, CHVAC Chair. "Loan programs can help us do that with very little risk." Loan periods are typically for at least two years. The City normally pays the artist a stipend for the loan of the artwork.

The CHVAC is recommending that the City enter into an agreement for the two year loan of Big Bronze Walking Eye Flower (2009) by world-famous sculptor James Surl

(jamescurls.com). "James is a very well-respected artist who lives and works in Colorado. We are so thrilled to have an opportunity to exhibit his work here in Cherry Hills Village," states Columbus.

The CHVAC believes that the small piece of land owned by the City on the northwest corner of Quincy

Avenue and University Boulevard may be an ideal location for this sculpture during its loan period.

The CHVAC will present their recommendation to the Parks, Trails and Recreation Commission and to the City Council for approval.



Concerned residents have asked for an update on the FAA's implementation of NextGen, especially in light of the delay in the public meeting with Representative DeGette, which was scheduled for March 23, 2018.

HERE IS SOME OF THE SALIENT INFORMATION:

1. On August 29, 2017 the United States Court of Appeals filed its decision, finding for the City of Phoenix against the FAA. Phoenix argued that the FAA's approval of the new flight routes was arbitrary and capricious and violated several Federal Acts. I have since been told that the FAA is negotiating with the City of Phoenix regarding dispersal of flight paths, rather than going through the NextGen approval processes it was found to have violated.

2. Last November many of you were notified that representatives of the FAA would be meeting with the Centennial Airport Noise Roundtable to discuss with the public the implementation of NextGen as it impacts our communities in Arapahoe County and the status of the EA (environmental assessment). As most of you know, the FAA cancelled its appearance the day prior to the event, without explanation.

3. In late January and early February, I met with the Chiefs of Staff of Representative Diana DeGette's office



and Cory Gardner's office to explain our community's concerns regarding the FAA and NextGen. I also expressed our frustration that many years ago DIA was located far east of any populated areas expressly for the purpose of reducing noise impact on residential communities. Currently it

appears that this well thought out plan was being disregarded by the FAA in favor of routes that saved fuel for commercial airlines by flying directly over areas of the metropolitan community that had never experienced significant air traffic noise in the past. To add insult to injury the argument put forth by the FAA was that there would be a net decrease in noise, without clarifying that the beneficiaries of this "net decrease" would be the agricultural fields, solar farms and cattle located to the east of DIA.

4. Diana DeGette's office was to give our community an update on the FAA and NextGen at our March meeting, which she had to cancel in order to attend a funeral. It is now rescheduled to June 15, 2018 and I urge you to attend.

5. Cory Gardner wrote a letter, dated February 16, 2018, to the Acting Administrator of the FAA asking that the FAA "immediately host a public meeting to meet directly with local communities to receive public input regarding the implementation of the Next Generation Air Transportation System (NextGen) for the Denver Metroplex." A copy of this letter can be found on the Village website. I am sure that you are not surprised to hear that no public meeting has been scheduled.

6. On April 2, 2018 I received an email from Council member Katy Brown who

serves on the Centennial Airport Noise Roundtable. She informed me that she had received an email from Robert Olslagers, the Executive Director of Centennial Airport, that in Denver the FAA is shifting from the NextGen process to scalable "PBN projects implemented through a single site process." The FAA's stated position was that it is "taking a pause" and will have more information to share in June of 2018.

7. The US Department of Transportation has a national transportation noise map available for public view. This map shows that Cherry Hills Village and much of Denver, Englewood, Lakewood and Golden currently experience very little aviation or highway noise. Where are we in this process, now that the FAA is going to create scalable PBN projects? *Heck if I know, this is like whack-a-mole.* As soon as I think I have a handle on how to properly make known our objections, the game changes. I think the FAA is trying to accomplish through the PBN process what it feared it could not accomplish with the existing NextGen process. First because of the Court decision in Phoenix, and second because we did a good job of making the FAA know that we, as a community, were not going to let this slide.

By the time you read this, I may have a better understanding of the impact of scalable PBN projects.

LAWN, TREE & SHRUBS

Maintenance: Myths & Facts

Some landscape maintenance companies tend to over propose what is needed to maintain healthy yards. Following are useful tips for making good decisions about your trees, shrubs and lawns.

TREES & SHRUBS: IS FERTILIZER NEEDED?

Native trees and shrubs do not, as a rule, need fertilizer. Adequate nutrients are found in our soil to support healthy tree and shrub growth. These nutrients are supplemented by the decaying needles, leaves and twigs which gather at the base of tree. Once this debris decomposes, it transforms into a rich fertilizer providing additional nitrogen and nutrients to trees and shrubs.

LAWNS: A RECOMMENDED FERTILIZER SCHEDULED

Lawn contracts often propose 4 – 6 fertilizations per year. What is really

needed is 2 – 3 fertilizations a year. Fall is the best time to fertilize a lawn. Fertilizing in the Fall helps turf prepare for winter and creates a green lawn in the Spring. Best times to fertilize lawns are in early June as a first application, possibly in late August after the Summer heat has passed and in late Fall (October or November). Lawns need only a nitrogen fertilizer. Many fertilizers include nitrogen, potassium and phosphorus.

Potassium and phosphorus will not harm your lawn, but they add unnecessary cost and can also

When reading through your landscape contracts for 2018, hopefully these tips will provide useful know how to make better decisions for your yard, your pocketbook and the environment.

CHOCOLATE FLOWER

COLORADO *Bee Swarm* HOTLINE

In Colorado, bees swarm from approximately April 1st until the end of the summer with May and June being the busiest months. A swarm occurs when a hive, wild or managed, becomes overcrowded and the old queen and approximately half of the original hive leaves to find a new home. Swarms are generally quite docile, but they can be disconcerting due to the sheer number of bees within the swarm. It is still a good idea to keep your distance so as not to make the bees feel threatened.

If you see a swarm instead of spraying it with insecticides or water, you can call the new toll-free bee swarm hotline. Volunteer beekeepers throughout the state can be dispatched to collect the bees and transfer them to a new home.

CENTENNIAL AIRPORT NOISE ROUNDTABLE *Implements Tools to Address Community Concerns*

Working to reduce noise impact to surrounding residents

The Centennial Airport Community Noise Roundtable (CACNR), which is comprised of elected officials, airport staff and community members, is working to reduce noise impacts to surrounding communities by providing easy-to-use tools to help residents report any noise issues openly and effectively.

These tools include a recently-launched website, an online reporting system and a Noise Hotline.

feedback,” said CACNR Chairman Brad Pierce. “We are here to support our communities and collaborate with the other partners, which include airport users, the airport Board, and the FAA, to adequately address any noise issues that may arise.”

The website, www.centennialairportnoise.com, provides information on noise abatement outreach to pilots, noise monitors that measure and report decibel levels of overhead aircraft, tutorials and FAQs.

To track overhead aircraft activity and/or report noise incidents, residents can use WebTrak (webtrak.bksv.com/apa) which can be found in the Report Noise section of the website.

The **Noise Hotline (303-790-4709)** is another option for community members to call with any noise concerns.
