The purpose of the Lakota Ride is to create positive, healthy and long-term relationships between the Lakota People and those seeking to better understand the Lakota culture, history, and way of life, and to raise critically needed funds for projects underway on the Pine Ridge Indian reservation.

The riders will arrive at John Meade Park in Cherry Hills Village on the afternoon of Sunday, July 14th. (The estimated arrival time is 4pm, but since participants include horses and young people, some flexibility is understandable!) Traditional Lakota drummers will welcome the riders as they arrive. # MAYOR'S REPORT

## Tribute to Judge Richard P. Matsch

I write this month to mark the death on May 28, 2019 of United States District Judge Richard Paul Matsch, one of the Village's most distinguished residents. Judge Matsch and his wife Elizabeth ("Libby") raised five children in Cherry Hills Village before moving to a 30-acre horse property in Boulder County a few years ago. Libby Matsch (nee Murdock), who passed in 2017, served on the Cherry Hills Village Parks and Trails Committee. Their children enjoyed the Village Club and rode horses on the High Line Canal. Judge Matsch is survived by daughters Katherine Daley, Molly Briggs, and Marti Matsch; a son, Dan; and six grandchildren.

Judge Matsch believed that judiciary's most important role was to protect citizens from governmental abuses of power. He held attorneys, especially government attorneys, to the highest possible standard of preparation and performance. It was typical for attorneys scheduled for a Judge Matsch hearing or trial to double or their triple their preparation efforts.

As a former federal prosecutor and city attorney, Judge Matsch understood the importance of the role of the FBI and police in our justice system. He insisted that law enforcement personnel always abide by the Constitution, perform their jobs with integrity, and testify honestly.

On the bankruptcy bench Judge Matsch instituted night court, allowing many debtors to attend their required court hearings without missing work. The extended court hours were an early sign of Judge Matsch's view that government should make accommodations to serve and protect its citizens.

After elevation to the district court, Judge Matsch was zealous in protecting the Constitutional rights of accused criminals. Defense attorneys rejoiced when their case was assigned to him because they



knew Judge Matsch would protect their client's rights, no matter how unpopular his ruling might be to the public.

Prosecutors also preferred Judge Matsch because they knew his rulings would be quick, decisive, and invariably correct. Judge Matsch never allowed his courtroom to become performance theatre.

Even criminal defendants convicted and sentenced in his courtroom expressed respect and appreciation for Judge Matsch, who would periodically visit the federal penitentiary.

For civil disputes Judge Matsch believed that federal courts exist primarily to enforce federal law (such as patents, trademark, and antitrust). But for those state-law contract and negligence cases that came to him under diversity jurisdiction, he applied the same attention and urgency to resolve issues in a just, speedy, and cost effective manner. He often reminded parties that although litigation and jury trials are imperfect, they are far better alternatives than blood feuds and street fighting.

A brief sample of his cases gives some sense of the profound influence Judge Matsch had on our state and nation. He presided over the conviction of Timothy McVeigh and Terry Nichols in the Oklahoma City bombing trial; tried and sentenced two members of The Order who murdered talk show host Alan Berg; ruled that Colorado's sex-offender registry violated the due-process rights of three plaintiffs; sentenced the forestry worker who started the Haymon fire; ruled for injured plaintiffs in the first Dalkon Shield IUD case; presided over the sexual-assault lawsuit filed against Kobe Bryant; oversaw the desegregation of Denver Public Schools and entered the final unification order ending the Keyes case; ordered the removal of the nativity scene from the Denver City and County Building; ruled that the Ku Klux Klan could speak at the state Capitol steps on Martin Luther King Day; and declared that the First Amendment protected adult bookstores. His decisions were

often appealed to the Tenth Circuit and United States Supreme Court, but seldom reversed.

Two prominent portraits in Judge Matsch's chambers reflected his judicial temperament. The first was a large picture of a wolverine, the mascot of his beloved University of Michigan and its football team. On football Fridays he usually sported a maize and blue tie discreetly covered by his black robe. The second was a portrait of General George S. Patton, his inspiration for the leadership and relentless doggedness required by litigation and trial.

Judge Matsch, who always wore cowboy boots in chambers, loved the Old West and its association with freedom and individual liberty. He continued to conduct trials and manage a full calendar and heavy caseload until his death at age 88.

Judge Matsch made enormous personal sacrifices when he accepted the appointment to the bench. He believed that judges should refrain from any public appearances and comments that might suggest bias or reflect poorly on the judiciary. As a federal judge he assumed a very private persona and avoided almost all public events and extra-judicial communications. The nature and extent of his sacrifice could be truly appreciated only by those of us who were fortunate to know that Judge Matsch was, in private and in chambers, a brilliant, engaging, funny, and delightful raconteur.

Judge Matsch was an extraordinary American who made extraordinary contributions to our nation by protecting the Constitution and rule of law. He was consistently ranked by trial lawyers as one of the best and brightest federal trial judges in the United States. That he did so under the radar of his neighbors and the press is a testament to his personal integrity and respect for the Constitution. As befits his judicial role and demeanor, Judge Matsch requested no public ceremony for his funeral.
