CITY FLOODPLAIN DEVELOPMENT REGULATIONS AND NATIONAL FLOOD INSURANCE PROGRAM REQUIREMENTS

The City has participated in the National Flood Insurance Program (NFIP) Community Rating System (CRS) since 1978, making residents eligible for federal backed flood insurance and flood insurance discounts. In October 2017, the City was designated a Class 7 through the NFIP Community Rating System. While there are many benefits to CRS class designations, the most significant is lowered cost flood insurance rates. As a Class 7 community, residents of Cherry Hills Village are eligible for a 15% NFIP policy premium discount. CRS Classes are rated from 10-1 with a Class 1 being the highest level of floodplain management.

In order to participate in this discount program, the City has adopted minimum standards and regulations for floodplain development, conducts regular drainage way maintenance and provides community outreach on floodplain issues. Cherry Hills Village is then rated on a 'credit point system' in order to determine

eligibility for lowering the CRS Class. The City continues to work towards a lower rating and continues to expand our best management practices in dealing with floodplains. There are approximately 200 properties in the city limits that intersect a floodplain designated on the FEMA Flood Insurance Rate Maps (FIRMs) adopted by the City. If the residential structure on the property is located in a floodplain, flood insurance will be required by most mortgage lenders.

In Cherry Hills Village, most development in the floodplain is prohibited unless a special development permit is granted by City Council. If you want to know if your property is in the designated floodplain or for more information on floodplain development permit requirements, you can contact the Cherry Hills Village Community Development Department at (303) 783-2721 or stop by the Village Center at 2450 E. Quincy Avenue. The Community Development Department maintains records of all current and past adopted floodplain maps and Flood Hazard Area Delineation (FHAD) areas, flood depth data for most currently mapped areas of the City and FEMA issued elevation certificates.

HELPFUL TIPS...

The following are helpful tips for residents who live in flood prone areas:

- Know the extent and nature of the flood hazard in your area.
- Plan escape routes to high ground.
- Buy flood insurance for your property.
- During times of heavy rainfall watch the level of water in the drainage way and stay tuned to radio or television for possible flood warnings.
- Evacuate the flood hazard area in times of an impending flood.

POLICE EMAIL NOTIFICATIONS

One of the features of the City's website is an integrated email notification system, called **Notify Me**. With Notify Me residents can be more specific in choosing which email notifications they would like to receive. If you only want to receive notification about important Police Department alerts, you can sign up for Police Department alerts only. Do you

want to read the latest issue of the Village Crier online instead of receiving a paper copy? Only interested in receiving Board and Commission minutes and agendas?

Notify Me allows you to customize the types of notifications you receive from the City and the Police Department so you only receive the emails that are most important to you. **Notify Me** is also the fastest way for City staff to notify residents of important City information, events and emergency alerts.

TO SIGN UP FOR Notify Me, you

can visit the City's website at www.cherryhillsvillage.com. Click the link in the middle of the home page that says "Email Notifications". Once you click the link, you can enter your email address and select any type of notification you would like to receive via email (the website can send text messages too).

Alternative ways to stay informed of City events, meetings, emergency notifications and other important information is to follow the City of Cherry Hills Village on Nextdoor or like the City's page on Facebook.

MAYOR'S REPORT

The first weeks of the Council have been filled with many meeting with citizens; introductions to other metropolitan Mayors, outside agencies and organizations; and meeting with leaders of our Village's schools, clubs, and churches. Here's an update on Council actions and several issues of concern to our Village:

Highline Canal Hampden Underpass. In 2016 Arapahoe County, the City and County of Denver, and Cherry Hills Village agreed to partner to enhance safety and connectivity of the High Line Canal trail. On January 15, 2019, the City Council passed Resolution 3 approving a negotiated easement with Denver First Church that was the final action needed so that final engineering could be completed. The largest part of the project is the Colorado Boulevard and Hampden Underpasses that will be paid for with \$4,050,000 from the federal Transportation Improvement Program ("TIP"); \$1,450,000 from Arapahoe County; \$450,000 from Denver, and \$450,000 from Cherry Hills Village. The second part of the project is the High Canal pedestrian bridge and ramp to the Hampden Underpass, which be paid by Arapahoe County (\$265,000) and Cherry Hills Village (\$257,215). Construction and traffic delays are likely to begin in 2020.

Cantitoe Litigation. On January 16, 2019, the Colorado Court of Appeals entered a final order concluding Maven Properties LLC v. City of Cherry Hills Village (17CV30551). Maven Properties sought a declaration that certain bridal paths in the Cantitoe subdivision are private easements reserved solely for the use of residents of the Cantitoe neighborhood. The Village counterclaimed seeking a declaration that the challenged easements were public



bridal paths. Following discovery and cross-motions for summary judgment, on August 16, 2018 Judge Weishaupl ruled that the City failed to show an unequivocal intention by the predecessors-in-interest to dedicate the challenged easements to the Village. The parties negotiated a settlement agreement incorporating Judge Weishaupl's ruling and the civil action was dismissed.

MetroPlex-Denver/NextGen. Sixth District Congressional Representative Jason Crow, a former Village resident, spoke at the January meeting of Arapahoe County Mayors and City Managers about the FAA's Next Generation Air Transportation System (NextGen). NextGen could result in changes of flight patterns for DIA that would require General Aviation traffic at Centennial Airport traffic to pass over Littleton, Centennial, Lone Tree, Greenwood Village, and Cherry Hills Village. The project will require the FAA to prepare an Environmental Assessment. Representative Crow asked the FFA to hold public workshops in May 2019, and a formal comment period between June and September 2019. I and other Arapahoe County Mayors have also reached out to Congresswoman Diana DeGette and Senators Gardner and Bennett to for support and assuring an open public process that considers the concerns of affected areas.

Colorado General Assembly. This is a busy time for our state Senators and Representatives. Many of the pending bills affect municipalities and are being followed by the Colorado Municipal League. Of some interest to our Village are Senate Bill 103, known as the "lemonade-stand bill" enacts a state law prohibiting municipalities from regulating the sale of goods or services by persons under 18 years of age. SB 103 is co-sponsored by nearly half of the members of the General Assembly,

and depending on final language affect our Village's home business regulations. House Bill 1096 known as the "right-to-rest" law, would among other things, prohibit municipalities from restricting camping or sleeping in public parks or on sidewalks. As I write, however, the sponsors of HB 1096 have suggested that they will withdraw the Bill and watch how Denver's right-to-rest Initiative 300 fares on the May ballot. Also almost certain to pass a bills that allow counties and municipalities to set minimum wages in their jurisdictions, and a bill providing for a state version of the Family and Medical Leave Act which extends coverage to all employers, provides paid benefits, and is funded by a 50-50 "fee" imposed on employers and employees.

I met with Meg Froelich our new Colorado House District 3 Representative. Representative Froelich, served for several years on Greenwood Village City Council and is familiar with our shared ideas about traffic and development. Representative Froelich mentioned her concern over recent teen suicides and is sponsoring a series of mental health presentations in her District. We will partner with Representative Froelich and schedule a day-long presentation and training session in the Village later this spring.

This February Council retired is liaison procedures in which one Council member was assigned to attend Board and Commission meetings. Council will, instead, schedule regular meetings and study sessions with Council and Commissions and Boards throughout the year. Council has also begun to post to the website Council meeting agendas on Wednesday before the every regular Tuesday Council meeting.

Finally, Council Member Randy Weil is recovering from a recent hospital stay. Boosting his recovery and rehabilitation, Randy and his wife Susan recently learned that their daughter, Alexandra, has been selected as the 2018 United States Tennis Association Colorado Female Player of the Year! We look forward to Randy's continued speedy recovery and soon rejoining our regular Council meetings.

PHONE SCAMS – PREDATORS ON THE PHONE

Phone scammers and unsolicited callers usually attempt to obtain your personal information for purposes of identity theft and/or monetary gain. Phone scammers may use tactics such as fear or intimidation. Knowing these tactics and trusting your instincts can help you from becoming a victim of a phone scam.

Most recently, reports have been received of “**SPOOFED**” scam calls allegedly from “Arapahoe County.” The caller ID might show up as “Arapahoe

County Government,” or “Arapahoe County Sheriff’s Office.” If concerned, don’t answer these calls. Instead, let these calls go into your voicemail. Chances are, scam callers will not leave a message. If there is a message, and a specific office is mentioned, verify the phone number before calling back by going to the Arapahoe County website at: <http://www.co.arapahoe.co.us>, or contact Leslie Cannon, Customer Service Representative, Arapahoe County at **303-795-4400**.

Tips to prevent becoming a victim of these scams:

- Do not trust caller ID
- Ask for a phone number to call back – but always look one up yourself
- Know your local agency. Arapahoe County Sheriff’s Office or Cherry Hills Village Police Department will never call people about a warrant or ask for payment to cancel a warrant.
- Do not give them any money, credit card information or gift card information over the phone.
- Just hang up!

KEEP THE VILLAGE TRAILS CLEAR OF WASTE

WE often view someone who doesn't pick up after their dog to be rude or inconsiderate.

Surprisingly, it is estimated that 40% of American dog walkers don't pick up after their dog. The EPA classifies dog poop as an environmental pollutant. It is important that we, as responsible pet owners, pick up after our pups to keep our community healthy, happy and safe. Let's look at solutions to the top 5 dilemmas!

1) Forgot bags at home

Problem: How many times have you been walking your dog and suddenly your dog squats to do his business, and that's when you realize, "I don't have a bag!"

Solution: If you get the newspaper, tie that bright colored bag on your leash the moment you take the newspaper out! Alternatively, purchase a bag holder that clips onto your leash. There are also pet waste stations on our village trails, including the High Line. These stations are equipped with amazing "poop bags" and a trash canister too!

2) Can't see at night

Problem: You walk your dog one last time before bedtime. He does his business but the darkness makes it impossible to see!

Solution: Flashlight to the rescue! Honestly, if you can't see your dog's poop, a car can't see you and your dog! Carry a flashlight for safety's sake (or attach one to your dog's collar) and if you forget, your phone has one! This way, you can see not only what you need to pick up but cars are alerted to you both!

3) Don't want to carry a gross bag

Problem: This is probably the most common reason why people don't pick up after their dogs. It's a dirty job, but somebody's gotta do it.

Solution: There are many products that attach that stinky bag to the leash like the "Poopy Carrier," the "H-clip" and the "Fifth Paw". There are also many bag stations with trash cans throughout the village for your convenience!

4) On the run

Problem: Who better for a running companion than "man's best friend"? But then your dog needs to "go". Some joggers choose to bag and leave it with full intention to pick it up on the way back. Unfortunately, they often forget to reclaim it.

Solution: This is probably my number one "pet peeve" (no pun intended!). Besides the solutions listed in #3, there are two more brilliant inventions for people on the go! The Turdle Bag and PoopPac are two clever devices that allow you to remain "hands free" while you continue your run until you can properly dispose of the waste.

5) Thinking dog poop will quickly decompose.

Problem: The common misconception is that poop is natural and should be allowed to simply break down.

Solution: Sadly, this is far from the truth. Dog waste takes months to decompose and is detrimental to the soil. It can contain parasites which are contagious to both humans and other animals.

An average dog produces about 275lbs. of waste per year. Please be responsible owners and clean up after your pets!

Bring your medications for disposal to the Cherry Hills Police Department at 2460 E. Quincy Ave. The service is free and anonymous, no questions asked.

It is important to remember that the following items are **NOT ACCEPTED** during these take back events.

The items are as follows:

- Needles & Sharps
- Mercury (thermometers)
- Oxygen Containers
- Chemotherapy/Radioactive Substances
- Pressurized Canisters
- Illicit Drugs

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs.

Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines—flushing them down the toilet or throwing them in the trash—both pose potential safety and health hazards.
