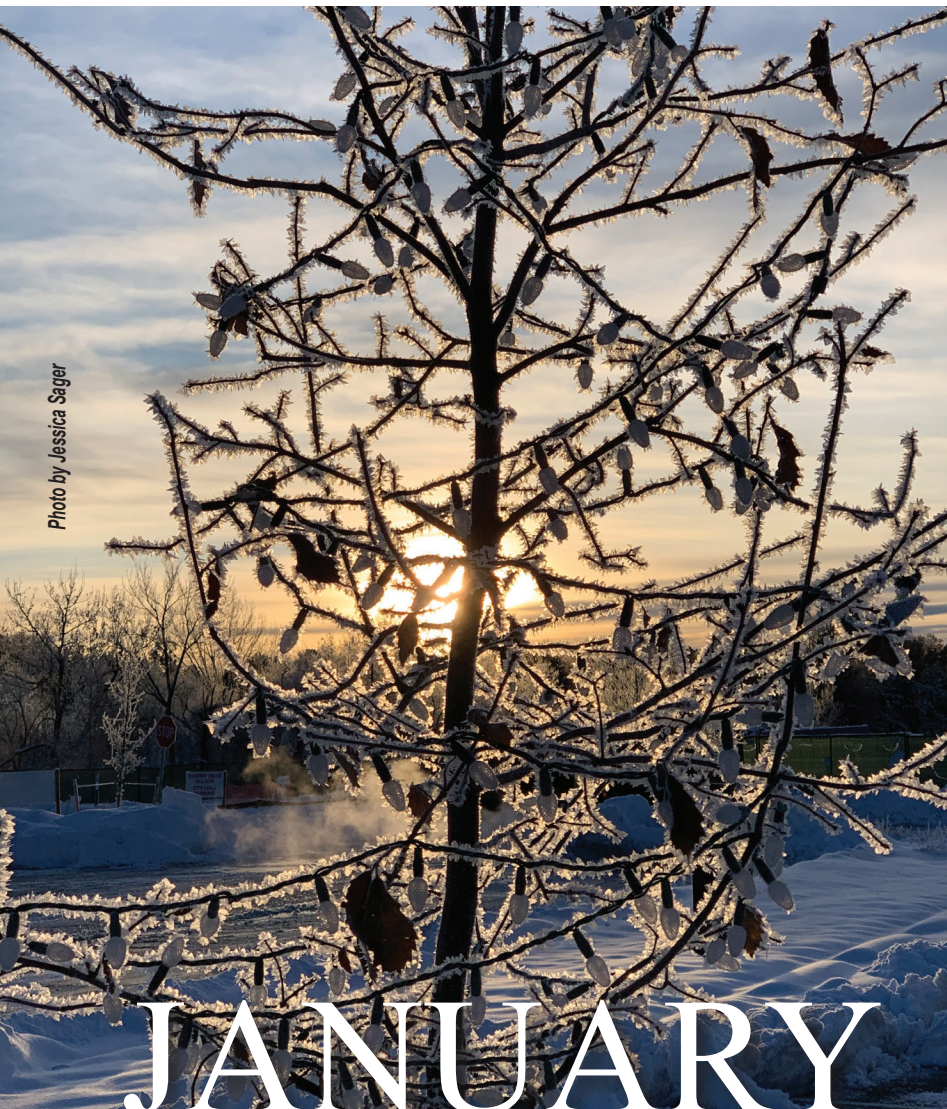

# JANUARY

## INCORPORATION

### *Incorporation Became The Solution*

**I**n the December issue of the Crier, we described how Denver expansion was marching southward in part by annexing western parts of Arapahoe County into its land mass and tax rolls. The October 5, 1944, issue of the Englewood Enterprise noted that as Denver took property off the County's tax rolls, it made the tax burden that much greater on the properties still within the County's boundaries.

The newspaper account levels this charge against Denver: "Denver could ultimately force Arapahoe County taxes up to or beyond those of Denver. This would make later stages of the game much simpler as residents might be forced to seek annexation [into Denver] in self-defense."

The Cherry Hills District Improvement Association, which had established itself in 1939 in order to put forward its own zoning map, could feel Denver breathing down its back. The District Association had invited Kenneth Robinson, an attorney for Arapahoe County, to speak at its February 1944, meeting. Robinson noted the County had already won a temporary injunction against the City and County of Denver prohibiting it from seizing an airport site more than five miles outside its limits, and they were pursuing a permanent injunction as well which Denver would then have the right to appeal.

It was clear that the situation was heating up when a special meeting of the Association was called on October 3, 1944, to hear Arapahoe and Adams County Commissioners and Englewood City Council members. A motion was passed to

form a committee with the power “to take every legal means within its power to stop Denver.”

Even though District members had decided to fight tooth and nail to stop Denver’s southern march gobbling up land in Arapahoe County, they knew it was just a matter of time before Denver got its land for an airport.

In the meantime, CHDIA members had become cognizant of some existing case law in other states where suburbs facing some of the same issues had prevailed by means of an elegant solution. The answer to encroachment

for these suburbs had been incorporation. That, then, allowed them to pass their own ordinances that could protect what they valued most. For the Cherry Hills District, that would include an ordinance to put a height ceiling on how low planes could fly over the city. This would effectively prevent an airport from being built to our immediate south.

A petition to incorporate made the rounds within the District and was then presented to Arapahoe County Court. Judge

Henry M.T. Teller appointed the election commissioners. Not surprisingly, the five commissioners were mostly the wives of CHDIA members.

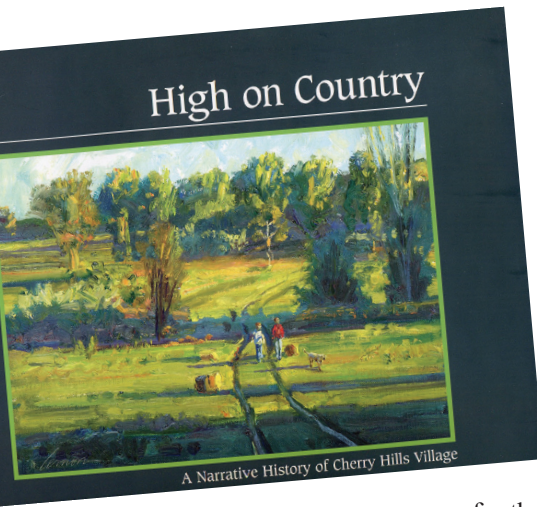
The election for incorporation was held on February 20, 1945, at the Cherry Hills Schoolhouse. Needless to say, the vote to incorporate won the day.

Three months later, another election was held at the Schoolhouse to elect city officials. Because there were no local newspapers, notices for this election had to be posted on various visible structures like telephone poles.

At the Schoolhouse meeting, electors decided on a geographic-based representation for the Village. Villagers divided themselves up according to their geographic districts. These groups then retreated to different corners of the schoolhouse room where they came up with their own nominations for Trustees. To give some idea of the size of Cherry Hills Village at that time, a total of 70 ballots were cast at this gathering.

The first mayor was Joe Little. Little’s characteristic sense of humor came through with the motion that was made to close the nominations immediately after his name, and only his name was put on the ballot. At this, Little piped up, “I’ve been railroaded. . . . You see before you a victim of dirty politics. Of course, I’ll admit I haven’t been elected yet.” Following his statement, he was elected, fair and square. The City’s first trustees included Caldwell Martin, Earl Loser, J.H.K. Martin, Albert Brooks, Paul Spencer, and Edna Catron.

Cherry Hills Village may have been small in size in those days, but it had still been wily and powerful enough to rebuff its giant neighbor to the north.

# SNOW, ICE AND STREET SWEEPING OPERATIONS

**T**he Cherry Hills Village Public Works Department is responsible for snow, ice and sweeping operations of approximately one hundred lane miles of City streets and approximately eight miles of paved trails and sidewalks. The department provides snow removal and sweeping services to all City streets, paved trails and sidewalks on a priority basis. It is the department's goal to have all City streets, paved trails and sidewalks maintained within twelve hours after the snow has stopped falling. This time frame estimate is based on an average snow event of four inches. The department will not plow residential streets for snow events of less than three inches as determined by staff. Sidewalk/paved trail sweeping is done on an as needed basis. When conditions allow, street sweeping and sidewalk/paved trail sweeping operations directly follow any snow and ice control operation where sand is used. Street and sidewalk/paved trail cleaning is provided for community safety, health, environmental and aesthetic purposes.

The Public Works Department utilizes many resources to determine when and how snow and ice control operations should begin. Use of the National Weather Service, local news television, web and phone based applications and the City's

own weather station with a live feed camera are utilized by the Public Works Department to obtain the most current and accurate weather forecast information. Additionally, communication with the Police Department is maintained to ensure prompt response is available for emergency situations.

The City's priority is to keep primary intersections and collector streets safely maintained to permit emergency vehicles to reach all parts of the City without delay and to facilitate resident traffic on those streets. This priority has been determined by the City. These main streets are where traffic numbers and safety demands are the greatest within the community. The second priority is to safely maintain all remaining residential streets. The third priority is to safely maintain all remaining paved trails and sidewalks.

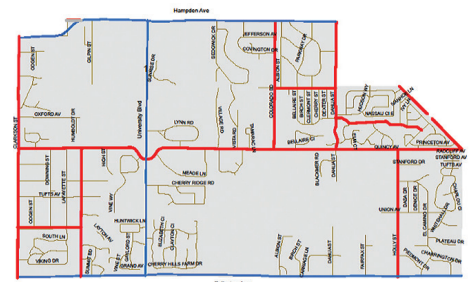
Primary intersections and collector streets will be the first to receive snow and ice control measures. The length and severity of the weather event dictates when the department will start snow and ice control on all secondary streets and paved trails and sidewalks. Typically, this operation begins immediately after the pinnacle of the storm event and the majority of the snow has stopped accumulating. The City is divided into four sections and snow removal and street sweeping operations are performed on a rotating basis. Each section contains approximately the same street lane miles. This rotation is maintained throughout the winter so that all parts of the City have the same opportunity to be maintained first and

no area is always last. Streets are swept in the same priority they are plowed.

The map below illustrates the City limits and the streets maintained by the Cherry Hills Village Public Works department. The red lines show primary intersections and collector streets. These streets and intersections provide emergency vehicle access to all locations of the City during a snowstorm. The blue lines on the map are the streets maintained by the Colorado Department of Transportation. Only during extreme conditions and by the request of the Police Department does the City assist with plowing the streets maintained by CDOT.

**Section 11-1-20** of the Cherry Hills Village Municipal Code requires that residents remove snow and ice from sidewalks on or adjacent to their property within twenty-four hours of accumulation, whether the property is occupied or not.

## DOG LICENSE RENEWAL

REGISTER AND  
PAY ONLINE...  
IT'S QUICK AND EASY

**T**he Cherry Hills Village Municipal Code requires every resident that owns a dog six months of age or older to obtain a City dog license. Licenses are valid for the calendar year and must be renewed annually. Dogs are required to wear the license any time they are off their own property and a rabies vaccination is required to obtain the license. A dog license helps reunite lost dogs with their owners, allow Animal Control officers to regulate dangerous dogs and encourage dog owners to vaccinate their dogs against rabies. Residents can obtain a dog license online at [www.cherryhillsvillage.com](http://www.cherryhillsvillage.com); the cost is **\$10.00 for every dog over six months of age, per year**. Click the button on the right that says "Pay and Register Online" and then click the dog license link to complete the dog license application. Once the dogs have been registered and the payment has been processed, the Cherry Hills Village Police Department will mail the tag(s) to the address that was provided. ## NEW PEDESTRIAN CROSSWALK SIGNS INSTALLED

**A**s your travels through the City take you up or down Holly between Quincy and Belleview, you may notice new pedestrian crosswalk signs that have been installed by the Public Works Department. The two trail crossings have always had painted crosswalks advising drivers that pedestrians may be present. Use of these trails have increased, including children using the crosswalks to get to and from school, so the signs were added to enhance driver awareness of pedestrians in these areas. Please keep in mind that pedestrians must still use caution when crossing in these areas, stop look both ways and make sure it is safe to cross so you can make it to your destination safe and sound.

# MAYOR'S REPORT

*Here is wishing everyone a happy and prosperous 2020! This month's report updates on Belleview Station, the 2020 census, the 2020 General Assembly agenda, and coyotes.*

## ***Belleview Stations and the I-25 Interchange***

Belleview Station is a 51-acre development on the northwest of I-25 and Belleview, located in the City and County of Denver. When completed the mixed-use development will include 1,800 residential units, 2.2 million square feet of office space, 300,000 square feet of retail space, and two hotels. Located on the light rail Belleview stop, construction of this high-density urban center will increase traffic and congestion in surrounding areas of Greenwood and Cherry Hills Villages. Engineering studies estimate that by full build out of Belleview Station in 2040, peak hour traffic flows on Quincy Avenue will increase by 14% and increase on Happy Canyon by 18%.

Immediately south of and adjoining Belleview Station is Greenwood Village and the I-25 interchange. Last year Greenwood Village, CDOT, and others began studying several different technical alternatives for reconstruction and improvement for the interchange. At this time, they are narrowing down the final technical recommendations. Included in these options is a "Split Diamond" configuration as well as a "Single-Point Urban Interchange." The Split Diamond would potentially include new on and off ramps at I-25/Union Boulevard. Cherry Hills Village is working with Greenwood Village and the consultants to schedule a date for them to attend a Council meeting for a question and answer session. At this time, there is no funding for either design option.

## ***2020 Census***

The 2020 census count will soon begin. Forms will be distributed in March; if you receive something that looks like census materials before then, it is not genuine.

The federal census will not ask for birthdates or social security numbers. This year citizens will be able to provide answers to 10 questions through a secure internet website.

Responses will also be accepted by telephone or in person interviews. Counting everyone is important; for every person missed, communities can lose hundreds or thousand dollars in federal funding each year until the next census. Colorado is also poised to gain an additional seat in Congress based on an anticipated substantial increase in Colorado's population.

## ***General Assembly 2020 Agenda***

The new General Assembly session is underway and early agenda items relevant to our Village include transportation, water conservation, and vaping.

**Transportation.** Colorado voters recently rejected several state-wide proposed tax increases to fund highway construction and other transportation projects. Current law allows municipalities, with approval of voters, to create Regional Transportation Authority (RTAs) to finance, construct, operate or maintain regional transportation systems. Legislation now being considered would make it easier for local governments to form RTAs by resolution for specific purposes; tax increases would require approval of voters in the district. For our area, this could allow the Denver Regional Council of Governments (DRCOG) to serve as a taxing entity to finance highway and other transportation improvements. Those opposed to the change express concern that if larger municipalities with a robust tax base (e.g. the metro area) finance their own transportation systems, support for statewide solutions could suffer.

**Water Conservation.** The General Assembly will consider legislation encouraging municipalities to address water conservation in their master planning process and updates. In 2020, the Village will begin a public process to revise and update our Master Comprehensive Plan, which will include



goals and strategies for water conservation.

## **Vaping.**

Greenwood Village and other nearby municipalities require nicotine sellers to be 21 and prohibit sales within 1,000 feet of schools. Possible state-wide legislation is being discussed that could bring uniformity to restrictions on vaping by increasing the minimum age for purchasing nicotine to 21.

## ***Coyotes***

As spring approaches, Village coyotes are finding mates and staking out territory. Coyote sightings were once rare, as the animals were routinely killed by ranchers and harvested by trappers. Coyotes now thrive in our semi-rural environment and have adapted to the schedules and behaviors of residents and their pets. The Village has been advised over the last several decades by Dr. Stewart Breck, working from the USDA National Wildlife Research Center and the Denver Urban Coyote Project. Dr. Beck and his partners recently authored an article published in the Journal Nature. A copy is available on the Village website or can also be found at: <https://www.nature.com/articles/s41598-019-38543-5>. The conclusion of the paper is that urban coyotes are bolder and more exploratory than their rural cousins, and that this behavioral adaption results in more attacks on pets and humans in areas like ours. The Village has a coyote management plan to manage conflicts with coyotes and resolve threats to humans, livestock and pets. # SUSAN COOPER ART SHOW WRAP-UP

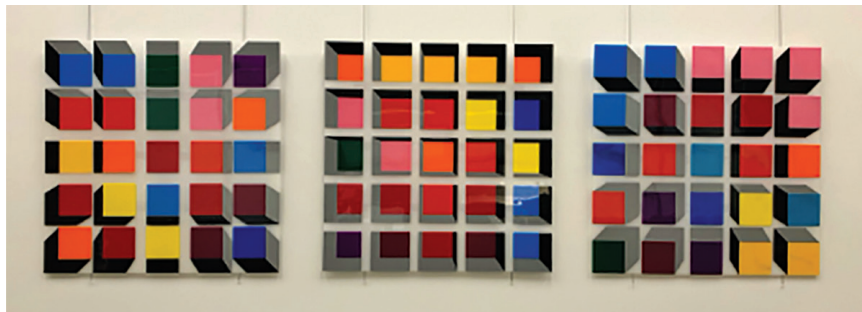

## ANNUAL & FALSE ALARM PERMITS

The Cherry Hills Village Police Department will be mailing security alarm permit invoices towards the end of January. All alarm permits can be paid on the City's website at [www.cherryhillsvillage.com](http://www.cherryhillsvillage.com) using a checking account or any type of credit card. Click on the "Pay & Register Online" button to the right and select the Sewer or Security Alarm Invoice link. Instructions for paying the permit will also be printed on the invoice. If you have set up your Xpress Bill Pay account as an "auto pay account," you will receive a notification that an invoice is ready. Xpress Bill Pay will automatically debit the payment type that was originally attached the account so you will not need to respond to the invoice, it is for informational purposes only. Security alarm systems can help prevent burglaries; however, false alarms divert police resources from other important duties. Most false alarms can be prevented through both the proper maintenance and careful operation of the alarm system. In order to promote the responsible usage of alarm systems, the City of Cherry Hills Village Municipal Code (Chapter 6, Article IV) regulates the operation of security alarm systems. The key provisions of the Code are as follows:

• **An annual security alarm permit is required to use a security alarm system.**

The fee for this permit is \$25.00.

• **The City Code establishes the following false alarm response service charges:**

RESPONSE CHARGES ARE PER CALENDAR YEAR

**1st Response** – No Charge — **2nd Response** – No Charge

**3rd Response** - \$100.00 — **4th and Subsequent Responses** - \$200.00/each response

• **It is unlawful for an alarm to be in use without a valid permit.** Violation of the City Code could result in the user being cited into Cherry Hills Village Municipal Court.

If you receive a security alarm invoice, but you are no longer using the security alarm system, please email Police Clerk, Paul McCarthy at [pmccarthy@cherryhillsvillage.com](mailto:pmccarthy@cherryhillsvillage.com) the following information so your account can be deactivated:

• **The homeowner's name**

• **Mailing address**

• **Customer number** (not the invoice number)

## CHERRY HILLS VILLAGE MAKES FINAL PAYMENT

In 2004, Cherry Hills Village residents voted to withdraw from the South Suburban Recreation District. Through litigation, Cherry Hills Village was ordered to pay South Suburban for preexisting bond debt and the fair market value of the parks land. **In November of 2019, the City made the final payment to South Suburban** and a Full Satisfaction of Judgment was filed with the Arapahoe County District Court.
