## JOHN MEADE PARK UPDATE

**C**onstruction on John Meade Park will be completed this month! Check the City's website ([cherryhillsvillage.com/jmp](http://cherryhillsvillage.com/jmp)) and social media pages for a specific opening date. The park contains a new picnic shelter with restrooms, a play area with a saucer swing and hammock, a tree climber, and an observation tower. There are now fishing piers at both ponds, a boardwalk through the wetlands, and 125 new trees that will grow up to provide plenty of shade. On the Alan Hutto Memorial Commons side, there is a concrete performance area, pathways, and terraced grass amphitheater. Now that construction is wrapping up, some finishing touches like interpretive signage are in the works.

# TOP-PERFORMING PERENNIALS

**C**hoosing the best perennial for your garden can feel overwhelming; especially when you see the wide variety of plants available at your local garden center. That's where the Colorado State University Flower Trial Garden comes in. Founded in 1971, the Flower Trial Garden evaluates the performance of different annual and perennial cultivars from plant companies all over the US and the world. Each perennial must have been introduced within the past three years to be entered into the trial. Each cultivar is evaluated over three growing seasons, including two winters, to see how it fares in our challenging Rocky Mountain environment. In 2019, these six perennials were awarded "Top Performer" designations. You can find reports on all of the winners, past and present, at [flowertrials.colostate.edu](http://flowertrials.colostate.edu).

**Millenium Ornamental Onion**  
Described by the judges as a "show stopper" with an "insane" amount of lilac-purple rounded clusters of flowers in mid-summer. Also great as a long-lasting cut flower. Plant this where it will get full sun.

**Kahorie® Scarlet Border Pinks** Pinks have been a popular garden perennial for centuries. This cultivar gives a spectacular spring show with hot-rose flowers with a white center and grassy foliage. Consider shearing it back after the first bloom to maintain its shape and promote a second bloom in late summer or fall.

**SUMMERIFIC® Cherry Choco Latte Rose Mallow** The name sounds like a fabulous summertime coffee drink. Instead, it's a fabulous new hardy hibiscus with large two-tone blooms of pink and white on a plant with bronzed leaves sized perfectly for urban spaces. This plant will be the highlight of your late season garden.

**Lami™ Dark Purple Spotted Deadnettle**  
With a name like deadnettle, this plant might not sound promising. Au contraire, this low-growing groundcover will make that shady spot glow with dark purple flowers in late spring and early summer. It can take some sun so it's good for those transition areas between sun and shade as well.

**GRANITA® Orange Ice Plant** If you're looking for an orange explosion, this is the plant for you. Large, vibrant orange flowers blanket this groundcover beginning in mid-spring and continuing for weeks after. When it's not blooming, the foliage makes a nice dense mat covering the ground. It can't get enough of our hot summer sun.

**Bandwidth Maiden Grass** At 3-4 feet in height, this grass is perfect for today's smaller landscapes. Although it doesn't bloom, the yellow and green banded foliage puts on plenty show enough. You won't be disappointed.

There's still time to plant any or all of these prize winners in your garden. ## 2021 CITY BUDGET CALENDAR

**T**he City Charter requires the Council adopt a budget calendar by resolution each year. The following calendar was adopted as the budget calendar for the preparation of the 2021 annual budget by the City Council at the January 7, 2020 meeting:

**1** The City Manager submits the proposed 2021 budget on or before September 15, 2020.

**2** The City Council holds a study session to review the proposed 2021 budget on or before October 6, 2020.

**3** A public hearing will be held concerning the proposed 2021 budget and first readings of the Appropriations Ordinance and Mill Levy Ordinance on or before November 17, 2020.

**4** The Appropriations Ordinance and Mill Levy Ordinance will be adopted on second reading before the certification of tax levies deadline of December 15, 2020 required by Arapahoe County Assessor's Office.

# THE DANGERS OF *DISTRACTED DRIVING*

**D**istracted driving can have **tragic consequences**. In 2018, according to the International Association of Chiefs of Police, distracted driving claimed the lives of more than 2,800 people in the United States. This included 1,730 drivers, 605 passengers, 400 pedestrians, and 77 bicyclists.

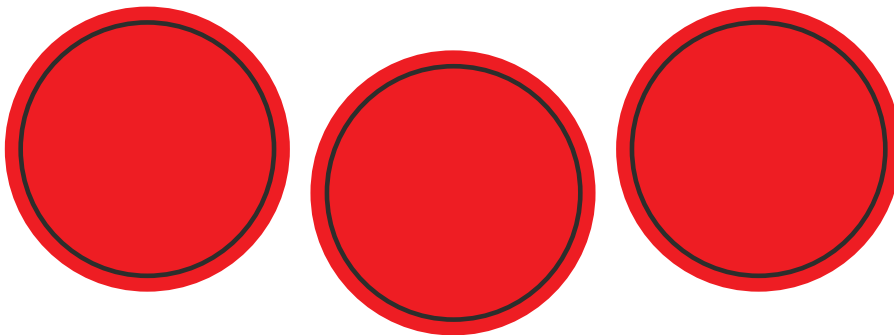
Distracted driving is any activity that takes your eyes off the road, hands off the wheel, or mind off driving. Personal grooming/checking yourself in the mirror, eating or drinking, attending to pets, and programming your GPS navigation while driving, are just a few examples of possible distractions that can increase your risk of being involved in a crash.

Cell phone use while driving is similarly considered distracted driving. It

requires the driver to take his or her eyes off the road, hands off the wheel and his or her mind is not on driving but instead on the screen of the cell phone. Colorado law prohibits the use of a cell phone for text messaging, as well as manual data entry and transmission (which includes social media browsing) for all motorists. For motorists under the age of 18, any use of cell phone while driving is prohibited. That includes voice calls, text messaging, or any other forms of manual data entry and transmission.

The Cherry Hills Village Police Department encourages you to focus on driving and remove any and all distractions when you get behind the wheel. Follow these recommendations for a safe driving experience:

- Make sure your car is parked before utilizing your cell phone (calling, texting or entering a location into a GPS application on your phone or vehicle).
- Enlist a passenger's help to assist you in driving safely. Allow them to access your phone to respond to calls and/or messages.
- Cell phone use can be habit-forming. Struggling with texting and driving? Put the cell phone in the glove box or back seat of your vehicle until you arrive at your destination. Another option is to put the cell phone in "Do Not Disturb" mode while driving or download a safe driving application, both of which will block incoming notifications from messages or calls while you are driving. The "Do Not Disturb" mode is especially useful for new underage drivers.
- Leave a pet at home or secure them before driving so that they do not roam freely. Reaching in the back seat to attend to them, or having them climb on your lap, can cause a distraction.
- Secure all loose items in the car before driving. Loose items can be a distraction as well as a safety hazard.

# MAYOR'S REPORT

*Last month in this column I discussed the Conservation Easement held by Colorado Open Lands and its restrictions on public use of the Quincy Farm property. This month I can report on planning and the process for long-term funding and governance of the Farm.*



The potential transferees were concerned that the financial obligations could be substantial and challenging. They were prescient. Estimates this year place the need of repairs at more than \$2.5 million, and future operation, maintenance repairs will easily be several

times that amount.<sup>1</sup>

Properties like Quincy Farm with conservation easements often are conveyed by donors with an initial endowment for maintenance and operations. Catherine Anderson was not able to provide an initial endowment for Quincy Farm.

In October 2012, the City Council created the Quincy Farm Visioning Committee to evaluate challenges and opportunities posed by the conveyance of the property to the Village. Foremost among the challenges was funding and long-term financial viability, as the Visioning Committee explained in its final 2014 Recommendation to Council:

**Funding.** The Village must determine how potentially significant capital expenditure requirements (including those mandated by the Conservation Easement) can be met on a sustainable basis. CHV is likely the primary funding source, but CHV reserves may not be sufficient to sustain Quincy Farm on top of meeting the increasing demands for limited Village funds. To enhance potential for outside funding partners, CHV must create a broad vision and plan for the Property that is appealing to funding communities, in and outside the Village.

**Recommendation.** City Council should evaluate the ability of CHV to be a meaningful, long-term source of funding for Quincy Farm.

In 2015 the Council established a Committee to advise Council on matters related to Quincy Farm. In the Resolution, Council directed the members to:

Determine the appropriate mechanism or legal structure for private fundraising for the benefit of the Property, including formation of a 501(c)(3) non-profit corporation.

This year the Village received a letter of interest from the Anderson family, raising the possibility that the Anderson family could take the lead in establishing an entity to take title to Quincy Farm, secure private donations, and achieve the vision contained in the Conservation Easement. Those conversations led to the current discussions of the Quincy Farm Committee and the recommendation to Council. Significant implications of transfer to a newly formed entity include:

1. The Conservation Easement and the opportunity it allows for public enjoyment will remain in fixed in place, regardless of whether the title is held by the Village or a different entity.
2. Village taxpayers would be relieved and released from the obligation owed to Colorado Open Lands to maintain the property and comply with the Conservation Easement.
3. Opportunities for private fundraising from donors inside and outside the Village would be available for a non-profit entity. Several donors in the Village have publicly and privately expressed a desire to donate generously to a non-profit entity formed to support Quincy Farm.

This is an important decision-point for the Village and Quincy Farm. Your thoughts and comments are always welcome and appreciated. Watch for developments.

In late August the Quincy Farm Committee, a group of seven appointed Village citizens, recommended that City Council explore options for transferring title to the Quincy Farm property for purposes of long-term fundraising and governance. The recommendation was prompted, in part, by a letter from Catherine Anderson's family expressing an interest in taking title to the property and assuming the obligations owed to Colorado Open Lands.

Two important assumptions underlie these proposals. First, the Conservation Easement and the opportunity it allows for the public's enjoyment would not change if title to Quincy Farm were conveyed. The Conservation Easement will be enforced by Colorado Open Lands in perpetuity regardless of title ownership. And second, a conveyance of title would release Village taxpayers from large financial obligations and open opportunities for appealing to private philanthropy.

A brief history of the Village's association with the Quincy Farm property is helpful to understand why the Quincy Farm Committee concluded that the interests of the Village, the Anderson Family, and Village citizens are served by exploring a conveyance of fee title.

In 2007 when Catherine Anderson granted the Deed of Conservation Easement to Colorado Open Lands, she had not resolved who would take title and assume obligations of the property following her death. The Deed of Conservation Easement itself identified three preferred (though not exclusive) entities for this role: (1) the Conservation Fund; (2) the City of Cherry Hills Village, and (3) Catherine Anderson's immediate family members, heirs, or beneficiaries.

When Catherine Anderson deeded the property to Cherry Hills, neither the Conservation Fund nor Catherine Anderson's heirs were able to assume the financial responsibility of the property.

<sup>1</sup> The entire 2020 budget for operating and maintaining all parks and trails in the Village and construction of John Meade Park is only \$4.4 million. The Village's General Fund annual budget is \$7.5 million and the entire annual budget for all funds is just over \$15 million [www.cherryhillsvillage.com/ArchiveCenter/ViewFile/Item/877](http://www.cherryhillsvillage.com/ArchiveCenter/ViewFile/Item/877). The financial demands of Quincy Farm could consume a substantial percentage of the Village's annual budget each year.
