
## CITY HALL TO RE-OPEN TO WALK-IN TRAFFIC

Cherry Hills Village City Hall is tentatively planning to re-open towards the end of May once most of the employees have been vaccinated. In the meantime, the City is still available for all business and encourages everyone to conduct business through the City website ([www.cherryhillsvillage.com](http://www.cherryhillsvillage.com)) or by phone (303-789-2541) until City Hall opens. Many services are available through the City website

such as building permits, right-of-way permits, municipal court fines, sales tax payments, dog registration, alarm bill payments, public works and parks service requests, housewatch requests, and code enforcement requests.

City Council is continually evaluating when it will be safe to resume in-person meetings. Until then, the City will continue to hold public meetings electronically. City meetings are live streamed and recorded on the City's website at [www.cherryhillsvillage.com/MeetingVideos](http://www.cherryhillsvillage.com/MeetingVideos). You don't have to sign up to watch a meeting. To speak during audience participation or a public hearing, members of the public must follow the instructions on each meeting

## BENEFITS OF TREE DIVERSITY

Trees serve so many good purposes in a landscape. They add beauty, privacy, and shady places for family recreation and relaxation. They increase curb appeal and increase home values. They support pollinators and provide habitat for urban wildlife. They bind carbon dioxide, release oxygen, and add humidity to the air. They absorb harmful radiation, provide windbreaks, and their shade cools homes, reducing energy costs. Trees do important work!

### Diversity is Key

Many cities have urban forest initiatives to build and diversify their tree canopy. These initiatives strive to improve urban environmental quality, sustainability, and human health by introducing and maintaining a diverse population of tree species. Arborists measure diversity by calculating the percentage of each species within a particular area, combined with the age and size distribution of the trees within each species. Tree experts recommend that no more than 10% of the trees in a defined area be of a single species.

### Aesthetics and Benefits to Wildlife

Planting a variety of trees creates an aesthetically pleasing and more

biodiverse habitat for birds and pollinators. Different species of trees bloom at different times throughout the season thereby offering pollinators a more continuous source of nectar and pollen. According to Doug Tallamy, professor of Entomology at the University of Delaware, oak trees support almost 900 caterpillar species in the United States. Birds and wildlife that feed on berries or fruits produced by a wide variety of trees or shrubs also benefit from a continuous food source. A broader range of landscape color is available by planting a mixture of species.

### Disease Reduction

The most important reason that tree experts encourage species diversity is to prevent widespread destruction to the urban canopy from a disease or invasive pest. Remember Dutch Elm Disease? Over 90 years ago, elm bark beetles transmitted a devastating fungus to over 75 million elm trees in the USA. Lack of tree diversity was part of the problem. Today, Emerald Ash Borer presents a similar threat to our urban forest. Colorado State University estimates that there are 1.45 million Ash trees in the Denver metro area. Because of their mature size, Ash trees make up a significant portion of the urban canopy.

If trees in your landscape are diseased or drought stressed, consider replacing them with a different species. For large shade trees, consider lesser-used species like Kentucky Coffee Tree, an Oak or Catalpa. Serviceberry or Redbuds are great choices if you desire a smaller ornamental tree.



A healthy urban forest is one where trees are planted with regularity so that the canopy is constantly in flux. New trees in different species can replace those past their prime. Diversity in the tree canopy can create a resilient, enduring landscape for all to enjoy.

## HOW TO PLANT A TREE

- Determine depth of planting hole.
- Dig a saucer-shaped planting hole 3X root ball diameter.
- Set tree on undug soil.
- Remove root ball wrapping materials.
- Stabilize root ball at the base.
- Break up large clods and backfill the planting hole.
- Soil amendment is optional.
- Water to settle the soil.
- Add 3-4" of mulch on the backfill area; no mulch on the root ball or against the trunk.

# THE BEES are coming to Quincy Farm!

## Be a part of building something new.

As we all reacquaint ourselves in the coming months, gathering and working together again, we are pleased to introduce a similar community constructing their new normal—an apiary at Quincy Farm. You likely know what an aviary is, but have you heard of an *apiary*? An apiary is an environment where beehives and honeybees are kept. Cherry Hills Land Preserve is thrilled to install a community apiary at Quincy Farm in May.

## Did you know?

Bees need water to survive. Bees are known to travel up to five miles to their watering source. Luckily, we have the High Line Canal and the pond at Quincy Farm to keep our bees hydrated. Of course, bees need pollen too. Along with our wildflower patch at Quincy Farm, we encourage our community to grow pollinator-friendly plants at home.

## Healthy pollination takes a village.

Have you heard of neonicotinoids? These insecticides, literally meaning “new nicotine-like insecticides,” behave like nicotine and act on receptors in the nerve synapse of invertebrates, like insects. These pesticides cause paralysis and death to bees. While more toxic to bees than mammals and birds, these chemicals find their way into our soil and water, threatening aquatic insects and the birds and fish that feed on them. To find out if you use neonicotinoids on your landscaping, check the pesticide’s label or ask your landscaper. We encourage the use of organic, bee-friendly pesticides that don’t contain these harmful chemicals: Acetamiprid, Clothianidin, Dinotefuran, Imidacloprid, Nititenpyram, Thiocloprid, and Thiamethoxam.

# MAYOR'S REPORT

*This month a report on three federal and state legislative developments that directly affect our Village.*



## *American Rescue Plan Act*

**O**n March 11, 2021 President Biden signed the \$1.9 trillion American Rescue Plan Act, a small piece of which authorizes aid to local governments. Of the nearly two trillion dollars, the Coronavirus Local Fiscal Recovery Fund provides \$350 billion in direct aid for states, municipalities, tribes, and territories, including \$65 billion for the 19,000 municipalities in the United States.

The state of Colorado is required to allocate its share of the \$65 billion to cities in Colorado according to a simple per-capita formula. Colorado must distribute money to municipalities like ours as directed by Treasury Department regulations.

Under the existing formula, Cherry Hills Village is scheduled to receive approximately \$700,000 in 2021 and another \$700,000 in 2022. The funds must be spent before December 31, 2024.

Congress authorized the funds to be used to "make necessary investments in water, sewer, or broadband infrastructures." The Treasury Department is preparing guidance explaining the types of projects permitted by this definition. These guidelines will allow spending by municipalities with unserved and underserved broadband needs. The National League of Cities and the Colorado Municipal League are urging the Treasury Department to adopt guidance that permits spending for any broadband-related purposes, such as enhancement of existing cell and new 5G service.

## *Public Safety/Law Enforcement Integrity Act*

Last year, in response to the George Floyd incident in Minnesota, the Colorado General Assembly quickly drafted, debated, and enacted SB 20 217 – Enhance

Law Enforcement Integrity Act (LEIA). LEIA is one of the most ambitious and comprehensive legislative efforts to change the rules and standards for police accountability in the United States. LEIA has a direct effect on our Village and our police department.

As I reported in the January 2021 Crier, a priority of the Colorado Municipal League is to support efforts to fix flaws in the quickly drafted LEIA. This year several authors of the original law introduced HB21-1250 to do just that. HB21-1250 clarifies a few issues, but also imposes new requirements and creates new concerns. Among the bill's provisions still being negotiated are:

- *Use of Force.* HB21-1250 provides that peace officers "shall not use physical force upon another person unless the officer has exhausted all reasonable de-escalation tactics and techniques and ... such force is proportional and necessary to effect an arrest or prevent harm to another person." This is a heightened standard from that imposed by last year's law. CML is proposing that the General Assembly add language such as "when possible" or "if possible," to cover situations where there is no time for de-escalation tactics. CML is also urging the General Assembly, if the new standard is adopted, to give municipalities time train officers in the new standard.
- *Civil Liability.* LEIA created a cause of action against local – but not state – peace officers. HB21-1250 now extends potential liability to the Colorado State Patrol and all other peace officers employed by the state. The LEIA also provided that local governments must indemnify peace officers for any liability incurred by the peace officer, except that governments did not have to indemnify (pay) a peace officer if the "officer was convicted of a criminal violation for the conduct from which the claim arises." HB21-1250 now proposes to add "unless the city was a causal factor in the violation, through its action or inaction." CML opposes

this change as a violation of fundamental criminal law and public policy principles that no one should ever receive payment for criminal conduct.

- *Data Collection.* Instead of narrowing or clarifying the definition of a police "contact" for which data collection will be required, HB21-1250 expands "contact" to include welfare checks. Recording "contacts" by peace officers is time consuming and requires expensive data storage, but the types of "contacts" that must be recorded and reported are not clear. Are all conversations with residents on the street or homes "contacts?" Or are "contacts" limited to situations where a peace officer believes there is probable cause to make an arrest or conduct a search?

## *Regulation of Family Child Care Homes*

Section 16-2-720(c) of our Village Code allows the operation of home childcare facilities if the operator complies with state law, resides on the property, and can provide sufficient off-street parking. Our Code also limits the number of facilities within a 500-foot radius and prohibits long-term parking and storage of commercial vehicles.

HB 21-1222 expressly preempts these provisions of our Village Code. If passed, local governments must allow childcare homes serving up to 12 children in single-family residentially zoned districts. The bill prohibits the Village from imposing "any additional regulations that do not also apply to other residential properties," meaning that no local permitting requirements may be imposed on the operator of a childcare home in a residential neighborhood. The Colorado Municipal League opposed the bill as an unwarranted infringement of local zoning control, but HB 21-1222 passed the House and is expected to be approved by the Senate and signed by the Governor.

City employees have and will be receiving vaccinations so City Hall will soon reopen for normal use. My regular in-person Monday office hours will begin again on Monday, May 17th. 
