## Police Commander Patrick Weathers Retirement

Police Commander Patrick Weathers announced his retirement after having served almost 41 years for the Cherry Hills Village Police Department. He was hired as a Patrol Officer on December 16, 1981, was promoted to Sergeant in 2005, Senior Sergeant in 2009, Lieutenant in 2010, and Commander in 2011. He served as interim Chief of Police in 2012, and again in 2022. His last day at the City was October 20, 2022.

He was named Colorado's Law Enforcement Officer of the Year in 2005 and has received many commendations for quick and decisive actions that saved many lives, including a Life Saving Medal

for saving the life of a choking infant, performing life saving measures on a four-year-old who accidentally drove her wheelchair into a swimming pool, timely action during a fire in Englewood that resulted in saving lives and personal property, and saving the lives of three horses that fell into an icy cold swimming pool.

He has been in charge of numerous high profile dignitary visits and worked with the Secret Service, FBI, U.S. Capital Police, DHS, and Arapahoe County Sheriff's Office to coordinate police and security activities during visits from former Presidents George W. Bush and Donald Trump, Speaker of the House John Boehner, Senator Harry Reid, First Lady of Panama, First Lady Michelle Obama, and Senator Mitt Romney. He organized traffic control for numerous first responder funerals for Police and Fire Agencies from the surrounding Metro area; attended innumerable HOA meetings in the City; participated in promotional assessment processes for other jurisdictions; organized the U.S. Women's Open Golf Tournament in 2005, the Men's Amateur Open Golf Tournament in 2012, and the BMW Classic Golf Championship in 2014, all held at Cherry Hills Country Club.

The City Council presented a proclamation at their October 3, 2022 meeting to express its gratitude and appreciation to Commander Weathers for his many years of dedicated service to the police department and providing safety to the community.

Results remain unofficial until the risk-limiting audit is complete and the canvass board certifies election results. The canvass is scheduled for November 29, 2022.

## Public Works – “Who are we?”

The mission of the Cherry Hills Village Public Works Department is to provide high quality, streets, infrastructure, parks, and open space for all residents. The Department strives to be stewards of the environment and be fiscally responsible in all aspects of its operations. The Cherry Hills Village Department of Public Works is comprised of 2 main divisions (Parks and Streets) with 17 full-time and 6 seasonal employees who possess special

skills and knowledge acquired through education, training, and experience to meet the public's needs. Some of the many responsibilities of the Department include:

- Maintain 50 miles of streets (100 lane miles)
- Maintain 26 miles of bridle trails, 55 acres of open space and park land
- Stormwater management
- Operate 36,000 feet of sanitary sewer lines
- Oversee all City facility maintenance and repairs
- Plan and manage recreation special events
- Administer the Recreation Reimbursement Program
- Manage the household hazardous waste program and Spring Clean-Up
- Right-of-way construction permitting
- Capital construction management
- Snow removal

# MAYOR'S REPORT

This month a review of the Cherry Hills Village proposed 2023 budget.

*Our Home Rule Charter requires Council to adopt a budget every calendar year. At the October 3, 2022 Council meeting, Finance Director Doug Farnen presented a proposed budget for which a public hearing and first reading are scheduled for November 15, 2022. Here are highlights:*

**General Fund.** Every Cherry Hills Village annual budget must have a balance between the total estimated expenditures and total anticipated revenues. The projected general fund revenues and expenditures for 2022 are \$8.4M. The ending fund balance is estimated at \$11.7M, which exceeds our Fund Balance Reserve Policy amount of \$4.2M (a minimum of six months of the current year's expenditures).

For 2023 the \$8.4M in revenue is obtained from 7.3 mills of property tax (\$2.8M); use tax on motor vehicles (\$1.2M); sales tax (\$1.1M); ownership tax (\$324K); franchise fees (\$560K); licenses and permits (\$1.3K); charges for services (\$443K); intergovernmental (\$339K); and interest income (\$270K).

The sales tax forecast is an estimate, based on previous year receipts, of revenue anticipated to be received by the Village from all vendors including our locals like Pino's with a place of business in the Village and remote vendors like Amazon. The election and result of ballot question 2A might affect the proposed 2023 budget and the long-range financial forecast.

For 2023 the planned expenditures from the General Fund are as follows: Police (\$3.7M); Administration (\$2.0M); Public Works (\$1.1M); Community Development (\$495K); transfer to Capital Fund (\$471K); payments on certificates of participation for non-parks and recreation purposes (\$334K) (an additional \$408K is paid from the Parks Fund); judicial (\$99K); and information technology (\$217K).



The 2023 budget proposes that employees receive a 4% cost-of-living increase and up to 2% merit increase for eligible employees. The Village conducted salary surveys of other municipalities which showed average pay increases falling within the 5% to 6% range. Health premiums are projected to grow by 8% for medical and 5% for dental.

The Village plans to conduct a full compensation study in 2023 to assess the compensation position of Village employees vis-à-vis comparable market and job skills. The Village's property and liability insurance premiums increased 10%.

## **Parks and Recreation Fund.**

The Parks and Recreation Fund receives 7.422 mills (\$2.8M) as a result of the 2002 vote of Village citizens to withdraw from the South Suburban Park and Recreation District. The Parks Fund is also projected to earn \$44K in interest income.

The expenditures for 2023 are projected at \$3.5M, including personnel (\$1.4M); operating (\$902K); capital expenses (\$46K); transfer to capital fund (\$725K); and Certificate of Participation debt payment allocated to parks and recreation (\$408K) (an additional \$330K is paid by the General Fund). The ending fund balance is projected to be \$1.6M in 2023, above the minimum reserve requirement of \$700K (3 months of the current year revenue).

**Conservation Trust Fund.** This fund was created to receive about \$66K each year in proceeds from the Colorado Lottery, the use of which is restricted to the acquisition, development, and maintenance of parks and open space. The budget projects spending \$66K and having a 2023 ending fund balance of about \$488K.

## **Arapahoe County Open Space Fund.**

This fund was created to receive a portion of a county-wide sales tax, which amounts to about \$190K annually. This tax was made permanent by Arapahoe County voters in November 2021. These funds are restricted and may be used only to acquire new parks or open space, as well as improve, and manage existing parks and open space. The budget projects spending \$100K and an ending 2023 fund balance of about \$1.1M.

**Water and Sewer Fund.** This fund accounts for revenue and expenditures related to the consolidation of water and sewer utilities under the City's direction. The 2023 expenditures will be used for sewer line repairs of \$326K. The estimated ending 2023 fund balance is \$167K.

**Catherine Anderson Fund.** This Fund was established to receive fees when subdivisions in the Village were platted and approved. As the Village matured, the name and purpose of the funds was changed to accept donations to be used for the acquisition and maintenance of open space, parks and trails. The budget projects spending of \$99K and an ending 2023 fund balance of \$224K.

## **American Rescue Plan Act (ARPA) Fund.**

This fund was established to account for the ARPA grant revenues and are restricted for specific uses outlined by the U.S. Treasury. There are currently no planned expenditures for 2023. Funds need to be obligated by the City by 2024. The estimated 2023 ending fund balance is \$1.5M.

**Capital Fund.** The Capital Fund is used to separately account for capital assets, i.e. personal and real property that cost more than \$5,000 and have a useful life of more than one year. Examples include Village trucks and motor vehicles, street improvements, and park equipment. The Fund is funded by transfers from the General Fund and the Parks and Recreation Fund. For 2023 the largest capital expenses will be for High Line Canal stormwater infrastructure (\$500K); three new police vehicles (\$203K); bridge maintenance (\$100K); new parks department pick-up (\$90K); storm sewer mapping (\$59K); and hydro-jetter and mini-excavator (\$75K).

## **Long Range Financial Forecasts.**

Normally a long-range financial plan is presented to Council along with the fiscal year Proposed Budget. But because of the uncertainty surrounding the effect of the sales tax ballot measure 2A, the long-range financial forecast will be updated and presented to Council in 2023.
