# POTENTIAL BALLOT MEASURE

The City is considering placing a Remote Sellers/ Internet Sales Tax issue on the November 2022 ballot. If it goes on the ballot, the issue would ask voters to update the language in the City Code as it relates to sales tax collection on sales of items delivered into the Village by businesses that are not physically located in the Village, including sales by online vendors.

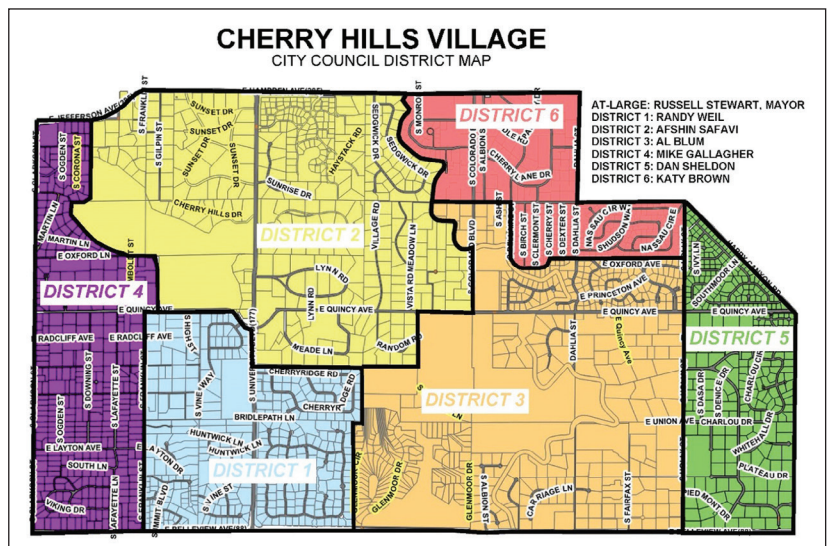

## New City Council Boundaries Established Based on 2020 US Census Data

After reviewing several different options to adjust City Council District boundaries based on population data from the 2020 US Census, the City Council adopted a new Council District map at the May 17, 2022 meeting. The Village Charter requires the City Council to re-evaluate Council District boundaries after each federal decennial census to ensure that the Districts have approximately the same number of voters. The City uses ten percent as a best practices threshold, and the previous District boundaries resulted in a population difference larger than ten percent.

**The only change** between the previous and new District boundaries is to the southern border between District 3 and District 5, which was shifted to align with Holly Street.

Although all City Council members are elected at large, it is helpful for each Village resident to know who their main representative is on the Council. The new Council District map can be viewed on the City website at [cherryhillsvillage.com](http://cherryhillsvillage.com) under the City Council tab, along with contact information for each Council member.



# MAYOR'S REPORT

*This month a report on a possible change to City sales tax policy.*

## **Possible November 2022 Ballot Question**

Like virtually every similar municipality in Colorado, Cherry Hills Village has for many years imposed a 3.5% sales tax on purchases of tangible personal property. But unlike virtually every similar municipality, our Municipal Code levies a sales tax only on entities that *maintain a physical place of business* in the City, which in our Village are few indeed. The tax codes of most municipalities, by contrast, impose sales tax on entities *doing business in their city*, which includes internet retailers that mail or deliver goods into their jurisdictions.

The City is not proposing to change the 3.5% rate. The potential November ballot question would only expand the definition of sellers who must collect and remit sales tax to the Village.

As I described in Crier's April 2021 Mayor's Report, the Village Code sales tax provision was enacted by the Village when the United States Constitution *prohibited* cities from taxing mail order and other retailers that had no physical presence in the municipality. See *Nat'l Bellas Hess, Inc. v. Dep't of Revenue of State of Ill.*, 386 U.S. 753 (1967), which held that no state or city could impose the duty of tax collection and payment upon a seller whose only connection with customers in the state is by common carrier or the United States mail.

Four years ago, the United States Supreme Court in *South Dakota v. Wayfair, Inc.*, 138 S. Ct. 2080 (2018) executed a 180-degree reversal and ruled that cities like Cherry Hills Village can – consistent with the Commerce Clause – collect sales tax from sellers who do not have a physical presence within a municipality (“remote sellers”).



The City Council is now considering asking voters this November to approve an amendment to the City Code that would extend the 3.5% sales tax to remote sellers and align our city with the *Wayfair*

decision. ***The proposed***

***amendment would not increase***

***the existing 3.5% sales tax rate.***

Instead, the approval of this amendment would authorize the City to apply the current sales tax to remote sellers using existing language in the City Code. Because this is a change in tax policy that will increase revenue to the Village, the Colorado Taxpayer Bill of Rights (TABOR) requires a vote of the people.

The Village now collects more than \$1 million each year in sales tax revenue from internet and other remote sellers who – despite our Code's language and staff's efforts at education – routinely collect and remit to the Village a 3.5% tax on sales of tangible personal property delivered to the homes of Village residents. The Village currently receives about 13% of its total revenue from payments remitted by remote sellers, and approval of this amendment is an important policy change to maintain operations and fiscal health. Because the Village must maintain an annual balanced budget, reducing City revenue by 13% would require cutting money spent on staffing and operations in Police, Public Works, and Administration Departments.

Sales tax revenue is also essential to the long-term financial health of the Village. As explained in the Crier's November 2020 Mayor's Report, in 2017 our Village borrowed about \$11.5 million to complete a new Public Works Facility, to build a new City Hall, and to improve John Meade Park. Each year the City pays about \$742,000 in principal and interest on Certificates of Participation (bonds) to pay for these building projects. The COP payments will continue through the year 2042. Today,

the total debt obligation of the Village (principal and interest due through 2042) is about \$14.8 million. Most of the funds used to pay the COPs are drawn from the Capital Fund monies set aside by past city councils.

The Capital Fund does not have adequate reserves to retire the COPs. The Village's 2022 Annual Budget explains that without sales tax revenue from remote sellers, the Capital Fund will be depleted by 2027, and the General Fund will be depleted by 2032:

The City's long-range financial plan is projected to 2042. This is because the City will have interest and principal payments for the Certificates of Participation that were issued in 2017. If revenues and expenditures increase as projected, the Capital Fund will be depleted in 2027 and the General Fund will be depleted in 2032. The long-range financial plan . . . assumes that there will be no remote or outside Cherry Hills Village sales tax beginning in 2023.

If voters decline to extend the 3.5% sales tax to remote sellers, the General Fund is forecast to fall below minimum reserve amounts within ten years. If voters approve extending the 3.5% sales tax to remote sellers, current levels of City services can be maintained, and the projected date of General Fund depletion will be pushed beyond 2035.

Council members and City staff have been meeting with residents for the last several months to explain these possible changes to the Code's tax policy. The garden is located amongst the most mature trees in the southwest corner of John Meade Park, on a rise where the rest of the park can be seen. # USE INDICATOR WEEDS FOR A HEALTHY LAWN

**Summer is here.** Trees are green and flowers are blooming, and so are those darn weeds! Every year homeowners fight weeds in their lawns and every year they come back. With a little detective work and some changes to your lawn care program, weeds can be kept at bay.

Of course, the best defense against weeds in the lawn is good maintenance. A thick healthy lawn will choke out most weeds over time. That means proper watering, fertilizing, and mowing.

Certain types of weeds in the lawn, called indicator weeds, can signal what may be going wrong. Prostrate spurge, knotweed, mouse-ear chickweed, or annual bluegrass can indicate that the soil is compacted. To correct this, core aerate in the spring and fall to break up the compaction.

Crabgrass, yellow wood sorrel, and white clover are a sign that the mower is set too low. Recommended mower height is 2.5 to 3 inches. Taller turf grass shades the ground so weed seedlings have a harder time germinating.

Insufficient water encourages dandelions, black medic, and bindweed. Check your irrigation system to make

sure it's properly covering all lawn areas. Use a catch-can test to determine if there is a coverage problem. If poor coverage isn't the problem, you may need to increase the amount of water. Programming your system with a cycle and soak setting can reduce water runoff.

On the flip side, overwatered lawns invite annual bluegrass, crabgrass, violets, and ground ivy. Make sure the sprinklers aren't running too long or too often.

Over application of fertilizer can encourage henbit, yellow wood sorrel, and annual bluegrass. Fertilize turf once in May to mid-June, once in September, and once in November, using the amount recommended for your turf type.

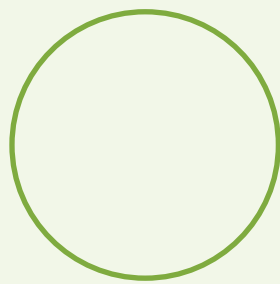
Insufficient fertilizer and too much water can create ideal conditions for black medic, plantain, and white clover. If these weeds are a problem, cut back on the water and fertilize.

Herbicides are an option for controlling weeds until the changes you've made to your lawn care take effect. If you have only a few weeds, spot treat them rather than applying herbicide to the entire lawn. Apply herbicides on a calm, clear day when the temperature is between 50 and 85 degrees. Don't apply if rain is predicted in the next 12

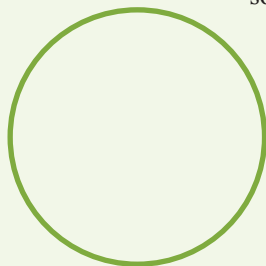
hours and don't irrigate for 12 hours after application. And most importantly, always read and follow all directions on the herbicide label.

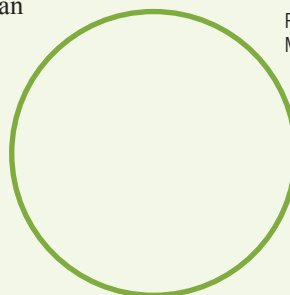

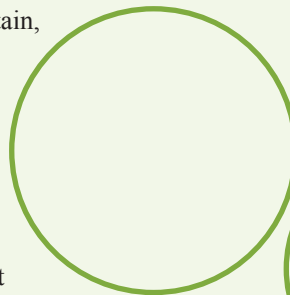

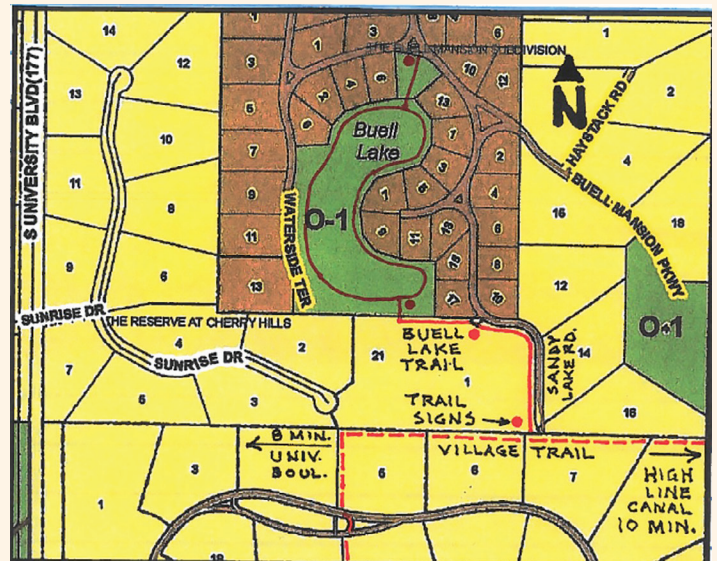
# ON THE TRAIL

WITH PARKS, TRAILS, AND  
RECREATION COMMISSIONER

Cherry Hills Village contains approximately eighteen lakes or large ponds. These lakes or ponds are located primarily on private property. Only five of these lakes are accessible to the public. These five water bodies include the two ponds immediately adjacent to our village administrative offices, the two large lakes on the Kent Denver School property, and Buell Lake. Walkers and anglers frequently visit these lakes. Buell Lake is located within the Buell Mansion Property. It is also a large lake in a very peaceful setting. It takes about fifteen minutes to walk completely around the lake. Snow geese and ducks can be seen here nearly year-round.

Buell Mansion is a 116-acre exclusive residential community on the southeast corner of Hampden Avenue and University Boulevard. It was developed in the early 2000's and is named for noted American (and Denver) architect Temple Buell (1895-1990) who lived on this property for many years in the Buell Mansion which now serves as the community meeting center. Buell Lake was on this property prior to the residential development.

The trail around Buell Lake is very flat and contains three sitting benches and two trash can/dog bag stations. There are two



pedestrian entrances to the lake itself. The north entrance is off of Gooseberry Lane and is the primary lake entrance for Buell Mansion residents. The south entrance is located where Sandy Lake Road ends. The signed Village Trail proceeds east from this point to the High Line Canal (10-minute walk) or west to University Boulevard (8-minute walk). The round-trip walk from this south entrance around the lake and back takes about twenty-two minutes. The actual trail signs ("Buell Lake Trail") should be installed this summer.

## MOSQUITO CONTROL PROGRAM

The City of Cherry Hills Village has a Mosquito Control Program that has identified numerous potential mosquito breeding habitats in public areas maintained by the City. Only female mosquitos bite and can lay up to 250 eggs every week in still water, which hatch in 7 to 14 days. These sites are

checked weekly from Spring through September and treated with a biological larvicide as needed. This program was developed to help reduce the risk of mosquito borne diseases, like West Nile Virus, to the residents, visitors, and workers.

West Nile virus is a disease that can be transmitted to humans by mosquitoes. It first appeared in the U.S. in 1999 in New York and now is in Colorado. It is not common to get a severe case of this illness and most infected people will not get sick or will have only mild symptoms. However, West Nile virus can be fatal.

West Nile virus is carried long distances by infected birds and then spread locally by mosquitoes that bite these birds. The mosquitoes can then pass the virus to humans and animals, particularly horses. There is a vaccine for horses, but none for humans. House pets do not spread the illness.

You can help reduce mosquito breeding sites around your property by checking for items that might hold stagnant water including wheelbarrows, toys, garden equipment, pool covers, tarps, plastic sheeting, pipes, drains, boats, ponds, ditches, rain gutters, flowerpots, plant saucers, puddles, buckets, and cans.

# Updated Bicycle Law: **SAFETY STOP**

As of April 2022, Colorado state law allows bicyclists to perform the “Safety Stop” at intersections. The Safety Stop gives people on bikes and other “low speed conveyances” the legal option to ride slowly through stop signs without stopping first, as long as they are yielding right-of-way to pedestrians and other road users who have the right-of-way. Bicyclists and users of low-speed conveyances may also proceed at red lights after coming to a complete stop, if there is no oncoming traffic. Bicyclists and low-speed conveyance users can approach intersections at a reasonable speed and choose to apply the Safety Stop or continue to perform a traditional stop at both stop signs and red lights. Only bicyclists ages 15 and over may perform the Safety Stop. Younger riders may do so when they are with a parent or legal guardian.

The Safety Stop is safer for bicyclists and motorists alike. Intersections are by far the most dangerous locations for bicyclists. According to Colorado Department of Transportation (CDOT) data, in 2017-2019, 72.2% of reported crashes between bicyclists and drivers took place at intersections or were “intersection related.” When bicyclists are able to get out of the intersection and away from that conflict zone before a potential crash can occur, their safety improves. Research shows that the Safety Stop:

- ▲ Reduces interactions between motorists and bicyclists in intersections.
- ▲ Reduces crashes in intersections.
- ▲ Increases the visibility of bicyclists in the intersection.
- ▲ Reduces the number of bicyclist-only injuries associated with starting and stopping on a bicycle

Colorado is the ninth state to pass a Safety Stop law; Utah, Oklahoma, and North Dakota passed similar laws in 2021.

## *Fishing at John Meade Park*

Both ponds at John Meade Park are open for fishing. Two piers were installed in the park during the renovations – one at each pond. Both ponds were also dredged to remove muck and provide healthier habitat. The ponds were stocked with bluegill last year by Colorado Parks and Wildlife. The ponds also have some bass and carp that have come down Greenwood Gulch. Anyone 16+ should have a valid license.

# Respect Equestrians on Trails

**SAFETY REMINDER:** *cyclists yield to pedestrians on trails, and all trail users yield to horses!* Horses are large, easily startled prey animals. Yielding keeps you, the rider, and the horse safe.

In addition to yielding, you should always announce your presence if you’re coming up on an equestrian along the trail. With horses in particular, please use your voice, not a bell! Bells can spook horses. (Sometimes they’ll even startle people!) Spooked horses might jump...onto you. Ouch.

Thank you for being respectful! Horses are a special part of the history of Cherry Hills Village, and your courtesy on trails allows riders to safely continue the City’s equestrian tradition.
