## POTENTIAL BALLOT MEASURE: REMOTE SELLERS/INTERNET SALES TAX ISSUE

The City is considering a ballot issue that would ask voters to approve an update to the language in the City Code as it relates to sales tax collection on sales of items delivered into the Village by businesses that are not physically located in the Village, including sales by online vendors.

The City Code contains outdated wording that can be construed to limit the City's ability to collect sales tax on retail purchases from vendors that do not have a "place of business" in the Village, including internet vendors.

In 2018, the United States Supreme Court ruled that a business may be required to collect local sales tax on retail transactions even if that business does not have a physical presence in the local jurisdiction if certain requirements are met. The State of Colorado and virtually all other home rule municipalities are already doing this under the language in their current codes. The City would like to revise the language in the City Code to modernize the City's ability to collect local sales tax from remote vendors, consistent with marketplace realities and current law. The proposed ballot issue would not increase the City's sales tax rate of 3.5%.

The City has been researching this potential ballot issue over the past few months via focus groups and a survey of residents, and is now implementing a public information program to explain the issue and answer any questions residents may have. # ON THE TRAIL

## WITH PARKS, TRAILS, AND RECREATION COMMISSIONER FRED WOLFE

Old Cherry Hills (west of University Blvd.) includes one of our most visited village parks. Known as Woodie Hollow Park, this ten-acre park was dedicated to Elizabeth “Woodie” Noel (1919-2005) on November 11, 1989.

The bronze plaque next to the park’s horse-ring reads as follows:

*The Noel family came to Cherry Hills Village in 1946 when Woodie was twenty-seven years old. The Village’s population at that time was only 700 (today’s population is over 6,000). In 1951, Woodie began working for Cherry Hills Village at \$50.00 per month. She retired in 1992 after forty-one years with the Village.*

The trail named after Woodie Hollow Park was created in 2020 by combining several existing bridle trails. This 1.4-mile trail

connects Woodie Hollow Park with John Meade Park next to City Hall. It takes about thirty minutes to walk from the primary South Franklin Street trail entrance (on the south) to John Meade Park (on the north). There are mileage and trail etiquette plaques mounted on each Woodie Hollow Park signpost. The secondary park entrance on the south is located where the trail meets Bellevue Avenue, but this half-mile section of trail is seldom used. There are three pedestrian bridges over Little Dry Creek within the park which makes the trail more interesting to walk. The trail sign plaques all remind trail users to keep dogs on-leash and dispose of dog poop bags in the provided trash cans.

This park is dedicated to “Woodie” Noel in recognition of her many contributions and devoted service to the City of Cherry Hills Village as City Clerk and Finance Director since April, 1952.

### Candidate Information Session

A Candidate Information Session will be held at City Hall on August 9, 2022 from 4-5pm. Interested residents will hear about City operations, logistics of being on City Council, and steps to becoming a candidate.

### City Council Candidate Requirements

- At least 21 years old
- Citizen of the United States
- Resident of Cherry Hills Village for at least 12 consecutive months preceding the date of the election
- Registered elector
- Resident of the district the candidate wants to represent.

Any person elected as a City Council member must continue to live within the district for which he or she was elected throughout the term of office.

The Mayor need only continue to live within the City.

### ELECTION TIMELINE

**August 9, 2022** First day candidate nomination petitions may be circulated

**August 29, 2022** Candidate nomination petitions are due to the City Clerk by 4:30 p.m.

**September 2, 2022** Last day an Affidavit of Intent for Write-In Candidate may be filed with the City Clerk

**September 6, 2022** Draw lots for candidate order on ballot; Last regular Council meeting to add ballot issues or measures

**October 17, 2022** First day ballots can be mailed

**November 8, 2022** ELECTION DAY

**January 3, 2023** Organizational Meeting – Newly elected officials are sworn in and take office



# RALPH'S READING GARDEN

## in John Meade Park

Project and Right-of-Way Manager Ralph Mason retired in March after 40 years with the City. To honor his extraordinary service to Cherry Hills Village, the Parks division has created "Ralph's Reading Garden" within John Meade Park. Ralph often suggested creating a reading garden as a park improvement, so we are thrilled to be able to honor his idea! Staff extends a special thank-you to the Parks, Trails, and Recreation Commission for their support of this project.

The garden is located amongst the most mature trees in the southwest corner of John Meade Park, on a rise where the rest of the park can be seen. Our horticulturist on staff, Hans Kaufenberg, has designed a circular garden bed with a bench and seating rocks. The design includes a Colorado-themed section of plants,

featuring a single boulder representing a mountain surrounded by ornamental cultivars of Colorado's state plants—Blue Grama grass, Columbines, and a tiny dwarf Blue Spruce – as a nod to Ralph's mountain-climbing adventures all over the state. It features a bench and plaque in honor of Ralph and his forty years of service. The garden is now complete, so families and children from the nearby schools can visit and enjoy the new space. won a Webby Award (the equivalent of an Oscar) for the Best Interactive Internet Site of the Year. Tiffany was "Amanda" on the famous website known as Amanda Cam .com. She and her little dog, Oliver, became webcast stars.

After retiring from internet production, Tiffany moved home to Denver to be near her mother and father. Tiffany left us with a legacy of love, intelligence, charity, and the will to move forward in her memory.

Tiffany is survived by her mother, her father, her sister, Ashley Chesler, and her fiancé, Terence Beshara.

# MAYOR'S REPORT

*Our Village is delighted to welcome Jason Lyons as our new Chief of Police and Doug Farnen as our new Treasurer/Director of Finance and Administration. Here are some highlights of their backgrounds, experiences, and talents that they bring to their new roles.*

## **Jason J. Lyons, New Chief of Police.**

The Village's Master Plan identifies public safety as the most important concern and responsibility that residents entrust to our elected officials and staff.

Chief Lyons was selected from more than 37 applicants after a thorough search and comprehensive review of his background and experience. Chief Lyons attended high school in Ohio, obtained a Bachelor of Science degree in Administration of Criminal Justice from Mountain State University in West Virginia, and earned a Master's Degree in Justice Administration from Norwich University in Vermont.

Chief Lyons began his career in Pinellas County Florida in 1996 as a deputy sheriff and advanced steadily as Detective, Sergeant, and Lieutenant before accepting an offer of a position in the Castle Rock, Colorado, police department in 2010. He was promoted to Commander of the Castle Rock department in 2012 where he served until joining Cherry Hills Village.

Chief Lyons has extensive public safety training at the FBI National Academy, the FBI-LEEDA Command Institute for Law Enforcement Executives, the FBI-LEEDA Supervisor Leadership Institute, the FBI-LEEDA Executive Course, the Police Executive Research Forum's Senior Management Institute, the Northwestern University School of Police Staff and Command, and the Colorado Association of Chief of Police, New Chief Orientation Course.

Chief Lyons served as an instructor/professor with the FBI-Law Enforcement Executive Development Association, Arapahoe Community College, Colorado Association of Chiefs of Police at the

Supervisors and Command Staff Institutes, and the Southeastern Public Safety Institute at St. Petersburg College in Florida.

The Village's selection process was lengthy and rigorous. Commander Lyons was interviewed by a citizens advisory committee comprised of the Mayor, one Council member, and three citizens; a Village staff panel headed by the City Manager; and a professional panel of local criminal justice and public safety professionals, including a district attorney and police chiefs from other municipalities. Commander Lyons also passed a comprehensive background check and additional interviews.

While many of the applicants for the position were qualified by experience, Chief Lyons distinguished himself as the best qualified and best fit for the job in Cherry Hills Village. In his time at Castle Rock, Commander Lyons conceived and implemented community policing and public safety initiatives that have been a model for departments across Colorado. He has excellent job and communication skills, and he has the temperament, energy and vision to assure that Cherry Hills Village continues to be the safest suburb in Colorado.

## **Doug Farnen, New Treasurer/ Director of Finance and Administration.**

While the Village's budget at \$11 million is modest compared to our larger neighbors, our debt financing, restricted funds, and limited commercial property tax based create challenges as complex as our larger and more populous neighbors.

Director Farnen, like Chief Lyons, started with the Village on May 23, 2022. And like Chief Lyons, Director Farnen brings a wealth of experience and the highest credentials to his position with the Village.

Director Farnen was awarded Bachelor of Arts degree in Accounting from Washington State University in Pullman Washington and became a licensed Certified Public Accountant.



Director Farnen worked as the assistant Finance Director for the City of Edmonds, Washington where he managed the payroll, oversaw purchasing and municipal billings, and created the annual budget document and annual financial report.

Director Farnen moved and accepted a position of

Finance Director for the City of Kenmore, Washington, where he managed a staff of four and city budget of \$40 million and performed capital project and long-term planning.

In July 2007 Director Farnen moved to Colorado to serve as Finance Director for the City of Littleton. There he managed a staff of 10 and city budget of over \$87 million, and also performed capital project and long-term planning. He also managed an investment portfolio of \$60 million.

In 2017 Director Farnen became the Finance Director for the City of Centennial, where he managed a staff of 13 and oversaw a department budget of \$2.2 million. For Centennial Mr. Farnen also oversaw capital project and long-term financial planning, chaired the City Audit and Budget Committees, and managed investments of more than \$100 million.

In 2021 Director Farnen took a position as the Chief Financial Officer for the Colorado Retirement Association, but Mr. Farnen was persuaded to return to municipal government with Cherry Hills Village. The Village received many applications for the position, but like Chief Lyons, Director Farnen's knowledge and experience made him the best qualified for the position.

With these key hires our Village is well-positioned to continue to reinforce our reputation as the safest and best suburb to live in the United States.

# JUNE IS POLLINATOR APPRECIATION MONTH!

In 2020, City Council passed a resolution “Recognizing the Importance of Protecting and Supporting Pollinators and Declaring June as **Pollinator Appreciation Month** in the City.”

The resolution recognizes challenges to pollinators such as habitat loss and food supply issues caused by development and pesticide use, and commits that the City will reduce and minimize all chemical pesticide use on City lands and in City buildings. It also states that the City will continue to enhance safe and healthy pollinator forage habitat on City lands and will encourage schools, neighborhoods, households, and other entities within the City to adopt pollinator policies as well.

## **Pollinator-Friendly Practices in the City:**

In addition to minimizing pesticide use, the Parks division takes actions to proactively support pollinators. Parks staff does not chemically control dandelions; we deliberately let them flower in spring before mowing to give honeybees an early food source. Our horticulturist on staff has also selected and planted many pollinator-friendly perennials and shrubs in the ornamental beds around the City. Staff has also stopped mowing certain areas in our open spaces to encourage growth of wildflowers and other pollinator-friendly plants to help create pollinator corridors throughout the City.

## **Pollinators at Quincy Farm:**

Staff maintains two Pollinator Gardens on the west side of Quincy Farm, designed in partnership with the Butterfly Pavilion. This year, staff has created native bee houses for each garden. The Cherry Hills Land Preserve also maintains two honeybee hives on the east side of the Farm. ## CHERRY HILLS VILLAGE NEW CHIEF OF POLICE ANNOUNCEMENT

The City conducted a nation-wide recruitment search for the Chief of Police position upon Chief Michelle Tovrea's retirement, with the help of Koff & Associates. **Jason Lyons**, currently Commander of Special Operations at the Town of Castle Rock, was selected as the next Chief of Police of the City of Cherry Hills Village.
