
NEW UPDATE

MASTER PLAN UPDATE – 2ND COMMUNITY SURVEY

The City is in need of your input! Please take a few minutes to visit the project website at chvillagevision.com and share your feedback on alternatives for the City's Master Plan. The survey touches on topics like community character, transportation and infrastructure, and parks, trails, and open space. The feedback will be used by the Planning and Zoning Commission to help chart future directions on these topics. The survey will be open through April 15th and is only available online.

The Master Plan is a critical document that the City uses to help make decisions about a variety of things. From funding capital improvement projects to making decisions on land use applications, the Master Plan is the City's guide. Per Colorado state law, every jurisdiction is required to have a Master Plan (sometimes called a Comprehensive Plan). The Master Plan is a long-range policy document that generally looks at time horizons of 20 to 30 years. It is standard practice for communities to update their Master Plan every five to ten years. The first Master Plan in the City of Cherry Hills Village was adopted in 1970 and was updated in 1993. The current Master Plan was adopted in 2008.

ON THE TRAIL

Walking on our trails after a fresh snowfall is a delightful experience. It is quiet and very still. Only the soft crunch of snow underfoot is heard. I am sure that cross-county skiers and snowshoers feel the same way. As long as the snow depth does not exceed four to six inches, this snow walk is quite manageable if the proper boots are worn. It also helps if you use a ski pole or a trekking pole for stability and balance on slippery ground.

Trekking poles are made by many different companies including Leki,

Black Diamond, Foxelli, Trail Buddy, and Trekology. All of these poles collapse to shorter lengths for easy packing and use several different types of shaft locking systems. One carbon fiber pole weighs one pound. All of the current trekking poles have comfortable foam padded grips with strong wrist straps. For additional stability on ice and snow,

the trail walker can attach to his or her boots different types of footwear traction. Microspikes, coiled wire, and ice cleats are all available either online or at REI. It will take a few minutes of practice walking on snow and ice with these boot traction systems before the walker feels comfortable.

Many segments of our bridle (or dirt) trails are located in the constant shade of fences, retaining walls, trees, and shrubs. This shaded snow accumulates over the winter months and does not melt away until late spring. As more trail users tramp through this shaded snow, the trail becomes broken up and rough to walk on. At night, these areas will refreeze. Icy areas must be constantly observed and avoided if possible. Daily walks can continue to be made on our trails through the winter months if the above-described gear is used.

If you have more than ten gallons of paint to recycle PaintCare will provide a direct pickup service for free by calling 720-854-8722. You can also visit their website (paintcare.org) for over 180 sites in Colorado where paint, stain and varnish can be dropped off and disposed of for free.

WM CURBSIDE

The City currently contracts with Waste Management Curbside for "At Your Door" recycling. You must be a Cherry Hills Village resident and there is a \$20 copay for a maximum 1-bag pickup (bag holds 10 gallons). Residents can call 1-800-449-7587 and provide a list of items to be collected. WM Curbside will process payment, send a kit that includes the bag, and they will provide a date and time for the pickup. Below is a list of accepted and unaccepted items that they recycle:

ACCEPTED ITEMS:

Household Chemicals:

Ammonia, cleaning compounds, bleach, floor stripper, drain cleaner, rust remover, carpet/upholstery cleaner, tile/shower cleaner, and more

Automotive Products: Antifreeze, motor oil, oil filters, fluids, polish, waxes, vehicle batteries, upholstery cleaner, and more

Consumer Electronics:

Computers, laptops, keyboards, monitors, microwaves, DVD/CD players, CD ROM, fax machines, cell phones, VCRs, desktop printers, scanners, gaming systems, related cords and more

Paint Projects: Oil-based paint, latex paint, spray paint, artist paint, wood preservative, stain, caulk, sealer and more

Batteries: Batteries of various sizes, AA, AAA, C, D and rechargeable

Garden Chemicals: Herbicide, insect spray/insecticide, fertilizer, pesticide and more

Fluorescent Light Bulbs: Compact fluorescent lamps (CFL) and straight fluorescent tubes

Thermometers and Thermostats: Numerous items that contain mercury

Flammable Items: Kerosene, gasoline, solvents and more

Syringes and Lancets: Sharps, syringes, needles and lancets

Swimming Pool Chemicals: Pool acid, stabilizer, chlorine

NON-ACCEPTED ITEMS:

Asbestos, biological waste, medicines and prescriptions, ammunition and explosives, commercial or business supplies, unknown or unlabeled materials, trash (including bulky items and furniture), incandescent light bulbs, **appliances:** washing machine, vacuums, tools or refrigerators, tires, liquid mercury, radioactive items, containers over 5 gallons, leaking or empty containers, smoke detectors, lamp fixtures, construction related materials, items improperly packaged for transportation.

Bring your medications for disposal to the Cherry Hills Police Department at 2460 E. Quincy Ave. The service is free and anonymous, no questions asked.

It is important to remember that the following items are not accepted during these take back events. The items are as follows:

- Needles & Sharps
- Mercury (thermometers)
- Oxygen Containers
- Chemotherapy/Radioactive Substances
- Pressurized Canisters
- Illicit Drugs

This initiative addresses a vital public safety and public health issue. Medicines that languish in home cabinets are highly susceptible to diversion, misuse, and abuse. Rates of prescription drug abuse in the U.S. are alarmingly high, as are the number of accidental poisonings and overdoses due to these drugs. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet. In addition, Americans are now advised that their usual methods for disposing of unused medicines—flushing them down the toilet or throwing them in the trash—both pose potential safety and health hazards.

MAYOR'S REPORT

This month, an update on plans for the High Line Canal and significant legislation being debated by the 2022 General Assembly:



High Line Canal Stormwater Master Plan

Beginning in 2019 the Village conferred with fourteen neighboring jurisdictions to plan the future of the High Line Canal. The result was the adoption of the High Line Canal Collaborative, comprised of the Canal Collaborative Forum (CCF), the Canal Collaborative Leadership Team (CCLT) and the Technical Advisory Committee. A critical part of this work was the completion of the High Line Canal Stormwater Master Plan, which provides an engineering roadmap for the conversion of the High Line Canal from an irrigation facility to a 78 mile-long stormwater drainage facility.

On January 18, 2022 Council approved funds to retain Icon Engineering to perform a High Line Canal Stormwater Analysis specifically focused on the three-mile segment of the Canal flowing through Cherry Hills Village. The analysis will include the following:

Partial Plans and Drawings. Drawings, including plan, profile, and cross section showing necessary canal improvements and identifying downstream infrastructure deficiencies.

Ecology. Recommendations for improvements to weed management, vegetation enhancement, and reclamation of disturbed areas to improve the High Line Canal ecosystem.

Specifications and cost estimates for operation and maintenance.

Specifications and cost estimates for annual maintenance, including hazard tree removal, vegetation restoration, weed mitigation, channel cleaning, trail maintenance, irrigation needs, and tree replacement.

Cost estimates for capital improvements.

Estimates for the cost to construct all necessary capital improvements along the 3-mile Village section of the Canal, including water quality berms

and facilities, weirs, channel improvements, overflow facilities, and landscaping and vegetation improvements.

Cost estimates for easements. Estimates for costs for temporary and permanent downstream easements needed because of the capital improvements.

Icon Engineering will also provide its findings and conclusions to the High Line Canal Conservancy to supplement and update the Canal Master Plan. This will include technical appendices with modeling, plans, specifications and cost estimates.

As I reported in last month's Crier, American Rescue Plan Act funds are available and could be used to offset these capital construction costs.

Colorado General Assembly 2022 Legislative Update

The Colorado Municipal League is following and lobbying several bills this legislative term. Among those of interest to the Village and its residents are:

Attorney's Fees Recovery For Meritless Claims. It has long been the rule in Colorado courts that a defendant is automatically entitled to attorney's fees if tort claims are dismissed early in the case and before trial. Municipalities often rely on this provision to deter and settle meritless lawsuits. HB22-1272 would delete this long-standing protection and eliminate the ability of cities to recover the expenses of legally meritless litigation. CML is opposed.

Alcohol Extended Service Hours. Current state law allows bars holding liquor permits to open from 7 a.m. to 2 a.m. HB22-1142 would allow bars to open at 5 a.m. or close at 4 a.m. (but not both), if allowed by the local municipality. The idea for the change came from police suggestion that problems arising when all bar patrons exit at 2 a.m. might be mitigated by staggering closing times. The 5a.m. opening time was proposed by bars live streaming European football games. CML supports this increase in local control over licensing and permitting.

Prohibit Flavored Tobacco and Regulation of Synthetic Nicotine. HB22-1064 would prohibit the sale, marketing, display, or advertising of any flavored cigarette, tobacco or nicotine product.

Flavored means anything that tastes or smells similar to fruit, menthol, mint, wintergreen, chocolate, cocoa, vanilla, honey, candy, alcoholic beverages, herb or spice. The argument for the regulation is that these products target young people for whom vaping has become a serious public health concern. On the other side, these products already are restricted to adults ages 21 and older in Colorado, and state voters recently approved an increase in tobacco taxes. Although sales taxes are generally matter of local concern, CML is neutral on this legislation.

Homeowner Association Regulation. The General Assembly has discussed legislation affecting residents living in covenant-controlled communities. HB22-1137, for example, as now drafted and being debated would:

- Require Associations to alert owners of delinquencies by 3 different methods of communication
- Require Associations, before seeking foreclosure, to offer an installment payment plan
- Require Associations, when conducting reserve studies, to simultaneously perform a reconciliation of all reserve accounts
- Require Associations to vote in a noticed, open meeting to refer delinquent accounts to collection agencies or attorneys
- Prohibit Associations from imposing late fees of more than \$500
- Prohibit Associations from charging fees to provide owners' statements of account
- Require Associations to adopt a policy providing owners with contact information for foreclosure counseling services, legal aid services, translation services, mental and behavioral health services, veteran's services, and seniors' services in the county where the community is located

This proposed legislation is aimed at a handful of HOAs in Colorado – not our Village – often run by property management companies that are engaged in dozens of foreclosure proceedings. These requirements and restrictions would, if passed by the General Assembly and signed by the Governor, present challenges for self-governing HOAs in the Village.
