## JULY

### Keeping the Community “OUT OF THE WEEDS”

Due to the large amount of recent rain, The Cherry Hills Village Code Enforcement Division has seen an EXPLOSION in vegetative growth within the City and will begin taking a proactive approach by sending compliance letters out starting this month.

#### Per Municipal Code Section 7-3-20.

It is the duty of every person owning vacant or improved property, including easements and drainage ways within the City, to keep cut to within ten (10) inches of the ground all weeds and to keep said property free from brush and rubbish of all kinds. However, this Article shall not apply to vegetable gardens, flower gardens and shrubbery plots. Wheat, barley, oats, rye and similar agricultural commodities also shall be so exempted.

*Please do your part in keeping the community “Out of the Weeds”!*



## TREE CITY USA


Did you know that Cherry Hills Village is a Tree City USA Community? The City has been a member for 16 years! There are over three thousand other Tree City communities around the country. The program is managed by the Arbor Day Foundation, and Parks staff recertifies each year. To remain eligible, the City must meet specific requirements about tree ordinances, spending a specific amount on forestry, and observing Arbor Day. The tree canopy is a critical part of the parks and trails in Cherry Hills Village, and we are proud to affirm its importance through this certification.



## MOSQUITO CONTROL PROGRAM

The City of Cherry Hills Village has a Mosquito Control Program that has identified numerous potential mosquito breeding habitats in public areas maintained by the City. These sites are inspected and treated weekly from Spring through September by Parks staff. This program was developed to help reduce the risk of mosquito borne diseases, like West Nile Virus, to residents, visitors, and workers in the City.

You can help reduce mosquito breeding sites around your property by checking for items that might hold stagnant water including wheelbarrows, toys, garden equipment, pool covers, tarps, plastic sheeting, pipes, drains, boats, ponds, ditches, rain gutters, flowerpots, plant saucers, puddles, buckets, and cans.



## SUSTAINABILITY PRACTICES

**Merriam-Webster Dictionary defines sustainability as a method of using a resource so that the resource is not depleted or permanently damaged.** Sustainable landscapes strive to combine the natural with the man-made to create a healthy balance between people and the environment for the benefit of both.

**The number of sustainability practices varies depending on the education resource used, however, below are the most common:**

**WATER CONSERVATION** is here to stay and should be practiced in every landscape. Conserving water is achieved in a variety of ways. Eliminating 2,300 square feet of turf, using xeriscape and native plants, mulching and using drip irrigation are important water conservation practices.

**NATIVE PLANTS** are adapted to the drought-challenged climate and require less water because they fit the conditions of the soil and the environment. Native plants often require no fertilization and are more resistant to disease and pests. They are also regionally appropriate and require less maintenance.

**CREATE A WILDLIFE HABITAT** so all plants serve a purpose in the landscape. Plants support pollinators and local wildlife by providing food and shelter. Select a wide variety of plants that will draw a broad range of pollinators all season and help sustain them through the winter.

**RIGHT PLANT, RIGHT PLACE** is a landscape practice to match a plant to its appropriate conditions. Selecting diverse plants that are adapted to the soil, sun/shade, water availability, existing hardscapes and overall growing conditions reduces water requirements, chemicals and maintenance. This also helps to create a more natural looking landscape.

**FEED THE SOIL** because it is the foundation of plant success. Good soil increases water retention and nutrients. Add organic matter if needed, however, be aware of over-amending. Native plants, by nature, thrive in native soils. Use organic mulches to help with soil temperature, retain moisture, assist with erosion and inhibit weed growth. Decomposed mulch feeds the soil which improves plant health and dramatically reduces the need for fertilization.

**MANAGE PESTS RESPONSIBLY** using IPM (Integrated Pest Management), an environmentally sensitive approach. Understand the insects and diseases and their level of damage to a plant or another insect before treating. Check the landscape each week to aid in early detection of problems.

**There are additional sustainability practices that are appropriate for homeowners to consider:**

**RECYCLE** leaves, clippings, conifer needles and other trimmings into mulch or compost.

**CONSERVE ENERGY** through proper landscaping that helps lower energy costs. With strategically planted trees, shrubs, vines and man-made structures, the climate can be modified to protect from winter winds, shade from summer sun and even help with protection in wildfire areas.

**EDIBLE LANDSCAPES** combine fruit and nut trees, berry bushes, vegetables, herbs and edible flowers into a design that is aesthetically beautiful and beneficial to both humans and wildlife.

**REMOVE INVASIVES** to help protect the ecosystem from unwanted plants that are aggressive and threaten native plants and animals.

## MAYOR/COUNCIL REPORT

### CITY CELLULAR SERVICE (Or Lack Thereof)

**Imagine** a time where you could reliably make and receive phone calls from a cell phone while in your own home. Or how about finishing a phone call while driving through the Village without dropping the call and having to call someone back? Or better yet knowing that you had reliable service during an emergency. What I just described sounds like a sales pitch from a cell phone company from the 1990's, but the sad reality is that it's 2023 and those conveniences that we take for granted elsewhere do not come so easily to us here in the City of Cherry Hills Village.

I recently vacationed with my family through the Greek islands and one day we found ourselves hiking in and around the Nea Kameni volcano, last active in 1950. This volcano is an island of its own, approximately 2 miles offshore from civilization on the island of Santorini. Shortly after we began our hike, I was amazed to see other explorers on their cell phones making phone calls. I was shocked that an island with no visible infrastructure was able to somehow provide cell phone coverage. I looked at my family and said something along the lines of "...it's crazy that we're here in the middle of nowhere and we're able make calls, but back home in Cherry Hills Village it's like we're on a volcanic island in the middle of nowhere!"

**Why** you might ask does one of the wealthiest cities in the country fail to have good cellular coverage. The answer really lies in a question. A math question to be more precise. If you're one of the top cell carriers, and you have money to invest in a market, where would you rather put that

money? In rapidly growing and potentially swelling population areas like Sterling Ranch in Douglas County with 12,000 new homes (at an average of 2.3 people per home = 27,600 residents) being built over the next decade and the likelihood of more dense development including multi-family, townhomes, or condominiums. Or in semi-rural Cherry Hills Village where we have approximately 4,000 acres of land with only 6,442 residents. The cell carriers "bang for their buck" is greater in areas of higher density housing, and as a result, they aren't incentivized to invest their limited infrastructure dollars in a low density, low "bang for their buck" area.

**How** do we solve this problem? In 2021 and 2022, during the City's public outreach to the community regarding the updating of our Master Plan (which we update approximately every 10 years), we asked the citizens if they would like to see the cellular coverage improved. Of course, nearly everyone responded that they would like improved coverage. But when we asked them if they were willing to pay for it in the form of increased taxes, the interest level went down considerably. The follow-up question was then asked about whether the citizens would be interested in improving the cellular coverage if it didn't cost them anything and their taxes remained the same. Once again, their interest level was very high. In the fall of 2022, I approached the Cherry Hills Village City Council and asked if they were up for the challenge of trying to solve the poor cellular coverage issue but doing so without a tax increase on its citizens. After discussing a few options for how to pay for it, the City Council decided to investigate it further.

In early 2023, we engaged a consulting firm called HR Green ([hrgreen.com](http://hrgreen.com)) to study the options for

improving cell coverage for the City. The direction from the City to the consultant was to explore the available technology, the citizens' needs and desires, economic factors, regulatory requirements, etc.

Right now, the consultant is in a stage where they're summarizing what existing infrastructure the City has and what can be reused. By the time this article comes out the online surveys will be posted at [cherryhillsvillage.com/cell](http://cherryhillsvillage.com/cell). The City will publicize the surveys through NotifyMe and social media. It's important that you fill out the surveys. Also coming soon, HR Green will be hosting workshops for both the public and City Council to attend. These exercises will assist them in coming up with a Vision and Goals for the City. From there, they will work on preliminary design and a cost estimate. This portion of the assignment will be completed with limited financial guardrails in hopes that they'll complete a design that represents our most effective cellular coverage solutions. At that point, a financial analysis and a proforma that will include all potential revenue streams (the cell carriers usually pay rent on the towers where they house their equipment) will be put together. Finally, we'll review funding alternatives. This could include City cash on hand, grants, matching funds, and private partnerships.

All these steps will hopefully lead us to a functional and financially viable solution. The timing for HR Green to complete the study is by year end 2023. This would then allow the City to begin implementation in 2024. Let's put an end to the dropped cell calls in the Village once and for all! Look for further Crier updates from me on this topic in the future.

## ‘Resilience’ Sculptures for John Meade Park – Monarch Sculpture

Acclaimed Colorado artist Joe Norman has designed a custom sculpture series for John Meade Park, and you can help the Cherry Hills Village Art Commission raise the funds to purchase the last sculpture! The Art Commission specifically asked the artist to include a monarch in one of the designs. The monarch butterfly, which is now endangered, can be found in Cherry Hills Village in June on its way north and in September on its return migration to the south.

All three pieces appear to be local wildlife (a monarch butterfly, a broad-tailed hummingbird, and a Great Horned Owl) when viewed from one direction and playing children when viewed from a different angle. Scale models of each sculpture (as pictured here) are available to view at City Hall. The three sculptures total \$120,000 for fabrication and installation and are being funded

primarily through community support. Donors of \$100 or more will appear on a recognition plaque. ## CHERRY HILLS COUNTRY TO HOST THE 2023 US AMATEUR OPEN

The Cherry Hills Country Club will host the 2023 US Amateur Open **August 14-20, 2023**. In preparation for this event, residents may see signage related to the event around the Country Club, at St. Mary’s Academy, and Kent Denver. There will also be staging and broadcasting equipment at the northwest corner of E. Quincy Avenue and S. University Boulevard.

The Country Club has provided the following short narrative for the event:

The Amateur Championship is a unique event, far different from the typical professional tour event. Spectator attendance is far less, and traffic impacts are consequently much lower. The event begins with 312 golfers competing at two courses in two days of stroke play, but the field is then cut to 64 players for a match play format which will be played at Cherry Hills, ending with only two golfers in the final match on Sunday. The galleries are small (mostly family and coaches) because the players are relatively unknown. The course does not require grandstands or roping, the tournament is a low-key event with a focus on amateur golf.

Animal ownership is welcomed within the City and our goal is to make Cherry Hills Village the best place to live for both you and your pets! Pet parents have a responsibility to manage their pets' behavior and follow certain rules of pet etiquette, or "PETiquette."

- **Scoop the Poop:** When walking your pet off your property, you are required to have a viable means to pick up your pet's waste. Additionally at home, your pet's yard is required to be kept in a clean and sanitary condition. Please remove excrement in a timely manner to prevent a public nuisance.
- **Barking Dogs:** To preserve the peace in your neighborhood, please keep your pets quiet; noise from a barking dog(s) is considered excessive after just 30 minutes.
- **Always Leash Your Dog:** Unless specified otherwise, dogs are required to be on a tethered leash whenever they are off your property.


## INTRODUCING!
