

**A RESOLUTION
OF THE CITY COUNCIL
OF THE CITY OF CHERRY HILLS VILLAGE
REAPPOINTING MEMBERS AND APPOINTING A NEW MEMBER
TO THE PARKS, TRAILS AND RECREATION COMMISSION**

WHEREAS, Section 3.1 of the City of Cherry Hills Village City Charter authorizes the City Council to "delegate to board and commissions...such functions, powers and authority of the City as it deems proper and advisable"; and

WHEREAS, Ordinance 02-06 established the Parks, Trails and Recreation Commission (the "Commission"); and

WHEREAS, Sections 2-8-20 and 2-8-30 of the City Municipal Code require that the Parks, Trails and Recreation Commission shall consist of seven (7) members: one (1) from each Council district; and one member appointed by the City Council on an at-large basis; provided, however that if the Council is not reasonably able to appoint one member from each Council district the Council may appoint one or more members of the commission on an at-large basis. On the date of appointment, each district member shall be a registered elector of the City for at least three (3) years immediately preceding the date of appointment. Each district member shall be a resident of the district on the date of appointment and throughout his or her term of office; and

WHEREAS, Commissioner Aron Grodinsky has chosen not to seek reappointment at the end of his current term which ends on May 20, 2025; and

WHEREAS, Commissioners Tory Leviton and Mary Presecan are ending their terms on May 20, 2025; and

WHEREAS, Commissioners Leviton and Presecan desire reappointment; and

WHEREAS, applications were solicited through the Village Crier, the City website, and City social media accounts; there was one past applicants from the last two years; and

WHEREAS, Councilor Robert Eber and Councilor Dave Heller reviewed applications and conducted interviews; and

WHEREAS, Councilor Robert Eber and Councilor Dave Heller recommend reappointment of Mr. Leviton and appointment of Mark Williams to serve on the Commission; and

WHEREAS, the City Council determines that Mr. Leviton, Ms. Presecan, and Mr. Williams are qualified and desires to reappoint Mr. Leviton and Ms. Presecan and appoint Mr. Williams to the Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO THAT:

The City Council hereby makes the following appointments to the City of Cherry Hills Village Parks, Trails and Recreation Commission:
