

A RESOLUTION
OF THE CITY COUNCIL
OF THE CITY OF CHERRY HILLS VILLAGE
REAPPOINTING MEMBERS AND APPOINTING A NEW MEMBER
TO THE CHERRY HILLS VILLAGE ART COMMISSION

WHEREAS, Section 3.1 of the City of Cherry Hills Village City Charter authorizes the City Council to “delegate to board and commissions...such functions, powers and authority of the City as it deems proper and advisable”; and

WHEREAS, the Cherry Hills Village Art Commission (the “Commission”) was established by Resolution 6, Series 2011 and expanded by Resolution 10, Series 2017; and

WHEREAS, Commissioner Della Patteson has resigned before the end of her term on the 2nd Tuesday in May, 2027; and

WHEREAS, Commissioners Ann Marie Morrow, Christine Fedorowicz, and Julie Mirr are ending their terms on May 20, 2025; and

WHEREAS, Commissioners Morrow, Fedorowicz, and Mirr have indicated their desire to serve for another three-year term; and

WHEREAS, applications were solicited through the Village Crier, the City website, and City social media accounts; there was one past applicant from the last two years; and

WHEREAS, Councilor Robert Eber and Councilor Dave Heller reviewed applications and conducted interviews; and

WHEREAS, Councilor Robert Eber and Councilor Dave Heller recommend appointment of Catherine Darch to serve on the Commission; and

WHEREAS, the City Council determines that Ms. Morrow, Ms. Fedorowicz, Ms. Mirr, and Ms. Darch are qualified and desires to reappoint Ms. Morrow, Ms. Fedorowicz, and Ms. Mirr to a three-year term and appoint Ms. Darch to a partial term on the Commission.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE THAT:

The City Council hereby makes the following appointment to the City of Cherry Hills Village Art Commission:
