September 16, 2025: Introduced as Council Bill 3, Series 2025 by Mayor Pro Tem Earl Hoellen, seconded by Councilor Robert Eber, and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

October 7, 2025: Considered in full text on second reading. Passed by a vote of 5 yes and 0 no.

**A BILL FOR AN ORDINANCE
OF THE CITY OF CHERRY HILLS VILLAGE, AMENDING THE 2025 BUDGET,
APPROVING A SUPPLEMENTAL APPROPRIATION IN THE CONSERVATION
TRUST FUND, AND APPROVING AN INTERFUND TRANSFER FROM THE PARKS
AND RECREATION FUND TO THE CONSERVATION TRUST FUND FOR THE
QUINCY FARM POND RESTORATION PROJECT**

WHEREAS, Ordinance 9, Series 2024 and Ordinance 10, Series 2024 approved the 2025 budget for the City of Cherry Hills Village (the "City") and appropriated funds in accordance with such budget; and

WHEREAS, Section 9.10, titled *Additional Appropriations*, of the Cherry Hills Village Home Rule Charter (the "Charter") authorizes City Council to make additional appropriations by ordinance during the fiscal year for unanticipated expenditures required by the City, but such additional appropriations shall not exceed the amount by which actual and anticipated revenues of the year are exceeding the revenues as estimated in the budget; and

WHEREAS, in conformance with the City's Purchasing Policy, the City issued an Invitation for Bid (IFB) No. 2025-011 for the Quincy Farm Pond Restoration Project (the "Pond Project") to restore and improve the pond at Quincy Farm; and

WHEREAS, at the September 16, 2025 City Council meeting, City Council approved the Construction Contract with Western States Reclamation LLC to complete the Pond Project; and

WHEREAS, the Pond Project is important to the City's parks, trails, and open space infrastructure as it will ensure the pond's future long-term health and provide recreational and educational opportunities to City residents; and

WHEREAS, the City desires to begin the Pond Project in 2025, but the total required expenditures for the Pond Project were not included in the 2025 budget; and

WHEREAS, the City Council desires to approve a supplemental appropriation to the 2025 Budget in the amounts set forth herein to complete the Pond Project; and

WHEREAS, in accordance with Section 9.10 of the Charter, the additional appropriation contemplated herein does not exceed the amount of estimated and actual revenues in budget year 2025.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

Section 1. That the 2025 Budget and Appropriations be hereby amended and supplemented by increasing the following fund and account by an additional amount of \$137,917.00, to-wit, to provide an interfund transfer from the Parks and Recreation Fund to the Conservation Trust Fund, and the Conservation Trust Fund for the Quincy Farm Pond Restoration Project:

Section 2. Severability. If any provision of this Ordinance should be found by a court of competent jurisdiction to be invalid, such invalidity shall not affect the remaining portions or applications of this ordinance that can be given effect without the invalid portion, provided that such remaining portions or applications of this Ordinance are not determined by the court to be inoperable. The City Council declares that it would have adopted this Ordinance and each section, subsection, sentence, clause, phrase, or portion thereof, despite the fact that any one or more section, subsection, sentence, clause, phrase, or portion would be declared invalid.

Section 3. Effective Date. This Ordinance shall become effective ten (10) days after publication on second reading in accordance with Section 4.5 of the Cherry Hills Village Home Rule Charter.

Adopted as Ordinance No. 3, Series 2025, by the City Council of the City of Cherry Hills Village, Colorado, on the 7th day of October, 2025.
