December 14, 2010: Introduced as Council Bill 31, Series 2010 by Councilor LaMair, seconded by Councilor VanderWerf, and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

January 4, 2011: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

**A BILL FOR AN ORDINANCE
OF THE CITY OF CHERRY HILLS VILLAGE
AUTHORIZING A SUPPLEMENTAL APPROPRIATION
FOR THE REPLACEMENT OF THE CARPET IN THE VILLAGE CENTER**

WHEREAS, the City of Cherry Hills Village desires to replace the carpet within the Village Center in 2010; and

WHEREAS, this project is important to the City's employees and their well being and health; and

WHEREAS, this project is important to the City's Public Safety and Administrative operations; and

WHEREAS, the City desires to complete this project in 2010, but the expenditure was not included in the 2010 budget; and

WHEREAS, performing these operations at this time is necessary to provide for the health, safety, and welfare of the City's residents; and

WHEREAS, it was unforeseen that the City would be performing this improvement during the 2010 fiscal year; and

WHEREAS, the City Council desires to commence the necessary improvements during 2010 for the reasons set forth herein.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

Section 1. That the 2010 Budget and Appropriations be hereby supplemented by increasing the following funds and accounts, to-wit:

General Fund 01-441-1101

As determined on or before December 31, 2010

Section 2. The City Council hereby ratifies all expenditures heretofore and hereafter made pursuant to this supplemental appropriation ordinance.

Adopted as Ordinance No. 1, Series 2011, by the City Council of the City of Cherry Hills Village, Colorado this 4th day of January, 2011.


