Series 2011

May 17, 2011: Introduced as Council Bill 3, Series 2011 by Mayor Pro Tem Stewart, seconded by Councilor Griffin, and considered in full text on first reading. Passed by a vote of 5 yes and 0 no.

June 7, 2011: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

**A BILL FOR AN ORDINANCE
OF THE CITY OF CHERRY HILLS VILLAGE,
AUTHORIZING A SUPPLEMENTAL APPROPRIATION
FOR THE REPAIR AND REPLACEMENT OF
PORTIONS OF THE VILLAGE CENTER BUILDING ROOF**

WHEREAS, the City of Cherry Hills Village desires to repair and replace the failing portions of the roof on the Village Center Building; and

WHEREAS, this project is important to the City's ability to operate its administrative functions; and

WHEREAS, the City desires to complete this project in 2011, but the expenditure was not included in the 2011 budget; and

WHEREAS, performing these operations at this time is necessary to provide for the health, safety, and welfare of the City's residents, staff and visitors to the Village Center; and

WHEREAS, it was unforeseen that the City would be required to proceed with this project during the 2011 fiscal year; and

WHEREAS, the City Council desires to commence the necessary improvements during 2011 for the reasons set forth herein; and

WHEREAS, the City has solicited bids from multiple qualified contractors to perform the necessary work to repair the Village Center roof that is failing.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:


Section 1. That the 2011 Budget and Appropriations be hereby supplemented by increasing the following funds and accounts, to-wit:


Section 2. The City Council hereby ratifies all expenditures heretofore and hereafter made pursuant to this supplemental appropriation ordinance.
