### Series 2011

August 2, 2011: Introduced as Council Bill 6, Series 2011 by Mayor Pro Tem Stewart, seconded by Councilor Brown, and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

August 16, 2011: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

### A BILL FOR AN ORDINANCE OF THE CITY OF CHERRY HILLS VILLAGE, AUTHORIZING A SUPPLEMENTAL APPROPRIATION FOR PRECONSTRUCTION SERVICES RELATED TO THE PLANNING AND DESIGN OF THE PROPOSED NEW JOINT PUBLIC SAFETY FACILITY

**WHEREAS**, the City of Cherry Hills Village desires to complete the design and development of a joint Public Safety Facility in cooperation with the South Metro Fire Rescue Authority, and wishes to retain Adolfson and Peterson Construction for preconstruction services related to the preliminary design of the facility

**WHEREAS**, the City of Cherry Hills Village has entered into an MOU on February 1, 2011 with the South Metro Fire Authority recognizing that both parties desire to move forward in the preliminary design and planning of the proposed joint facility, and

**WHEREAS**, the facility will be designed jointly by the parties and if built will be built on an approximately 2+ acre parcel of land to be subdivided from Lot 1, Block 1, Cherry Hills Center Subdivision, and

**WHEREAS**, this project is important to the health, safety and welfare of the City's and Fire Authorities constituents to ensure that proper and adequate life safety facilities exist; and

**WHEREAS**, the City desires to commence with this project in 2011 for the reasons set forth herein.

### **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:**


Section 1. That the 2011 Budget and Appropriations be hereby supplemented by increasing the following funds and accounts, to-wit:

#### Capital Fund 01-441-1101 Village Center Improvements


