September 6, 2011: Introduced as Council Bill 10, Series 2011 by Councilor Roswell, seconded by Councilor VanderWerf, and considered in full text on first reading. Passed by a vote of 6 yes and 0 no.

September 20, 2011: Considered in full text on second reading. Passed by a vote of 5 yes and 0 no.

**A BILL FOR AN ORDINANCE
OF THE CITY OF CHERRY HILLS VILLAGE,
AUTHORIZING A SUPPLEMENTAL APPROPRIATION
FOR THE PLACEMENT OF ASPHALT ROAD SURFACE ON
SOUTH MONROE STREET**

WHEREAS, the City of Cherry Hills Village desires to complete the paving of the South Monroe Street during 2011; and

WHEREAS, pursuant to the requirements outlined in the City's Development Agreement between the Denver First Church of the Nazarene and the City the Church is responsible for the cost of paving the street; and

WHEREAS, The Church desires to pave the street prior to the requirements outlined in the original Development Agreement dated September 19, 2000; and

WHEREAS, the Church will reimburse the City for the cost to pave the street; and

WHEREAS, performing these operations at this time will provide for the health, safety, and welfare of the City's residents; and

WHEREAS, it was unforeseen that the City would be managing this project for The Church during the 2011 fiscal year; and

WHEREAS, the City Council desires to commence the necessary improvements during 2011 for the reasons set forth herein.


**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS
VILLAGE, COLORADO, ORDAINS:**

Section 1. That the 2011 Budget and Appropriations be hereby supplemented by increasing the following funds and accounts, to-wit:

<u>General Fund 02-441-3101</u>		
As determined on or before December 31, 2010	<u>From</u> \$486199.00	<u>To</u> \$531,199.00
Street Improvement Program (South Monroe Street Paving \$45,000.00)		


Section 2. The City Council hereby ratifies all expenditures heretofore and hereafter made pursuant to this supplemental appropriation ordinance.
