

## ORDINANCE NO. 25

## Series 2010

October 5, 2010: Introduced as Council Bill 25, Series 2010 by Councilor Klasina VanderWerf, seconded by Councilor Harriet Crittenden LaMair, and considered in full text on first reading. Passed by a vote of 5 yes and 0 no.

October 19, 2010: Considered in full text on second reading. Passed by a vote of 5 yes and 0 no.

**A BILL FOR AN ORDINANCE  
OF THE CITY OF CHERRY HILLS VILLAGE,  
AUTHORIZING A SUPPLEMENTAL APPROPRIATION  
FOR AN APPRAISAL OF REAL PROPERTY**

**WHEREAS**, the City of Cherry Hills Village has been in discussions with the Trust for Public Lands regarding certain real property located within the City that may be available for acquisition as open space through the granting of a conservation easement; and

**WHEREAS**, the Trust for Public Lands has asked the City to share in the cost of an appraisal of the property in order for the parties to better determine whether an acquisition is feasible; and

**WHEREAS**, the funds to undertake an appraisal were not included in the 2010 budget; and

**WHEREAS**, the Trust for Public Lands has agreed to undertake the appraisal, and to provide all materials related to the appraisal report to the City; and

**WHEREAS**, the City Council is willing to contribute one half of the cost of the appraisal, up to a maximum of four thousand dollars (\$4,000.00) to the Trust for Public Lands, with such funding to come from the Catherine H. Anderson Land Donation Fund, account number 08-450-6068.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:**

Section 1. That the 2010 Budget and Appropriations be hereby supplemented by increasing the following funds and accounts, to-wit:


Catherine H. Anderson Land Donation Fund, 08-450-6068
