March 1, 2010: Introduced as Council Bill 8, Series 2010 by Mayor Pro Tem Russell Stewart, seconded by Councilor Mark Griffin, and considered in full text on first reading. Passed by a vote of 4 yes and 0 no.

March 15, 2010: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

**A BILL FOR AN ORDINANCE
 OF THE CITY OF CHERRY HILLS VILLAGE
 AUTHORIZING A SUPPLEMENTAL APPROPRIATION
 FOR THE EXPENDITURE OF FUNDS FOR THE DRY CREEK TRAIL IMPROVEMENTS
 FOR FISCAL YEAR 2009**

WHEREAS, the City of Cherry Hills Village received a grant in 2007 in the amount of \$240,600 from Arapahoe County for the Big Dry Creek Trail project; and

WHEREAS, the expenditure of these funds was made in 2009, but were not included in the 2009 budget; and

WHEREAS, the City desires to amend the 2009 budget to include the expenditure for the project and the grant revenue.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS VILLAGE, COLORADO, ORDAINS:

Section 1. That the 2009 Budget and Appropriations be hereby supplemented by increasing the following funds and accounts, to-wit:

Parks and Recreation Fund 30-441-1000
 As determined on or before December 31, 2009


