**Series 2010**

April 20, 2010: Introduced as Council Bill 11, Series 2010 by Councilor Scott Roswell, seconded by Mayor Pro Tem Russell Stewart, and considered in full text on first reading. Passed by a vote of 5 yes and 0 no.

May 4, 2010: Considered in full text on second reading. Passed by a vote of 6 yes and 0 no.

**A BILL FOR AN ORDINANCE  
 OF THE CITY OF CHERRY HILLS VILLAGE,  
 AUTHORIZING A SUPPLEMENTAL APPROPRIATION  
 FOR THE REPAIR AND REPLACEMENT OF  
 THE PUBLIC WORKS ROOF AND FUEL MANAGEMENT SYSTEM  
 FOR FISCAL YEAR 2010**

**WHEREAS**, the City of Cherry Hills Village desires to complete the installation of a new roof on the Public Works Facility as well as a new fuel management system; and

**WHEREAS**, these projects are important to the City's Public Safety and Public Works operations; and

**WHEREAS**, performing these operations at this time is necessary to provide for the health, safety, and welfare of the City's residents; and

**WHEREAS**, the funds for these projects are available in the budget due to savings that have been realized within the capital improvement budget for 2010; and

**WHEREAS**, these projects were not budgeted for in 2010, and are necessary and essential to the operations of the City; and

**WHEREAS**, the City Council desires to commence these improvements during 2010 for the reasons set forth herein.


**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHERRY HILLS

Section 1. That the 2010 Budget and Appropriations be hereby supplemented by increasing the following funds and accounts, to-wit:
